




One of the Great Legal Works of Seventeenth-Century France

#### 1. Bacquet, Jean [d.1597]. Ferriere, Claude de [1639-1715].

Contemporary mottled calf, gilt spine with raised bands and lettering piece, speckled edges. Some rubbing to extremities, chipping to spine ends, corners bumped and somewhat worn, front board beginning to separate but secure, rear joint just starting at ends. Title page printed in red and black, handsome woodcut head and tail-pieces. Early signature to head of title page. Some offsetting, soiling and edgewear to preliminaries and rear endleaves, interior otherwise fresh. \$300.

\* Later edition. Bacquet, an important French jurist, was King's Advocate of the Treasury Chamber, was a prolific author on a wide variety of topics. First published in 1597, four parts of this work are treatises on escheat, aliens, land tenure and judicial administration. The fifth is a compilation of law reports compiled by Claude de Ferriere, a law professor at Paris and prolific author. Bacquet's *Oeuvres* went through several issues and editions. The final was edited by Ferriere's son, Claude-Joseph de Ferriere, and published in 1744. Identical in content, format and collation, the 1688 edition was issued by several Parisian printers. KVK locates 5 copies from 1688 imprint, but none by Cochart. OCLC locates 1 copy of a 1688 imprint (another non-Cochart impression at the University of Montreal). Copies of this edition located in the United States at Harvard Law School and Louisiana State University Law School. Not in Camus or the *British Museum Catalogue*.





\* First published in 1850, this useful household dictionary aimed at the rural consumer went through at least six subsequent editions. (The latest imprint we located is from 1868; Some issues, identical in contents, have a slightly different title beginning with *Manuel des Familles Contenant Dictionnaire....*) All editions are scarce. OCLC locates no copies of any edition in North America, but we found copies at George Washington University law library (1863) and the Library of Congress (1866). *British Museum Catalogue* (Compact Edition) 2:415 (citing a 1858 imprint).




A Landmark in the History of Penology

Contemporary quarter calf over marbled boards, lettering piece and gilt and blind ornaments to spine, marbled edges and endpapers, ribbon marker. Some rubbing to extremities with light wear to spine ends and corners, front joint just starting at head, front hinge cracked. Light toning to text, moderate toning to plates, occasional light foxing. A few minor tears to plates, interior otherwise fresh. An appealing copy. \$1,750.

\* First edition. With plates depicting prisons and their floor plans. In 1831 Beaumont and Tocqueville were commissioned by the French government to examine America's latest prisons, which were renowned for their innovative approaches to penology. Their nine-month tour included visits to prisons in Connecticut, Maryland, Massachusetts, New York and Pennsylvania. Du Systeme Penitentiaire aux Etats-Unis, the result of their tour, was an immediate success that was quickly translated into English and German. It was one of the most influential books on penology ever written. Beaumont and Tocqueville were affected deeply by their experiences in the United States. It led Beaumont to espouse abolition and inspired Tocqueville to write De la Democratie en Amerique (1835). Sabin, A Dictionary of Books Relating to America 4190.

Woodcut head and tail-pieces. Some toning to text. Early annotations to verso of front free endpaper, two early struck-through signatures to title page, interior otherwise clean. \$750.

\* First edition. Organized alphabetically, this guide to French law and judicial administration is an encyclopedia, a treatise and a reform tract. As the title indicates, it outlines different jurisdictions in order to advance an argument for a comprehensive uniform court system. The "questions" relate, for the most part, to tricky aspects of family law. Some of the topics its covers are the marriage of wives of absent husbands, dowries, bastards, the passing on of jewelry, the marriage of minors, second marriages, subrogation, wills, and wards. Bretonnier was an avocat of the Paris Parlement. First published in 1718, his treatise went through five editions, the final appearing in 1783. All are scarce in North America. OCLC locates 3 copies of the first edition in North America, 2 in law libraries (Harvard, University of Michigan). This edition not in Camus.



Contemporary reversed calf, raised bands and fragments of later hand-lettered title label to spine. A few scuffs to boards, rubbing with wear to board edges, spine ends and corners, front board beginning to separate but secured by cords. Woodcut head-pieces, tail-pieces and decorated initials. Moderate toning to text, light browning in places. Early owner signatures to title page and rear endleaves, annotations throughout text in fine early hand. \$850.

\* Seventh edition. Originally published in 1563 as Traicte des Loix Abrogees et Inusitees en Toutes les Cours du Royaume de France, this was a handbook for lawyers who needed to reconcile conflicts between the three legal systems of pre-revolutionary France: canon, customary and civil. It was a useful work that went through several editions and issues, in French and Latin, into the eighteenth century. However, copies are scarce in North American law libraries. OCLC locates 4 copies of the 1578 edition (George Washington University, Harvard, Library of Congress, Northwestern). #### Concerns Canon, Roman and French Law

Moderate rubbing, considerable chipping to spine ends, corners bumped and somewhat worn, joints just starting at ends, a few cracks to text block. Title page with large printer device printed in red and black, woodcut head-pieces, tail-pieces and decorated initials. Some toning, faint dampstaining to lower third of text block, light browning in places. Early owner signatures to title page, interior otherwise clean. Ex-library. Location label to foot of spine, shelf number to front pastedown, small inkstamp to title page, card pocket to rear pastedown. Still a solid copy. \$200.

\* Later edition. Cabassut, a French theologian, priest and authority on canon law, was a distinguished writer on ecclesiastical history, canon law, and theology. His writings reflect his adherence to Probabilism, a moral system applicable to cases of conscience that involve the obligation of doubtful laws. Like other Prababilists, Cabassut believed that a doubtful law is invalid. It is therefore permissible to follow an opinion contrary to that law if it is clearly probable. This idea is central to his *Juris Canonici Theoria et Praxis*. First published in 1675, it is a comparative study of the *Ius Commune* and French ecclesiastical and customary law. Considered an important work, it went through several editions in the seventeenth and eighteenth centuries. *Dictionnaire de Theologie Catholique* II:1297. 

\* Fourth edition. Sweet and Maxwell include this in its list of major bibliographies and notes: "the second volume is a descriptive bibliography of French, English, foreign and Roman law, well indexed. The bibliography lists 2,348 books and provides historical, critical and bibliographical notes on several remarkable books of French jurisprudence." Sweet & Maxwell, A Legal Bibliography of the British Commonwealth 1:1-2 (7).





Contemporary limp vellum, early calligraphic title to spine, ties lacking. Negligible light shelfwear, text block partially detached from binding. Woodcut printer device to title page, woodcut decorated initials. Some toning, light dampspotting and early annotations to a few leaves. \$2,000.

\* First edition. Choppin (or Chopin) was a French jurist and an avocat of the Parlement of Paris. Like Jean Bacquet and Jean Bodin, Choppin drew on Roman law and feudal principles to advocate a centralized state under royal rule. De Privilegiis Rusticorum addresses legal privileges enjoyed by rural people in Roman and French civil law. A well-written and remarkably comprehensive work, it went through seven subsequent editions in Latin. Its final edition, translated into French, was published in 1634. This was a rarely explored topic, and Choppin's treatise is the only early example we have encountered. According to the Biographie Universelle, "it deserves notice for the singularity of its subject, for its profound research, and the decisions it contains" (8:499). All editions are scarce today and rare in North American law libraries. OCLC locates three copies of the 1575 edition (at Columbia, George Washington University and Harvard). Contemporary three-quarter vellum over marbled boards, red and black calf lettering pieces to spines. Light soiling and some rubbing, chipping to edges of some lettering pieces. Occasional toning, light browning and foxing. Later owner signatures and bookplates to front endleaves, interiors otherwise clean. \$1,500.

\* Reissue of an edition first published in 1658 containing all editions and original works. Cujas, a professor of law at the universities of Cahors, Bourges, Valencia and Turin, was the preeminent authority on Roman law in his day and one of its most important scholars. He recovered and published the *Codex Theodosianus* and the *Basilica* and published several commentaries and editions. "He is the outstanding representative of humanism in Roman law. The glossators had studied Roman law as it stood at Justinian's death and the commentators, or Bartolists, had used their comprehensive knowledge of Justinian acquired by the glossators as the basis of a systematic science, but as their was practical they introduced non-Roman elements into the civil law and adapted it to contemporary needs. The school of Cujas viewed the Roman texts as historical documents, interpreting them in the full setting of ancient history and literature. A consummate master of jurisprudence, philology and history, Cujas may claim to be the greatest legal scholar of all time" (Zulueta). Fabrot was a French jurist who continued the work of Cujas and edited the first complete edition of the *Basilica*. His collected-works edition of Cujas was reissued several times. OCLC locates 2 copies of this edition, neither in North America. KVK locates 5 copies, 1 in North America at the National Library of Canada. 1 other copy located at Harvard Law School. This edition not in the *British Museum Catalogue*.

\* Second edition. Du Moulin was a distinguished French humanist lawyer. First published in 1546, Extricatio Labyrinthi is a detailed commentary on the Roman law governing loans and interest. The other book is a commentary on marriage contracts, gifts and testaments. 

Contemporary calf, gilt rules to boards, gilt ornaments and lettering piece to spine. Moderate rubbing with some wear to spine ends and corners, front joint just starting at ends, front free endpaper lacking. Title page, with large engraved allegorical vignette, printed in red and black, woodcut head-pieces, tail-pieces and decorated initials. Moderate toning to title page, light toning to text. Early ownership inscription "Ce livre apartient a Monsieur du Plessix, Brindejon" to front pastedown, interior otherwise clean. \$950.

\* First edition. This commentary on the customary law of Anjou and surrounding vicinity was reprinted in 1725. Pineau was also the author of the posthumous Coustumes du Pais et Duche d'Anjou (1698). A native of Angers and a successful lawyer there and in Paris, Pineau was later appointed Conseiller au Presidial d'Angers and Maitre des Requetes de l'Hotel de Marie de Medicis. Observations is a scarce title. OCLC locates 4 copies of the first edition in North America, 3 in law libraries (George Washington University, Harvard, UC-Berkeley), no copies on the 1725 reissue. \* Only edition. The Congress of Panama was organized by Simon Bolivar in 1826. It aimed to organize a league of the new Latin American republics with unified policy towards Spain, a common military, a mutual defense pact and a supranational assembly. Its goals were never realized. The proceedings, which took place in Panama City from June 22 to July 15, 1826, attracted a good deal of attention from the international community. Dufour de Pradt was an ambassador sent to observe the proceedings by the French government. This book is a summary of his observations. OCLC locates 7 copies in North America, none in law libraries. *British Museum Catalogue* (Compact Edition) 7:827.

#### A Sophisticated Defence of Gallicanism

Some rubbing to extremities with wear to corners and foot of spine, front joint starting at head, early bookplate to front pastedown, clean tear to rear leaf mended with archival tape. Light toning to text, heavier in places, title page creased. Early annotations to endleaves, early owner signature to head of leaf following title page, interior otherwise clean. \$200.

\* First edition. A commentary on the four propositions of the "Declaration of the Clergy of France of 1682," the landmark document fashioned by the great French cleric Jacques Benigne Bossuet (1627-1704), which gave definitive form to the principles of Gallicanism elaborated earlier by Gerson and Richerthat the church and king of France have rights of their own, independent of Rome. Bossuet's declaration shaped church-state relations in France for the next two centuries, asserting not only the autonomy of the Church of France vis-a-vis Rome, but also a sphere of autonomy and supremacy for secular authority in France. Dupin defends each of the four propositions of the Declaration. Cautioning that one must above all practice moderation, he proceeds "with all due respect to the pontiff, to contest the maxims of the ultramontanes." There were later editions in 1724 and 1788. Camus, Bibliotheque Choisie des Livres de Droit 2724.


#### The End of the Bourbon Line

Light shelfwear to boards, spine abraded, most of backstrip worn away, a few cracks to text block, binding secure. Engraved bookplate of Cardinal Ernest-Louis Dubois [1856-1929], Archbishop of Paris, to front pastedown. Toning and light foxing to text, internally clean. A rare title. \$650.

\* In February 1820, Charles-Ferdinand, Duke of Berry, the last living male in the Bourbon line, was stabbed to death in front of the Paris Opera by an apparently deranged citizen. The murder (or as some claimed, assassination) had profound repercussions for French society and closed the final chapter of the Bourbon dynasty. The present work critiques the official coroner's reports following the assassination. The author describes himself as "Ancien Chirurgien de l'Hotel-Dieu, membre des ci-devant colleges et academie royale de Chirurgie, ancien professeur particulier d'accouchemens et membre eligible du college electoral du departement." OCLC locates 2 copies, both in France. Not in the Harvard Law Catalogue.

\* Second edition. First published in 1741, this is a comprehensive treatise on forest and game law during the *ancien regime*. Much of this book is devoted to the decree of August 1669. A notable early example of environmental legislation, it regulated the use of forests to insure a steady supply of wood for the construction of warships. It also ordered the planting of new trees and the careful management of forest resources. It remained in effect until it was supplanted by the *Code Forestier* of 1827. The other laws discussed in this treatise also aimed to conserve fish and game by restricting the number of people who may fish and hunt legally. A third edition was published in 1692. OCLC locates no copies of any edition in a North American law library. We located 1 copy of the second, however, at George Washington University Law School and a third edition at Harvard Law School. \* First edition. With a glossary of terms. Written by Colbert for Louis XIV, the *Ordonnance* of 1681 is significant as the first modern maritime code and a landmark in the history of insurance. As a clear exposition of maritime insurance it soon became a standard reference. More important, Articles 9, 10 and 11 appear to be the first published statement on life insurance. It describes circumstances in which lives may be insured to deal with situations unique to passengers, crews and slaves, most notably capture for ransom. This distinction was exploited initially by dealers in the slave trade, but it had a wider meaning as well. 



"The distinction between religion and law or morality is not clearly made, but Grotius' principle of an immutable law, which God can no more alter than a mathematical axiom, was the first expression of the *droit naturel*, the natural law which exercised the great political theorists of the eighteenth century, and is the foundation of modern international law" (Carter and Muir). The first edition, in Latin, was published in Paris 1625. The first French-language edition is scarce. Copies have not appeared at auction since 2006, where one sold for \$6,000. 



Beyond its legal value, it is significant as the first book published in Grenoble. Guy de la Pape was a legal scholar and statesman who spent most of his career in Grenoble. The three-volume edition from 1554-1554 went through six later editions, the last one in 1613. A unique treatise by a master of the genre on a specialized topic of the law relating to debtor and creditor and other areas involving claims and compensation. Subrogation is the principle by which an individual who discharges a liability of another may exercise all rights appropriate to the latter in obtaining relief from any liable third party. This is the only treatise listed under this topic in Camus. Renusson (here pseudonymously spelled Dernusson), was a third generation advocate, one of the ablest jurisconsults of his time, and a prolific author with at least four major treatises to his credit. \* The Bolo Pasha affair involved a French traitor, Paul Bolo, who convinced the Egyptian Khedive (Viceroy), Abbas Hilmi, to sponsor an anti-war movement in France through the press using \$2,500,000 raised from German sources. (Granted the title Pasha by the Khedive, Bolo renamed himself Bolo Pasha.) Convicted of treason, he was executed by a firing squad in April 1918. Sem's caricatures portray the judge, defendant, witnesses and judges at various points in the trial. Gorsat, or Goursat, was a French caricaturist and illustrator active from the late nineteenth century to 1934. His lasting fame rests on his depictions of French ruling class and French high society during the *Belle Epoque*. He was a regular contributor to the leading French periodicals, produced albums of caricatures depicting current events and social life and designed several path-breaking advertisements. His work is highly esteemed today.
