

Contemporary laced vellum, later repair to spine with portions of existing spine laid down, edges of text block rouged. Light soiling and a few small stains, remnants of early hand-lettered



title to head of spine, early annotation and (illegible) owner signature dated 1680 to front pastedown. Moderate toning to interior, somewhat heavier in places in second volume, light foxing and minor faint dampstaining to a few leaves, small ink library stamp to half-title and title page of first volume, tear to margin of leaf R6 (pp. 187-188) of first volume without loss to text, small hole to leaf U8 (pp. 319-320) of second part with very minor loss to text but not legibility.

LATER EDITION. First published in 1651, *Metamorphosis Telae Judiciariae* is an extensive collection of accounts of amusing and unusual court cases, several of which are accompanied by poems or songs. The second volume contains an additional 150 cases. The final edition appeared in 1712.

Recent (twentieth-century) patterned wrappers. Wrappers beginning to separate from text block but secure. Text in single column with linear gloss. Light toning to interior, occasional small stains and light soiling, tiny wormhole to outer margin of last ten leaves not affecting text, leaves C2-C5 (ff. [14-17])



soiling and faint staining to final leaf, which

has several mended tears with loss to text and final woodcut tree, early hand-coloring to first woodcut tree, annotations to first eight leaves in an early hand, a few affected by trimming at fore-edge.

D'ANDREA was an Italian canonist and professor of canon law at the University of Bologna. An eminent figure who received the highest tributes from Arithemius, Baldus, Forster and Bellarmin, his principal writings circulated widely in manuscript and were among the earliest printed works on canon law. The Super Arboribus is a fundamental treatise on degrees of consanguinity and affinity, also known as blood relations, and spiritual relationships created by godparents and their families. It was a work of vital importance in cases regarding estates, incest and conflicts of interest. It went through numerous manuscript and printed editions into the modern era. Our 1511 edition is the fifth of six printed by Landsberg and features five attractive woodcut trees of consanguinity and affinity. The annotations appear to consist of both brief glosses and longer interpretative notes.






chipping to foot of spine, light wear to board edges and corners, hinges cracked. Light toning to interior, occasional light foxing, small ink marks to right margin of p.109. An appealing copy.

F1FTH AND F1NAL ED1T1ON. An authority on mercantile law, Azuni was an Italian jurist and a writer who later became a French citizen, president of the appeal court at Genoa and judge of the Commercial Court at Cagliari. He is best known for his *Maritime Law of Europe* (1806), which was a standard authority in the United States. Adapted in part from Baldasseroni's *Dizionario* (1807), it is more an encyclopedia or essay collection than a dictionary. Both synthetic and critical, it refers often to the leading treatises of commercial law. Marvin found it useful because it "contains the results of many authors, not readily accessible." Useful for its definitions, it is equally interesting because it has detailed criticism of the literature by a contemporary expert. The first edition was published in 1786-1788.

All editions are scarce; OCLC locates 3 copies of the fifth edition, one in North America (Harvard Law School). Marvin 81-82.


SECOND EDITION. Covering the whole of the *ius commune* from Abbate to Zelo, this dictionary

was compiled from Barbosa's works by Johann Otto Tabor and published in 1652. It was expanded in subsequent editions by Tobias Otto Tabor, Samuel Stryk [1640-1710] and Andreas Christoph Rosener [1657-1719]. The final edition was reissued in 1719 and 1737. The *Thesaurus* is an encyclopedic dictionary; most of the definitions are remarkably long and detailed with numerous citations; many are divided into complex sub-categories. Barbosa was a notable Portuguese canonist, later Bishop of Ugento, who spent his professional career in Rome and Madrid. A prolific author, his work is distinguished by a close reading of sources and a taste for controverted questions. Johann Otto Tabor was a distinguished German jurist and professor of law at the University of Giessen and the brother of Tobias Otto.

All editions are scarce. OCLC locates 3 copies of the second edition in North America (at Harvard Law School, Princeton and UC-Berkeley Law School). This edition not in the *BMC* or Roberts.

Later binding from a 14th or early 15th-century manuscript, endleaves renewed, early vellum front pastedown with early ink annotations (dated 1543). Soiling, minor tears and small holes to exterior manuscript leaf, light rubbing to extremities, light wear to spine ends and corners, which are bumped, hinges cracked, minor worming to rear free endpaper. Moderate toning to interior, occasional light soiling, faint dampstaining in a few places, partial crack in text block between leaves a7-a8, all leaves secure, leaves a8, b1, b2, g6 and h1 recently reinforced at gutter, small wormholes to margins of a few leaves, no loss to text, occasional early underlining, manicules and brief annotations, some affected slightly by trimming.

BETWEEN 1250 AND 1450, the Post-Glossators, a group of legal scholars and teachers in Italy, initiated the recovery of Roman law texts from the corruptions of the medieval Glossators. Their efforts to apply Roman law to the jurisprudence

of their day also prepared the way for the natural law school of the seventeenth century and helped to lay the foundations of the modern state. The greatest member of this group was Bartolo of Sassoferrato, better known as Bartolus. In addition to the commentaries on the *Corpus Juris Civilis* for which he is best known, he wrote a number of treatises on law and politics. *Tractatuli* gathers several of his works, including a brief commentary on Book XII of the *Code* and additional short treatises on nobility, the legal aspects of heraldry, military action, and the authority of states and the rights of their subjects. The latter includes references to Aristotle's *Politics* and an index to Thomas Aquinas's commentary on that work.

Contemporary three-quarter vellum over marbled boards, red and green lettering pieces and gilt decoration to spines, ribbon markers. Light rubbing to boards, moderate rubbing to board edges, light soiling to spines, chipping to edges of lettering pieces, spine ends and corners bumped, corners lightly



worn, small blind embossed ownership stamps to preliminaries and a few leaves in each volume. Light

toning and foxing to interior, light creasing to folding tables, one of which has a small clean tear just touching table, faint dampstain to upper corner of first 20 or so leaves of Vol. I.

ONE OF THE F1RST COLLECTIONS of Beccaria's works. Volume I contains *Dei Delitti e Delle Pene*, Voltaire's famous commentary on that work and two anonymous commentaries: "Giudizio di Celebre Professore Sopra il Libro de'Delitti e Delle Pene" and "Riposta ad uno Scritto, Che s'Initola Note ed Osservazioni sul Libro de' Delitti e Delle Pene." The other two volumes collect Beccaria's writings on economics, aesthetics and other topics. The frontispiece appears to be a variant on Perseus's presentation of Medusa's head to Athena. In this version Perseus is an executioner holding three severed heads in one hand and a sword and guillotine blade in the other. Athena, who is horrified, represents Lady Justice. (Her scales are resting beside her with symbols of justice and industry.)

Contemporary mottled calf, blind rules to boards, gilt spine with raised bands and red and green lettering pieces, marbled endpapers, edges rouged,

silk ribbon bookmark. Light rubbing and minor scuffing and scratching to boards, moderate rubbing to extremities, somewhat heavier to joints, chipping to spine ends, front joint starting at foot, corners bumped and lightly worn, front hinge starting, rear hinge cracked, later bookplate (of Otto Zeilinger) to front pastedown. Woodcut head and tail-pieces. Moderate toning to interior, occasional light foxing.

FIRST EDITION. This treatise discusses the law of exchange in the Holy Roman Empire with attention to bills of exchange, promissory notes and foreign exchange. The frontispiece shows the busy work taking place in a Baroque exchange office with wooden paneling, cornice statutes and pictures, as well as the figure of Mercury, famously the Roman god of trade and patron saint of merchants, with a caduceus, winged shoes and winged helmet. Apparently a well-received work, a second edition was published in 1751.






ONLY EDITION. The *coutume* of the duchy of Burgundy in eastern France, which governed five *baillages*, was codified in 1459 and reformed in 1575. This edition of the *coutume* was compiled by Jean Bouhier, an eminent French magistrate and the first president of the *parlement* of Burgundy from 1704-1729. 

FINAL AND BEST EDITION. Brisson was a renowned French jurist and philologist. Widely respected, he was appointed president of the Parliament of Paris in 1588. First published in 1557, Brisson's *Verborum* was the standard legal dictionary of its day and remained an authoritative source for hundreds of years. In this edition, the definitions are preceded by a useful digest of Roman and French laws and interesting sections on marriage, adultery and the feudal system. Edited and corrected by Johann Gottlieb Heineccius, an important German jurist and scholar at Halle, it is much larger than its predecessors. It includes more notes and entries and a section on the interpretation of Latin grammar by Bohmer, the director of the Halle Royal Academy. Our copy was presented as a school prize from the Amsterdam Latin School in 1811 to Theodoro Lamberto Kock. The initial presentation leaf is signed by the school's rector ("Hirm. Bosscha").

SCHOLARS ARE UNSURE when the coutume of Brittany was compiled, or the names of its authors, but it was first cited officially in 1341. Its final codification was issued in 1580. It deals primarily with civil and criminal procedure and is original in many respects. It also incorporated some aspects of English law, especially in matters concerning succession of certain fiefs, and a good deal of canon law, more so than any other coutumiers. The first part of our pocket-sized edition is the text of the coutume. The second and third parts address parts of the coutume dealing with maritime law, commercial law and territorial jurisdiction. These three parts were also issued separately.

THIS PROCLAMATION introduced a new tax on chimneys and additional taxes on food and wine to support Piacenza's army. It was issued shortly after a major plague epidemic in Italy 1655-1656, which had strained a treasury already depleted by decades of economic stagnation.

LATER EDITION. Widely considered to be the founder of German legal science, Carpzov did much to systematize German law and secure a wide recognition of the Germanic legal tradition. First published in 1635, his magisterial treatise on Saxon criminal law was the first systematic study of its kind. It discusses major crimes, including murder, counterfeiting, blasphemy, perjury and witchcraft, lesser crimes, such as robbery, and the criminal process, including procedure and torture. It had a profound influence on the development of criminal law in the Holy Roman Empire and went through numerous editions into the late eighteenth century.

THIRD AND FINAL EDITION. Chiericato, or Clericato, was a highly regarded expert in canon-law jurisprudence. Vicar-general of the Diocese of Padua for much of his career, he published several books on canon and civil law. First published in 1708-1715, *Discordiae Forenses Civiles et Criminales* is a comprehensive, carefully organized treatise on distinctions between civil and criminal matters in canon law.

It was first printed in Perugia by Petrus Petri de Colonia and Johannes Nicolai de Bamberga around 1474 and reached its tenth edition in 1577. A LANDMARK in the development of maritime law, the *Consolato del Mare* is a digest of the law and practice commonly followed by the commercial judges in the chief ports around the Mediterranean. It became a foundation for subsequent European maritime laws and customs. In addition to legal topics, it contains a great deal of information about commerce, the day-to-day operations of a ship and practical advice on seafaring. It was first published in Barcelona in 1484 (in Catalan). As suggested by the present edition, its circulation was widest in Italy, especially among the Venetians, but it was also influential in Western Europe.

THE *IUS PATRONATUS* is the body of laws concerning patronage by members of

the church, including the granting of privileges, lands and goods. First published in 1506, the commentary of Rochus

Curtius was a standard work on this subject into the seventeenth century. Our edition is remarkable for its magnificent typography and notably wide margins. The printer is not stated in the colophon; he is only identified by the woodcut device on the title page. As a result, this imprint is often mis-attributed.

ONLY FRENCH EDITION. First published in 1544 in Latin as *Pupillorum Patrocinium*, this is a comprehensive treatise on the law of guardian and ward. Like Damhouder's works on civil and criminal law, it has woodcut illustrations, 10 in this case, that illustrate points in the text. One depicts three young orphans with their guardian, tutor, godfather, conservator and executor before a magistrate, facing preface. Other plates depict situations in later stages of life, such as a guardian introducing a child to a teacher, the guardian and child at a shoemaker's shop and the guardian making a record of his charge's assets with an accountant. The French edition includes an address to the reader in verse by Antoine Tiron.

Vandenpeereboom [1843-1917] was a politician who served as prime minister of Belgium in 1899. In 1880, he presented it to a friend along with a note addressed to "Mon cher Jean." This note is laid in to the volume along with a fragment of an 1884 letter that seems to identify the recipient as a Jean Bethune.

COMPLETED IN 1444, this important, alphabetically digested encyclopedia of canon law is an enlargement of the *Summa de Casibus Conscientiae* by Bartholomew of San Concordio. Two other important texts are appended: the *Canones Poenitentiales* by Astesano and Alexander de Nevo's (or Nievo's) analysis of the Church's view of Jewish money lenders, *Consilia Contra Judaeos Fenerantes*. These two texts appear in editions of the *Supplementum* published after 1476. The *Consilia* appears last in our volume and ends with its date of composition, 17 November 1441, but the colophon appears at the end of the *Canones* and dates the printing to 1482.



SECOND EDITION. This is a concise but scholarly dictionary of terms from canon, civil, and Roman law that draws on the work of Ulrich Zasius and Francois Hotman. Some attention is given to classical Greek law as well. The entries, which range in length from a few sentences to several paragraphs, address lexicographical and philological issues and conclude with references and citations. A list of ancient and modern authorities, divided into the following categories, precedes the main text: *Lexicographi, Iuris Auctores, Interpretes, Ex Iure Pontificio, Alii Lexicographi, Ex Medicis, Ex Aliis Classicis*. Little is known about Duprat, and the title page of this edition does not list any academic or professional distinctions. According to notes cited in Roberts's *South African Legal Bibliography*, he was born in Aubusson and taught at the University of Lyons (246). His range of references, descriptive method, organizational style and facility with Latin and Greek demonstrates that he received a solid humanistic education. In addition to the present work, he published and edited treatises on French, Greek and Roman law. The *Lexicon Iuris* went through four editions, the first in 1567 and the last in 1584.

A HEAVILY ANNOTATED COPY, clearly intended as a reference work, of Napoleonic-era bulletin laws dealing with civil procedure and commercial law. Beginning in 1792, bulletin laws with the text of legislation and government regulations were published for circulation to army units and villages with 2,000 or more occupants. The annotator, Maigne Sauzinet, was a Riom jurist. His extensive interpretative annotations include 26 additional leaves with alphabetical tables and notes elaborating on sections of the laws and referencing later statutes. (The latest date in the notes is 1813.) Together, they provide an in-depth look at the evolution and reception of the law in the Napoleonic era.



One of the woodcuts is a trial scene; another is an execution. The plates, by the notable Swiss-German artist Amman, depict a military encampment and land and naval battle scenes.



ONLY EDITION, one of two issues, the other issued the same year as a folio. Submitted as an academic thesis, this work is a detailed commentary on the sections on matrimonial law in Book IV of the *Decretals* of Gregory IX, one of the four works known collectively as the *Corpus Juris Canonici*. Among the topics discussed are marriage contracts, child marriage, bigamy, consanguinity and reasons for annulment, such as non-consummation. Unlike the typical thesis of the era, which is brief and confined to a single, well-defined topic, this work is broad and comprehensive.

FOURTH AND FINAL EDITION. Gremp von Freudenstein was a lawyer and state official who spent his professional life in Tubingen and Strassburg. A well-regarded commentary first published in 1567, *Analysis* is a textbook commentary on Justinian's *Institutes* derived from a manuscript by Brederode, a Dutch jurist and diplomat. Cast in

question-and-answer form, it follows Justinian's text, paraphrasing, abridging, or adapting the text. It is equally interesting for its insights into the reception of Roman law at the end of the sixteenth century.


FIRST PUBLICATION OF THE SECOND EDITION. This landmark work presented a system of international relations based on morality-based legal principles that superseded the laws of individuals or nations. As Carter and Muir point out in *Printing and the Mind of Man*, this basis, "which God can no more alter than a mathematical axiom, was the first expression of the *droit naturel*, the natural law which the great political theorists of the eighteenth century, and is the foundation of modern international law."

Featuring nearly a thousand revisions by Grotius, this edition was both the first edition in folio format and the first to be printed in Amsterdam. Ter Muelen and Diermanse say this is the "most important"

of the first five editions because it contains the most authorial corrections and was the basis for all later editions produced in the author's lifetime. Tuck described it "as the authoritative edition of the book that shaped international law for the whole world." The first edition was published in Paris in 1625. It was followed by a pirated edition printed in Frankfurt in 1626. The 1631 Amsterdam printing by Blaeu was the authorized second edition of this work.

The Mures were a prominent Scottish family of jurists and politicians. An annotation on the title page indicates this book was acquired in Leiden in 1702 by "Gulielme Mure," most likely William Sr. [d. 1722]. William Jr. [1718-1776] was a politician and friend of David Hume. The annotations, which range in length from a sentence to a paragraph, are mostly interrogative in nature and indicate a deep engagement with the book.

(The notice also attests to the accuracy of Blaeu's printing of his work.)

It was frequently bound with or included alongside De Iure Belli Ac Pacis. Using a sophisticated argument based on natural law, it argued for the free navigation of the seas. More specifically, it defended Dutch fishermen who were attempting to operate near the English coast and the Dutch East India Company, which was engaged in a territorial dispute in the Caribbean with Portuguese traders.





Probably the work of a law student, the extensive annotations in our copy, which include references to other Roman-Dutch treatises, date to the late 18th to early 19th century. They indicate a careful and sustained engagement with Grotius's text.





THE REPORT of a commission established by Article V of 1840 to codify Hungarian criminal law and propose reforms. The commission included important Hungarian jurists such as Ferenc Deák, an important figure in the Hungarian liberal movement,




Our edition by Chambon, who added additional content, includes Caccialupi's *Tractatus de Modo Studendi in Utroque lure*, an introductory textbook for law students, and Rosate's *Breve Compendiolum de Orthographia*, a guide to legal writing. 

COMMISSIONED BY THE EMPEROR JUSTINIAN in 530 CE, the body of writings known collectively as the *Corpus Juris Civilis* reformed, restated and preserved early Roman law. Its subsequent influence on European jurisprudence is difficult to underestimate. Edited by van Leeuwen, likely the most prominent Dutch jurist of the late-seventeenth and early-eighteenth centuries, this volume is based on Godefroy's seminal 1583 edition with additional notes by Jacques Cujas, Denis Godefroy, Antoon Anselmo and other important French and Dutch jurists. According to Willems, this edition is renowned for its excellent typography. Our copy appears to have been annotated by two students. The annotations are mostly glosses of the text or summaries.





SECOND EDITIONS. Our volume contains volumes 2 and 3 of the 1595 Vignon/Stoer edition of the *Corpus Juris Civilis*, covering the *Code* and the *Authenticorum*, a selection from the *Novels*. The *Code* contains the laws in force during Justinian's reign. The *Authenticorum* is believed to be a body of laws intended for Italy, though this claim is disputed today. Both received a great deal of commentary during the medieval and early modern eras. That of Denis Godefroy was influential well into the twentieth century. Godefroy was a jurist, humanist, historian, scholar of Roman law and professor at the Universities of Geneva and Heidelberg. He was also the first to apply the collective name *Corpus Juris Civilis* to Justinian's works. The annotations to our copy include interesting brief commentaries on the text, such as a note on p. 776 about "raptores virginum honestarum" (kidnappers of virgins), and a

list of headings opposite the first title page.

COMMISSIONED BY THE EMPEROR JUSTINIAN in 530 CE, the body of writings known collectively as the *Corpus Juris Civilis* restated all existing Roman law. It has four components: the *Code*, *Novels, Institutes* and *Digest*. Intended for students, the *Institutes* is a synopsis of the reformed legal system. Rediscovered during the late Middle Ages, it became the standard textbook of Roman law. The main text of our 1501 imprint is accompanied by Accorso's great *Glossa Ordinaria* (or *Magistralis*). A Professor of Law at Bologna and a leading figure in the revival of classical jurisprudence, Accorso examined every extant note and commentary when he prepared his epochal edition of Justinian's *Institutes, Digest* and *Code*. This massive effort eliminated much of the obscurity and contradiction introduced by earlier writers. His editions, which superseded all previous attempts, remained definitive until the 1583 revision by Denis Godefroy.



THESE VOLUMES contain every part of the *Corpus Juris Civilis* except the *Digestum Vetus*. The texts used in this edition, along with the gloss by Accursius, were the standard versions from the high middle ages until 1583, when they were supplanted by Godefroy's seminal critical edition.

FIRST EDITION. The first official Italian translation of the French Penal Code introduced by Napoleon in 1810. The Code came into force in the Kingdom of Italy under Napoleon's personal rule on January I, 1811. It is divided into four books, with the first two covering criminal responsibility and sentencing, the third defining felonies and misdemeanors against the state and individuals and the fourth enumerating "violations," crimes dealt with strictly on the police level. The 1810 code is notable for its harsh penalties, including extensive use of the death penalty and long prison sentences or a lifetime of hard labor for felonies. It reinstated branding and life imprisonment and gave judges significant discretion in sentencing. It is also of interest for its reliance on the idea of criminal responsibility, independent of contingent circumstances and absolute in its consideration of criminal behavior.

The present copy may have belonged to the jurist Luigi Piantanida (1770-?), who was a lawyer in Milan and a great supporter of Napoleon, to whom he dedicated his treatise *Della*



Giurisprudenza Marittima-Commerciale Antica e Moderna (1806-1808). The detailed notes appear to concern later updates to the Code and subsequent case law. The latest date in the notes is 1813.

FOURTH AND FINAL EDITION. First published in 1484, this is a masterly scholastic exegesis of four principal volumes of canon law: the *Liber Sextus* of Boniface VIII (1298), the *Clementinae*, or *Liber Septimus Decretalium* (1317), the *Extravagantes* of John XXII (1325) and the *Extravagantes Communes* of later popes to 1484. Along with Gratian's *Decretum Gratiani*, or *Concordia Discordantium Canonum* (1151), these works are known collectively as the *Corpus Juris Canonici*. Vanckel, perhaps the leading German canonist of his time, was a professor of law at the University of Cologne.



Some are notably interesting, such as a 24-line statement on p. 32 concerning a woman's right to acquire or retain jewelry without permission from her father or husband in cases of death, remarriage, separation or divorce. Francois Bréchard [b. 1770] was a lawyer in Poitiers, later a deputy judge. Well-respected, he was known for his lively and engaging manner in the courtroom.

ONLY EDITION. This book discusses the history of judicial combat and ordeals in Germany, practices intended to determine the truth of a person's claims through violence or gruesome tests with a supernatural element. Examples of ordeals listed include submersing the arm of the accused in boiling water or overtly religious tests such as the consumption of a communion wafer. It also provides extensive bibliographic details with contemporary sources for each type of ordeal. Notably, Majer's goal was not only historical, but ideological, and the work treats the history of ordeals as reflective of German national identity and essential to understanding German culture.

ONLY EDITIONS. The author was a distinguished jurist and professor of civil, canon and criminal law at the University of Padua. Apophtegmata is a collection of maxims on, to use a modern term, family law. Most of these address marriage and inheritance. The maxims are accompanied by commentary, some of it topical, as in Apoph. 3, which refers to the struggle of Henry VIII and the pope. Other entries refer to the problems of a Paduan colleague (Apoph. 16) and abortion (Apoph. 187). The second work is a brief treatise on the legal status of children and young people (fourteen years old and under) in Padua. It does not have the errata on p. 80 present in some copies and may represent an earlier issue.

THIS IS A COLLECTION of canon law writings by Louis Boniface, intended (so the title page states) to restore discipline at the famous Augustinian community of Grand Saint Bernard in the Swiss Alps, where the author was coadjutor and provost. We understand it to be an official report, later distributed as manuscript copies, which was presented at a synodical meeting of 1718. Much of the study concerns money and property. Other subjects include the officers of the community and a ban on women servants. Showing its high status as a report, other copies are found in the Grand-Saint-Bernard archives. Our copy has a remarkable binding featuring blind-stamped floral designs with red-painted inlay. It was probably made from a wall hanging or wallpaper. The archive of Grand Saint-Bernard has a copy of Boniface's baptism certificate (1664) and several of his papers, which include works on cosmography, geography and history, and a thirty-year travel diary.

The archives of Grand Saint Bernard record four other manuscripts with the same author, title and date (AGSB 5056, 5057, 5058, 4049). We located no other copies.

THIS IS A PERSONAL COPY of a law-degree thesis on woman and marriage according to Roman law and the laws of pre-revolutionary and contemporary France. Its author, Dossat, was born and probably educated in Grenoble. He had a successful legal career, first as a lawyer in Bordeaux and later as a judge in Annecy. He appeared to have a deep interest in the legal status of women. In 1872, he delivered an address at the opening session of the Bordeaux Court of Appeals titled *De l'Emancipation de la Femme*, which was published (Bordeaux: G. Gounnouihou, 1872).

arrangement of material and binding suggest a German university at the end of the eighteenth century.

THIS MANUSCRIPT records an introductory class on the foundations of contemporary civil law. It begins with a brief chapter on the nature of law and proceeds to longer chapters on broad legal systems, such as natural law, and then to detailed chapters on Roman law and canon law. Overall, it offers a fine perspective on the conceptual framework that guided preliminary courses of legal study in the German states at the end of the eighteenth century.



Light soiling and shelfwear, "Formularium Instrorum" to front cover in later hand, along with lists of years 1801-1806 and some other, illegible marks, "1797" to head of spine. Light toning to interior, light soiling to a few leaves, text in neat legible hand.

THE FRONT PASTEDOWN IS SIGNED "Advocado Jo: [Giovanni] Baptista Bonta," who was probably the compiler of this manuscript. Its small format, wallet binding, topical organization and index suggest it was a portable reference work. The portions in Latin, many with book and chapter citations, primarily appear to be paraphrased excerpts from the civil statutes of the Republic of Genoa. Others are in question-and-answer format and appear to deal with topics in Roman law. Many, if not most, of the Latin passages are followed by forms in Italian dealing with the area of law cited in the previous passage; some of the statutory material appears in Italian as well. The manuscript generally deals with practical topics, such as notaries, wills, contracts and some procedural matters, and likely served as a portable manual of everyday practice for a working lawyer. One of the forms appears to be dated April 13, 1797, almost precisely two months before Genoa became the Ligurian Republic under Napoleon, suggesting that the manuscript may also provide insights into late Genoese legal tradition and practice within a system on the brink of transformation.

THIS IS A CAREFUL TRANSCRIPTION of the *Institutes* of Justinian with detailed notes in ruled columns in the outer margins. Added to about one-half of the text, they are under the headings "Renoardus" or "Bengeus." These are likely the names of law professors, which suggests these are notes taken during lectures. In contrast to Justinian's text, the notes are not as neat and have occasional crossouts and corrections. Written around 161 CE, the *Institutes* is an elementary treatise on Roman private law that served as a standard text for 300 years.



F1RST ED1T1ON. Mazzolini, a theologian and wide-ranging scholar, was an inquisitor and censor of books for Rome. An early opponent of Martin Luther, he was involved in the juridical process against him. (Mazzolini was also involved in cases against Johann Reuchlin, Pietro Pomponazzi and Erasmus). A great deal of his scholarship was devoted to the works of St. Thomas Aquinas. Also known as the *Egregium vel Potius Divinum Opus in Iohannem Capreolum*, Mazzolini's *Compendium* is a summary of a work of another Aquinas scholar, Jean Capreolus [c.1380-c.1444] dealing with Aquinas's commentaries on the *Libri Quattuor Sententiarum* of Peter Lombard [c.1096-1160], one of the great works of Medieval



theology. Silberschlag, the former owner of this copy, was a professor of theology at the University of Erfurt.

LATER EDITION. A work of great authority, this popular dictionary was first published in 1559. It went through more than twenty-five editions, with several variations in content, during the sixteenth and seventeenth centuries. All editions have two principal parts: the fifteenth-century *Vocabularius* attributed to Jodocus of Erfurt and Nebrija's *Lexicon luris Civilis*. It is a curious hybrid of late-medieval and renaissance scholarship; the former work is a typical scholastic compilation, the latter is a humanistic work grounded in philology and historical commentary.

Nebrija was an important Spanish scholar and educator. Educated at the universities of Salamanca and Bologna, he read widely in law, medicine and theology. His philological work, which included the first Spanish grammar and dictionary, led to the standardization of the language. In 1502 he was a member of a group of scholars gathered by Cardinal Ximenes de Cisneros at Alcala to produce the Complutensian Polyglot Bible.



REISSUE OF THE THIRD EDITION. This was the first work devoted to German definitions of Latin legal terms. As much an encyclopedia as it is a dictionary, it contains extended discussions of several topics in Roman and German law. It is an indispensible reference for research into eighteenth-century Feudal, Cameral, Saxon and Holy Roman Law. The first edition was printed in 1721. Seven reissues and editions followed, the last in 1753.

ISSUED during the turbulent pontificate of Pius VII, this interesting volume provides fascinating insights into policy-making in the Papal States during the early years of the



Napoleonic era. The period covered in this volume was one of great political tension and uncertainty. Pontifical rule was re-established after the fall of the short-lived Roman Republic in 1799, but the States remained insecure. They were annexed by Napoleon in 1809. Prefaced with a detailed manuscript index, the volume's contents are arranged chronologically. Subjects addressed range from monetary policy to control inflation to laws restricting the manufacture and possession of firearms and the unauthorized export of antiquities or artworks. These latter proclamations were a

property. Manuscript additions to ff. II-I2 suggest the volume was likely compiled by a lawyer from the papermaking city of Fabriano in Le Marche, then a part of the Papal States.

All of the thirty-one printed items are rare. Eighteen are not recorded on OCLC or ICCU. Of the remainder, seven are not traced outside Italy. A detailed complete list is available on request.



He was a prolific author; several of his works were standard texts. *Verhandelinghe van Handt-Opleggen ende Besetten* is a comprehensive treatise on arrest and seizure of property. First published in Latin in 1654 as *De lure Sistendi*, it went through several Latin editions into the seventeenth century and was one of the titles included in the *Tractatus Universi Juris* (1584-1586), the multi-volume anthology



of key contemporary legal works edited by Francesco Ziletti under the patronage of Pope Gregory XIII. The translation edited by Van Leeuwen, possibly the most widely read Dutch jurist of the late-seventeenth and eighteenth centuries, expanded its audience. First published in 1653, it went through seven subsequent editions, the last one in 1784.

The Van Leeuwen editions are scarce. OCLC locates 2 in North American law schools, a 1569 edition at Yale and a 1712 edition at UC-Berkeley Law School. Dekkers 99, 131.

SECOND EDITION. First published in 1497, this landmark treatise on the nature of contracts under Roman law, canon law and Catholic doctrine was the first work to offer a comprehensive and systematic attack on the prohibition of Usury. "Summenhart's contribution was twofold: first, in enormously widening all the possible exceptions to the usury prohibition, i.e. the *census* and *lucrum cessans*; and second, in launching a blistering direct assault on all the time-honoured arguments against whatever usury contracts remained. On the first, Summenhart developed the argument for insured or guaranteed partnerships far more subtly and extensively than before. He also widened the *lucrum cessans* exception far more than anyone else had ever done. Money is fruitful, Summenhart declared boldly, it is the merchant's tool, which he can make fruitful by the use of his labor. Consequently, the merchant should be compensated for loss of the use of his money just as a farmer should be recompensed for the loss of his fields" (Rothbard).

Alexandre Rosenberg [1921-1987], an art dealer, and his wife, Elaine [1921-2020], were important collectors of illuminated manuscripts and early printed books. Picasso, who was represented by Alexandre's father, the eminent Paris art dealer Paul Rosenberg [1881-1959], was a lifelong friend.



ONLY EDITION. This dissertation discusses the rights of women, with an emphasis on married women, in Roman law and the Napoleonic Code, which was the law of the Netherlands until 1838. The main text is followed a poem by Gerardus Dorn Seiffen (1774-1858), a notable classicist and scholar of Roman law. Our copy's handsome binding suggests it was the author's, possibly bound as a gift to him, or bound by him for presentation.

F1RST ED1T1ON. Berry, located in central France, is known as the birthplace of several kings and members of the French royal family. First codified in 1540, its customary law was influenced deeply by Roman law. This work is an important commentary on its *coutume* by the French jurisconsult, historian and numismatist Gaspard Thaumas de La Thaumassière. The fourth and final edition appeared in 1694.

Our copy contains interesting annotations discussing later case law and comparing the author's remarks to other commentaries. For instance, one note discusses a 1672 judgment in the case of "Madame la Princesse de Guéméné" where customary law took precedence over Roman law. Other notes cite the *Journal du Palais* and commentaries on the customary law of Orleans, Paris and Rheims, among other sources.

LATER EDITION. André Tiraqueau, lawyer at the Parliament of Paris since 1541, was



an authority on civil law and a leading legal humanist. First published in 1543, *De Utroque Retractu* is a comparative work on the civil law and the customary law of Poitou. A well-received work, it went through several later editions and issues into the seventeenth century.

Based on the handwriting style and content, our copy appears to have been annotated in the late sixteenth or early seventeenth centuries. Several notes relate to inheritance and succession. Others indicate penalties (p. 86) and prohibitions of alienation of the goods of others (p. 200). Throughout, the annotator quotes judgements of the Parliament and does not, in several places, hesitate to contradict Tiraqueau.

More important, by combining these works and filling the gaps with original entries he was able to

create a dictionary that covered the whole language of the law. Vicat's definitions are brief, but they contain comprehensive reference to authorities and texts, as well as conjugations, common phrases using the words, metaphors, alternate definitions and antonyms. Vicat was a jurist and the director of the University of Lausanne's library from 1749 to 1762. A pioneer in library science, he was the first to issue a printed catalogue.

LATER EDITION. Vigelius, a professor at Marburg, was one of the leading legal methodists of the late sixteenth century. His *Gerichtsbüchlein* is a comparative collection of cases judged under Roman law, canon law and the customary laws of the Holy Roman Empire. First published in 1588, it went through several editions and issues into the eighteenth century. Our 1635 edition has an attractive copperplate pictorial title page with a depiction of Lady Justice.



LATER EDITION. Vigelius, a professor at Marburg, was one of the leading legal methodists of the late sixteenth century. First published in 1565, *Methodus Universi luris Civilis* is a series of proposals for the reorganization of Roman law based on the needs of modern courts. Its final edition was published in 1628.

THE CORPUS JURIS HUNGARICI consists of the Tripartitum, the first distillation of Hungarian customary law, the Cynosura, its separate accompanying indices, and Hungarian statutes issued after the Tripartitum in 1517. The first compilation to use the title Corpus Juris Hungarici was published in 1696 by Márton Szentiványi; later editions, such as ours, also include the Praxis Criminalis of Ferdinand III. Though later editions were known to be defective, the Corpus Juris Hungarici maintained its authority by frequent use in the courts and provided the basis of Hungarian law until 1848.




LATER EDITIONS. The two titles in this book, both rare, are an edition of the *Tripartitum*, with anonymous notes, and an analytical commentary on, to cite its title, 100 "controversial" and "doubtful" points in that work. Compiled by Werböczy and presented to the Diet of Hungary in 1514, the *Tripartitum* was the first to provide a distillation of Hungarian customary law. It aimed, for the most part, to enumerate the rights of the Hungarian nobility, mostly in respect to lands its members held, and outline the principles of Hungarian procedural law. The work was prefaced by a prologue that drew on a largely unidentified array of canonical and civilian texts. It was first published in 1517. Though never an official work, it was the basis of Hungarian law until 1848, and some



of its passages were retained in later collections of Hungarian law. The annotated *Tripartitum* was first published in 1700, its final edition in 1822. The *Centuria Certarum* was first published in 1619 with later editions, some incorporated into editions of the *Tripartitum*, into the 1800s.

OCLC locates 4 copies of the 1762 *Tripartitum* and 3 copies of the 1764 *Centuria Certarum*; it locates a volume identical to ours at the University of Chicago and no other editions of either title in North America.

THIS BOOK collects three important early legal reference works. First published in 1475, *Modus Legendi Abbreviaturas* is a dictionary of abbreviations compiled by the fifteenth-century jurist Wernherus

of Schussenried. First published in 1497, *Legum Flosculi*, more commonly known as *Flores Legum*, is an anonymous collection of maxims arranged alphabetically. Attributed to Portius Azo, the *Brocardia Iuris* is a legal handbook. These three titles were often published together or bound together by owners.

In North America, OCLC locates I copy of this edition of *Modus Legendi Abbreviaturas* (Yale Law School), 2 copies of *Legum Flosculi* (Yale Law School, Charleston Library Society) and I copy of *Brocardica Iuris* (Yale Law School). *USTC* 198601, 154650, 154630.

SECOND EDITION. Parlodorio's life or career was an advocate in Valladolid and a legal advisor to the Spanish monarchy who was renowned throughout Europe for his knowledge of civil, administrative and commercial law. His works went through many editions and were published in several important publishing centers. *Opera Juridica* is a collection of his most important works. First published in 1595, its final four editions were published in 1688, 1734, 1761 and 1762. All are scarce.

OCLC locates 10 copies of the second edition, none in North America. USTC 6154013.


