Contemporary vellum, raised bands and early hand-lettered title to spine, another title to foot of text block in early hand, ties lacking. Light soiling, rubbing to extremities with some wear to spine ends, top edge of front board and corners, a few worm holes to boards and front pastedown, partial crack between text block and rear free endpaper. Attractive crible initials. Toning, faint dampstaining to endleaves and a few text leaves. Early owner signature to foot of title page, annotation in his hand to endleaves, interior otherwise clean. \$1,000.

\* Later edition of a work first published in 1530 (one of three imprints issued in 1537, the others in Cologne and Venice). An important Italian humanist and professor of law at Avignon, Bologna, Milan, Padua, Ferrara and Bourges, Alciati was one of the first jurists to base his interpretation of civil law on the history, languages and literature of antiquity, and to conduct original research on the texts rather than merely copy earlier glosses. His work was deeply influential and his services were retained by the kings of France and Spain, as well as by several Italian princes. As one would expect, there was a large market for his works. In addition to those published by Alciati there are several unauthorized publications based on lecture notes compiled by his students. First published in Cologne in 1530, *Iudiciarii Processus Compendium*, a treatise on procedure in civil and canon law, appears to fall into this latter category. Some sources say it is not based on Alciati's work and is the work of an anonymous author. It was nevertheless a popular work that went through several editions and issues over the next 30 years. OCLC locates 3 copies of this imprint, 1 in North America (at the University of Iowa). Not in Adams or the USTC.

\* Second edition. This handy treatise was first published in 1534 and went through three editions, the last in 1540. The first part offers pointers for lawyers practicing in the Kingdom of Naples. The second part, entitled *Tractatus Cautelarum*, addresses Neapolitan civil law and procedure. All editions are rare. OCLC locates 2 copies in North America at UC-Berkeley Law School and the Library of Congress; both have copies of the 1534 edition. *Censimento Nazionale delle Edizioni Italiane del XVI Secolo* CNCE3098.



\* Only edition. "Meditatio Fugae is an old principle of Scots law that if a creditor could make an oath that his debtor was in meditatione fugae to avoid payment of his debt, he may apply to a magistrate who may grant warrant for apprehending the debtor for examination, and subsequently, grant warrant to imprison the debtor until he finds caution judicio sisti" (Walker). OCLC locates no copies in North America. Copies located at the Library of Congress and Harvard Law School. Walker, Oxford Companion to Law 832. 

\*Only Dublin edition, stated the third, presumably a reissue of the sixth London edition (1791). This popular work was first published in London in 1766 and was generally referred to as "Boote's Suit at Law." It went through several editions, the last one in 1839. "The history of procedure [in the eighteenth century] is represented by [this book]. It is an able summary of which I have made use of in a preceding volume of this History. One of the objects of the book was to lay a foundation for some very necessary reforms in this branch of the law, the need for which was clearly explained by the author" (Holdsworth). The English Short-Title Catalogue locates 6 copies in North America, 2 in law libraries (Columbia and York University). This imprint not in Sweet & Maxwell. \* First edition. Organized alphabetically, this guide to French law and judicial administration is an encyclopedia, a treatise and a reform tract. As the title indicates, it outlines different jurisdictions in order to advance an argument for a comprehensive uniform court system. The "questions" relate, for the most part, to tricky aspects of family law. Some of the topics its covers are the marriage of wives of absent husbands, dowries, bastards, the passing on of jewelry, the marriage of minors, second marriages, subrogation, wills, and wards. Bretonnier was an avocat of the Paris Parlement. First published in 1718, his treatise went through five editions, the final appearing in 1783. All are scarce in North America. OCLC locates 3 copies of the first edition in North America, 2 in law libraries (Harvard, University of Michigan). This edition not in Camus.



Early owner signature (Lemuel C. Baine) to front free endpaper and following endleaf, interior otherwise clean. \$150.

\* This appears to be a true first. Cohen lists this as an 1829 (c. 1828) imprint with the following pagination: viii, 212 pp. This copy has a title page dated 1828 and a different pagination. Shaw list the 1829 imprint but omits the 1828. OCLC locates 4 copies dated 1828 with the pagination of the 1829 imprint, 2 identical to ours. See Cohen, Bibliography of Early American Law 4634. \* Only edition, published the same year in London and New York. "[T]he author trusts he will not be thought presumptuous in stating, that a compendious digest, immediately calculated for the use of merchants and their agents, still remains a desideratum in the merchant's world. With a view to supply this deficiency, he commenced the following compilation": (vii). Burn was a barrister of the Inner Temple who published several law books. The appendix contains summaries of two recent English decisions, and the form of an insurance policy for a ship or goods. Cohen, *Bibliography of Early American Law* 7055.

\* First German edition, published the same year as the first Venice edition. Carocci discusses the Roman law dealing with priorities of claims and liens. According to the title, this edition corrects numerous inaccuracies of the Venice edition. It was published at the expense of Peter Kopff, a notary in Frankfurt. A second edition was published in Venice in 1603. All are scarce. OCLC locates 3 copies of the 1597 imprints in North American law libraries, 2 of the Venice (UC-Berkeley, University of Michigan), 1 of the Frankfurt (Harvard). \* Fourth edition, published the same year as the first three. "As soon as it appeared, Cushing's *Manual*...became a guide for the procedure of all organized assemblies. Its sale was extensive, and thousands of copies were abroad as well as in this country...It was so thorough and complete in its original form that it is in constant use today by legislative bodies. From town-meeting to cabinet meeting, the *Manual* gave order to the democratic process.": Grolier Club, *One Hundred Influential American Books Printed Before 1900* 53. \* Second edition, "continued to the end of the last session of Parliament, 1713," which adds an addenda to the first edition of 1708. It was one of the earliest books on the subject. According to Sweet & Maxwell, the first studies were *Freedom of Elections to Parliament* (1680) and *Observations Concerning the Regulation of Elections for Parliament* (1689), a work attributed to the Earl of Shaftsbury). OCLC locates 6 copies, 3 in North America (at the Library of Congress, Harvard Law School and Stanford University). \* Second edition. Ercolani's treatise addresses the Roman law of interdict, a category of orders or prohibitions issued by a magistrate and addressed to a particular person to give immediate protection to a threatened interest of a complainer. They were also used to protect public interests, such as waterways. The first edition of this treatise was published in 1569, third and final in 1580. 7 copies located in North America, 2 of this edition (at UC-Berkeley and Harvard Law Schools). 





\* The work, compiled from unidentified sources by an unidentified compiler, was originally published in Rome in 1479 with colophon title *Procuratorum Formularius*. Usually referred to as the *Formularium Procuratorum*, it is a collection of canon-law legal instruments established by the Roman Curia relating to procedure, actions and defenses. It offers an excellent "ground level" view of canon law practice in the early modern era. No copies of the 1514 Lyons imprint located on OCLC, or in Adams or Baudrier. One copy located in North America (at GWU Law School).

\* Only edition. Written when he was Probate Register for Cumberland County, Freeman was a lawyer and judge in Portland, Maine who served in the Provincial Congress (1775) and the Massachusetts House of Representatives (1776, 1778). He wrote several legal manuals including *The Probate Directory* (1803) and *The Massachusetts Justice* (1795). Cohen, *Bibliography of Early American Law* 4683.



\* Second edition, enlarged. Added here is an act pertaining to elections in the Scottish Parliament. The first edition was published in 1733. An appealing copy of a scarce title. \$1,500.

\* Only edition. Hoogh was a *doctor juris* and an advocate of the High Court of Mechelin, an influential tribunal. Like a modern casebook, Hoogh's book is a collection of cases arranged to demonstrate general legal principles. It cites numerous medieval and Renaissance authors. OCLC locates 4 copies, all in the Netherlands. Other copy located in the Robbins Collection at UC-Berkeley and Harvard Law school. Dekkers, *Bibliotheca Belgica Juridica* 83.

\* Only edition. Two studies related to marriage, parental consent and illegitimacy. Launoy (of Lennoi) appended a reprint of Hervet's work, which was first printed in 1556. Not in the *British Museum Catalogue* or Camus. OCLC locates 1 copy in North America (at Yale University).



Contemporary sheep, blind rules to boards and spine. Light rubbing to extremities, small chip to head of spine, rear joint just starting at head, front hinge cracked but secure, rear pastedown loose and worn around the edges. Clean tear to fore edges of a few leaves with no loss to text. Offsetting to margins of endleaves, toning to a few text leaves, interior otherwise fresh. From the Earls of Macclesfield library with their armorial bookplate on the front pastedown, the library's small embossed stamp to title page, small shelf labels to spine. A lovely unsophisticated copy very well preserved in the original state. \$750.

\* First edition with parallel texts in English and Law French. Written during the reign of Edward IV [1442-1483] and first published around 1481, Littleton's *Tenures* is probably the most revered treatise in the history of the common law. Much admired for its learning and style, it is concerned with tenures and other issues relating to real property. This venerable work, which Coke called "the ornament of the Common Law, and the most perfect and absolute work that ever was written in any humane science," is considered a landmark because it renounced the principles of Roman law (and Latin) in favor of guidelines and doctrines drawn from the Year Books and, when necessary, hypothetical cases. Mackenzie was Lord Advocate during the reigns of Charles II and James II. Best known for his role in the persecution of Scottish Presbyterians, which earned him the nickname "Bloody MacKenzie," he was an important jurist, scholar and author, and the founder of the Advocates Library, which is now part of the National Library of Scotland. 



The book concludes with a pair of related essays by Bembo and Pico della Mirandola. This was a popular work that went through several editions and imprints to 1615. All editions are scarce, however. Maitland on *The History of English Law Before the Time of Edward I* and his correspondence with Oliver Wendell Holmes, which was published posthumously as *The Holmes-Pollock Letters*.

[The] case came for trial before a special jury at Durham. Mr. Scarlett (afterwards Lord Abinger), a most consummate advocate, conducted the prosecution, and Brougham the defense. Brougham made a magnificent speech, but it was rather a political manifesto than a wise appeal to a jury at Durham, who were not likely to be pleased with torrents of irony addressed to such topics as the revenues and management of their palatinate.
