






\* First edition. According to Marvin, this "is said to be an unequal performance," but "is a useful and convenient book." 





\* Second edition. Bird produced a well-regarded series of handbooks on a broad rage of legal topics. The Law Respecting Tithes was not an exception. First published in 1800, it went through six editions, the last on in 1817. All editions are scarce today. \* Reissue of the first, and only, edition. "The first edition was published in London, 1836; the selections were made by John Warren Smith, whose name did not appear in the book. Smith and Warren prepared the extracts for publication. The 1837 publication is a verbatim reprint, according to Warren's preface to his 1855 abridgment" (Eller). Warren wrote several fictional and non-fictional works about the law, such as the novel Ten Thousand a Year (1841) and the classic primer A Popular and Practical Introduction to Law Studies (1836). In 1855 he published another Blackstone-based primer, Blackstone's Commentaries Systematically Abridged. It had a second edition in 1856. \* Second and final edition. One of the earliest books on the topic, this brief treatise was originally published in 1670 under Blount's name with a slightly different title. Blount was a member of the Inner Temple. Prohibited to practice at the Bar because he was a Catholic, and blessed with a large private income, Blount turned to legal scholarship, historical studies and lexicography. 



\* Only edition. A notable work of Historical School jurisprudence, this treatise addresses the Roman law of inheritance and succession and wills with comparisons to these laws in Prussia and, to a lesser extent, other German states. Bluntschli was one of the great Continental jurists of the nineteenth century. He published a code for the Canton of Zurich and works on German private law, the law of war and international law. His most important historical work is the Geschichte des Allgemeinen Staatsrechts und der Politik (1864). \* Later edition of a work first published in 1594. Bronkhorst was a professor of law at the University of Leiden from 1587 until his death. According to Roberts, his work was cited often by the leading Roman-Dutch authorities, especially van Leeuwen. *Enantiophanon* is an extensive treatise on controversial topics in Roman-Dutch law. 



\* Second edition, with supplement; the best edition of this work. "The first edition of this book sprang from the author's desire to bring order out of chaos. There was a need for a collation of authorities on the Law of Trade-Marks and kindred matters; and that need was felt, not only by owners of applied symbols of manufacture and commerce, but also by bench and bar alike. (...) It is probable that no other branch of legal science has had a more rapid growth during the twelve years since the first edition appeared. (...) An historical sketch of the legislation, prior to 1869, has been consequently compressed within the limits of a single chapter; and for the same reasons the cases cited are comparatively few" (Preface). \* Second edition. "This treatise is intended to contain a summary of those principles of Law and Equity which govern the acquisition and transfer of property in mines, and the duties, rights, and liabilities of Mine-owners and adventurers, arising out of their relations among themselves and the public" (Preface). Collier's first edition was published in London in 1849, then reissued in Philadelphia in 1853. All editions are scarce. 



\* Sir Richard Hill was a strict Methodist and a fiery controversialist. *Pietas Oxoniensis* is a violent attack on the university authorities who expelled six students from St. Edmund Hall, Oxford, for adopting Methodism in 1768. Nowell, the principal of St. Mary Hall and Public Orator, replied on the university's behalf. Hill continued the debate in 1769 with *Goliath Slain: Being a Reply to the Rev. Dr. Nowell's Answer to Pietas Oxoniensis*. The tipped-in newspaper clipping is an announcement for this pamphlet. *English Short-Title Catalogue* T14247, T21992.

\* Third edition, and the final authorial edition. With indexes. Huber was a well-known Dutch jurist and professor at the Universities of Francker, Utrecht and Leyden. He was also a judge in Friesland and the author of numerous legal works on Roman and Roman-Dutch law. He was as important in his day as Grotius, and his work remains influential in South Africa. First published in 1664, *Digressiones Justinianeae* went through eight editions, the final in 1721. More an essay collection than a treatise, it collects his thoughts on a variety of Roman law topics. He also discusses legal pedagogy and the work of his contemporaries and near-contemporaries, such as Grotius and Hobbes. These latter sections are especially interesting because they show what a learned contemporary thought of their work when it was new. 



\* Tenth edition. "Maine indicates the place in the development of a legal system of such agencies as legal fictions and equity. He explains the history of the concept of a law of nature; and in his account of the contrast between primitive and modern society--between the place which the law of persons occupies in primitive and modern law--he comes to the famous conclusion that the government of progressive societies has been from status to contract.": Holdsworth, History of English Law XV:363-64. \* First edition. This is one of the earliest and most extensive legal works on auctions under Roman and Roman-Dutch law. Among other topics, it addresses the rules governing auctions, judicial sales, public contracts and the sale of confiscated merchandise. Matthaeus was a jurist, professor of law at the University of Utrecht and the author of the influential treatise *De Criminibus* (1644). A leader of the Dutch Elegant School of jurists and, to quote Wessels, "a consummate Roman lawyer and a great student of antiquity," his work was renowned for its erudition, literary quality and philological sophistication. 

\* First edition. This scarce book is a fine guide to the state of conveyancing during the mid-seventeenth century. This was a fairly successful work; its final edition, the fifth, was published in 1683. Sir Frederick Pollock [1845-1937], one of the greatest British judges and legal scholars of his day. His treatises on contracts, jurisprudence the common law and other subjects did much to clarify and systematize English law. Several of these were standard texts that went through several editions. He is also remembered for his collaboration with F.W. Maitland on *The History of English Law Before the Time of Edward I* and his correspondence with Oliver Wendell Holmes, which was published posthumously as *The Holmes-Pollock Letters*. Sir Frederick Pollock's Copy of The Lawyers Light



\* Only edition. Sir John Dodderidge, or Doddridge, a judge during the reign of Charles I, was a formidably learned jurist who was both a common lawyer and a civilian who held a D.C.L. from Cambridge. Held in high esteem by Holdsworth, he is best known for English Lawyer: Describing a Method for the Managing of the Laws of this Land (1631). 





While Bracton earns the highest praise as the father of legal learning, Fleta earns a share of it for the illustrations he offered to some of the obscurities found in Bracton. Selden's appended dissertation (pp.453-553) contains many interesting observations about Bracton, Britton, Fleta, and Thornton "and shows what use was made of the Imperial law in England whilst the Romans governed here, at what time it was introduced into this nation, what use was formerly made of it, how long it continued, and when the use of it totally ceased in the King's Courts at Westminster" (Bridgman). 



\* Only edition. Sabin remarked humorously that this was "light reading for the Gold Hunter on his voyage around the Horn." Rockwell's *Compilation* addressed the needs of miners and other individuals who needed to reconcile Mexican land titles with the new U.S. laws that went into effect in the territory acquired by the United States in the recently concluded Mexican-American War (1846-48). An impressive achievement and a notable contribution to comparative law, it discusses Mexican mining and real estate laws, and their Spanish colonial antecedents, and offers comparisons to the common law of mines and mining. Also included are treaties and other general documents, such as the Treaty of Guadalupe Hidalgo and Mexican colonization laws from 1823 to 1846, and a vocabulary of Spanish words. Recognized as an authority at the time of its publication, it remained a standard work for decades and is even cited today. The present volume, which was first published as an appendix to the Lawes and Actes, is a dictionary of ancient Scottish legal terms. 

\* From the *Pamphleteer* Vol. IV, No. 8. Talfourd, then 18 years old, argues against the pillory and corporal punishment, which, he states, is not meant to reform, but to "render evil more abundant. Thus the Pillory is the preparation for the scaffold, though a stormy interval of rapine and crime frequently elapses between them (538). OCLC locates 10 copies, 1 in a law library (Harvard). Also a notable poet, playwright and literary critic, Talfourd was a Justice of the Court of Common Pleas.

Tomlins was a leading legal writer of his day. 

In 1819 he was fined 1,500 pounds and imprisoned for three years for six counts of "blasphemous libel." He published this account of the first day of his 1819 trial after his release. It deals with the information against him for publishing Thomas Paine's Age of Reason and Examination of the Passages in the New Testament Quoted from the Old and Called prophecies concerning Jesus Christ, which Carlile issued as The Age of Reason, Part the Third. The son of Samuel Johnson's associate James Boswell, Sir Alexander Boswell, first Baronet [1775-1822] was a Scottish poet, antiquary, and song writer. He used the funds from his inheritance to purchase a seat in Parliament and later achieved a Baronetcy for his political support of the Government. After he left Parliament, Boswell wrote a series of anonymous essays denouncing Stuart, a prominent Whig. When Stuart suspected Boswell's authorship, he demanded that Boswell deny authorship or apologize. Boswell refused to do either, so Stuart challenged him to a duel. Boswell deliberately fired wide, but Stuart, who had never before handled a gun, shot Boswell in the collarbone. The wound was fatal. Despite Boswell's popularity, Stuart was acquitted unanimously. 





A solid Romanist, he was also, says Wessels, "a great authority not only on the law of Utrecht, but also on the law of Holland." *Opera Omnia* was first published in 1692 and it collects his principal works. The first part is a detailed article-by-article commentary on the Novellae Constitutiones of the Province of Utrecht in Dutch and Latin. The other parts address the Roman and Roman-Dutch law of husband and wife, dowry, community property and compensation.
