

* Second edition. Andler was a state official in Schwarzenberg and a counselor to the Holy Roman Emperor. First published in 1673, *Corpus Constitutionum Imperialium* is a comprehensive digest of the laws governing the Holy Roman Empire. Later editions were published in 1700 and 1704. All are scarce in North America. OCLC locates no copies of the first edition, 2 of the second (at Harvard and Yale Law Schools), 2 of the third (at Harvard and UC-Berkeley Law Schools) and no copies of the fourth. 

* Second edition, enlarged. With the preface of the first edition. First published in 1776, Bentham's trenchant analysis of contemporary legal and political ideas offered the first significant criticism of Blackstone. "If it were nothing more, it would have no interest for later generations, which do not regard Blackstone as an authority upon speculative questions of politics or history, and therefore do not need to have Blackstone's theories corrected or disproved. But in criticizing Blackstone's views, Bentham necessarily expounds his own. As Bentham is one of the few English writers of mark upon the theory of political institutions, and as his doctrine forms a link in the chain of English political philosophy, we still read the Fragment of Government in order to see, not how far Blackstone was wrong, but how far Bentham was right": Montague, "Introduction" in Bentham, A Fragment of Government (Oxford, 1891) 59. 

* Bero, Later edition; Marzari, first edition. *Quaestiones Familiares* was first published in Bologna with title *Familiares Quaestiones*. Its 136 *quaestiones* deal mostly with Roman or canon law. Whatever the topic, most of Bero's authorities come from canon law. A durable work, it went through five editions, the last in 1629. As indicated by its title, Marzari's treatise addresses the Roman law of fideicommissum, the request by a testator to any person who benefited by his will or intestacy to give certain objects to a third party. Both titles are scarce, especially Marzari's. * This is the only known copy of this gallows broadside recording six simultaneous executions in London on 22 August 1814, a capital display excessive even for that noose-happy age. Henry Lye and John Field, burglars, Michael Maroney, John Ashton, and Francis Sturgess, highwaymen, and John Mitchell, forger, all met their end with a single drop from the gibbet, and the broadside memorializing them is illustrated with a crude woodcut of the six malefactors after their launch into eternity. Each went relatively without incident, save Ashton, who had been in a state of insanity some days. When he came on the drop he began to dance, clap his hands, and, huzzaing, exclaimed "I am Lord Wellington." After drop had fallen, he sprung up onto the platform, began to dance again and exclaimed, "am I not Lord Wellington now?" The executioner was obliged to push him off, and he died in great agony. 

* Bartlett was the leading actor of Inglestone's San Pareil Theatre company, who had been playing at the nearby annual fair at St. James' Barton, Bristol. He had been married to Sarah Lewis for only a couple of months before the discovery of his mother-in-law's body. It transpires that before their marriage Sarah's father had handed over a dowry of £47 to Bartlett, with the caveat that no more money would be forthcoming until the death of Mary Lewis. Bartlett had been seen alone with Mary on a number of occasions in the days leading up to her murder. With evidence stacking up against him Bartlett was arrested and committed to trial, where he pleaded "not guilty." However, he was found guilty by the jury and executed on April 15, 1837. 

* This is the first digest of Colombia's laws since the nation became independent in 1821. It also includes the texts of treaties with England, the United States, France, and the Netherlands (with parallel translations). "By virtue of the laws of May 4, 1843 and June 12, 1844 the Congress of New Grenada [Colombia] specified the statutes then in force and ordered their compilation, a task which was entrusted to senator Lino de Pomba. This celebrated collection, popularly known as the *Recopilacion Granadina*, contained the extant legislation from 1821 to 1844 inclusive, arranged under appropriate headings, and was a work of high merit for its time": Backus and Eder, *A Guide to the Laws of Colombia* 125. 





* Only edition. The Ligurian Republic was a short-lived French client state formed by Napoleon on 14 June 1797. It consisted of the old Republic of Genoa and the small Imperial fiefs owned by the House of Savoy inside its territory. Its first Constitution was promulgated on 22 December 1797, establishing a directorial republic dedicated to "Liberta," "Eguaglianza" and "Rappresentenza Nazione." 





* Only edition, first issue. "The author and compiler undertook this work for the purpose of furnishing the profession in the United States what seemed to him a deficiency or a necessity. The difficulties which have presented themselves in the territories ceded to the United States by Mexico relative to the rights pertaining to real estate have been exceedingly great. There are many questions arising under Mexican laws in said territories yet unsettled and innumerable ones must necessarily arise by virtue of the increase of trade, of progress, and of the transfer of property within the present domain of the Republic of Mexico" (Preface). 

* Only edition. Hemings was a barrister of the Middle Temple. His detailed entries include translations (as appropriate), glosses and historical authorities. The book is prefaced by an interesting essay that discusses "definitions of maxims-whence maxims derived," "civil law maxims," "maxims in French," "maxims in equity," "exceptions to maxims," "books treating of maxims" and "the maxims with illustrations and their applications, and the maxims merely." 

* Second Italian edition, a translation of the second French edition, 1812. De la Competence des Juges de Paix (Paris, 1805) was the first manual based on the Code Napoleon and a standard work for many years. The transfer of French law to Italy during the Napoleonic era created a need for this translation with occasional notes to reflect local practice. * Frankfurt's Jewish ghetto was home to one of Germany's largest Jewish communities. Jewish emancipation in Frankfurt was instituted during the Napoleonic period through the efforts of Grand Duke Karl von Dalberg. His reforms included freedom to live outside the ghetto, provoked a backlash. A backlash from city, the *Neue Stättigkeits-Und Schutz-Ordnung der Judenschaft* attempted to reverse Dahlberg's reforms and reestablish the ghetto. Our copy belonged to *Das Institut zur Erforschung der Judenfrage* (Institute for Study of the Jewish Question), a Nazi political institution in Frankfurt that supported anti-Semitic scholarly and propagandistic programs. It was also the depository for books, Torah scrolls and other materials looted from Jewish libraries and institutions in Germany and the territories it occupied. 

* These diaries were kept by two members of a prominent Providence, Rhode Island family. William Warner Hoppin, a lawyer, was the Governor of Rhode Island from 1854 to 1857. Also a lawyer, his son Frederick Street Hoppin was never engaged in active practice and lived the life of a leisured gentleman. William Hoppin's diary commences with the arrival of his arrival in France with his family. It goes on in great detail where the Hoppinses took their apartments in Paris, their experiences with French tutors, their tours around France and their visits with several prominent figures, such as the pope and the king and queen of France (The King said he had visited Newport and Providence and would like to visit them again.) A classic New Englander, Hoppin considered Paris a vulgar, sinful city. The period covered by this diary is October 9, 1845 through January 1846. Overall, his copious details are amazing. Frederick Street Hoppin, then 11 years old, went to the same places with his family. Given his age, his diary offers an interesting perspective on his father's impressions. His diary commences in February in France and goes through to the end of July, when the family paid a visit to Switzerland. Written by two observant individuals, both are wonderful examples of the diaries kept by well-connected wealthy Americans who traveled to Europe in the first half of the nineteenth century. * Steele was the governor of New Hampshire. His letter discusses facts pointing to the innocence or guilt of William Comings, who was convicted of strangling his wife with a handkerchief, then suspending her body from a bedpost to make her death look like a suicide. Comings was convicted and appealed his case unsuccessfully. He was then pardoned by Governor Steele, who felt the case had been mismanaged and the jury biased. * Only edition. Full account of the several trials connected with this famous Massachusetts case, by one of the accused. Daniel Webster served as one of the defense attorneys shortly after his return to private practice following his two terms in Congress. The respected and well-connected Major Goodridge's accusation of robbery against the witless, low-life Kenniston brothers was supported by popular sentiment, until Webster began his defence, which meticulously unraveled the Major's story and succeeded in gaining the Kenniston's acquittal. The trial was an early landmark in Webster's legal career, and his final address to the jury, first printed here, is considered a classic of Webster's oratory. It was later anthologized. Daniel Fletcher Webster [1818-1862], known as Fletcher Webster, was Daniel Webster's eldest son. Chief Clerk of the U.S. State Department when his father was Secretary of State, he commanded the 12th Massachusetts Infantry during the Civil War. He was killed at the Second Battle of Bull Run. 

* First edition. One of the first of four books of the subject, A Treatise of Feme Coverts examines the doctrines of English Common Law relating to a "feme covert," that is a woman under the legal guardianship of the man who heads the household she belongs to. (Stated simply, this group included all females except divorced women and widows.) Written from a perspective sympathetic to women, it deals with precedents of conveyances not covered in The Law of Baron and Feme (1700), and as such can be seen as a companion volume. The treatise concludes with an account of Robert Hyde's argument in the case of Manby v. Scott (1663), in which he argued that a husband who is separated from his wife is not liable to a vendor for goods the wife purchased from the vendor. Commenting on the case in his diary, Samuel Pepys referred to Hyde's judgment as "most amusing." Diary of Samuel Pepys, January 28, 1663. Robert Hyde was a Chief Justice of the King's Bench from 1663-1665, having gained appointment through the influence of his cousin, Edward Hyde, first Earl of Clarendon.
