First published in 1833, Joseph Story's *Commentaries on the Constitution* is generally considered to be the most important work written on the American Constitution before the Civil War. Dedicated to John Marshall, it presented a strongly Nationalist interpretation.

Comparing it to *The Federalist*, James Kent said that Story's work was "written in the same free and liberal spirit, with equal exactness and soundness of doctrine, and with great beauty and eloquence of composition.... Whoever seeks ... a complete history and exposition of this branch of our jurisprudence, will have recourse to [this] work, which is written with great candor, and characterized by extended research, and a careful examination of the vital principles upon which our government reposes.": cited in Marvin, *Legal Bibliography* 669-670. Apart from James Kent, no legal scholar has had greater influence on American law than Justice Story [1779-1845], who was appointed Associate Justice of the Supreme Court in 1811.
