





statutes and decisions. It also has several new sections, such as advice on legal study and a review of the recent progress in law and essays on local government in Great Britain, the British colonial system and local government in the U.S.

Reprint of the standard Latin language edition of the *Corpus Juris Civilis* and the basis for all modern English translations. Originally published from 1872 to 1895, this is one of the finest examples of German philology and legal scholarship. In this edition, sometimes called the "Berlin Edition," Krueger edited the Institutes, Momsen edited the *Digest*; the *Code* and *Novels* were edited by Schoell and Kroll. Commissioned by the Emperor Justinian in 530 CE, the body

of writings known collectively as the *Corpus Juris Civilis* reformed, restated and preserved Roman law. Its subsequent influence on European and international jurisprudence is difficult to overestimate.





Published just before the Civil War, this dictionary offers a fascinating glimpse into the American underworld in the first half of the nineteenth century. As New York City's Chief of Police and an owner of the National Police Gazette, Matsell [1811-1877] had an abiding interest in criminal speechways. Although Matsell compiled this dictionary for his

colleagues in law enforcement, he recognized its value to the linguist. The appendix contains samples of criminal speech and writing (with translations) and the vocabularies of gamblers, billiard players, pugilists and stock brokers.



The Fall River Tragedy A History of The Borden Murders



Lizzie Borden [1860-1927] was tried and acquitted for the 1892 axe murders of her father and stepmother in Fall River, Massachusetts. Speculation continues today about the sensational case that produced a famous nursery rhyme. Compiled immediately after Borden's sensational trial by Edwin H. Porter [1864-1904], the Police Reporter for the Fall River Daily Globe and a correspondent for the Boston Herald who aimed to provide "a connected

story of the whole case, commencing with the day of the tragedy and ending with the day that Miss Borden was set free." The book is handsomely illustrated with photos and line illustrations of the deceased, the accused, the jury and others.







This important work appeared 15 years after Sidney's beheading (by Charles II) for treason. Sidney proposes a doctrine of natural justice and governmental order from which all institutions vary at their peril. First American edition (first published in England 1698). Thomas Jefferson described this as "...probably the best elementary book of the principles of government, as founded in

natural right which has ever been published in any language; and it is much to be desired in such a government as ours that it should be put into the hands of our youth as soon as their minds are sufficiently matured for that branch of study." (Sowerby).



after the Bourbon restoration and still in force, it has served as the model for the legal codes of more than twenty nations throughout the world.




