* Assembled during the nineteenth century, this collection of rare and scarce tracts by Bentham was owned by Laski, the eminent English political scientist known for his contributions to economics and jurisprudence. Stason, a distinguished jurist, was dean of the Law School of the University of Michigan from 1939 to 1960. The inscription and letters show the book was a gift to Stason after a visit to Laski in September 1949. In both letters, Laski expresses a desire to visit Stason in Ann Arbor and visit the law school. 



* First edition. This is the first compilation of Illinois Supreme Court cases. Though not authorized, the state sanctioned the publication by subscribing to 150 copies. It was reprinted with additions in 1861 and 1877. Breese was an estimable Illinois jurist who gained national prominence for his decision in Munn v. Illinois, upheld by the U.S. Supreme Court, favoring the regulatory power of the state over business corporations. His fifty-year career spanned the legal and political development of Illinois. 

* First edition. Lord Mansfield thought these reports merely loose notes. "But Mansfield, in this as in other cases, was rather too ready to decry a set of reports because they contained a decision which was contrary to his own view of the law in the particular case before the court... Against Mansfield's condemnation we can set the opinions of Platt and Parker who recognized these reports as authoritative in 1853" (Holdsworth). The first edition was reissued in 1756 in Dublin. 



* Irish issue of only edition, published the same year as the (two-volume) London edition. Intended to be a practical tool, Burn eliminated most of the definitions in Law-French found in earlier dictionaries. (They became obsolete when George II ordered the exclusive use of English in 1733.) This elimination cleared space for other material and longer entries. Indeed, Burn's articles on such subjects as judgment, jury, purchase and will are broader, more detailed and better organized than they are in earlier dictionaries of this kind. 

* Only edition. This dictionary was originally intended to be a revised edition of Charles Sweet's *Dictionary of English Law* (1882), "but there is so little of Mr. Sweet's work, and that little has been so much altered, that the author has felt justified in publishing the book over his own name" (Preface). 





* Third edition. Dugdale's *Origines* provides a wealth of information about the sources of English law and the early history of English legal institutions, including the Inns of Court, on which it is a chief authority. It is a well-documented work: sources of manuscripts are listed, and, in many instances, the sources of the information for the printed book entries are given. Our copy is enriched with more than 100 leaves filled with copperplates, lithographs and woodcuts from a variety of sources (the latest from the early nineteenth century. 

* First edition. Kent said this work was, in the opinion of "the most competent judges," "learned, accurate and well digested." The preface indicates this work was edited by Sumner, who was then reporter of the decisions of the Circuit Court of the United States for the First Circuit. Dunlap was United States Attorney for Massachusetts from 1829 to his death in 1835. A second edition of this book was published in 1850. 

* Only edition. "In this work the effort has been to make the definitions as short as possible, yet so clear that a man without legal education can understand them. (...) Essays or long discussions of subjects have been avoided because few have time to read such, and fewer care to, while those who have time prefer to investigate for themselves" (Explanatory Statement). This is an uncommon book. OCLC locates 29 copies, a low number for a law dictionary published at the turn of the twentieth century. This is the first (non-reprint) copy we have seen. 

* Second edition. First published in 1664, this book, though ostensibly descriptive, was written chiefly to maintain the jurisdiction of the Admiralty Court in the new government. Beyond its political interest, it offers a detailed analysis of seventeenth-century maritime law and admiralty jurisdiction at the time when Great Britain was emerging as a major maritime and colonial power. Exton was educated at Cambridge, earning the LL.D. in Civil Law in 1634. He was appointed President of the High Court of Admiralty by Parliament in 1649, and was reappointed by the Duke of York after the Restoration. Two other editions were published in 1746 and 1755. 

* Second an final edition, a much-expanded edition of the first American book on patents. A true "Renaissance man," Fessenden was a lawyer, poet, journalist, inventor and venture capitalist who promoted various inventions. He was the holder of two patents for heating devices, and he promoted "scientific" techniques in *The New England Farmer*, a journal he founded. Also a prominent satirist, he wrote numerous pieces under the pseudonym Christopher Caustic for one of his other journals, *The Terrible Tractoration*. His treatise contains summaries of the relevant statutes, digests of leading cases (such as Whitney v. Carter over the invention of the cotton gin) and comparisons between the patent laws of the Unites States, Great Britain and France. The appendix contains the United States Patent Law of 1800, texts of later legislation, forms for U.S. patent applications and a bilingual collection of French patent laws. 

* Fourth edition. Hobart was Coke's successor as chief justice. These reports (in English), which have long been accepted as the standard source for the period, cover cases in King's Bench, Common Pleas, and the Star Chamber from 1603 to 1625, with some cases from the reign of Queen Elizabeth. A durable work, it passed through seven editions, unaltered, from 1641 to 1724. The final edition was followed by an American edition in 1829. The annotations in our copy are mostly cross-references to other reports, some are comments or summaries of main points. Marvin identifies Finch as the "honourable and learned hand." 

* Tenth edition, "With Great Additions and Improvements." As Cowley has pointed out, A New Law-Dictionary was both Jacob's masterpiece and "an entirely new departure in legal literature" that provided a model for several subsequent efforts. In contrast to earlier works, each entry summarizes all of the laws relating to the subject and offers extensive interpretive commentary. Obsolete terms are omitted. It was recognized almost immediately that Jacob created a highly useful legal encyclopedia that was more detailed and concise than any other abridgment of the period. An extremely popular work that went through twelve editions between 1729 and 1800, it offers unparalleled insights into Anglo-American law during the eighteenth century. 

* First English-language edition and the only American edition. Originally published in 1815, Marvin spoke highly of this work in his Legal Bibliography, noting that few have equaled his wide range of research and depth of learning. As late as 1921, G.L. Canfield, writing in the Michigan Law Review, called this work "one of the pleasures of the legal bibliophile" that "remain[s] essential today to a practitioner's library (19:580-582). Jacobsen, a German jurist, was an internationally recognized authority on maritime law. Laws of the Sea is based on a sixteen-year study of the laws of Italy, France, Great Britain, Holland, Denmark and Germany. It remains the most thorough single-volume study of English and continental maritime law in the early nineteenth century, a turbulent era shaped by the French Revolution and Napoleon. 

* Second, final and best edition. Lambard[e], a barrister, justice of the peace and legal historian, was also the keeper of records at the Rolls Chapel and the Tower of London. He is best known for his Eirenarcha, Or the Office of the Justices of Peace (1581). Archeion is a historical commentary on the central courts of justice in England that was published posthumously by his grandson, Thomas Lambard, in 1635. The first printing, which was produced without his authorization, led him to issue the "newly corrected" and "enlarged" edition, which appeared later that year. 

The trial established that Piers had seduced Lady Cloncurry as part of a bet. 





Drawing on the work of Gentili and Grotius, it was the first work to treat the law of nations as an ordered system, one in which the law of warfare played a subordinate role. It also helped to popularize the work of Grotius and Gentili and to make international law a part of English law. According to Holdsworth, this book succeeded for three reasons: "In the first place, (...) international law appeared for the first time in a compact and orderly form. In the second place, he so clearly defined it that no one in the future could be under any misapprehension as to its scope. In the third place, he originated the modern division of the subject into Peace and War." He notes, moreover, that "in his book the tradition, inherited from the medieval books, of grouping the whole subject round the rules of war, was finally abandoned."
