

First Edition of Blount's Dictionary

1. Blount, Thomas [1618-1679].

NOMO LEXIKON: A Law-Dictionary. Interpreting Such Difficult and Obscure Words and Terms, as are Found Either in Our Common or Statute, Ancient or Modern, Laws. With References to the Several Statutes, Records, Registers, Law-Books, Charters, Ancient Deeds, and Manuscripts, Wherein the Words are Used: And Etymologies, Where They Properly Occur. Contemporary calf, speckled blind frames to boards, raised bands and later lettering piece to spine, gilt tooling to board edges. Moderate rubbing to extremities, minor scuffing and staining to boards, front joint starting near head, a few cracks to text block, one between front endleaf and title page. Light toning to text, somewhat heavier in places. Early owner signature to head of title page, interior otherwise clean. An appealing copy. \$500.

* First edition. Blount was a member of the Inner Temple. Prohibited to practice at the Bar because he was a Catholic, but blessed with a large private income, Blount turned to legal scholarship, historical studies and lexicography. Blount aimed to correct the defects he found in Cowell's *Interpreter* (1607) and Rastell's *Termes de la Ley* (1523). In his preface, he observed that Cowell "is sometimes too prolix in the derivation of a Word, setting down several Authors Opinions, without categorically determining which is the true"; Rastell "wrote so long hence, that his very Language and manner of expression was almost antiquated." He hoped that by correcting these flaws he would create a dictionary useful to everyone in the profession from "the Coif to the puny-Clerk." The *Nomo-Lexikon* is clearer and more detailed than its predecessors. It is also the first English-language dictionary with entries that include word etymologies and citations. An immediate success that quickly supplanted its predecessors, it was reissued in larger and revised editions throughout the eighteenth century. Contemporary speckled calf, varnished, blind rules to boards, raised bands and lettering piece to spine, speckled edges, (later?) marbled endpapers. Light rubbing to boards, moderate rubbing to extremities, joints just starting at ends, corners bumped. Title pages, with large copperplate arms of the Holy Roman Empire, printed in red and black, large arms copperplate arms of Bohemia to versos, woodcut head-pieces, tail-pieces and decorated initials. Light toning to text, somewhat heavier in places, light foxing to a few laves, edges of title pages trimmed closely with minor loss, internally clean. Ex-library. * Fourth edition. Holy Roman Emperor Ferdinand II, a Habsburg, ruled the Kingdom of Bohemia. A document of the Thirty Years War [1618-1648], his *Vernewerte Landes Ordnung* (Revised Land Ordinance) for Bohemia, enacted in 1627, aimed to consolidate his power and suppress Protestantism, which was spreading though parts of that kingdom. Among other measures, it deprived the Bohemian estates of their military rights, placed all schools under Jesuit control and made Catholicism the kingdom's only legal religion. Due in part to his aggressive stance, Bohemia witnessed some of the most brutal battles of the war. Ferdinand, who died in 1637, was able to pass the kingdom to his heir, but the land and its crown were greatly

diminished. Editions of the Vernewerte Landes Ordnung were published in 1627, 1628, 1638, 1640, 1714 and 1753. All are scarce. * Only edition. Defense submission for an appeal involving three men convicted of smuggling tobacco in a suit initiated by the licensed tobacco contractor Massa and Carrara. The arguments are erudite and learned; there are citations to Bartolus and Alberico de Rosate, for example, and, on p. 33, a eight-line quotation from Virgil. This appears to be an unrecorded imprint. No copies located on OCLC.

* Third (stated) edition, actually the fourth. First published in 1584, this treatise on hire, leases and other types of contracts in Roman law went though at least eight editions; it was still an authority in the late seventeenth century. Few copies of any edition are held by North American law libraries. Regarding our 1597 edition, OCLC locates 1 (at Yale). Censimento Nazionale delle Edizioni Italiane del XVI Secolo CNCE9673.

* Later edition. First published in 1609, this treatise on the Roman law on the right to use the property of another (usufruct) went through several editions and issues in Italy, Spain, France and Germany. According to the title page, this Venetian imprint has unique additions. Complete in itself, this became the first part of a two-volume set when an additional volume was published by Turrinum in 1646. Castillo Sotomayor was a distinguished Spanish canonist. Not in the *British Museum Catalogue*.







* This is the first digest of Colombia's laws since the nation became independent in 1821. It also includes the texts of treaties with England, the United States, France, and the Netherlands (with parallel translations). "By virtue of the laws of May 4, 1843 and June 12, 1844 the Congress of New Grenada [Colombia] specified the statutes then in force and ordered their compilation, a task which was entrusted to senator Lino de Pomba. This celebrated collection, popularly known as the *Recopilacion Granadina*, contained the extant legislation from 1821 to 1844 inclusive, arranged under appropriate headings, and was a work of high merit for its time": Backus and Eder, *A Guide to the Laws of Colombia* 125.

* First edition. Unlike previous compilations, *Jus Feudale* is an original work. "Indeed Craig was the first systematic writer on law in Scotland. The *Jus Feudale* is not a mere textbook of the law of land rights, but is a learned disquisition upon a great social system. The opening chapters are devoted to an examination of the sources of law in general, and trace the history and development of the Civil, Canon and Feudal laws. If Craig had accomplished no more than that he would have been entitled to a foremost place amongst our jurists, for unquestionably the form of his book not only exemplified the philosophical outlook of the learned Scots lawyer, but provided a model of construction and treatment for his successors" Black, *The Institutional Writers* 62-63. *English Short-Title Catalogue* R232723



* First edition. This is the first English treatise on sheriffs. As its title suggests, it is a remarkably comprehensive work. Holdsworth, who cites it several times, says "in spite of a growing number of rivals, it continued to be a standard authority until the beginning of the eighteenth century.": History of English Law IV:119. 

* Second edition, a reissue of the first edition (1727) with an altered titlepage and a preliminary advertisement leaf. This was the first textbook on equity published since St. Germain's *Doctor and Student* (1523). It is generally considered to be the book that founded the field of equity jurisprudence. Francis outlines fourteen maxims, such as "Equality is Equity" and "Equity suffers not a right to be without a remedy." Each maxim is followed by a brief summary of cases that illustrate its application. As Roscoe Pound observed, Francis created a precursor to the casebook: "his maxims for the most part are independent attempts to state principles derived from the study of cases.": Pound, "On Certain Maxims of Equity" in *Cambridge Legal Essays* 261-262. *English Short-Title Catalogue* T118767.



^{*} First editions, except 7, which is a second edition. One of the most ambitious and admired works of its time, the *Modern Reports* began as a four-volume set issued from 1682 to 1703. A fifth volume was added in 1711. Six more, one of them in two parts, were issued by later reporters. Taken together, these books report cases from 21 Charles II to 4 George II (1669-1732). Thomas Leach edited the books and republished them in 1793-1796 as a twelve-volume set. Complete sets of early editions, such as ours, are rare in the trade. Very few have ever appeared at auction; we have not seen any sets in the past 30 years. (The Sweet & Maxwell annotation, otherwise excellent, gives incorrect publication dates for 3.) 

* Only edition located. An interesting work of comparative law that compares all of the articles in the Code Napoleon with comparable articles in the civil code of the Kingdom of the Two Sicilies and those of the Code of Justinian and other parts of the *Corpus Juris Civilis*. No copies located on OCLC.

* An edition of the *Institutes* by Cujas with extensive commentary and notes by Jean Lacoste, Theodore Marcile and Marc-Antoine Muret. These jurists, who followed Cujas' example, were leaders of the French humanistic school, which aimed to purge Roman sources of later corruptions. Their pioneering methods did much to establish the field of philology. Compiled around 161 CE, the *Institutes* is an elementary treatise on Roman private law that served as a standard text for 300 years. After its rediscovery during the medieval era it became a staple of European legal education. Not in the *British Museum Catalogue*.

* Second edition. Based on Styles's Regestrum Practicale (1657) and a standard reference during the eighteenth century, Lilly's Register was first published in 1719. It is divided into two parts. The first deals with conveyances. (The information is arranged under 36 alphabetical headings from "Assignments" to "Uses."). The second is a collection of precedents. As Holdsworth points out, "they are a varied collection, since they include, besides the ordinary conveyances of interests in real property, a settlement of stock, the assignment of a debt, compositions with creditors, an agreement between a high-sheriff and his under-sheriff, and agreement between a bishop's register and his deputy, and even a precedent for a private act of Parliament for the settlement of an estate.": Holdsworth, A History of English Law XII:376. 

Well-represented in European libraries, this title is not held by many libraries in North America, in any edition. 



The first two editions were published in 1687 and 1716, the last, mostly an original work by Pascucci published under his name, in 1773. All are scarce. 

Printed by James Franklin, the son of James Franklin (1697-1735), brother of Benjamin Franklin. The younger James Franklin and his mother Ann Franklin were official printers for the colony throughout much of this period. 

II. First edition. This fascinating work casts the nature of human salvation as a trial argued by Christ and Satan. Its author, Ayrer, was an important German playwright, early translator of Shakespeare and distinguished lawyer and state official. Based on the *Processus Belial* of Jacobus de Theramo [1349-1417], the canon lawyer and bishop, it is a didactic work on the nature of redemption cast in a humorous "legal" style for the amusement of lawyers. A popular work, it went through several editions into the seventeenth century. 



Span's treatise summarizes this body of law with an emphasis on the enactments of Holy Roman Emperors, and Kings of Hungary, Bohemia and Croatia, Ferdinand I and Rudolf II. 

* Third edition (stated). Spiegel was a lawyer, a privy counselor to Holy Roman Emperor Charles V and a notable humanist scholar who corresponded with Erasmus. The Lexicon Iuris Civilis, a dictionary of terms in Roman and canon law, is his best and most successful work. It went through twelve editions, the first in 1538, the last in 1577. The entries are rather brief, ranging from a sentence to a few paragraphs, and they contain references to examples in the Roman juristic literature. The second part of the work, Quae Lexico Huic Postrema Editione Recens Accessere, contains additional texts. It starts with a work entitled "In Verba Legum XII Tabularum Scholia," an edition of the Twelve Tables by Oldendorp, and is followed by several other texts by Oldenburg and Spiegel. Also appearing for the first time is the comprehensive addendum, which includes a commentary on aspects of Oldendorp's contemporary dictionary, De Copia Verborum. There are also pieces by Protestant leader Philip Melanchton ("Oratio de Scripto Iure, & Dignitate Veterum Interpretum Iuris', 'Romanum Ius Antecerere Legibus Aliarum Gentium', and his "Censura de Legibus") and Claude Chansonnette ("De Ratione Studii Legalis Paraenesis," Christoph Hegendorff ("Epitome Tyrocinii Iuris Civilis," "Exegeses in XII Libros Codicis" and Compendiariae Titulorum Codicis Iustiniani Exegeses"). The somewhat bizarre vellum binding on our copy defies identification or localization. 



The first is that of Sir Robert Spotiswoode of Pentland and New Abbey, who was appointed an ordinary Lord in 1626 and Lord President in 1633. Besides excerpts from civilians, Craig and Balfour, he notes cases from 1625 to 1637, not long before he had to fly to England to escape from the Presbyterians, together with a few earlier ones from 1541 derived from an unknown source. It has been described as 'an unfinished collection of materials for a Pandect of Scots law,' and is the earliest of the Practicks generally cited to the Court today" (Stair Society). Or, The Peoples's Right to Defend Themselves and Their Covenanted Religion, Vindicated (1669), a work that combines biblical, natural, and contractual arguments to justify violent resistance to tyrannical monarchs. He eventually returned from exile and practiced law in London under an alias. In 1679 he returned to Scotland and continued his involvement in state matters. In 1685 he wrote the Duke of Argyll's declaration of war in the rebellion, was accused of treason and pardoned by William III, who went on to appoint him Lord Advocate of Scotland in 1692" (DNB). The trials of Fitzharris and his accomplices are notable because they raised a set of jurisdictional issues involving the courts and the two Houses of Parliament. These issues, which involve constitutional issues as well, are discussed in Hawles's *Remarks*. Also known as the *Paratitla in Pandectas*, this is an important section-by-section commentary on the *Digest* and *Code* of the *Corpus Juris Civilis* by a leading Belgian humanist jurist and long-serving rector of the law faculty of the University of Wittenberg. A popular and influential study, it went through 34 editions in the Netherlands, Germany, Switzerland and France. The first edition was published in 1563, the last in 1669.
