



Softbound volumes bound into recent cloth, printed paper title labels to spines. Light browning to text, light soiling to title pages, internally clean. Ex-library. Stamps and penciled annotations to title pages. \$350.

\* Volume I: first edition; other volumes, second edition. Eventually filling 82 volumes by 1939, this is an annotated compilation of laws of the Argentinean Province of Cordoba, the province in the geographical center of the country. The four volumes offered here cover the establishment of the state during the Argentinean war of Independence to the mid-1870s. OCLC locates 3 copies in North America, none complete (UT-Austin, Harvard Law School), University of Michigan Law School).



# 2. Bankton, Andrew MacDowall, Lord [1685-1760].

Contemporary three-quarter calf over marbled boards, raised bands and lettering pieces to spine. Some rubbing and minor scuffing to boards and extremities, joints starting. Early armorial bookplates (of Alexander Thompson) to front pastedowns. Cracks near front and rear hinges of text blocks, small tears and chips to margins of a few leaves, larger chip to fore-edge of leaf in Volume I with minor loss to side-notes. Contemporary annotations in a few places, interiors otherwise clean. A nice set. \$750.

\* Only edition. With side-notes and comprehensive indexes. The 1707 Act of Union compelled Scottish and English jurists to comprehend each other's legal systems. As Bankton put it, "now, since the union of the two kingdoms, there is such an intercourse between subjects of South and North Britain, that it must be of great moment that the laws of both be generally understood, and their agreement or diversity attended to; so that people, in their mutual correspondence, may regulate themselves accordingly" (Preface). As one would expect of an eighteenth-century Scottish jurist, the arrangement of the *Institute* is strongly influenced by the *Institutes* of Justinian. *English Short-Title Catalogue* T90336.

Contemporary quarter cloth over paper boards, printed paper title label to spine. Moderate rubbing to boards, light rubbing to extremities, corners bumped and somewhat worn, hinges partially cracked but secure. Some toning, interior otherwise fresh. An appealing copy of a scarce title. \$500.

\* First edition. Bell was an important figure in the history of Scottish law. Two of his books, *Commentaries on the Laws of Scotland* and *Principles of the Law* of Scotland, are, according to Walker, "among the half-dozen classics of Scottish legal literature." As Marvin indicates, Bell's writings on commercial law and bankruptcy were highly important during the first half of the nineteenth century and were cited often by Kent, Legere, Story and other American jurists. 

Stab-stitched pamphlet bound into recent stiff marbled wrappers, printed title panel to front cover. Moderate toning to text, light foxing to a few leaves, small chip to fore-edge of title page, internally clean. \$2,000.

\* Only edition (in this form). Bollan was a lawyer and agent for Colony of Massachusetts. *A Succinct View* is an extract from Bollan's *The Freedom of Speech and Writing upon Public Affairs Considered*, a longer work first published in 1766, that discusses the role of parliamentary supremacy. It is a subtle and somewhat subversive work. Bollan begins by asserting "that the 'care of common rights' should be left to Parliament. In the midst of what was essentially an apologia for parliamentary supremacy, Bollan thus implied, first, that some non-common rights existed, and second, that protecting such rights might be within the purview of an authority other than Parliament" (LaCroix). Contemporary calf, blind rules to boards, crude early calf rebacking with hand-lettered title. Light rubbing to boards, somewhat heavier rubbing to extremities, corners bumped and somewhat worn, early bookplate to front pastedown, clean tear to front endleaf, a few partial cracks to text block, a signature partially detached, eighteenth-century bookplate of Galbreath Patterson to front pastedown. Light toning to text, occasional foxing, faint dampstaining to upper corners of some leaves at end of text. Later owner signatures H. Woodward, Samuel Laird, and Edward P. Pearson, prominent attorneys from counties near Harrisburg, Pennsylvania's capital, to front endleaf and title page, interior otherwise clean. \$400.

\* Irish issue of only edition, published the same year as the (two-volume) London edition. Intended to be a practical tool, Burn eliminated most of the definitions in Law-French found in earlier dictionaries. (They became obsolete when George II ordered the exclusive use of English in 1733.) This elimination cleared space for other material and longer entries. Indeed, Burn's articles on such subjects as judgment, jury, purchase and will are broader, more detailed and better organized than they are in earlier dictionaries of this kind. It is unclear whether Burn intended to publish this book; it was edited, expanded and published posthumously by his son, John Burn. Patterson lived in Dauphin County, Woodward and Laird in Lebanon and Dauphin Counties, Pearson in Berks and Lebanon Counties. *English Short-Title Catalogue* N20286.

Contemporary publisher boards, untrimmed edges, rebacked in period-style with paper backstrips and printed paper title labels. Some edgewear and minor spotting to boards. Some toning, light foxing in a few places, internally clean. \$300.

\* First edition, a later issue with the *Addenda*. Long a standard work, it reached its final edition, the ninth, in 1842. "It has always been deemed a book of authority; and Blackstone, in his *Commentaries*, mentions it as one of the very few publications on the subject of Ecclesiastical Law on which the reader can rely with certainty. Burn, by his diligent and accurate research, and by great judgment in the selection and use of his materials, laid the foundation of a work which subsequent editors have reared to a complete and full Treatise upon English Ecclesiastical Law. The author not only gives his authorities for his positions, but frequently the authority of the authorities.": Marvin, *Legal Bibliography* 163-64 (which lists a 1760 first edition in error). *English Short-Title Catalogue* T70032.

Title page with large woodcut device printed in red and black. Faint dampstaining to margins of title page, rubbing to edges of some leaves, internally clean. A decent copy worth rebacking. \$300.

\* Third edition. Located in Flanders between Brussels and Antwerp, Mechelen has been an important trading and manufacturing city since the 1300s. Its fortunes rose and declined several times. In the seventeenth century the city was a prosperous again, having survived devastation in 1572 by Spanish forces during the Eighty Years' War (Revolt of the Netherlands). It remained under Hapsburg Control as part of the Spanish Netherlands. This compilation edited by Christynen was first published in 1625. The standard compilation, it went through further editions in 1642, 1653, 1657, 1661 and 167. Dekkers, *Bibliotheca Belgica Juridica* 36.

A rare item. \$300.

\* Only edition located. A collection of laws and decrees regulating mining and the processing and sale of minerals. OCLC locates 1 copy (at the University of Miami).

# True First Edition of Hallam's Constitutional History of England

# 9. Hallam, Henry [1777-1859].

The Constitutional History of England from the Accession of Henry VII to the Death of George II. London: John Murray, 1827. Two volumes. xvi, 615; vii, 828 pp. Quarto (11" x 9").

Later signed calf binding by John Rumpus, Oxford. Gilt rules to boards, unidentified owner crest to front boards, raised bands and gilt titles to spines, top edges gilt. Light rubbing to extremities, a few minor marks to boards, light fading to edges of boards in a couple of places. Light foxing to a few leaves, interior otherwise fresh. A handsome copy of a scarce edition. \$650.

\* First edition. This classic study of the constitutional history of England from 1485 to 1760 was "long the standard work on the subject, and only surpassed one hundred years after its initial publication" (Marke). It was originally issued in a small press run in quarto format. An octavo edition was published later that year. As one would suspect, the quarto editions are quite scarce today. 

\* Only edition. Little seems to be known about Hansard and he did not appear to publish any other works. English Short-Title Catalogue R20439.

An attractive set. \$500.

\* Only edition. A compendium of thirty-five arguments, observations, opinions, and notes on a wide range of cases and topics, such as the illegality of domestic slavery in England, the inescheatability of trusts in inheritance, fines of land, taxing out of parliament, the rule in Shelley's Case, the legal time of human birth and the Walpole Case of mutual wills. 

Stab-stitched pamphlet bound into recent cloth, gilt title to spine, endpapers renewed. Negligible light rubbing to extremities. Light toning to text, some edgewear and light soiling to first and final leaves, faint dampstaining in a few places, chip to fore-edge of leaf with some loss to side-notes. Early manuscript page numbers added to upper corners of leaves, showing this item was once part of a bound volume, interior otherwise clean. Ex-library. Bookplate to front pastedown. \$500.

\* First edition. Britain's ecclesiastical courts received a great deal of scrutiny in early years of the Restoration. Dissenters, Parliamentarians and others who feared the power of the Church of England under the control of a Catholic or crypto-Catholic king, believed it was necessary to limit the scope of its courts. The work of an idiosyncratic Anglican Churchman who supported the Commonwealth, Hickeringill's pamphlet was one of the most important and legally detailed contributions to this argument. Recognized as an important work, a second edition was issued in 1683, a third in 1706. All are scarce. OCLC locates 2 copies of the first edition in North American law libraries (University of Michigan, University of Pennsylvania). *English Short-Title Catalogue* R2631.

Light rubbing to extremities, a few minor scuffs to boards, corners lightly bumped. Woodcut head and tail-pieces. Light toning to text, foxing to a few leaves, internally clean. A well-preserved copy. \$400.

\* Only French edition. First published in English in 1776 as *A Code of Gentoo Laws*, this is the first collection of Hindu law in a Western language. It is a translation from the *Vivadarnavasetu*, a digest in 21 sections (*taranga*). The *pandits* (*pundats*) are *Banesvara*, *Kriparama*, *Rama Gopala*, *Krishnajivana*, *Viresvara*, *Krishnacandra*, *Guarikanta*, *Kalisankara*, *Syamasundara*, *Krishnakesava* and *Sitarama*. Halhed, a leading Orientalist of his day, worked as a linguist for the East India Company. His work was compiled under the sponsorship of Warren Hastings, the governor-general of the East India Company. Produced to enhance English control of India, it was nevertheless an important work of scholarship and comparative law. 

Contemporary calf, blind fillets to boards, raised bands and lettering piece to spine. Some rubbing to extremities with some wear to corners, light chipping to spine ends, joints starting at ends, front hinge cracked, minor worming to margins of final few leaves, interior notably fresh. \$300.

\* Final British edition (followed by an important American edition in 1829) and the only British edition to be revised, quite substantially at that. It passed through six editions, unaltered, from 1641 to 1683. Hobart was Coke's successor as chief justice. These reports (in English), which have long been accepted as the standard source for the period, cover cases in King's Bench, Common Pleas, and the Star Chamber from 1603 to 1625, with some cases from the reign of Queen Elizabeth. Contemporary calf with early rebacking, raised bands and lettering piece to spine, endpapers renewed. Moderate rubbing, corners worn, chipping to spine ends, boards detached, later bookplates (of C.A. Russell and H. Barrs Davies) to front pastedown. Light toning to text, foxing to a few leaves, internally clean. \$200.

\* Second, final and best edition. Wallace calls this reporter, which covers the years 1667 to 1685, "a work of very reputable authority." It is held in equal regard by Holdsworth. Jones was a judge of King's Bench and chief justice of Common Pleas. The text here is in both law French and English, in parallel columns. Hargrave made a new English translation some years later, but it was never published. Wallace, *The Reporters* 343. Holdsworth, *History of English Law* VI:552, 561.



Light browning, light foxing in a few places, faint dampstaining to a few leaves. Presentation inscripton from author to Theodore Sedgwick to head of title page, interior otherwise clean. \$350.

\* Only edition. The author of this handbook, which covers the period from 1692 to 1810, was a probate judge from 1814 to 1821. Theodore Sedgwick, who served in the Continental Congress, was a United States Representative and Senator from Massachusetts. He served as the fourth Speaker of the United States House of Representatives. Appointed to the Massachusetts Supreme Judicial Court in 1802, he remained there until the end of his life. Attractive large printer device to title page and verso of final leaf, handsome arms of Leo I to verso of title page, decorated initials. Light browning and faint dampspotting to most of text, internally clean. Ex-library. Early hand-lettered shelf label to spine, institution name in faint early hand to title page. \$750.

\* This edition of the collected legal and theological writings of Pope Leo I was first published in 1561. Known as "the Great," Leo reigned from CE 440-461 and guided the development of the Church during the final decades of the Western Roman Empire. In power during its most turbulent period, he preserved the church through a vigorous reform of church discipline and persecution of heretics. The collation of this copy is identical with others dated 1569. The listing in *VD16* even gives the date of this imprint as "1568/1569," which suggests that it was issued twice with different dates. No copies of the 1568 imprint located. \* First edition. This interesting essay defines two "defects" in contemporary jurisprudence. Anticipating the codifiers of the nineteenth century, it argues for the simplification of the judicial system and the restatement of written law to enhance legal certainty. Muratori was a notable Italian legal reformer. Trained as an attorney, he was the duke of Modena's librarian and a prolific scholar. It went through four more editions in the eighteenth century, the last in 1794, and was reissued a few more times in the nineteenth and twentieth centuries. 

Thomas Parker (not to be confused with Sir Thomas Parker, 1666?-1732, first Earl of Macclesfield and Lord Chancellor) served as chief baron of the Court of Exchequer for some 30 years; these are his own reports of his decisions. "He published these reports he tells us, because there were few cases in print in which the law relating to revenue was explained. To these cases (1743-1767) he added some others decided (...) between 1678 and 1718" (Holdsworth). There were also octavo editions in 1791 and 1800. Holdsworth, History of English Law XII:133. It is a valuable resource for students of French medieval social history. This edition, which remains the standard text, includes an extensive glossary of terms by Chabaille. OCLC locates 6 copies in North American law libraries (American University, George Washington University, Harvard, UC-Berkeley, University of Michigan, US Supreme Court).



\* Later edition, a reissue of a 1718 Neapolitan imprint by Paolo Severini. First published in Naples in 1618, this treatise addresses legal and economic aspects of agriculture and natural resources including fields, forests, watercourses, game birds, such as doves, waters and watercourses. Due perhaps to its Neapolitan origins, it pays particular attention to the cultivation of olives and the production of olive oil. A useful work, it went through several editions into the mid-eighteenth century. All are scarce. OCLC locates few copies of any edition in North America, none of the 1730 Trani edition (at Harvard Law School). Not in Camus or the *British Museum Catalogue*. Cent.], Odofredus, Phanuccius de Phanucciis [16th. c.], Antonius Guibertus Costanus [fl.1550], Iacopo Bottrigari [1274-1348], Constant Roger and Baldo Bartolini [c.1408-1490]. Including all editions, OCLC locates 4 copies in North America, 1 copy of the fourth (at Stanford). Not in Adams or the *British Museum Catalogue*.


\* Only edition. This is a remarkable work comparable to the *Institutes* of Justinian. Etienne adds, "it is a principal work on the legal history of the Principality of Liege, the Comte of Namur and the Duchy of Luxembourg." OCLC locates 5 complete copies, none in North America. A complete copy located at the Library of Congress, incomplete copies located at UC-Berkeley and Yale law libraries. Not in Harvard Law School's online catalogue. # Watercolor Caricature of Sir Edward Sugden

\* Possibly intended as the basis for a lithograph, this cartoon depicts a drunken Lord Sugden, wig askew and clutching a table for balance. He is addressing the Bench: "My Lord, (hiccup) this Sir Edward Bug--no, damn it, I Mean Sir Edward Sug-hiccup) den-this Bug-Sug-Bug! My Lord, I beg pardon, I'm rather & & &." There is a quote from Shakespeare below the image: "It fitteth not a <u>Noble thus</u> to plead!" Sugden, lawyer, judge and conservative politician, was Solicitor General of Great Britain in 1829-30, Lord Chancellor of Ireland in 1835, then from 1841 to 1846, and Lord Chancellor of Great Britain in 1852. He is wearing barrister's robes in this caricature, which indicates the period in his career between 1831 and 1835, when he practiced as a barrister and sat in the House of Commons. The caricature appears to be a commentary on his role as a leading opponent of the Reform Bill of 1832, which made him a prominent figure in British politics. The artist refers to Sugden as Chancellor, which leads us to date the image to 1835, the year of his Irish Chancellorship and a time when he was famous for his opposition to the Reform Bill.

\* Second edition. Townesend was a clerk of the Court of Common Pleas. First published in 1675, he wrote his manual to improve the quality of pleadings, which had "much decayed" during the Civil War and Protectorate. A Latin-English dictionary for the most part, it aimed to "direct Attornies and Young Clerks, in the formalities of their Words and Writings" so "their Businesses may be more Clerklike drawn, and fairly entred on record" (Preface). The work was well-received. Its fourth and final edition was published in 1721. All are scarce today. OCLC locates 3 copies of this (1685) edition in North American law libraries (Columbia, Library of Congress, Yale). *English Short-Title Catalogue* R7084.



\* Only edition. "Brigadier General John Winslow accused Captain Joseph Loring Jr. of permitting his men to mutiny by failing to enforce a brigade order to appear on parade in protest of a change in Winslow's rank and command. In 1805 a division court martial acquitted Loring, but Major General Simon Elliot, after asking for a reconsideration of the decision, refused to accept the acquittal and dissolved the court. A second division court martial convened in 1806 found Loring guilty, and ordered him removed and disqualified for military service for three years. In 1807 Loring petitioned the Massachusetts General Court to ask that the decision be invalidated, arguing that it had not been regularly detailed and thus had denied him an impartial trial. The General Court overturned the 1806 decision and ordered Loring reinstated to his former rank and command" (Cohen). This was the first volume of *The Militia Reporter*. No other volumes were published. Cohen, *Bibliography of Early American Law* 13473, note to 13551.





\* Later issue of the first American edition (1787). The decisive influence of this classic study may be attributed to its eclecticism. Vattel rejected the extreme claims of the natural law of nations which went back to Aquinas. Instead, he recognized that the universal law of nature might have subsidiary force when customary or consensual international law was silent. "Le Droit de Gens is certainly a work of the first magnitude. It modernized the whole theory and business of International Law, brought it out of the study into the field, the mart, the council chamber, and the palace. (...) He did indeed, much for nations, for he imposed upon them theories of moral rational development up to which it became, in a sense, necessary for them to live" (MacDonnell). Rensealaer [1808-1860], a member of the distinguished New York family, was admitted to the New York bar in 1830. MacDonnell, *The Great Jurists of the World* 479, 504. \* Later edition, one of two issued by Tottell in 1561. A selection of reports for 1-50 Edward III (1327-1377), the *Book of Assizes*, is one of the most important of the Year Books and of unique value to the study of English legal history. As Stanley Milsom has observed, it is the "only collection of reports from the country," that is the only collection of reports from the justices on assize (circuit) rather than in the central courts at Westminster. It is therefore "rich in apparent curiosities" because "it reports processes we do not otherwise see, on circuit, before juries." The first edition was printed in 1514 by John Rastell. OCLC locates 5 copies of the 1561 edition (both issues) in North American law libraries (Columbia, Harvard, NY Law Institute, University of Pennsylvania, York University).
