

Scarce Eighteenth-Century Treatise on Prize Law and Privateering

* Second French edition. First published in Madrid in 1746, this treatise on prize law and privateering went through three other editions, all in France in a translation by the author, in 1753, 1758 and 1802. Little is known about Abreu, a minor Spanish noble and diplomat. According to the title page, he was a "membre de l'Academié Espagnole, & Actuellement Envoyé Extraordinaire de S.M. Catholique aupres du Roi de la Grande-Bretagne." OCLC locates 5 copies of all editions in the Americas, 1 of this edition (at Columbia University Law Library). Not in the *British Museum Catalogue*. 



* Only edition. "*Meditatio Fugae* is an old principle of Scots law that if a creditor could make an oath that his debtor was in *meditatione fugae* to avoid payment of his debt, he may apply to a magistrate who may grant warrant for apprehending the debtor for examination, and subsequently, grant warrant to imprison the debtor until he finds caution *judicio sisti*" (Walker). 

* Reissue of the first, and only, edition. "The first edition was published in London, 1836; the selections were made by John Warren Smith, whose name did not appear in the book. Smith and Warren prepared the extracts for publication. The 1837 publication is a verbatim reprint, according to Warren's preface to his 1855 abridgment" (Eller). Warren wrote several fictional and non-fictional works about the law, such as the novel *Ten Thousand a Year* (1841) and the classic primer *A Popular and Practical Introduction to Law Studies* (1836). In 1855 he published another Blackstone-based primer, *Blackstone's Commentaries Systematically Abridged*. It had a second edition in 1856. 

* First edition. Blake, a member of Lincoln's Inn, was a political reformer who called for the abolition of tithes and, later, repeal of the Corn Laws. *Political Tracts* collects his principal essays, which were composed between 1786 and 1787. This title was re-issued the following year with some additions and a somewhat different collation, but with the same publication date on the title page. 

* Only edition. A notable work of Historical School jurisprudence, this treatise addresses the Roman law of inheritance and succession and wills with comparisons to these laws in Prussia and, to a lesser extent, other German states. Bluntschli was one of the great Continental jurists of the nineteenth century. He published a code for the Canton of Zurich and works on German private law, the law of war and international law. His most important historical work is the *Geschichte des Allgemeinen Staatsrechts und der Politik* (1864). 

* Later edition of a work first published in 1594. Bronkhorst was a professor of law at the University of Leiden from 1587 until his death. According to Roberts, his work was cited often by the leading Roman-Dutch authorities, especially van Leeuwen. *Enantiophanon* is an extensive treatise on controversial topics in Roman-Dutch law. 

* First edition. An interesting work from the middle decades of Industrial Revolution. Browne considers railroads, canals, waterworks, gas companies, docks, harbors, mines, quarries, bridges, cemetery companies, ferries, wayleves and tramways. He also includes information for "parish authorities who may be called upon to rate the property of companies to the relief of the poor." A second edition was published in 1886. Both are scarce. 

* Second edition, with supplement; the best edition of this work. "The first edition of this book sprang from the author's desire to bring order out of chaos. There was a need for a collation of authorities on the Law of Trade-Marks and kindred matters; and that need was felt, not only by owners of applied symbols of manufacture and commerce, but also by bench and bar alike. (...) It is probable that no other branch of legal science has had a more rapid growth during the twelve years since the first edition appeared. (...) An historical sketch of the legislation, prior to 1869, has been consequently compressed within the limits of a single chapter; and for the same reasons the cases cited are comparatively few" (Preface). 

* This engraving depicts the front elevation of the original home of the Royal College of Surgeons. From 1752 to 1832 death sentences for murder in Great Britain stipulated that the condemned person's corpse be "dissected and anatomised" for the benefit of medical students shortly after the execution. This is why the Old Bailey had a surgeon's theatre. Hogarth's "The Reward of Cruelty," *The Four Stages of Cruelty*, Plate 4, is a satirical depiction of a dissection in this building. <u>Order This Item</u>





* Second edition, "continued to the end of the last session of Parliament, 1713," which adds an addenda to the first edition of 1708. It was one of the earliest books on the subject. According to Sweet & Maxwell, the first studies were *Freedom of Elections to Parliament* (1680) and *Observations Concerning the Regulation of Elections for Parliament* (1689), a work attributed to the Earl of Shaftsbury). 

Many notables are listed here, such as Sir Frederic Pollock (48, Great Cumberland Place, W.; 13, Old Square, Lincoln's Inn, W.C.) and Frederic William Maitland (6, New Square, Lincoln's Inn, W.C.). 

* Only edition. A work of painstaking research and a useful reference, this book has two parts: English Judges and Reports and American Judges and Reports. 

* Only edition. The first book of its kind produced in North Carolina, Hawks's *Index* digests the reports of Martin through Hawks, a period spanning 1796 to 1826. Hawks, a lawyer and historian, was the state reporter from 1820 to 1826. After that time he abandoned the law, entered the ministry and had a distinguished ecclesiastical career. Some records attribute this title incorrectly to Lambert Lilly. 

* First edition. This is one of the earliest and most extensive legal works on auctions under Roman and Roman-Dutch law. Among other topics, it addresses the rules governing auctions, judicial sales, public contracts and the sale of confiscated merchandise. Matthaeus was a jurist, professor of law at the University of Utrecht and the author of the influential treatise *De Criminibus* (1644). A leader of the Dutch Elegant School of jurists and, to quote Wessels, "a consummate Roman lawyer and a great student of antiquity," his work was renowned for its erudition, literary quality and philological sophistication. 

* Only edition. This is an interesting, historically grounded study of German criminal and civil procedure. A valuable work for legal historians, a facsimile edition was issued in 1965 by O. Zeller. Three of the woodcuts depict court scenes, the fourth is an allegorical (?) woodland court with animals. In this image a fox is being led to the gallows for his murder of a hen. (A lion is the judge, the executioner is a cat.) All of the images are discussed in the text. KVK and OCLC locate 4 copies, 1 in North America (at the University of Alberta). 

* First edition. This was a standard text that reached its eight and final edition in 1935. This edition is particularly interesting because it was published at a time when British cities were expanding rapidly, which created unprecedented demand--and several new legal issues--for suppliers of water and gas. 

* Only edition. "In a long course of years many abuses had grown up, which recent legislation has removed. The prizes held out have been brought more within the reach of the poorer class of inventors. One cannot be but sanguine in hoping that the community is likely to derive great benefit from the new objects and motives presented to the minds of our artisans" (Preface). * First edition. "When [Queen Caroline] died in 1821, the clergy of Durham refused to allow the bells to be tolled. Mr. John Ambrose Williams, who owned the Durham *Chronicle*, published an article in it attacking the conduct of the clergy, who set the law in motion against Mr. Williams in the shape of a criminal information for libel. [The] case came for trial before a special jury at Durham. Mr. Scarlett (afterwards Lord Abinger), a most consummate advocate, conducted the prosecution, and Brougham the defense. Brougham made a magnificent speech, but it was rather a political manifesto than a wise appeal to a jury at Durham, who were not likely to be pleased with torrents of irony addressed to such topics as the revenues and management of their palatinate. The result was that his client was found guilty..." (Archer). This pamphlet was also issued the same year in London and Edinburgh. 


