\* Second edition. *Coke on Littleton*, or *First Institutes*, is one of the cornerstones of the common law and a primary legal text for generations. Several abridgements of this work were produced. 



\* Only edition, 1 of 4 issues from 1718. In this pamphlet Dalrymple, then the Queen's advocate in Scotland, refutes the argument advanced in a pamphlet by the Scottish advocate Patrick Haldane. "The first person to review English criminal law at once critically and comprehensively was William Eden.... [His] book is a pioneer treatise. It discusses topics which, under the influence of Bentham and Romilly, aroused much attention in the last years of the eighteenth and the first years of the nineteenth century; and it discussed them effectively, because, as the author says in his closing chapter he had tried to establish his principles not as abstract propositions, 'but rather as argumentative inferences, interwoven with, and to be collected from, observations on the penal systems of different governments. (...) The conclusion which he draws, that the reform of the English penal code 'is become an important and almost necessary work,' is irresistible. (...) 





\* Only edition. This book responded to a demand for authoritative English versions of Latin forms after the act of 1731 that replaced Latin with English as the language of the records.
