





* First printing of a pamphlet defending the imprisoned liberal pamphleteer Rafael Davila. Freedom of the press was granted under the Constitution of 1812. Repudiated by Ferdinand VII in 1814, but eventually revived after the revolt of Rafael del Riego y Nunez in 1820. Richard H. Dillon notes Davila's importance and observes: "Pamphlets constitute the major source of fresh new material on nineteenth-century and earlier Mexico.... [O]ne can find no surer guide to the troublous times of eighteenth-and nineteenth-century Mexico than these booklets. Written in the heat of argument, of battle, of revolution, they bring to life a time and place removed from us by hundreds of miles and years.": *The Hispanic American Historical Review* 45, No. 2 (May 1965), 270-271. 

* Only edition. Among the first American books on political science, *Sketches* is a study of civil laws and obligations, the social state, rights of property, sovereignty and political power. He published an expanded version of this in 1833 titled *The Principles of Government*. Chipman was a Hamiltonian Federalist who played a key role in Vermont's admission to the Union. He was a United States Senator from 1797 to 1803, Vermont's Chief Justice from 1813 to 1815 and professor of law at Middlebury College from 1816-1843. Levi Bartlett [1763-1828], a New Hampshire physician and politician, was the son of Josiah Bartlett, a signer of the Declaration of Independence for New Hampshire, later New Hampshire's chief justice and governor. 

* Second edition. First published in 1724, a time when Great Britain was consolidating its status as the world's leading maritime power, Crouch's handbook is an encyclopedic account of English customs law. As one would expect, it contains a great deal of information relating to colonies. It went through five editions, the final in 1755. Taken together, they are a valuable source of information for students of Atlantic history and the economic origins of the American Revolution. * Processus: only edition; Constitutiones: sixth and final edition. The Processus is a comprehensive guide to the laws that apply to European soldiers. It is a digest of positive law and conventions established by treaty. Each point is illustrated with a case study. The work reflects both the greater destructive power of eighteenth century armaments and the Enlightenment-inspired movement to civilize the rules of military engagement. "Von der Section und Inspection des Coerpers," its eleventh chapter, is especially interesting. An early example of medical jurisprudence, it discusses methods to distinguish signs of torture or other unacceptable deeds on the corpses of soldiers or civilians. Constitutiones, a commentary on the great 1502 Constitutio Criminalis Carolina of Holy Roman Emperor Charles V, was first published in 1626. A standard work, it went through further editions in 1661, 1665, 1670, 1678 and 1702. The owner of this copy added a few references in the index concerning the sections on torture. Provisions for the liberal use of torture was one of the most controversial aspects of this code. There are very few copies of either title in North America. 



* Only edition. A paper on the increase in crime in Warwickshire, relative to the size of population, its causes and possible remedies. The author suggests that young offenders must be punished as much as older offenders. The paper was in response to Eardley-Wilmot's A Letter to the Magistrates of England on the Increase of Crime: And an Efficient Remedy Suggested for Their Consideration, first published in 1820, which suggesting that severe punishment of juvenile offenders often led them to a lifetime of criminal activity. He also argued for better prison conditions as an aid to rehabilitation of offenders, a claim refuted in Observations. 



* Named after the English suffragist Emmeline Pankhurst [1858-1928], Panko was produced by the Women's Social and Political Union (WSPU) to raise funds for its activities and publicize its goals. The cards were illustrated by E.T. Reed, best known for his work for *Punch* magazine. They reflect some of the key moments and characters in the Suffrage movement, such as Pankhurst wearing her WSPU sash, a Suffragist being escorted to a police station, a group of Suffragists trying to gain entry to the House of Commons, a Suffragist declaring a hunger strike in jail and an image of the attorney Christabel Pankhurst [1880-1958] Emmeline's daughter, addressing the viewer in her robes. 

* First edition. An associate justice of the U.S. Supreme Court from 1910-1916, Hughes resigned to accept the Republican presidential nomination. Secretary of State from 1921 to 1925, Hughes was appointed again to the Court as Chief Justice, an office he held from 1930 to 1941. He is the only person who served two terms on the Court. In 1928 Hughes represented the U.S. at the Pan American Conference. Pan American Peace Plans is his review of that event. Hughes believed this conference "represented the most complete and effective cooperation that has been witnessed in any meeting of the representatives of the American republics" (68). 

* This item from future Chief Justice of Massachusetts Lemuel Shaw to then Congressman and future Gettysburg orator Edward Everett contains two letters. It contains Shaw's original letter, requesting help for a friend who was seeking a commission as a purser in the Navy, and Everett's appended letter on behalf of Shaw's friend to the Secretary of the Navy, Samuel L. Southward. In the 19th century, Edward Everett was celebrated as a preacher and public orator. He is most famous for delivering a two-hour oration in 1863 at the dedication of the Gettysburg military cemetery. Everett's speech was subsequently eclipsed by President Abraham Lincoln's immortal, two-minute Gettysburg Address. At the time this letter was written Shaw had already served in both houses of the Massachusetts Legislature and had drafted the first charter of the City of Boston. In 1830, he became the Chief Justice of the Commonwealth of Massachusetts. He served on that court for 30 years and participated in such notable cases as the "Parkman-Webster" murder case and in Commonwealth v. Hunt, an important labor law precedent establishing that labor unions were not criminal conspiracies. Order This Item

McReynolds was was best known for his overt anti-semitism, and being one of the "Four Horsemen" (together with Willis Van Devanter, George Sutherland, and Pierce Butler), who represented the opposition to Roosevelt's New Deal. 

"In 1868 President Johnson appointed Rosecrans to be Minister to Mexico. Five months later, President Grant terminated the appointment. His brief diplomatic career convinced him that a prosperous Mexico would need peace, immigration, and railways, and he applied for a concession to build a narrow-gauge railway and telegraph line from Tampico to the Coast. The record of toil and travel, scheming, waiting on rich men and politicians, and of the final collapse of his Mexican dreams, forms a wearying chapter of the frustrating years from 1869 through 1873. 



First published in 1787, Park's Marine Insurances was the first legal work on insurance written by an English lawyer. Holdsworth has called it "the best text-book upon the law of insurance." A work of great authority, *System of Marine Insurances* went through numerous English and American editions and remained the standard text until the middle of the nineteenth century. This rare Portuguese edition was produced for lawyers and merchants in Portugal and Brazil. Holdsworth, *History of English Law* XII:390. * First edition. In The Formative Era of American Law, Pound refers to the Commentaries on the Laws of Bills of Exchange as one of the standard texts of the nineteenth century. As Marvin pointed out in 1847, it was certainly the most complete and wide-ranging text of its day. In addition to American and English sources Story draws on the work of Heineccius and other civil-law jurists. Apart from James Kent, no man has had greater influence on American law than Joseph Story. He was Dane Professor of Law at Harvard and an Associate Justice of the U.S. Supreme Court. His many books have been cited extensively in America and in Britain, and he remains an authority today. Stephen Eno [1762-1852] was a prominent lawyer and civic leader in Dutchess County, New York who practiced in Pine Plains, Amenia, and Poughkeepsie. A very wealthy man, he was known for his extreme frugality, which may be why he noted the purchase price in his owner inscription. Several of his descendants were lawyers, including his son (?), "L. 



* Likely the only printing. Lyman Kidder Bass had been a Buffalo, New York attorney and was Grover Cleveland's law partner. Bass's brief on behalf of the Denver and Rio Grande Railway Company was filed with the U.S. Circuit Court in Colorado in late December 1879, subsequent to a U.S. Supreme Court ruling in favor of the railway company that reversed an injunction against the company's intended route from Denver to Leadville. It includes a statement of facts, his arguments against and objections to the supplemental bill, and an extensive review of the testimony. Witnesses here include Oliver Wendell Holmes, Jr. and extensive testimony from General William Jackson Palmer, co-founder of the Denver and Rio Grande Railroad. This brief was a concluding event in what became known as the Grand Canyon War, which pitting the Atchison, Topeka and Santa Fe Railroad Company against the Denver and Rio Grande Railway Company. Both railroads sought dominance to monopolize the right of way through the Grand Canyon of the Arkansas River. The "War" was not limited to the courts; it involved violence between "armies" of the railroad laborers and townsfolk.

Despite the ruling of the U.S. Supreme Court, new issues were raised by a supplemental bill in December 1879 opposing the Denver and Rio Grande Company to which Bass responds here. On the 13th day of May the opinion and mandates of the Supreme Court were filed in the Circuit Court, and a motion was made for a decree in conformity thereto. After several more rounds of legal action culminating in a January 2, 1880 decision by the Circuit Court for Colorado affirming the Denver and Rio Grand's right of way and the U.S. Supreme Court's announcement to review the case, both parties decided to settle out of court. Wikoff, or as he called himself, Chevalier Wikoff, was an American impresario, occasional European correspondent for the *New York Herald* and, possibly, a spy for Lord Palmerston. He was engaged to Jane Catherine Gamble, an English woman. Gamble changed her mind shortly before the wedding and fled to Genoa. Wikoff tracked her down and apparently tricked her into coming along with him to his apartment. Shortly afterwards Gamble filed a complaint of kidnapping that landed Wikoff in an Italian jail for 15 months. He was found guilty in an Italian court and forced to return her letters and "extorted promise of marriage." Ever enterprising, Wikoff responded to the negative publicity with a memoir entitled *My Courtship and Its Consequences* (1855), which became a best-seller. 


