



\* First edition. Not published in English until the Boston 1840 American edition, Bentham's seminal work on penal reform and legislation established his reputation. The first of Bentham's works edited by Dumont, it consists partly of papers by Bentham, some of which were originally written in French and partly of a digest by Dumont of Bentham's ideas, including a memoire in French on the Panopticon. Dumont, a Swiss writer and journalist, had met Bentham at the house of Lord Shelburne in 1788. There followed an enduring relationship in which Dumont translated and edited many of Bentham's works, acting at the same time as Bentham's informal literary agent. 



\* First edition. The most influential publication in the history of modern Anglo-American law, the Commentaries on the Laws of England is based on a course of lectures delivered at Oxford University. Because they were not intended for aspiring practitioners, they described general principles rather than practical specifics. Sensitive to the systematizing trends of the day and the prestige of the natural sciences, he described the common law as an intricate, well-designed system akin to Newton's mechanistic universe. "Until the Commentaries, the ordinary Englishman had viewed the law as a vast, unintelligible and unfriendly machine. Blackstone's great achievement was to popularize the law and the traditions which had influenced its formation. He did for the English what the imperial publication of Roman law did for the people of Rome" (Carter and Muir).



The annotations and underlining show that Mr. Prickett, most likely Marmaduke Prickett [1733-1809], a member of a prominent Bridlington family, studied this copy carefully and thoroughly. His notes include glosses, cross-references, comparisons and citations to other sources. There are also notes that elaborate or dispute points in the text. Some of the notes appear to be in slightly different hands. They may have been written by Prickett at a later date, or by a subsequent owner, possibly Prickett's son, who was also an attorney.) 

\* First edition. Written between 1250 and 1256, De Legibus et Consuetudinibus Angliae [The Laws and Customs of England] is the first treatise on English law. A systematic work, it emphasizes the separation of procedural and substantive matters and also cites cases as sources of at least intellectual, if not formal, authority. The principles formulated in this work and its use of precedents determined the development of English law and established the method adopted by Littleton and Coke. In Maitland's words, it is "the crown and flower of English medieval jurisprudence" and "by far the greatest of our medieval law books.": Maitland, Collected Papers II:43. 

\* Third edition. Sir Robert Brooke was renowned for his great learning and probity as a judge. His Abridgement is based on Fitzherbert's Abridgement, but it contains much new material. In all, Brooke abridged nearly 21,000 cases and digested them alphabetically under 404 headings. It abridges fully the Year Books of Henry VII and Henry VIII. Brooke proceeded with great care and accuracy, and is believed to have had access to the original records of the Year Books. Coke calls the Abridgement "a worthy and painful work and an excellent repertory or table for the Year Books of the Law." This edition is superior to earlier printings, in which abbreviations are frequently unintelligible. A fair number of important early American lawyers had copies of this title, and it remained a reference into the nineteenth century. 

\* Second edition. First published in 1700, this is the first English treatise devoted exclusively to family law. Its third and final edition was published in 1738. It is a broadly conceived work. "I have herein considered Baron and Feme in all the circumstances of life, from the solemnization of marriage to the divorce, and have not omitted 'those collateral by-blows, (the title of bastardy making a considerable figure in our books;) and the variety of the matter made me some attonement for the labour" (To The Reader). According to the introduction, the anonymous author seems to have also been the author of the Infants Lanyer: Or the Law (Ancient and Modern) Relating to Infants (1697), a work attributed to Samuel Carter. \* First edition. This is the first English treatise on the subject and the first copy of this edition we have seen in 35 years. Its twenty comprehensive chapters consist of a digest of the case law relating to each topic with explanatory comments. Holdsworth notes that "[i]t was a useful book to practitioners since it covers all the topics connected with its subject." A third edition was published in 1726. All editions are scarce. 

\* First edition. The Second Part of the Institutes, an exposition of "many ancient and other statutes" including Magna Carta, was published by order of the House of Commons after the author's death. It is a landmark work because it offered a novel interpretation of Magna Carta. Reflecting contemporary struggles between the king and Parliament, Coke presented the charter as the ancient constitution of England, one that established the fundamental rights of Englishmen and placed royal power under the laws of the land. Perhaps the most famous section is Coke's commentary on the 29th chapter, in which he traced the origins of trial by jury and the right of habeas corpus. According to the ESTC, this edition has two states: "state 1 has pages 28-29 misnumbered 38-39; state 2 has the pages numbered correctly." \* Reprint of the London edition, 1776-1777. First published at the beginning of the seventeenth century, Coke's *Reports* are not reports in the conventional sense but highly detailed anthologies of precedents organized according to the cases they consider. In each instance Coke assembled a large body of cases, outlined their arguments, and explained the reasons for the judgment, using it as a basis for a statement of general principles. Taken together, the *Reports* form the most extensive and detailed treatment of common law pleading that had yet appeared. A work of immense authority, it was often cited as *The Reports*, there being no need to mention the author's name. 

\* First edition. The earliest work in English devoted to laws relating exclusively to women, this incomparable digest from the time of the Civil War is also known as *The Womens Lamyer*. It is notable, in part, as the first book in English with the phrase "women's rights." A wide-ranging work, it treats such diverse topics as age of consent, dower, hermaphrodites, polygamy, wooing, partition, chattels, divorce, descent, seisin, treason, felonies and rape. Some sources, such as the *English Short-Title Catalogue*, believe this work was written in 1603 by Sir John Doderidge [1555-1628], an important legal figure during the reign of James I. Its preface is signed T.E., who is believed to be Thomas Edgar. Jefferson owned a copy of this book. 

\* Second Tottell edition. One of the most imposing volumes in the history of English law, it has abridgements of over 14,000 cases under 260 titles in alphabetical order. First printed around 1514, it was the first serious attempt to arrange the common law systematically and it was a model to such writers as Brooke and Rolle. According to Boersma, Fitzherbert accomplished "nothing less that to abridge all notes of significant cases at common law." 

\* First Selden edition. De Laudibus Legum Angliae, a history of English law, was written for the instruction of Edward, the young Prince of Wales. Cast in dialogue form, it demonstrates that the common law was the oldest and most reasonable legal system in Europe. It also compares the common and Roman systems and extols the superiority of a constitutionally limited monarchy. De Laudibus was written around 1470 and first printed in 1567. Selden's was the first critical edition of this work, perhaps the first critical edition of an early English legal work. Aside from their value to the elucidation of Fortescue's text, Selden's notes interrogate aspects of Fortescue's text and offer rich insights into jurisprudence and the nature of the English constitution. As noted by Christianson, his conclusions disputed "the concept of immemorial custom argued by [Sir John] Davies and the anachronistic historical interpretations displayed by [Sir Edward] Coke." It was reissued in 1660, 1672 and 1737 with various additions. "Fortescue was a favorite among the old lawyers, and will be read with profit in modern times by those who are interested in the origin and progress of the Common Law.": Marvin, Legal Bibliography 321. 

This was the first textbook on equity published since St. Germain's *Doctor and Student* (1523). It is generally considered to be the book that founded the field of equity jurisprudence. Francis outlines fourteen maxims, such as "Equality is Equity" and "Equity suffers not a right to be without a remedy." Each maxim is followed by a brief summary of cases that illustrate its application. The introduction is in English and the texts of the Magna Carta and Carta de Foresta in Latin. This remarkable work is esteemed for its appearance and scholarship. Its physical appeal was recognized as early as 1829 in Richard Thompson's An Historical Essay on the Magna Charta of King John, which described it as a "beautiful and rare edition" and with notably elegant typography. Along with its elegant typography, this edition features an elegant engraved dedication to the Earl of Westmoreland surmounted with his armorial ensigns, engraved historiated initials in the text depicting views of buildings at Oxford University, engraved tailpieces on pages lxxvi and 73 with historical vignettes and ten other ten engraved tail-pieces depicting the royal seals that are attached to the original documents. Blackstone's essay, which is based on a great deal of original research, argued that the charter was the foundation of English liberties. This idea, first proposed by Coke, was a central tenet of Whig ideology. More important, Blackstone's research into the original texts demonstrated that all earlier editions of the charter were based on the significantly different reissue of 1225, in the reign of Henry III, rather than the original one endorsed at Runnymede. His philological approach was highly influential; it established the textual focus that has governed subsequent study of the charter. 



He set a new standard to the makers of these editions, to which subsequent editors made at least an attempt to conform. 
\* Mare Clausum, Panegyricus, Gustavo Magno, first edition; Successionibus; second edition; Panegyricus Dicatus, only edition. Selden's Mare Clausum is the most famous British reply to the argument of Hugo Grotius's Mare Liberum, which denied the validity of England's claim to the high seas south and east of England. Selden, argued that England's jurisdiction extends, in fact, to all waters surrounding the isles. His use of legal history and common-law principles to rebut Grotius's philosophical argument is quite impressive. De Successionibus is an exposition of rabbinical law and laws of inheritance by a commentator whose "familiarity with rabbinical literature was such as has been acquired by few non-Israelite scholars; and many details of oriental civilization and antiquities were certainly brought to the knowledge of Europeans for the first time in them" (DNB). The other two titles remind us that Mare Clausum dates from one of the most turbulent eras in European history. Vossius's piece is a poem commemorating the deeds of Frederick Henry, Prince of Orange [1584-1647], who led Dutch forces to victory, established the independence of the United Provinces and governed them for a large part of its golden age. Heinsius's essay praises Gustavus Adolphus of Sweden [1594-1632]. One of the greatest military commanders in European history, he established Sweden as a leading European power during the Thirty Years War. This treatise was one of the first attempts to outline criteria through which to determine the legitimacy of an insanity plea. This issue would be resolved later that year with the establishment of the McNaghten Rules, which this work undoubtedly influenced, and which are still applied in England today. Dr. Winslow, a London physician, was a member of the Royal College of Surgeons and the father of Dr. Winslow Lyttleton Forbes, who is best known for his work on the case of Jack the Ripper. 





One of England's greatest civilians, Zouch was an advocate of Doctors' Commons, Judge of the High Court of Admiralty and Regius Professor of Civil Law at Oxford. He published treatises on a broad range of legal topics and is best known for his contributions to international law. He is equally important as the first English writer to publish works on jurisprudence. Elementa Jurisprudentiae is an ambitious general study that lays out a general theory of general principles applicable to all branches and systems of legal science. The second, third and fourth parts, Descriptio Juris et Judicii Sacri; Ad Quam Leges, Quae Religionem, Et Piam Causam Respiciunt, Referuntur, Descriptio Juris et Judicii Maritimi; Ad Quam quae Navigationem et Negotiationem Maritimam Respiciunt, Referuntur are distinct essays on topics in English ecclesiastical law, the laws of war and military discipline and laws concerning ships and sea-borne cargo. The latter two essays also deal with international law. The first two editions were published in Oxford in 1629 and 1636. The following two editions, with different additional contents, were issued in Holland in 1652 and 1665. 


