




With Several Interesting Contemporary Annotations

Contemporary calf, gilt spines with raised bands edges rouged. Moderate rubbing and some scuffing and scratches to boards, heavier rubbing to extremities with considerable wear to spine ends and corners, hinges partially cracked, front pastedowns loose, several cracks to text blocks, some signatures loose and lightly edgeworn, faint dampstaining and minor worming to margins in a few places. Moderate toning, annotations in early hand to 30% of the leaves in each volume, owner signatures and doodles to endleaves, some in the hand of the annotator. \$1,500.

* Volume I-II: second edition; Volume III: first edition. The *Journal du Palais* was an authoritative digest of recent decisions of courts and *Parlemens* throughout France. A serial publication, its final volume, Volume XII, was published in 1695. The annotator of our volumes is a M.De Laiosnieve. His signatures to the title pages of Volumes I and III state he is a judge in Dorat, a town in the Nouvelle-Aquitaine region of western France. One of his signatures is dated 1690. Some of his annotations are brief, but most are several sentences long. They deal with matters of doctrine and interpretation. Many are notably argumentative. Overall, they form an interesting record a provincial judge's response to contemporary legal and legislative decisions. Order This Item




Rare Wide-Margined 1804 Edition of the Code Napoleon with Extensive Contemporary Annotations

Nineteenth-century quarter sheep over marbled boards, calf lettering piece to spine, marbled endpapers. A few scuffs to boards, rubbing to spine and extremities, chipping to edges of lettering piece, corners lightly bumped, hinges starting, light toning, faint dampstaining, mostly to gutter and head of text block, crack in text block between pp. 460 and 161, recent paper repairs to tears in final leaf. Text printed on wide-margined paper, annotations to margins in neat early hand throughout, signature of annotator to title page. \$4,500.

* Renaudière and Dufresne's wide-margined edition was published the same year as the first official edition issued by the Imprimerie de la République. Our copy belonged to a distinguished attorney named Théodore Boucherat of Bar-sur-Aube, a town in France's Champaign Region. His annotations are mostly from the years 1807 to 1811. They offer a fascinating view of how a practitioner responded to the Code shortly after it was enacted. Many annotations record amendments to articles and subsequent changes to those amendments through rulings by the Court of Cassation, courts of appeal and provincial courts. He also cites digests of decisions and legislation, such as the *Nouveau Répertoire de Jurisprudence*, the *Jurisprudence du Code Napoléon* and the pre-Revolutionary *Journal du Palais*. Boucherat's annotations are carefully written. They have full citations and often include references to articles of the Code. He also notes when an article seems inapplicable. Many are interpretive. For example, in the article listing reasons for a divorce (No. 232), he notes this article, which grants equal rights to men and women, has been undermined by a series of court decisions that have favored the rights of men. OCLC locates 7 copies of our edition, 2 in North America (Florida State University, Laval University). Boucheret is listed in the 1816 *Almanach Royal*, a directory of notable attorneys. His opinion concerning a commercial dispute is cited in Frédéric Moreau's *Code du Commerce des Bois Carrées* (Paris, 1840) 412-413.

Title page, with large engraved allegorical vignette, printed in red and black, woodcut head-pieces, tail-pieces and decorated initials. Moderate toning to title page, light toning to text. Early ownership inscription "Ce livre apartient a Monsieur du Plessix, Brindejon" to front pastedown, interior otherwise clean. \$500.

* First edition. This commentary on the customary law of Anjou and surrounding vicinity was reprinted in 1725. Pineau was also the author of the posthumous *Coustumes du Pais et Duche d'Anjou* (1698). A native of Angers and a successful lawyer there and in Paris, Pineau was later appointed Conseiller au Presidial d'Angers and Maitre des Requetes de l'Hotel de Marie de Medicis. *Observations* is a scarce title. OCLC locates 4 copies of the first edition in North America, 3 in law libraries (George Washington University, Harvard, UC-Berkeley), no copies on the 1725 reissue. 

Contemporary calf with cats-paw decoration, gilt spines with raised bands, edges rouged, marbled endpapers, ribbon markers. A few minor nicks to boards, moderate rubbing to extremities with some wear to spine ends and corners, which are lightly bumped, hinges cracked, armorial bookplate of Lord Farnham to front pastedowns. Moderate toning to text, light foxing in a few places. An attractive set. \$500.

* First edition. Published anonymously under a false imprint, this is a collection of unusual or bizarre court cases, many with erotic and humorous elements, such as "Against an Accusation of Seduction," " A Brief in Favor of Turkeys." Several re-issues and adaptations of this work appeared during the next few years. "Lord Farnham" is possibly Barry Maxwell, 3rd Baron Farnham and 1st Earl of Farnham [1723-1800], an Irish lawyer, peer and politician. 

Contemporary sheep treated to resemble tree-calf, gilt spine with raised bands, speckled edges. Some rubbing to extremities with minor wear to spine ends, corners bumped. Toning to text, faint dampstaining and spotting to a few leaves, internally clean. \$1,250.

* First edition. The author was the Archbishop of Embrun, later Prince-Archbishop of Metz. Mazarin appointed him ambassador to Venice in 1659. Louis XIV appointed him ambassador to Spain in 1667 to pursue French claims to the Spanish Netherlands in the name of Maria Theresa of Austria (1638-1683), the Spanish Infanta and Queen Consort of Louis XIV. These claims were tenuous and constructed on intricate legal foundations. French jurists argued that the Spanish Netherlands should not go to the still underage heir to the Spanish throne, Charles II of Spain (1661-1700), because he was the issue of the second marriage of Philip IV. Maria Theresa on the other hand was a result of his first marriage and the lands thereby 'devolved' to her and, of course, Louis XIV. France's claims led to the War of devolution (1667-68). Feuillade defends France's claims with an argument grounded in the "fundamental laws of Spain, the examples of past centuries and the solemn judgments of the Royal Council of Castile." 

Moderate toning, faint dampspotting to margins, light soiling to title pages, small burn hole (?) to rear free endpaper. \$950.

* First edition. This fictional work concerns a story shared by a young man in prison about a lovely widow who was no longer interested in living in a conventional marriage. Later editions were published in 1751 and 1755. All are scarce. OCLC locates 2 copies of the first edition in North American libraries (University of Pennsylvania, University of Toronto). 



Contemporary quarter calf over marbled boards, gilt spine with lettering piece. Moderate rubbing with wear to spine ends and corners, joints starting at ends, hinges cracked, front free endpaper lacking. Light toning, somewhat heavier in places, light foxing in a few places, light edgewear to preliminaries and final leaves, light soiling to title page. Occasional annotations to interleaves and text in neat contemporary hand. \$3,750.

* Third printing. The 1808 Code d'Instruction Criminelle, a code of criminal procedure, was one the four codes of civil and criminal law issued under Napoleon's direction after the Code Napoleon (Code Civil, 1804). The annotations, the latest dated 1827, range from a few words to several interpretive paragraphs. Most of these note modifications to the articles by imperial decrees or court decisions. The most extensive annotations, which fill three full interleaves in a tiny hand, concern juries. They are interleaved with first eleven articles of Chapter V, "Du Jury et la Manière de la Former" (pp.133-136). Order This Item







* First edition. An interesting guide to the laws relating to women after the Bourbon Restoration in the form of a novel. (This may have been a ploy to attract a female audience; French women were assumed to be fond of novels.) A second edition was published in 1828. Guichard was a prolific author of legal treatises and popular guides to the law. Not in Camus. This edition not in the *British Museum Catalogue*. Order This Item

* Only edition. This handsome set collects the legal opinions and other writings of a distinguished *avocat* of the Parlement of Paris. Camus notes that Héricourt de Vatier was known as the leading French canonist of his day. 



Contemporary blind-stamped calf, raised bands to spine, clasps lacking, hasps present. Moderate rubbing and a few minor scuffs to boards, heavier rubbing to extremities, corners and spine ends worn, calf worn away from two spine bands, a few cracks to text block, signature n (ff. 97-104) detached and moderately edgeworn. Printed throughout in red and black, large criblé printer device and decorative borders to title page, criblé initials and table of descents. Moderate toning and occasional light soiling and foxing, early annotations to endleaves and title page, additional early annotations and underlining to some leaves in the text. \$5,000.

* Commissioned by the Emperor Justinian in 530 CE, the body of writings known collectively as the Corpus Juris Civilis restated all existing Roman law. It has four components: the Code, Novels, Institutes and Digest. Intended for students, the Institutes is a synopsis of the reformed legal system. Rediscovered during the late middle ages, it became the standard textbook of Roman law. The main text of our 1501 imprint is accompanied by Accorso's great Glossa Ordinaria (or Magistralis). A Professor of Law at Bologna and a leading figure in the revival of classical jurisprudence, Accorso examined every extant note and commentary when he prepared his epochal edition of Justinian's Institutes, Digest and Code. This massive effort eliminated much of the obscurity and contradiction introduced by earlier writers. His editions, which superseded all previous attempts, remained definitive until the 1583 revision by Denis Godefroy. 

Light rubbing to boards, moderate rubbing to extremities, a few worm holes to spine, small chip to head, hinges cracked (exposing manuscript binder's waste). Light toning to text, later owner marking to front free endpaper, owner signature dated 1702 to title page. \$1,500.

* This pocket edition by followed two earlier editions in larger formats from 1543 and 1544. As early as the 12th century, French legal students began to refine their study and practice of law toward a "perfected" Justinian system. This interest was largely owed to the spread of the philologically oriented study of the books of the *Corpus Juris Canonici* at the University in Bologna. French universities followed suit. The spread of text-based Roman law in France eventually created a market of translations for the general public, such as our imprint by Lescut, a jurist, diplomat and secretary to Antoine the Good, Duke of Lorraine. He states in his preface that he took "great pains" to render the text in plain language. Despite the claim in his title, this book was not issued with a tree of descents (arbre civil). Contemporary signed morocco binding by Despierres, gilt frames enclosing arms of Count Walewski to boards, raised bands, gilt title and gilt Walewski crests to spine, all edges gilt, gilt inside dentelles, moiré-stamped endpapers, later armorial bookplate to front pastedown, woodcut of Walewski from a contemporary periodical laid in. Light rubbing to extremities, corners lightly bumped. Moderate toning, some leaves have light foxing, occasional small inkstamps to bottom margins. An appealing association copy of a scarce title. \$1,750.

* First edition. This interesting comparison between the English and French political systems was through later editions in 1862, 1863 and 1864. Its author was a leading political journalist. Count Alexander Walewski, to whom this book is inscribed, was the natural son of Napoleon I and Marie Walewska. A notable diplomat, he was ambassador to Florence, Naples, Madrid and London. Minister of foreign affairs from 1855 to 1860, he opposed Napoleon III on the Italian question and resigned his position. He went on to become the minister of fine arts. Despierres, the binder of this copy, was also binder to the emperor. All editions of this title are scarce. OCLC locates no copies of any edition in North America. British Museum Catalogue 14:931. 

Title page of *Constumes* printed in red and black. Moderate toning to text, somewhat heavier in places, moderate edgewear to *Extraict*, which is slightly larger than text block, light foxing and minor tears to a few leaves, brief early annotations to blank page of *Bouquet*. \$1,500.

* Coustumes: second and final edition. Bouquet: only edition located. Lorris-Montargis is located in central France. Its political jurisdiction extended to the Gâtinais province. "In the first half of the twelfth century, the parish of Lorris had already obtained a charter of privileges from King Louis VII in 1155, and Philip II Augustus accorded a new confirmation in 1187. The coutume of Lorris, which was renowned because of these franchises and privileges, was adopted very rapidly throughout not only the Gâtinais, but also in the Beauce and Solange. The priveliges of Lorris were renewed twice: first in 1448, under Charles VII, and later in 1625, under Louis XIII" (Caswell and Sipkov). First published in 1617, Lhost's edition is based on an annotated 1597 edition by Du Moulin. Apparently unrecorded, Bouquet is a collection of courtroom speeches by Lhost. 

* From the same year as the first edition with corrections. Linguet was a conservative lawyer and journalist who was executed during the Reign of Terror. *Théorie des Loix Civiles*, perhaps the author's most important work, went through several editions and issues, the last in 1787. It outlines an ideal form of government and proposes reforms in taxation, customs and the law. It also defends absolutism and attacks the politics of Montesquieu. Volume I contains extensive discussion of divorce and the position of women in society. *Catalogue of the Goldsmiths' Library of Economic Literature* 10377. Order This Item





Given its economic importance, and the jealousy of other cities and, on occasion, kings of France, the city was careful to record and assert its rights. As much a political statement as it a legal handbook, the *Privileges* is a compilation of laws, orders, privileges and other legislation granted to the fair of Lyon from 1349 to 1563. 

The outside columns are filled with classroom notes. Many of these have corrections, underlining and check marks. The inside columns contain notes added later. These are mostly references to other code articles, clarifications and interpretive remarks. * This is a carefully written manuscript copy of the first volume of the first edition of a treatise on game laws by Laisné based on a manuscript by Novion. (The copyist recorded the publisher and publication date.) It was first published in 1685 with later editions in 1686 and 1688. All three are rare. Of all editions, OCLC locates 1 copy in North America at George Washington University Law School, which has a 1686 edition. We located a copy of the 1685 edition at the New York Public Library. 



(Sédillez says in the introduction that he wished this book had been written by Montesquieu, Rousseau or Condorcet.) Similar in style to the "Tableau des Connaissances Humaines" found in Diderot and D'Alembert's *Encyclopédie*, the tables cover the laws in general, police, justice, interior administration, foreign relations, armed force and public treasure. Ignored in America, it became an important influence on French debates about government during the first phase of the French Revolution in this version translated by Faure, who transformed it into a 291-page book with the addition of notes by Pierre S. DuPont de Nemours, Nicolas de Condorcet and J.A. Gauvain Gallors, a translation of the new U.S. Constitution and notes from Virginia's ratifying convention. Originally attributed to William Livingston, this work was written by Stevens, an engineer and inventor best known for his work on the development of the steamboat. * The Bolo Pasha affair involved a French traitor, Paul Bolo, who convinced the Egyptian Khedive (Viceroy), Abbas Hilmi, to sponsor an anti-war movement in France through the press using \$2,500,000 raised from German sources. (Granted the title Pasha by the Khedive, Bolo renamed himself Bolo Pasha.) Convicted of treason, he was executed by a firing squad in April 1918. Sem's caricatures portray the judge, defendant, witnesses and judges at various points in the trial. Gorsat, or Goursat, was a French caricaturist and illustrator active from the late nineteenth century to 1934. His lasting fame rests on his depictions of French ruling class and French high society during the *Belle Epoque*. He was a regular contributor to the leading French periodicals, produced albums of caricatures depicting current events and social life and designed several path-breaking advertisements.
