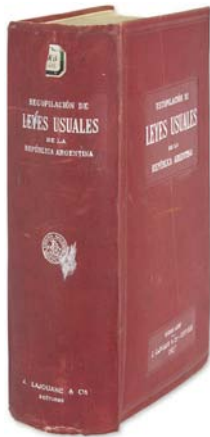

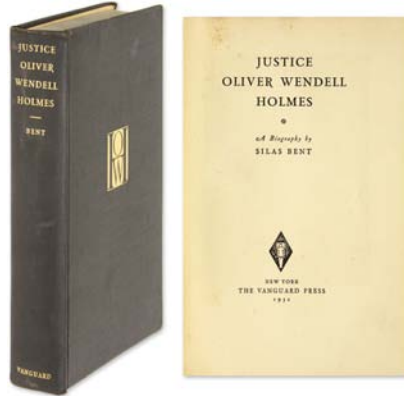

Light toning to text, worming to a final twelve leaves with minor loss to legibility to ff. 454-456. Early annotations to the second f. 187 (noting the duplicates), later annotation to front endleaf, interior otherwise clean. Ex-library. Bookplate to front pastedown. A nice copy. \$850.

* First edition. Asinio was a notable Florentine jurist who was patronized by Cosimo I de Medici. He is best-known for his treatises on practice and procedure in Roman and Florentine law. *De Executionibus* is a comprehensive treatise on creditors and debtors in Roman law. It appears to have been a well-received work; later editions were published in 1602 and 1607. All are scarce. OCLC locates 12 copies the first edition worldwide, 3 in North America, none in law libraries. *Censimento Nazionale delle Edizioni Italiane del XVI Secolo* CNCE3267.



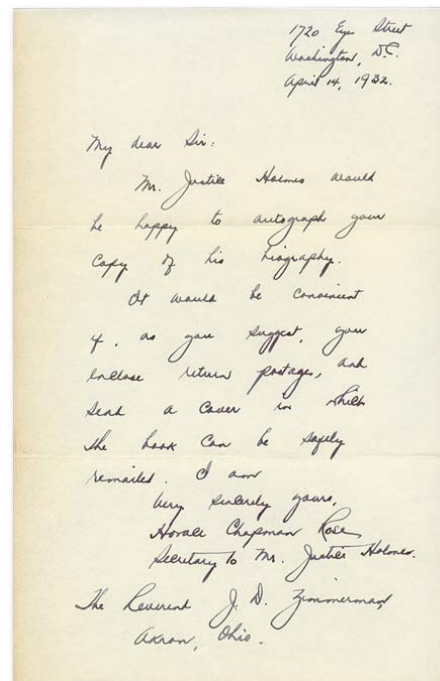
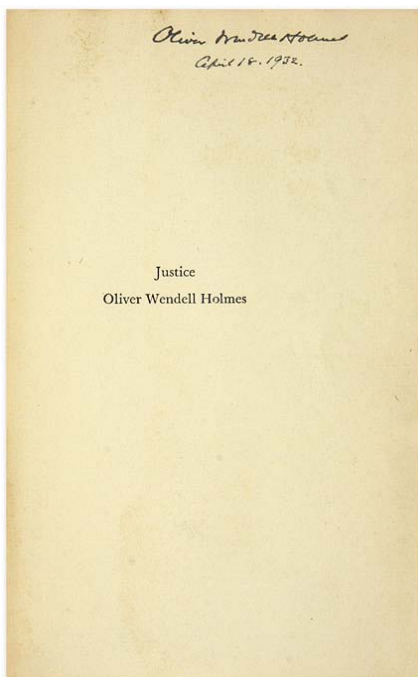

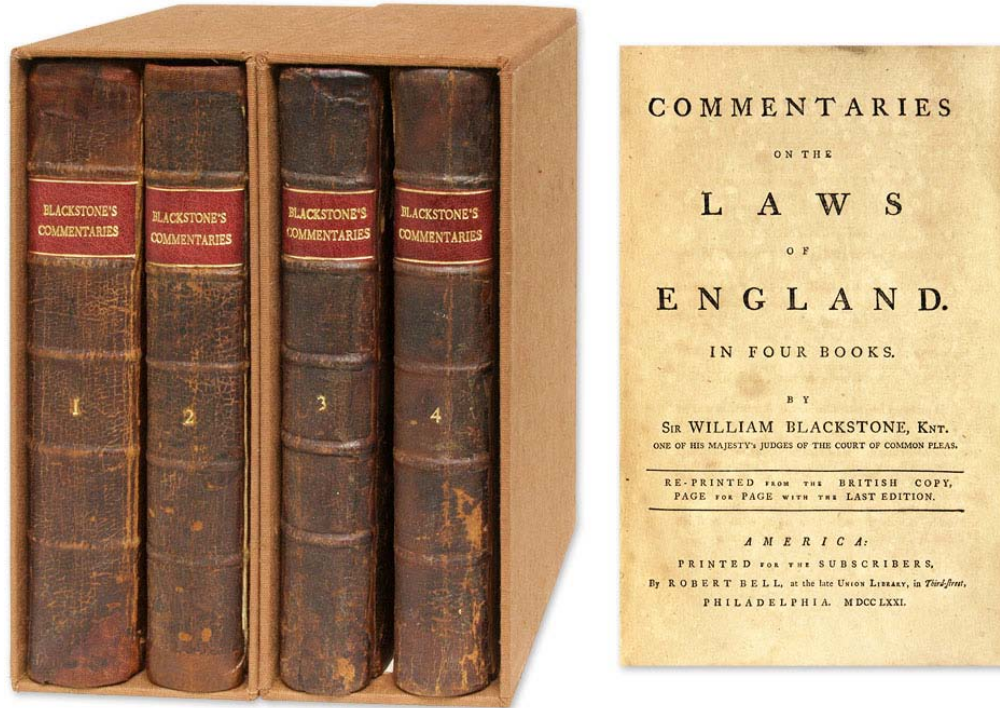

* First edition. This was the first biography of Holmes. The letter from Rose, Holmes's secretary, is a reply to the book owner's request for Holmes's signature. It reads, in part, "Mr. Justice Holmes would be happy to autograph your copy of his biography." The rest of the letter discusses shipping details.





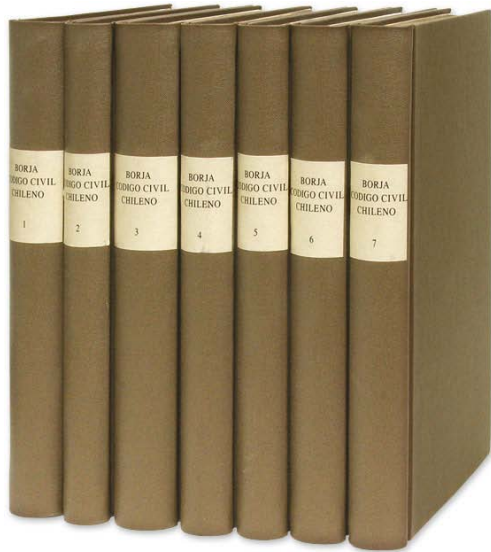

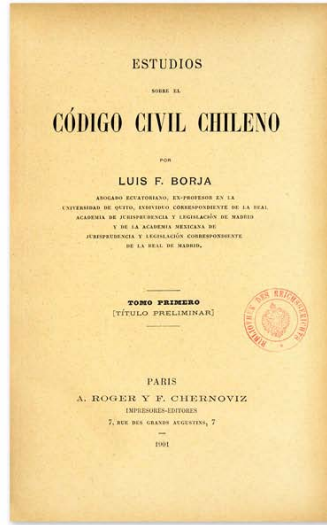

Contemporary calf, Volume I and II, and sheep with later calf rebacking, matching first two volumes, Volumes III and IV, raised bands and later uniform gilt volume numbers and calf lettering pieces to spines, repairs to spine ends of Volumes I-III and front joints of Volumes III and IV. Moderate rubbing to extremities with some wear, corners bumped, front joint of Volume III cracked, hinges starting, most of front pastedown removed from Volume I, early armorial bookplates of subscriber William Nicoll to pastedowns of other volumes. Moderate toning, somewhat heavier in places, occasional faint dampspotting, some places have foxing, a few leaves have light stains, moderate edgewear to endleaves, a few have chips, front free endpaper of Volume II partially detached. Owner signatures of Benjamin Nicoll to front free endpapers, later signatures in pencil of S.B. Nicoll, F. Nicoll, dated 1820, and William Nicoll to front free endpaper of Volume I. Books housed in attractive cloth slipcases. A set with an appealing association. \$17,500.

* First American edition. Blackstone's *Commentaries*, a synoptic review of the English legal system, is the most influential publication in the history of modern Anglo-American law. It was especially popular in America, where it was the standard introductory textbook into the late nineteenth century and was the primary, or only, book studied by hundreds of self-taught lawyers, such as Abraham Lincoln. The first multi-volume book printed in America, Bell's edition, a reprint of the fourth London edition, 1770, is a landmark in the history of American publishing. Our set contains the two tipped-in advertisement leaves, for *An Interesting Appendix* (Volume III) and *Ferguson's Essay on the History of Civil Society* (Volume IV), that are often missing in copies of this set. Volume IV also includes a 22-page subscriber list that includes John Adams, John Jay, John Dickinson, several colonial governors and many leading merchants, judges and military officers of colonial America. William Nicoll, an attorney and major landowner, was a member of the distinguished Long Island family that established the town of Islip. * Second and best edition. "[This work offers] a comparative treatment of the articles of the Chilean code, by concordances to the Roman law, the Code Napoleon, and the civil codes of a number of other South American countries, with references to the writings of the leading jurists, including appropriate translations and a brief commentary by the author. The work was inspired by the success of St. Joseph's celebrated 'Concordances,' and as a reference work has a decided value" (Borchard). This work was reissued in 1919. Its first edition is a one-volume work published in Quito in 1899. All editions are scarce. OCLC locates 9 copies of the second edition in North American law libraries. 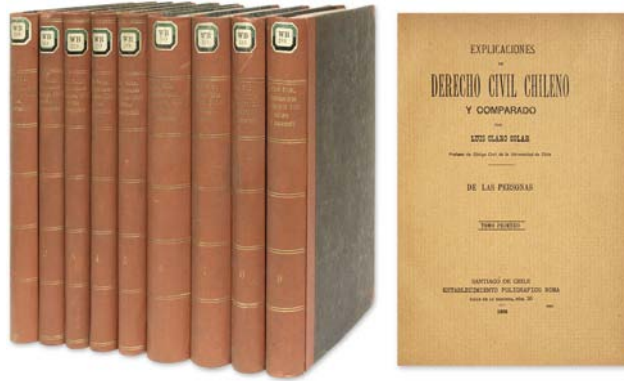

* Signed in type by "Americanus," this broadside discusses the cost of the Louisiana Purchase. The writer argues the difficulty, if not impossibility, of paying France without a special tax due to the revenue lost to the Embargo Act. The table described the proportionate cost to each New Hampshire county of the \$15 million bill. The author also warns of the threat of European war. No copies listed on OCLC. 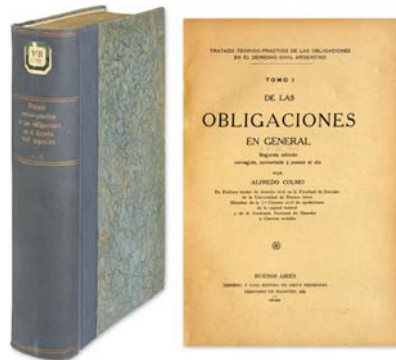

* First edition, Volume I a reprint of the first edition. Originally a one-volume work from 1898, this work evolved into one of the fundamental studies of Chilean law, a multi-part work in eighteen volumes completed in 1942. Our set offers the first two parts, each an individual study: De las Personas (Volumes 1-5) and De Los Bienes (Volumes 6-9). The other sections are: De las Pruebas del estado civil, De las Obligaciones, De la Sucesion por Causa de Muerte, De la Sucesion por Causa de Muerte and De la Prescripcion.

* Second and final edition, "corrected and augmented." This notable treatise on obligations and contracts under the Argentinean Civil Code of 1871, in force until 2015, was first published in 1920. Colmo intended to publish a second volume on specific cases, but he died before he could complete it. Both editions of Volume I are scarce. OCLC locates 8 copies of the second edition in North America, 6 in law libraries (Harvard, LA County, Library of Congress, Tulane, University of Michigan, Yale).

* Only edition, limited to 127 copies hand-printed for the author "for private circulation." "The recent barbarous beheading of a woman in Mississippi, while being hanged and the general discussion of the subject of capital punishment which has followed, is the excuse for this brochure. May 5, 1930" (Preface). OCLC locates 8 copies, 3 in law libraries (Library of Congress, University of Southern California, UT-Austin).

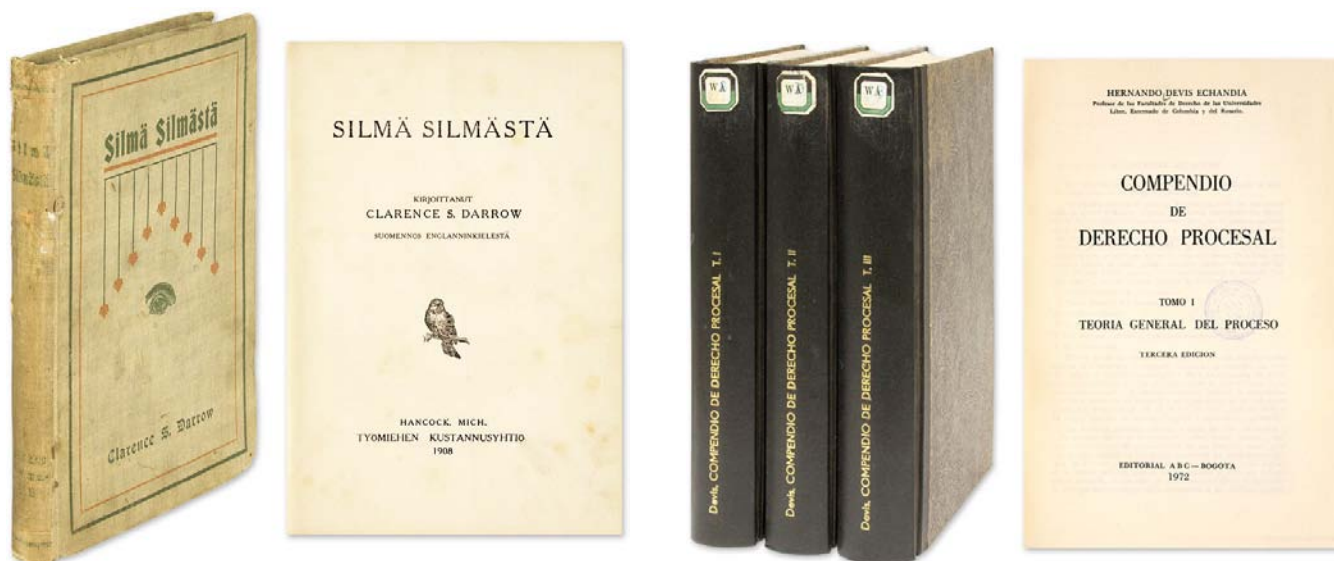

Title pages, each with a small copperplate portrait of Damhouder, printed in red and black. * Later editions. First published in 1557 and 1554 as *Praxis Rerum Civilium* and *Praxis Rerum Criminalium*, were standard works that went through several editions in Latin, French and Dutch into the early seventeenth century. Synthetic works drawn mostly from Roman-Dutch sources, they are notable as early examples of illustrated law books. Our 1660 edition of *Civile Saken* is distinguished by fine copperplates, most of them illustrating aspects of legal process. Our 1650 edition of *Criminele Saken* is illustrated throughout with cruder, but more vivid, woodcuts depicting adultery, murder, theft and many other crimes. Damhouder was an advisor to the Duke of Burgundy and a prolific author of legal and religious treatises. Dekkers, *Bibliotheca Belgica Juridica* 44.

* This edition in Finnish was published for the large Finnish-American community of Upper Michigan, which included many miners and lumberjacks who admired Darrow's effort to promote the rights of laborers. First published in 1905, *An Eye for an Eye* was Darrow's only fictional work, aside from his autobiographical novel, *Farmington*, published in 1904. It is a sociological novel about a man who, after a lifetime of poverty and abusive relationships, murders his wife in a fit of rage. OCLC locates 6 copies (Cleveland Public Library, Kent State University, National Library of Finland, Oregon Historical Society, University of Minnesota, University of Minnesota Law School). 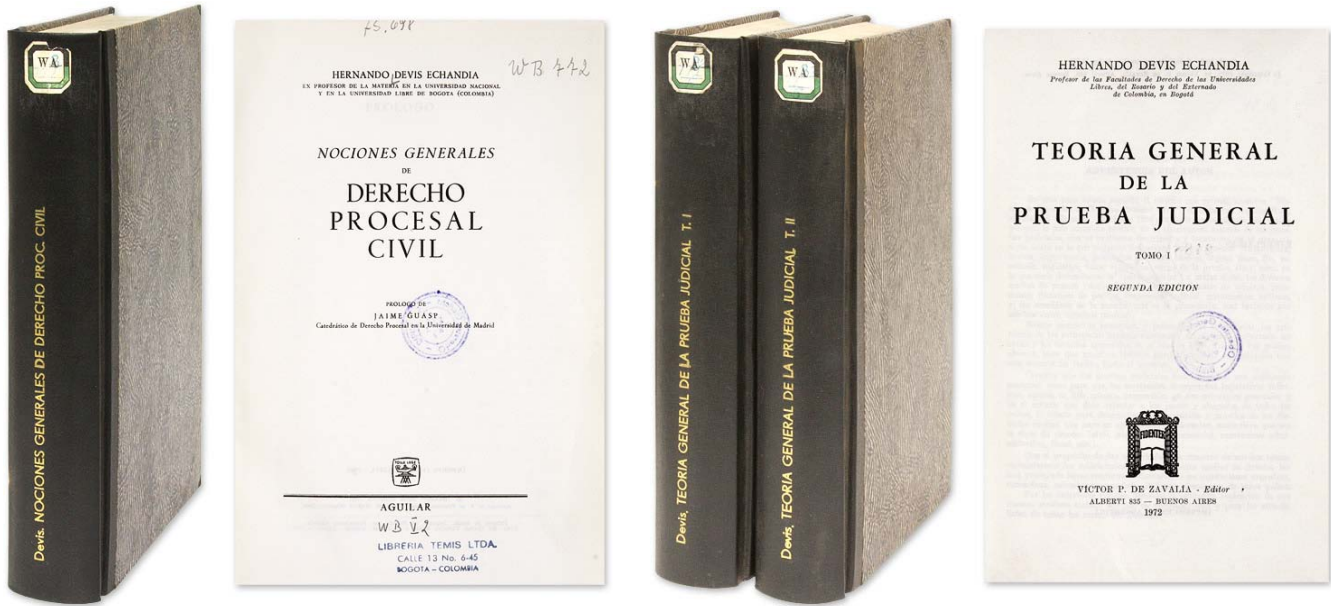

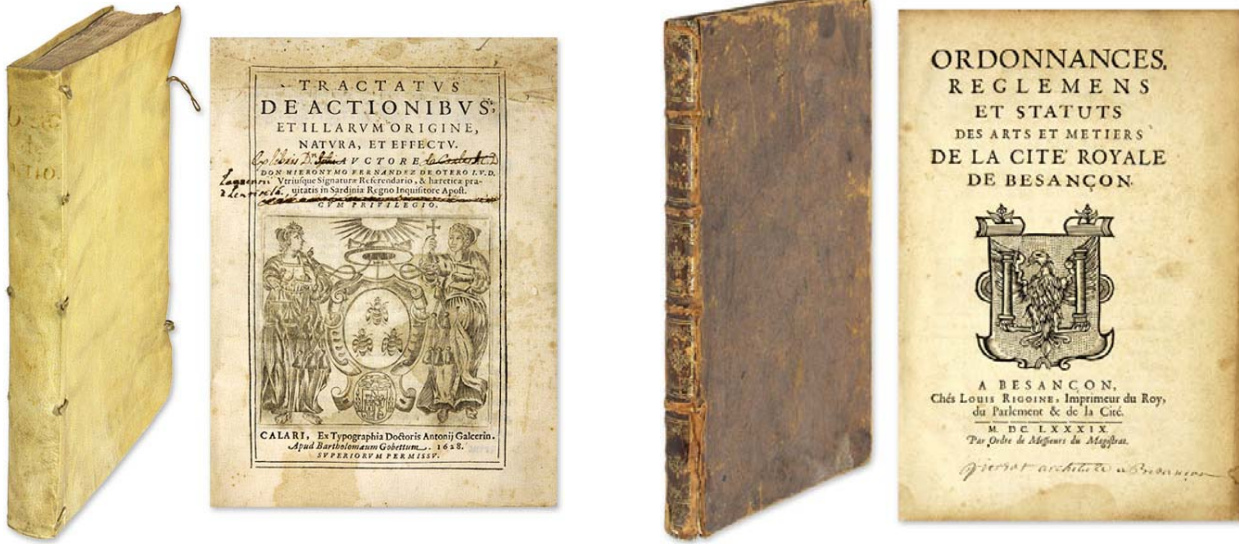

* Only edition. This remarkable collection of nearly 2,000 annotated treaties from 315 CE to 1730 is a notable testament to the Enlightenment belief that humanity would progress when it applied reason to large bodies of hitherto-unavailable evidence. It was begun by Carelscroon, a French publicist and continued in 1739 by Rousset de Missy and Barbeyrac. The treaties are in their original languages (Latin, German, Spanish and Dutch). The first volume of the five-volume *Supplement* is a history of diplomacy during antiquity by Barbeyrac. * Only edition located. Dedicated to Pope Urban VIII, this treatise presents a systematic overview of civil actions in Roman law, canon law and the law of the Kingdom of Sardinia. OCLC locates 5 copies, none in North America. *British Museum Catalogue* (Compact Edition) 9:164.

* First edition. Besançon is an important city in the Franche-Comte region in eastern France, close to the Swiss border. This collection of laws provides a fine overview of the city's commercial activity. The first section includes general information and regulations. The following chapters concern carpenters, roofers, launderers, metalsmiths, farriers, pavers, goldsmiths, silversmiths, pewterers, cabinet makers, hat makers, tailors, shoemakers, weavers, tanners, saddlers, harness makers, apothecaries, surgeons, bakers, pastry makers and butchers. Each chapter includes details concerning apprenticeships, trade regulations and other details. Later editions were published in 1698 and 1784. All are scarce. OCLC locates 1 copy of the first edition in North America (Columbia University). Another copy located at George Washington University Law Library. Not in Camus.



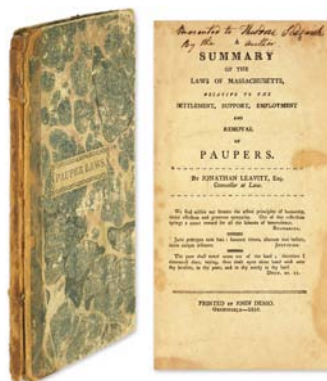

* Only edition. A valuable work today, this well-respected study begins with an early history of bondage and its construction in natural and positive law and the laws of European nations. He then outlines the evolution of slavery under English law and the United States Constitution. One of the book's most striking features is its neutral tone. As he notes in his presentation letter, this book, "published before the Rebellion on questions more directly affecting slavery as they appeared at that time," was soon obsolete, but he hoped it would retain some "historical interest." Hurd was an attorney and legal scholar in New York City. Farrar [1788-1874] was a distinguished lawyer and politician who served as a judge of the New Hampshire Court of Common Pleas and as a member of the Massachusetts House of Representatives. 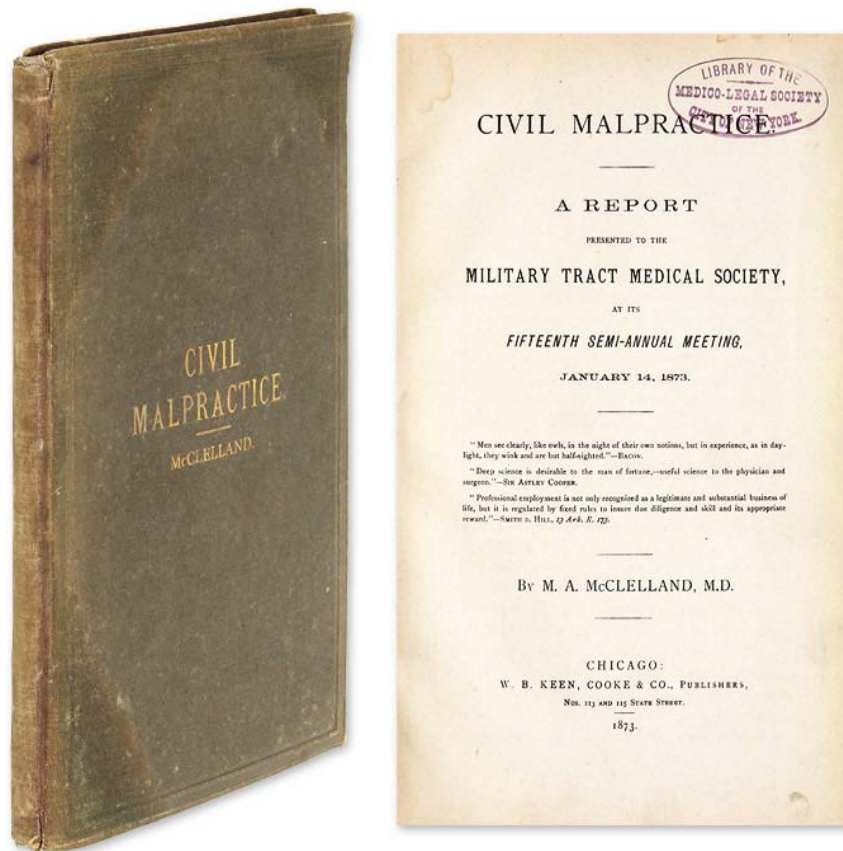

* Only edition. The author of this handbook, which covers the period from 1692 to 1810, was a probate judge from 1814 to 1821. Theodore Sedgwick, who served in the Continental Congress, was a United States Representative and Senator from Massachusetts. He served as the fourth Speaker of the United States House of Representatives. Appointed to the Massachusetts Supreme Judicial Court in 1802, he remained there until the end of his life. * Only editions. Spencer Cowper, a judge, was indicted for the murder of Sarah Stout. He was at the her house late on the evening before she was found drowned in a river. Cowper's alleged motivations were a desire to end an illicit love affair and avoid payment of a debt. Cowper's lawyers argued that Stout's parents wanted to hide the fact that their daughter committed a suicide, a heinous act among Quakers. The defence also suggested a political motivation: a desire by local Tories to harm the career of a rising Whig. Cowper had been at the woman's house late on the evening before she was found drowned in the river, but there was little material evidence against him. Also, his lawyers benefited from expert medical testimony from three leading physicians, Samuel Garth, Hans Sloane and William Cowper." He was acquitted. The trial attracted a good deal of attention and generated several pamphlets, including post-verdict pamphlets that attempted unsuccessfully to reopen the case. Our volume collects three examples. The *Tryal of Spencer Cowper* is one of the standard accounts of the trial. *The Hertford Letter* and *A Reply to the Hertford Letter* reflect the post-trial debates about the verdict. The *Tryal* and *The Hertford Letter* are scarce; *A Reply* is rare and apparently unrecorded. No Copies are listed on OCLC. * Only edition. Edward Fitzharris [1648?-1681] and his accomplices were conspirators against King Charles II and James, Duke of York. The trials of Fitzharris and his accomplices are notable because they raised a set of jurisdictional issues involving the courts and the two Houses of Parliament. These issues, which involve constitutional issues as well, are discussed in Hawles's *Remarks*. He concludes that the parties, while guilty, were tried illegally. *English Short-Title Catalogue* R10368.

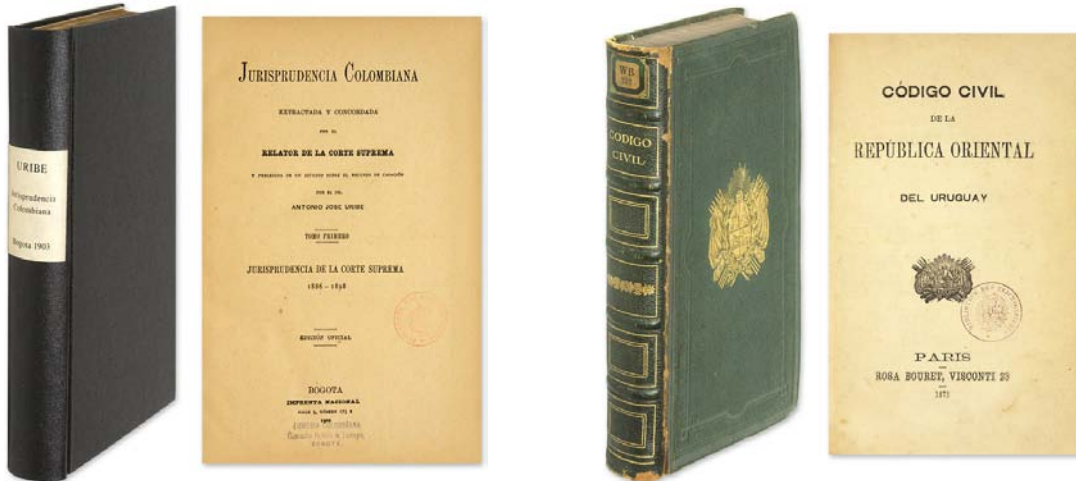

* Angelus de Ubaldis, a renowned jurist, was almost as highly regarded as his brother, Baldus de Ubaldis. First published in 1474, the *Super Authenticis*, also known as the *Lectura de Authenticis*, a commentary on the *Authentica*, a collection of 134 constitutions of Justinian, later included in the *Novels* of the *Corpus Juris Civilis*. It was believed to be a collection intended for Byzantine Italy, but this assumption is doubted today. Ubaldis's commentary was highly regarded; it went through at least 12 editions before 1500. Today, all editions are scarce. OCLC locates no copies of this imprint in North America. However, the GW locates copies at the University of Michigan Law School and the Walters Art Museum, Baltimore.
