

An Influential Treatise on Riparian Law

Contemporary vellum with later vellum rebacking, later hand-lettered title to spine, early hand-lettered title to foot of text block, endleaves renewed. Light scuffing and a few minor stains and wormholes to boards, which are slightly bowed, light wear to corners, front hinge cracked, rear hinge starting, bookplate residue to front pastedown, a few partial cracks to text block. Moderate toning, light foxing in places, light browning to a few leaves. \$1,850.

* Third edition. Aimo's influential treatise addresses a thorny aspect of riparian law: alluvium, that is, soil deposited on a shore by a river that modifies the dimensions of a parcel of land. A fine example of humanistic legal scholarship, it is notable for its application of geometry-based surveying techniques, which are illustrated in the plates and most of the woodcuts. Contemporary calf with later varnishing, blind rules and small central arabesques to boards, raised bands and later lettering piece to spine, spine ends and corners mended. * Only edition. Asinio was a notable Florentine jurist who was patronized by Cosimo I de Medici. He is best-known for his treatises on practice and procedure in Roman and Florentine law. *De Executionibus* is a comprehensive treatise on the section of the *Digest*, Book XI, Title 7, which addresses funeral rites and burial. It is a scarce title. Some toning to text, light foxing in places. * Later edition of a work first published in 1511. Tractatus Foecundus is concerned with the Roman law of prescription, the principle whereby a right or liability is created or extinguished over a certain period of time, usually in regard to a property title. It also includes an edition of a short treatise on this subject by Henricus de Segusio. It was a popular work that went through several issues and editions, the last one in 1582. Our 1564 copy was also issued in 1563. Both are identical in every respect and share the same entry number in EDIT16. All editions are scarce in North America. * Bero, Later edition; Marzari, first edition. *Quaestiones Familiares* was first published in Bologna with title *Familiares Quaestiones*. Its 136 *quaestiones* deal mostly with Roman or canon law. Whatever the topic, most of Bero's authorities come from canon law. A durable work, it went through five editions, the last in 1629. As indicated by its title, Marzari's treatise addresses the Roman law of fideicommissum, the request by a testator to any person who benefited by his will or intestacy to give certain objects to a third party. Both titles are scarce, especially Marzari's. * First edition (*Tractatus*); Only edition (*Annotationes*). The first title discusses interdictions and actions. A popular work, it was reissued several times well into the eighteenth century. The second work is a commentary on the *Constitutiones Sanctae Matris Eccleasiae*, Also known as the *Constitutiones Aegidianae*. This document, the first constitution of the Papal States, was adopted in 1357 and remained in force until 1816. Though bibliographically distinct, these titles appear to have been issued together. * Final edition. Bonacina was one of the foremost moralists of his age and an influential church official. A fine introduction to his work on law and theology, *Tractatus Tres* was first published in 1622. Other editions followed in 1627, 1625 and 1629. As its subtitle indicates, the first of the three *tractati* discusses the jurisprudence of canon law. The other sections discuss sin and the Ten Commandments from the viewpoints of law and theology. 

* First edition. This is a study of the laws concerning the transfer of land from an overlord to a vassal (investiture) in the Kingdom of Naples. A second edition was published in 1570. The second part of this book, the Repetitio Super Legem Imperialem de Prohibita Feudi Alienatione per Pedericum, was originally published in 1539. Both editions of Investitura Feudalis are rare. * First edition. With indexes. Claro was a Milanese jurist. This (bibliographically distinct) study of Roman criminal law and procedure, and the criminal law of Milan, was Book Five of an unfinished multi-volume work titled *Sententiae Receptae*. Six other editions were published in the sixteenth century and it was included in several collected-works editions, which began to appear during the seventeenth century. All editions of this work are scarce. * Commissioned by the Emperor Justinian I, the body of works known as the *Corpus Iuris Civilis* reformed, restated and preserved Roman law. The *Code* is the reformed legal system. The *Novels* is a compilation of additional laws and amendments. The *Institutes* is an elementary textbook about it. And the *Digest* is a collection of commentary by leading jurisconsults. The first modern edition, and the first titled *Corpus Juris Civilis*, was by Denis Godefroy [1549-1622]. Published in 1583, it became the standard version. Giunta's 1598 edition, which was reprinted in 1606 and 1612, is something of an anachronism because it reprints the collections of texts that were rendered obsolete by Godefroy. For this reason it offers an interesting comparison to Godefroy's edition. * First edition. This treatise deals with civil and criminal remedies in Roman, canon and feudal law. Little is known about Costa. The title page identifies him as a highly placed canon lawyer attached to the Vatican. The presence of a portrait frontispiece, with a cartouche bearing his arms, indicates that he was an important man. Costa is not to be confused with the French jurist Jean Lacoste (de la Coste) [1560-1637]. Costa's treatise went thought two later editions in 1629 and 1630. All three are rare. * Completed in 1444, this important alphabetically digested encyclopedia of canon law is an enlargement of the Summa de Casibus Conscientiae by Bartholomew of San Concordio. Two other important texts are appended: Alexander de Nevo's (or Nievo's) analysis of the Church's view of Jewish money lenders, Consilia Contra Judaeos Fenerantes, and the Canones Poenitentiales by Astesano. These two texts appear in editions of the Supplementum published after 1476. The ISTC locates 3 complete copies of this imprint in North America, none in law libraries. 

* Only edition. This treatise analyzes benefit of inventory, a concept in Roman (and civil) law concerning an heir's right to commission a legally binding inventory of his ancestor's estate for representatives of the estate's creditors. It also concerns the right to limit debts and legacies to the amount of three fourths of an estate, thus preserving one fourth for the heir. 

* Only edition. Ferretti was a member of the College of Jurisconsults during the papacy of Clement VII [1478-1534]. This volume collects 31 of his canon-law consilia (analyses of disputed legal points, usually submitted by a judge). This volume was reissued in 1563. 



In the early 1600s Genoa was prosperous and forward-looking, traits reflected in the "reformed" statutes of 1616. 

* The Concordia Discordantia Canonum, or as it is better known, the Decretum Gratiani, is the cornerstone of modern canon law. The first work of its kind, it was compiled by Gratian, a Camaldolese monk, around 1140. Using the latest scholastic and juristic techniques from the Corpus Juris Civilis in the study of the civil law, it became the basic text for the study of canon for many centuries. The Decretum Gratiani addresses various aspects of church jurisdiction, offenses and legal proceedings, as well as administrative issues like baptism, feast days, confirmation and the consecration of churches. In the following century an extensive gloss was added by Teutonicus. Known as the Glossa Ordinaria, it was later revised and enriched by another Bartolomeo of Brescia. The gloss and its revisions become a standard feature of subsequent manuscripts and printings. Though never an official edition of canon law, it was a standard work for nearly 800 years until it was superseded in 1918, along with the other books of the Corpus Juris Canonici, by the Codex Iuris Canonici. Our 1584 Venice edition incorporates the changes ordered in 1580-1582 by the council of revisers established by the Council of Trent (the Correctores Roman). It also includes Bolognini's edition of the Margarita Decreti, an index to the Decretals of Gregory IX. * Later editions. Riva di San Nazarro, a Lombard noble, was a learned jurist and humanist scholar. His many works, all commentaries on aspects of Roman and canon law, went through several editions and were often excerpted and anthologized. The two titles in this volume are from a deluxe series published by Giunta in 1575-1576. (All but the Repertorium are bibliographically distinct.) The Repertorium is an index to this set. In Primam, & Secundam Infortiati is a commentary on the books from the Digest of the Corpus Juris Civilis concerning aspects of personal and family law, such as donations between husband and wife, divorce, curatorship, wills and testaments and trusts and legacies. (The Medieval Glossators divided the 50 books of the Digest into three parts: Digestum Vetus, I-XXIV, Title 2, Infortiatum, XXIV, Title 3-XXXVIII, and Digestum Novum, XXXIX-L. 

* First edition. Rutilio was Italian jurist and humanist. He was also one of the first authors to compile biographies of lawyers. *Iurisconsultorum Vitae* describes the lives and achievements of 77 Roman jurists, from Papirius to Tribonian. Distinguished by its discerning criticism and careful use of sources, the work was well-received. It went through later editions in 1537, 1538, 1539, 1545, 1584 and 1718. All editions are scarce. 

This is a collection of tracts on canon, Roman, civil and other legal topics by Amadeus de Ponte, Antonio Faber, Bertrand Argentreus, Camillo Borello, Carlo Antonio Blancardo, Solsona, Hartmann Pistor and Maurice Bourgeois. This volume appears to have been compiled from Solsono's eighteen-volume *Tractatus Universi Juris* (1584-1585), an anthology of contemporary legal writings compiled under the direction of Pope Gregory XIII. 



* Second edition in octavo format and the final incunable edition. After the Fourth Lateran council of 1215 a number of manuals of confession appeared. Their purpose was the intellectual preparation of priests for a prudent and informed exercise of the office of confessor. Father Trovamala's is one of the best examples of this literature. Also known as the *Summa Casuum Conscientiae*, *Rosella Casuum* or *Summa Baptistiniana*, it was a standard work. First printed in 1482 and immediately successful, it was revised and expanded by the author as the *Rosella Casuum* or *Summa Rosella*. That edition was printed in 1484 with later editions in 1489, 1495 and 1499. A notable feature is its opinion of usury. Unlike other authors of summa for confessors, Trovamala argues that dry exchange is not usury because of its speculative nature. 


