



* First edition. With fascinating actuarial tables containing fees and mortality rates for whites, slaves and free blacks, an index of American Cases and an index of British cases. Angell was a Boston attorney and one of America's first significant legal writers. A prolific author, he published treatises on the law of corporations, watercourses and other topics. His works were esteemed highly. James Kent said they were indispensable to the intelligent lawyer (*DAB*); several were required reading at Harvard Law School. *Dictionary of American Biography* I:310. 

Later Riviere-style tree calf (by H. Sotheran, London), gilt rules to boards, gilt spine with raised bands, gilt tooling to board edges, gilt inside dentelles, all edges gilt. Light rubbing to extremities, corners and spine ends lightly bumped, a few minor nicks to boards, front joints starting, hinges cracked. A nice copy of a scarce title in a notably handsome binding. \$350.

*Second and final edition. With the additional plate added to some copies. According to Sweet & Maxwell, "the Halifax Gibbet-law is an institution which throws light on the nature of trial by jury in its earliest form". Walker defines the Law as "a right, probably a survival of the right of infangtheft, or possibly derived from a forgotten royal grant, held by the Burgesses of Halifax, to execute anyone taken within the liberty of Halifax found guilty of the theft of the value more than 13 pence. The execution was carried out on a hill outside the town by decapitation with an instrument resembling a guillotine." The victim could save himself from death, however, if he succeeded to escape during the execution process, and get over the Hebble Brook, a small river which marks the Parish boundary of Halifax. The first instance of its use was in 1286, thereby arguably making it the first guillotine device in history. It was used for the last time in 1650 and is mentioned in Daniel Defoe's *Tour Through the Whole Island of Great Britain* (1724-1727). Older sources attribute this work to Samuel Midgeley. Contemporary sources, such as the *ESTC*, agree that the author was William Bentley, the parish clerk of Halifax. The first edition of this book appeared in 1708. * First edition. "It has been the purpose of the author to bring together, as part of this treatise, those statutes and agreements which it is necessary to consider in determining these questions. The most important and complicated statutes have received careful consideration in the light of such judicial interpretation as they may have received. Comparatively few of these statutes, however, have received authoritative interpretation, and the construction given the same is therefore chiefly that of experience and individual judgment. The endeavor has been to give that interpretation most in keeping with the language of the statute, considered in the light of previous legislation, and which will best subserve the ends of justice.": Preface iii.

* Later edition. A landmark in the development of maritime law, the *Consolato del Mare* was first published in Barcelona in 1484. A digest of the law and practice commonly followed by the commercial judges in the chief ports around the Mediterranean, it became a maritime common law of the Mediterranean and a foundation for subsequent European maritime laws and customs. Its circulation was widest in Italy, especially among the Venetians, but it was also influential in Western Europe. In addition to maritime law, it contains a great deal of information about the day-to-day operations of a ship and practical advice on seafaring. *Il Portolano del Mare*, an appendix, is usually attributed to Alvise Ca da Mosto, a Venetian navigator who made two voyages to Guinea in the service of Portugal's Prince Henry the Navigator. 

* Cravetta was a renowned Piedmontese jurist who practiced in Milan. "If Cravetta says so, that's enough," ran a popular assessment of his authority. The first collection of his *consilia* was published in 1566. Another followed in 1572. The contents of both were combined in a single volume, with some additions and subtractions, in 1575. Our 1579 edition contains the 326 consilia found in the 1566 and 1572 editions and 3 *responsa* on behalf of Cravetta's son-in-law, Hector a Rubeis. Cravetta believed in the limitation of the absolute power of princes. This is the subject of Consilium 241, which became a standard text on the subject. Complete in itself, this collection was later continued by other publishers to comprise six parts in all (1000 consilia). 

*Only edition. The essay on nobility has a separate title page. The final treatment of customary law for the jurisdiction of Vitry-en-Perthois, in Marne, Champagne-Ardenne. It is preceded by a series of *coutumiers* (1651-1676) edited by Charles de Salligny, another series (1567-1656) edited by Charles Du Moulin, and a series of anonymous editions ca. 1511-1555. The author, Estienne Durand was an *avocat au Parlement*, and a resident of Rethel-Mazarin in Champagne-Ardenne, north of Reims. 



* First edition. "The order of [this book's] arrangement has been chosen with care--with a design to bring the different phases of the subject into review, in the form and order in which they naturally present themselves--beginning with the capacity to make and indorse negotiable paper, and ending with the sum recoverable upon the instrument" (vi). 



* First edition. The inscription reads: "Dear Bob/ This is not a Roland for an Oliver, but law, at least in my poor hands, is only on the river of philosophy./ But 'we live by symbols,' and this brings you my gay devotion & ardent hopes./ Yrs/ Felix/ 18 December 1936." "Bob" is probably Robert H. Jackson [1894-1954], one of Frankfurter's closest friends. In 1936 Jackson was the assistant attorney general heading the Tax Division of the Department of Justice. He was attorney general from 1937 to 1941 and an associate justice of the Supreme Court from 1941 to 1954.

* Third edition. Gilbert was a prolific author, but this is his only work on wills. A well-written work, its scope includes equity rules. Its first edition appeared in 1739, its final edition, the fourth, in 1792. 

Fol. 1 features a large woodcut frontispiece of Gratian surrounded by Old Testament figures, saints and church fathers. Printed marginalia. Large woodcut printed device to title page, woodcut decorated initials, text printed in gothic type. Minor worming to text block, occasional faint dampstaining to margins, internally clean. \$4,000.

* The Concordia Discordantia Canonum, or as it is better known, the Decretum Gratiani, is the cornerstone of modern canon law. The first work of its kind, it was supposedly compiled by Gratian, a Camaldolese monk, around 1140. Using the latest scholastic and juristic techniques from Bologna, he attempted to harmonize these disparate texts. Like the Corpus Juris Civilis in the study of the civil law, it became the basic text for the study of canon law for many centuries. The Decretum Gratiani addresses various aspects of church jurisdiction, offenses and legal proceedings, as well as administrative issues like baptism, feast days, confirmation and the consecration of churches. In the following century an extensive gloss was added by Teutonicus, a German prior living in Bologna. Known as the Glossa Ordinaria, it was later revised and enriched by another Bolognese prior, Bartholomew of Brescia. The gloss and its revisions become a standard feature of subsequent manuscripts and printings. Though never an official edition of canon law, it was a standard work for nearly 800 years until it was superseded in 1918 by the Code of Canon Law (Codex Iuris Canonici). In addition to the Glossa Ordinaria of Joannes Teutonicus and the glosses of Bartolomeo da Brescia this imprint includes the Canones Poenitentiales of Astesano and the Margarita Decreti of Polonus Martinus. 

* With side notes. A code in many respects, this important Parliamentary act restated the body of English maritime and naval laws dating back to the medieval period. The core of the act is a list of 36 articles; other sections outline procedure and other matters. This was one of the acts passed during the Parliamentary session from November 1747 to November 1748, the 21st regnal year of King George II. Issued independently, this printing was intended to be bound with other session acts.



^{*} First edition. This was Greenleaf's first book. It went through four editions, the last appearing in 1856. A lawyer in Maine since 1806, he became a professor at Harvard Law School in 1833. (At that time he and Joseph Story comprised the school's faculty.) He is best known for his classic *Treatise on the Law of Evidence* (1842-1853), the standard work before the publication of Wigmore's treatise (1904). 

* Third American edition. First published in London in 1680, and in Boston in 1693 and 1772, this 1798 Philadelphia edition was the first printed after the Revolution. Possibly a response to the recent passage of the Alien and Sedition Acts, it has an interesting preface by the bookseller, Alexander Brodie: "But lest (sic) the title 'The Englishman's Right' should give offence to any, it is proper to observe that the Charter of the Liberties of England is a grant from their kings obtained by force. This charter is the fountain of all their Rights; and among others of the Englishman's Right to be tried by a Jury of his Equals. As Americans we possess the same Right, and Juries by our Laws have the same powers and privileges, as by the Law of England. Neither we or our Ancestors ever were Slaves. We hold our Liberties from God alone, and to him alone are we accountable for the use or abuse of them. It is no mark of Vassalage to borrow instructions from English Jurisprudence. To understand our rights well, we must study them, and endeavour to profit by the experience of other Nations. The better to enable Jurymen to discern between Judge and Prisoner, if a lawless stretch of power should be attempted, of which at present there appears no danger, from the high character of our American Judges, I have prefixed by way of Introduction, Lord Bacon's Essay on the Moral duty of a Judge. And let it be remembered, that Judges are appointed to interpret the Laws faithful but Juries were instituted to watch and restrain Judges; so may the blessing "Him That Was Ready To Perish Upon Them!" A staunch Whig, Hawles wrote The Englishman's Right to outline the rights, duties and proper behavior of a juryman and to promote the jury system as a bulwark against tyranny. Immediately successful among Whigs and others who saw themselves as defenders of English liberties, it was received with great enthusiasm in America, where it was reprinted several times well into the nineteenth century. The work of a talented scribe, this handsomely produced volume is a reminder that the manuscript transmission of texts continued long after the advent of printing. In some cases a manuscript was produced for a special occasion. More often, they were a less-expensive alternative to printing when only a few copies of a text were required. * This appears to be the only edition of a set of legal arguments refuting France's attempts to lay claim to portions of the Spanish Netherlands. "Louis's claims to the Spanish Netherlands [in 1667] were tenuous. His wife, Maria Theresa, the daughter of Philip IV, had renounced her rights of a Spanish inheritance in return for a large dowry at the time of her marriage. The dowry had yet to be paid, however. When Philip died in 1665, the king's lawyers justified his possible claims by arguing that, while Spanish laws of succession meant the throne of Philip IV would pass to his son Charles II, ancient laws of Duchy of Brabant ruled that the Spanish Netherlands could 'devolve' to Philip's daughter from his first marriage, Louis's wife." (Wikipedia). Spain's refusal to acquiesce to Louis's demands led to the War of Devolution (1667-1668). Francisco Ramos del Manzano was a lawyer, an eminent professor of law at the University of Salamanca and archdeacon of Malaga. He was a lawyer in the Council of Castile during reign of Felipe IV and was an instructor to Carlos II. The New Catholic Encyclopedia says he was "among the illustrious writers of treatises in the 16th and 17th century" and that he enjoyed "high prestige in the most distinguished circles of Europe." Peeters-Fontainas suggests this book was printed in Brussels while Palau says Antwerp. * One of England's greatest civilians, Zouch was an advocate of Doctors' Commons, Judge of the High Court of Admiralty and Regius Professor of Civil Law at Oxford. He published treatises on a broad range of legal topics, and he is best known for his contributions to international law. The present volume contains four important treatises. *Elementa Jurisprudentiae* (1629) is an ambitious general study that lays out a general theory of legal science. It includes sections on the philosophy of law, civil law, military law and maritime law. The other titles develop topics outlined in *Elementa Jurisprudentiae*. *Descriptio Juris et Judicii Sacri* (1636) concerns English ecclesiastical law, *Descriptio Juris & Judici Militaris* (1640) addresses military law and *Descriptio Juris et Judicii Maritimi* (1640) deals with the law of ships and sea-borne cargo. According to Willems, some copies of this book were printed by van der Marse, de Croy and Hackius with counterfeit title pages.
