



Contemporary calf, gilt spine, gilt insignia of the Royal Library of Versailles to front boards, marbled edges and endpapers. Worn, several boards and backstrips detached, a few backstrips and a board lacking, text blocks intact. Moderate toning to text, occasional light foxing, internally clean. Ex-library. Location labels to spines, stamps to title pages, annotations to versos. A reback-worthy set with an interesting provenance. \$500.

* Only edition. d'Aguesseau was an important magistrate, parliamentarian and judge during the time of Louis XIV and XV. A pupil of Jean Domat, he served two terms as chancellor of France in 1717-1722 and 1727-1750. Edited by Pardessus, this sixteen-volume critical edition collects most of his work. The contents of this set deal mostly with legal matters, but several pieces relate to politics and diplomacy. This copy belonged to the "Pages du Roi, Versailles," a library in the Versailles Palace at the time of King Louis XVIII [1755-1824]. Order This Item



* From an edition limited to 750 copies, this number 606. Hémard presents Balzac's 1825 study of rogues (fripons), described for the benefit of "decent people," with witty color pochoir illustrations. Hémard, a prolific artist, illustrator, designer and author, is best-known for his illustrated editions of serious non-fiction books, most notably the French penal code, tax code and civil code, book one. 

* First published in 1850, this useful household dictionary aimed at the rural consumer went through at least six subsequent editions. (The latest imprint we located is from 1868; Some issues, identical in contents, have a slightly different title beginning with *Manuel des Familles Contenant Dictionnaire...*) All editions are scarce. OCLC locates no copies of any edition in North America, but we found copies at George Washington University law library (1863) and the Library of Congress (1866). 

* Fourth edition. Sweet and Maxwell include this in its list of major bibliographies and notes: "the second volume is a descriptive bibliography of French, English, foreign and Roman law, well indexed. The bibliography lists 2,348 books and provides historical, critical and bibliographical notes on several remarkable books of French jurisprudence." * First edition. Choppin (or Chopin) was a French jurist and an avocat of the Parlement of Paris. Like Jean Bacquet and Jean Bodin, Choppin drew on Roman law and feudal principles to advocate a centralized state under royal rule. De Privilegiis Rusticorum addresses legal privileges enjoyed by rural people in Roman and French civil law. A well-written and remarkably comprehensive work, it went through seven subsequent editions in Latin. Its final edition, translated into French, was published in 1634. This was a rarely explored topic, and Choppin's treatise is the only early example we have encountered. According to the Biographie Universelle, "it deserves notice for the singularity of its subject, for its profound research, and the decisions it contains" (8:499). All editions are scarce today and rare in North American law libraries. OCLC locates three copies of the 1575 edition (at Columbia, George Washington University and Harvard). 

* First edition. This commentary on the customary law of Anjou and surrounding vicinity was reprinted in 1725. Pineau was also the author of the posthumous *Coustumes du Pais et Duche d'Anjou* (1698). A native of Angers and a successful lawyer there and in Paris, Pineau was later appointed Conseiller au Presidial d'Angers and Maitre des Requetes de l'Hotel de Marie de Medicis. *Observations* is a scarce title. 

Contemporary speckled calf, gilt spine with raised bands and lettering piece, edges rouged. Some rubbing to extremities with wear to corners and foot of spine, front joint starting at head, early bookplate to front pastedown, clean tear to rear leaf mended with archival tape. Light toning to text, heavier in places, title page creased. Early annotations to endleaves, early owner signature to head of leaf following title page, interior otherwise clean. \$200.

* First edition. A commentary on the four propositions of the "Declaration of the Clergy of France of 1682," the landmark document fashioned by the great French cleric Jacques Benigne Bossuet (1627-1704), which gave definitive form to the principles of Gallicanism elaborated earlier by Gerson and Richer--that the church and king of France have rights of their own, independent of Rome. Bossuet's declaration shaped church-state relations in France for the next two centuries, asserting not only the autonomy of the Church of France vis-a-vis Rome, but also a sphere of autonomy and supremacy for secular authority in France. Dupin defends each of the four propositions of the Declaration. Cautioning that one must above all practice moderation, he proceeds "with all due respect to the Pontiff, to contest the maxims of the ultramontanes." There were later editions in 1724 and 1788. 

Moderate toning, some what heavier in a few places, worm hole from front board through most of text block with minor loss to text, small early stamp of Masonic organization (?) to title page. \$750.

* First edition. Dupuy chronicles the political and legal suppression of the Knights Templar, the Catholic military order established in 1119 and disbanded around 1312. Skilled fighters who played a leading role in the crusades, and the inspiration for a great deal of medieval lore and legend, the Templars had significant land holdings in Europe and the Middle East, a naval fleet and a banking network. Support for the Templars faded after the failure of the crusades and several powerful people began to openly resent their power and wealth, among them King Philip IV of France, who was deeply in debt to the order. In 1307, using a lurid rumor about the Templars's secret initiation ceremony as an excuse, Philip ordered several French members of the order arrested. They were tortured into giving false confessions and burned at the stake. Later, under pressure from Philip, Pope Clement V disbanded the order in 1312. Jean-Baptiste L'Écuy [1740-1834] was the last abbé général of the French Premonstratensian Order before the French Revolution. Brunet, Manuel du Libraire et de l'Amateur de Livres II:902. 

* Only edition. The essay on nobility has a separate title page. The final treatment of customary law for the jurisdiction of Vitry-en-Perthois, in Marne, Champagne-Ardenne. It is preceded by a series of coutumiers (1651-1676) edited by Charles de Salligny, another series (1567-1656) edited by Charles Du Moulin, and a series of anonymous editions ca. 1511-1555. The author, Estienne Durand was an avocat au Parlement, and a resident of Rethel-Mazarin in Champagne-Ardenne, north of Reims. 

* First edition. Claude de Ferrière was a prominent *jurisconsulte* and professor at the Law Faculty of Paris who later held, simultaneously, the Chair of Civil and Canon Law and Chair of French Law at the University of Rheims. He produced numerous works on subjects ranging from Roman, canon, and customary law to notaries, the law of fiefs and patronage and civil and criminal practice. Generally designed for the practitioner, they were useful works that retained their popularity long after the author's death. His son, Claude-Joseph [c.1680-c.1748], was an important legal writer and the compiler of an important law dictionary. *Texte des Coutumes*, a study of the customary laws of Paris and their correspondence with civil law, went through four editions, the final appearing in 1764. * In February 1820, Charles-Ferdinand, Duke of Berry, the last living male in the Bourbon line, was stabbed to death in front of the Paris Opera by an apparently deranged citizen. The murder (or as some claimed, assassination) had profound repercussions for French society and closed the final chapter of the Bourbon dynasty. The present work critiques the official coroner's reports following the assassination. The author describes himself as "Ancien Chirurgien de l'Hotel-Dieu, membre des ci-devant colleges et academie royale de Chirurgie, ancien professeur particulier d'accouchemens et membre eligible du college electoral du departement." Light rubbing and staining to boards, extremities bumped and rubbed with some loss to spine ends and corners, a few small pieces lacking from edges, front hinge starting, fragment of early bookplate to front pastedown. Light toning, minor foxing to top margins, light soiling to title pages, small strips cut from bottom margins of two leaves of *Laon* (for bookmarks?), no loss of text, faint dampstaining in a few places, minor tears and chips to margins of a few leaves, internally clean. \$2,750.

* Composed in 1448 and revised in 1556, the Vermandois contume governed much of the ile-de-France and Picardy, lands that included four of the six French ecclesiastical peerages: the Archbishopric of Rheims, and the Bishoprics of Laon, Chalons and Noyon. Rheims's, which applied to areas beyond ecclesiastical control, was written in 1481 and first published in 1615. The contume of Chalons, written in 1571, applied also to parts of Vitry and Barrois, that of Vitry-en-Pethois was issued in 1509 and first printed in 1618. 



* First edition. An interesting guide to the laws relating to women after the Bourbon Restoration in the form of a novel. (This may have been a ploy to attract a female audience; French women were assumed to be fond of novels.) A second edition was published in 1828. Guichard was a prolific author of legal treatises and popular guides to the law. Not in Camus. This edition not in the *British Museum Catalogue*. Order This Item


