"The object of [this book] is to investigate the original establishment, and to trace the progress of the modern rule of Law which raises the presumption of a grant of an incorporeal right, or hereditament, after a quiet enjoyment of twenty years duration. * First edition. In 1831 Beaumont and Tocqueville were commissioned by the French government to examine America's latest prisons, which were renowned for their innovative approaches to penology. Their nine-month tour included visits to prisons in Connecticut, Maryland, Massachusetts, New York and Pennsylvania. Du Systeme Penitentiaire aux Etats-Unis, the result of their tour, was an immediate success that was quickly translated into English and German. It was one of the most influential books on penology ever written. Beaumont and Tocqueville were affected deeply by their experiences in the United States. (He even includes a table of cases.) Cooper, a chemist and lawyer by training, was a polymath who published books on law, political science, economics, medicine and the natural sciences. A friend of Joseph Priestley and Thomas Jefferson, he was a professor of chemistry at Dickinson College and the University of Pennsylvania. *With index. Commissioned by the Emperor Justinian in 530 CE, the body of writings known collectively as the Corpus Juris Civilis preserved and restated all existing Roman law. It has four books: the Code, Novels, Institutes and Digest. Intended for students, the Institutes is a synopsis of the reformed legal system. It supplanted the earlier Institutes of Gaius. Stryk was a distinguished German jurist who was instrumental in developing German law from native sources rather than from received Roman law. He was eminent Professor of Law at Halle whose pupils included Thomasius, Boehmer, Heineccius and Ludovici. His annotated edition of the Institutes was first published in 1698 and went through five editions, the last in 1726. The annotations, all of them footnotes, are extensive. * Second edition. Petyt, a member of the Inner Temple, was active in the Whig cause. In return for his support he was appointed Keeper of the Records in the Tower Of London after the Glorious Revolution, a post he held until his death in 1707. First published in 1690, Lex Parliamentaria is one of his five major works on Parliament that advanced Whig ideology. The others are Ancient Rights of the Commons Asserted (1680), Miscellanea Parliamentaria (1680), Rights of the Commons Answered (1681) and Jus Parliamentaria (1739). This book is also attributed to George Phillips. The ESTC records an edition from 1698. Our edition, designated the second, is not dated. Wing and the ESTC, based on a reading of the contents, which include acts to 1700, assign the date c. 1701. The ESTC locates 3 copies in North America, none in a law library. * Only edition. The Liberal Revolution overthrew the regency and initiated a series of parliamentary deliberations that resulted in the Portuguese constitution of 1822. Written to influence the constitution's authors, this contemporary pamphlet by an anonymous (royalist) author offers proposals for the monarchy's role. This is a rare title. No copies located on OCLC.

* Only edition. Portugal's September Revolution of 1836-38 led to a new constitution. By 1844 there was public pressure, ultimately successful, to return to the more monarchist pre-war Charter. * Only edition. The Liberal Revolution overthrew the regency and initiated a series of parliamentary deliberations that resulted in the Portuguese constitution of 1822. It remained in force until May 1823, when D. Joao VI renounced it. The reign of Maria II marked the beginning of the "liberal regime," which brought a return to projects for constitutional reform, such as our anonymous example. In the end the 1822 constitution was reinstituted with modifications. This is a rare title. No copies located on OCLC.

* Only edition. One of the principal centers of the slave trade, Gambia was colonized by a succession of European governments and commercial groups during the sixteenth and seventeenth centuries. Great Britain and France fought to possess it during the seventeenth and eighteenth centuries, and it became a British possession in 1783 under the Treaty of Versailles. Gambia was originally subject to the government of neighboring colony Sierra Leone, which annexed it in 1821. Gambia became a separate colony in 1843. It was part of the West African Settlements from 1866 to 1888. Established as a crown colony in 1888, it achieved its independence in 1965. OCLC locates 5 copies. * This heavily annotated volume, which contains two standard works of the Elizabethan era, provides excellent insights into the study habits of a contemporary law student, Henry Tilston, whose name appears on the title page of *Plees*. (He also notes that he purchased the book on 15 November 1604 for 12 shillings.) First published in 1557, Staunford's *Plees* is divided into three parts. The first treats offences, the second treats jurisdiction, appeals, indictments, and defenses. The third addresses trials and convictions. *Exposition of the Kinges Prerogative* was first published in 1567. It addresses discretionary rights enjoyed by the monarchy in foreign policy, domestic affairs, legal and governmental administration, religion and economic matters. The annotations, some in English, some in law-French, include extensive underlining, case citation, cross-references, references to other legal texts, glosses and analytical comments. He also added a list of twelve principles to a rear endleaf. He even records the date when he completed the two books: "1 February" at the end of *Plees* and "24 february 1604 (i.e. 1604/5)" at the end of *Exposition*. The owner was probably Henry Tilston of Cheshire [b.1589]. He matriculated at Brasenose College, Oxford, in 1600 and became a barrister of the Inner Temple in 1610. Borrowing a shotgun from a neighbor, he called on Mrs. Schermerhorn in Rotterdam, New York; while she was going upstairs to get some wadding he requested, he shot her in the back" (McDade). Our sis one of the three accounts of this case. All are scarce. OCLC locates 3 copies of the Christian imprint in law libraries (Harvard, Library of Congress, Yale). He was a judge in the Circuit Court of Missouri from 1815 to 1830 and was professor of law at the College of William and Mary, his alma mater, from 1834 to 1851. "This work was the first authoritative and original printed texts of these important documents... It is, in short, the book which may be considered as the Magna Carta of the United States. It is scarcely necessary to say that this important work has been repeatedly reprinted" (Monthly Review cited in Sabin). * Only edition. Voorhees was the defense lawyer of John E. Cook [1830-1859], one of the leaders of John Brown's raid on Harper's Ferry. We wonder how his second address was received. Secession and fear of Lincoln's election was on the mind of many Virginians when it was delivered. Voorhees was a Federal district attorney in Indiana. He represented that state in the U.S. House of Representatives and was a U.S. Senator for 20 years. OCLC locates 4 copies in law libraries (Harvard, University of Iowa, U.S. Supreme Court, Yale). Not in Sabin.

* Third edition, corrected. First published in 1720, Wood's *Institute* was the only treatise until Blackstone's *Commentaries* to furnish a comprehensive view of the common law. According to Holdsworth, it was "the most important and the most popular of his books. It was written, he tells us, to supply the want of a methodical book on English law, which could be put into the hands of students in the Inns of Court and the Universities." Blackstone says "his work is undoubtedly a valuable performance; and great are the obligations of the student to him, and his predecessor Finch, for their happy progress in reducing the elements of law from their former chaos to a regular methodical science.": *A History of English Law* XII:419.
