* Promulgated in 1298, the *Liber Sextus* of Boniface VIII is one of the works known collectively as the *Corpus Juris Canonici*, a collection of papal decisions comprising the law of the Catholic Church and lands governed by the Pope. John XXII added the final official collection, the *Liber Septimus Decretalium*, better known as the *Constitutiones Clementis V*, or *Clementinae* in 1317. The *Extravagantes* of John XXII were added later along with the *Extravagantes Communes* of other popes through 1484.

Our attractive small-format printing was compiled for the use of students at the Faculté de Droit in Paris. The four parts are frequently catalogued separately but were commonly issued together with other parts of the *Corpus Juris Canonici* and shared among booksellers. Jean Kerbriant (or Kerbriand), the printer of our edition, was a Brittany native active in Paris from 1516-1550 specializing in liturgical printing. * Eleventh edition, one of two issues from 1719. Coke's *Institutes*, which eventually comprised four volumes, are thought to be the first textbooks on the modern common law. Taken together, they are a virtual legal encyclopedia of the law as it stood in Coke's lifetime. The first *Institutes*, better known as *Coke on Littleton*, contains the text of Sir Thomas Littleton's *Tenures* with extensive commentary. It was first published in 1628, and was a standard work for decades, often used as a textbook. Our copy of this title belonged to the Earls of Macclesfield. 

The advertisement on the last page, possibly written by Sir John Fielding, is headed "To the Public." It advertises a domestic employment agency that offers servants free of "the rude Behaviour and Insolence of Servants of all Kinds" that has "become a general complaint." Some of the more interesting acts include several acts to do with infrastructure and "An Act for Restraining and Preventing Several Unwarrantable Schemes and Undertakings in His Majesty's Colonies and Plantations in America." This was an extension of the Bubble Act of 1720, meant to protect investors by forbidding the creation of joint-stock companies without a royal charter. Notably, the South Sea Company itself supported this act, which reduced its competition but did not prevent the collapse of the company in the "South Sea Bubble" or the massive losses to investors that followed. The American extension also made provision for remuneration of losses in unauthorized "schemes and undertakings," a frequent feature of colonial economies. The *Liber Sextus* of Boniface VIII followed in 1298, and John XXII added the final official collection, the *Liber Septimus Decretalium*, better known as the *Constitutiones Clementis V*, or *Clementinae* (1317). The *Extravagantes* of John XXII were added later in 1325, along with the *Extravagantes Communes* of other popes through 1484. * Three notable eighteenth-century trials. Admiral Byng was court-martialed after electing to repair his damaged fleet at Gibraltar rather than relieve a British garrison. The court acquitted him of personal cowardice, but convicted him of failure to "do his utmost to take, seize and destroy the Ships of the French King." Upon the court's recommendation, several members of the Admiralty petitioned George II for clemency, but this was denied. Byng was executed by firing squad, the last of his rank to be executed in this manner. The execution of Ferrers was similarly notable. An eccentric nobleman with a violent temper, he was convicted of killing his steward in a drunken rage and holds the dubious honor of being the last peer to be hanged and anatomized. Blandy, a notorious female criminal, was found guilty of poisoning her father with what her suitor Captain William Henry Cranstoun claimed was a "love philtre." (It was, in fact, arsenic.) She was sentenced to death by hanging, but as indicated by her last request to the execution officials, she remained a proper middle-class lady to the end. "For the sake of decency, gentlemen," she pleaded, "don't hang me high." 

* Only edition. One of the cruelest hoaxes in British history and the inspiration for a wave of anti-Catholic violence, the Popish Plot was the invention of Titus Oates, an Anglican clergyman, and his friend, Dr. Israel Tonge, a cleric and passionate anti-Catholic. They pretended to have discovered a Jesuit plot to assassinate the King, massacre Protestants, and set James, Duke of York, the King's Catholic brother, on the throne. The trial of Green, Berry and Hill was one of its most shameful episodes. In October 1678 Godfrey, a justice of the peace to whom Oates first described the plot, was found dead in a ditch, apparently the victim of murder. The Catholic community was blamed and Green, Berry and Hill were eventually hanged for his murder. Many questions about this case remain, however, including the exact circumstances of Godfrey's death.

One theory holds that Godfrey was killed by Oates and his supporters to underpin their own invented plot, another that he was murdered for reasons unconnected with any Catholic plot. It is also possible that Godfrey committed suicide; when his body was found it was manipulated to fit the plot scenario. In any event, Godfrey was buried in an elaborate funeral as a martyr to the Protestant cause. This event stoked the fires of anti-Catholic hysteria, provoked a political crisis that threw the right of royal succession into question and contributed to the establishment of the first political parties in the British system. *Dictionary of National Biography* VIII:33-34. *English Short-Title Catalogue* R24642. 

In 1688 James II reissued his Declaration of Indulgence, which suspended the penal laws enacted against Catholics and dissenters, and ordered the Anglican clergy to read it to their congregations. The Archbishop of Canterbury and six bishops petitioned against this order on the grounds that the suspending power had been declared illegal by Parliament. They were indicted in the King's Bench for seditious libel, but were acquitted to great public acclaim. The "Trial of the Seven Bishops," as it came to be known, confirmed the subject's right to petition the crown and raised new questions for the reform of libel laws. The trial also reflects the antipathy of English Protestants towards Catholicism and the Stuarts, which would culminate in the Glorious Revolution of 1688. 



The Bairds testified that he had experienced violent fits in the weeks leading up to the murder, though he was well-known and respected in the community before these incidents. The jury returned a guilty verdict, but recommended mercy in light of questions of Van Arsdale's sanity, and many members of the community agreed. Despite this, he was sentenced to death, but the New Jersey Court of Pardons commuted his sentence to life in prison. Order this Item





* Sixth (stated) edition. As suggested by its title, this is a manual for justices of the peace. The first part is arranged in tabular form. Each entry lists an offense, conditions for an action, the number of justices required to hear the case, the appropriate punishment and references to authorities. The second part is a condensed version of Staunford's *Plees del Coron* (1st. ed. 1557), a standard treatise on criminal law in the fifteenth and sixteenth centuries. Published as the sixth edition, it is actually the third. The first, second and fourth were published in 1643, 1650 and 1663. Sweet & Maxwell list a 1620 edition titled Justices, Their Vade Mecum and Cornucopia, but it appears to be a ghost. All editions are scarce. 


