* Second French edition. First published in Madrid in 1746, this treatise on prize law and privateering went through three other editions, all in France in a translation by the author, in 1753, 1758 and 1802. Little is known about Abreu, a minor Spanish noble and diplomat. According to the title page, he was a "membre de l'Academie Espagnole, & actuellement Envoye Extraordinaire de S.M. Catholique aupres du Roi de la Grande-Bretagne." 5 copies located in the Americas, 1 of this edition (at Columbia University Law Library). KVK locates 13 copies of all 4 editions, all in Europe. * Later edition. Bacquet, an important French jurist, was King's Advocate of the Treasury Chamber. As indicated by *Les Oeuvres*, he was a prolific author on a wide variety of topics. First published in 1597, the five volumes contain treatises on escheat, aliens, land tenure and judicial administration. There is also a compilation of law reports compiled by Belut. Well-respected works, they went through several editions. The final edition, by Claude-Joseph de Ferriere, was published in 1744. OCLC locates 2 imprints from 1664 in the United States (Tulane Law Library, University of Kansas). * First Italian edition. This comprehensive dictionary devoted to civil procedure and commercial law was originally published in Paris in 1834-35. It went through several editions during the nineteenth century. Versions were produced for France, Belgium and the Kingdom of the Two Sicilies, which had a legal system founded on the Code Napoleon. 2 copies located in North America, 1 of this edition (at SMU Law School). This edition not in the British Museum Catalogue.

* First edition. A notable work of Historical School jurisprudence, this treatise addresses the Roman law of inheritance and succession and wills with comparisons to these laws in Prussia and, to a lesser extent, other German states. Bluntschli was one of the great Continental Jurists of the nineteenth century. He published a code for the Canton of Zurich and works on German private law, the law of war and international law. * Fifth edition, corrected, with additions. With indexes. Bohmer was perhaps the leading German authority of his age on ecclesiastical law and its history. He played a leading role in the adaptation of canon law for use in the Lutheran church and established sound theoretical foundations for Lutheran church law. First published in 1701, *Ius Parochiale* addresses issues relating to church property, tithes and clergy. * Later edition of a work first published in 1594. Bronkhorst was a professor of law at the University of Leiden from 1587 until his death. According to Roberts, his work was cited often by the leading Roman-Dutch authorities, especially van Leeuwen. Enantiophanon is an extensive treatise on controversial topics in Roman-Dutch law. * Later edition. With prefaces by Denis Godefroy [1549-1622] and Hermann Vulteius [1565-1634]. Calvinus was a German jurist and professor of law at the University of Heidelberg who wrote several books on politics, Jewish law and Roman law. The Lexicon Juridicum proved to be his most honored and durable publication. First published in 1600, it went through numerous editions during the seventeenth and eighteenth centuries. It draws on several authors, including Albericus, Brisson, Cicero, Hotoman and Tacitus. A scholarly work, it contains an extensive list of sources. The definitions are admirably clear and concise; each one includes a list of citations. Roberts says this dictionary is "more useful" than those of Vicat and Brisson. * Only edition. One of the leading American jurists of the second half of the nineteenth century, Cooley was a Justice of the Supreme Court and professor at the University of Michigan whose writings were "long deemed authoritative" (Walker). He was also the dominant commissioner when he was with the Interstate Commerce Commission. This pamphlet discusses the effects of the Interstate Commerce Act on railroads. * Only edition. This treatise deals with the Roman law of rescission, that is, the cancellation or annulment of a transaction or contract by mutual consent. Little is known about Costa. The title page identifies him as a canon lawyer attached to the Vatican. He is not to be confused with the French jurist Jean Lacoste (de la Coste) [1560-1637]. "Since 1875 it has been the announced and settled policy of the State of New Jersey by the enactment of laws first wise then liberal to attract incorporated capital to the state, and by like legislation to protect capital thus invested against attacks from within and from without. (...) The state has kept pace with modern legislation...but always with a view of doing no violence to the established scheme of incorporation, and always preserving vested rights and acquired franchises" (xvii).

The other sections are a pleading manual (pp. 131-190), a charming list of "Suggestions to Students" (pp. 191-215) and a law glossary (pp. 217-246). Not in Eller.

* Fourth edition. The first edition was published in 1893. A durable work, it reached its seventh and final edition in 1907. Giauque was an authority on the laws of Ohio and editor of *The Revised Statutes of the State of Ohio* (1889 and later editions).

The first important American work on evidence, it freed the bar from its dependence on English sources. (...) While he is a consummate carpenter of ideas, it is evident that he has in this work branched out into legal doctrines, legal theories and legal reasonings. He has treated many principles in a truly lawyer-like way. But we apprehend that the greatest merit of this work remains in the fact that it affords an accurate key to a very great mass of adjudications; and this is the greatest merit of any legal text-book. * First edition. A title in the series Transactions and Collections of the American Antiquarian Society. Includes a biographical sketch by J. Hammond Trumbull. Lechford was the first professional attorney in the Massachusetts Bay Colony. He was also a controversial figure because he advocated the use of English common law instead of the Puritan system, which was based on Mosaic law, especially in criminal matters. * This pamphlet was published a year before Lieber's code, and it contains several ideas that were incorporated into that work. Halleck's commission resonates with our current debates concerning the definition of "enemy combatants" and prisoners of war. In the letter to Lieber that is reproduced as a preface Halleck states: "The rebel authorities claim the right to send men, in the garb of peaceful citizens, to waylay and attack our troops, to burn bridges and houses, and to destroy property and persons within our lines. They demand such persons be treated as ordinary belligerents, and that when captured they have extended to them the same rights as other prisoners of war; they also threaten that if such persons be punished as marauders and spies, they will retaliate by executing our prisoners of war in their possession. Notably reactionary, Schwenken is best-known for his 1820 criminal-law treatise *Uber die Beruchtigsten Judischen, Gauner and Spitzbuben [About Notorious Jews, Swindlers and Rascals*]. * First German edition. Stryk was a distinguished German jurist who helped to develop German law from native sources rather than from received Roman law. Originally published in Latin in 1684, *De Cautelis Contractuum* is one of the first treatises on contract law and its unique problems and dangers. It has four parts. The first part describes contracts that should be entered into with care, such as those concerning church or civil property, or those that involve children, drunks, or the deaf, dumb, or blind. The second part discusses loans, deposits, pledges and securities, bail, buying and selling, renting and leasing, inheritance, business partnerships and proxies. The third part addresses guardianship, inheritance, insurance, exchange and marriage. The fourth part is concerned with issues involved in the discharge and termination of contracts, including debts and receipts. Uncommon in the trade. * Second edition. Zype was a canon lawyer and church official attached to the Bishop of Antwerp. First published in 1635, this useful and important book on the civil and canon law of the Spanish Netherlands went through at least four more editions and issues into the eighteenth century. Topics include procedure and the law concerning commerce, marriage, the military and other topics. *Second edition. As Vicat explains in his preface, he compiled this dictionary from those of Francois Hotoman, Barnabe Brisson, Johannes Calvinus (Kahl) and, especially, Alexander Scotus to bring their "excellent" work to a wider audience. More important, by combining these works and filling the gaps with original entries he was able to create a dictionary that covered the whole language of the law. Vicat's definitions are brief, but they contain comprehensive references to authorities and texts as well as conjugations, common phrases using the words, metaphors, alternate definitions and antonyms. The first edition was published in 1759. Vicat was a jurist and the director of the University of Lausanne from 1749 to 1762.
