





* Second edition. Agustin, a Spanish cleric and jurist, was Archbishop of Tarragona. He was a leading member of the group of antiquarians in mid-sixteenth century Rome who were involved in the study of ancient Roman institutions. First published in 1583, *De Legibus* is a dictionary of Roman law with an emphasis on legislation. The final section, a set of plates preceded by a half-title reading *Leges et Senatusconsulta Quae in Veteribus cum ex Lapide tum ex Aere Monumentis Reperiuntur*, is a collection of transcribed documents. *De Legibus* went through four editions, the last in 1694. All editions are scarce. 

* First edition. "Mr. Angus' publication possesses high merits, and will be of great utility. There is a large number of police burghs that have not yet availed themselves of their powers to erect local police courts. As this is done, the newly-elected magistrates and the assessors who have to guide them will seek for information both reliable and in handy form for rapid reference. The present work will give them light on almost all the ordinary cases that come before police courts.": J.B. Baxter, *The Juridical Review* 7 (1894) 193-194. A third edition was published in 1936. 

* First Italian edition. This comprehensive dictionary devoted to civil procedure and commercial law was originally published in Paris in 1834-35. It went through several editions during the nineteenth century. Versions were produced for France, Belgium and the Kingdom of the Two Sicilies, which had a legal system founded on the Code Napoleon. 2 copies located in North America, 1 of this edition (at SMU Law School). 

* Second edition, with "the Addition of Above Six Hundred Words." Blount was a barrister and a member of the Inner Temple. Prohibited to practice at the Bar because he was a Catholic, Blount turned to legal scholarship and lexicography. Blount aimed to correct the defects he found in Cowell's *Interpreter* (1607) and Rastell's *Termes de la Ley* (1523). In his preface, he observed that Cowell "is sometimes too prolix in the derivation of a Word, setting down several Authors Opinions, without categorically determining which is the true"; Rastell "wrote so long hence, that his very Language and manner of expression was almost antiquated." He hoped that by correcting these flaws he would create a dictionary useful to everyone in the profession from "the Coif to the puny-Clerk." The *Nomo-Lexikon* is clearer and more detailed than its predecessors. It is also the first English-language dictionary with entries that include word etymologies and citations. An immediate success that quickly supplanted its predecessors, it was reissued in larger and revised editions throughout the eighteenth century. 



* Reissue of the second and final edition (1840). A highly regarded dictionary dealing with commercial law, commerce and political economy. According to the preface, it was intended to be a companion to the author's *Codigo Commercial Portuguez* (1836). It was originally published in 1839. Both editions of this dictionary are rare. 



* Final and best edition. Brisson was a renowned French jurist and philologist. Widely respected, he was appointed president of the Parliament of Paris in 1588. In 1591, however, he was hanged by The Sixteen, a group of insurgents who captured Paris in a bizarre coup. First published in 1557, Brisson's *Verborum* was the standard legal dictionary of its day, and it remained an authoritative source for hundreds of years. In this edition the definitions are preceded by a useful digest of Roman and French laws and interesting sections on marriage, adultery and the feudal system. Edited and corrected by Johann Gottlieb Heineccius, an important German jurist and scholar at Halle, this edition is much larger than its predecessors. It includes more notes and entries and a section on the interpretation of Latin grammar by Bohmer, the director of the Halle Royal Academy.

Our copy was presented as a school prize from the Amsterdam Latin School in 1811 to Theodoro Lamberto Kock. The initial presentation leaf, bound into the volume, is signed by the school's rector ("Hirm. Bosscha"). Walker, *The Oxford Companion to Law* 153. 

* Irish issue of only edition, published the same year as the (two-volume) London edition. Intended to be a practical tool, Burn eliminated most of the definitions in Law-French found in earlier dictionaries. (They became obsolete when George II ordered the exclusive use of English in 1733.) This elimination cleared space for other material and longer entries. Indeed, Burn's articles on such subjects as judgment, jury, purchase and will are broader, more detailed and better organized than they are in earlier dictionaries of this kind. It is unclear whether Burn intended to publish this book; it was edited, expanded and published posthumously by his son, John Burn. English Short-Title Catalogue N20286. Order This Item

* Only edition. With indexes. Encyclopedic in scope, this is a reference for notaries in the Kingdom of Sardinia (Piedmont-Sardinia). The entries are quite detailed; several entries have sub-divisions and many contain cross-references. A Sardinian notary was an important legal officer with a role analogous to a present-day English solicitor. The Kingdom of Sardinia led the Risorgimento and its legal system was adopted by the states that comprise present-day Italy. One copy found on OCLC (at UC-Berkeley Law Library). 

* First edition of this important and finely printed reference work. Tudeschi, a Benedictine canonist from Sicily, earned his doctorate in canon law at the University of Bologna. Also known as Panormitanus for his position as archbishop of Palermo, he taught at the Universities of Siena, Parma and Bologna. "It was his canonical works, especially his 'Lectura in Decretales' 'In Sextum,' and 'In Clementinas,' that won him the title of 'lucerna juris' (lamp of the law) and insured him great authority" (Catholic Encyclopedia).


The present volume is a comprehensive reference companion to Tudeschi's works, organized alphabetically in the form of a dictionary. Corsetti, also a lecturer at the University of Bologna, was highly respected as a canonist and appointed by Pope Alexander VI to the Sacra Roman Rota in 1500. "This table of contents, made in Bologna 1486, is his best work and makes the writings of Panormitanus accessible" (Schulte).


The printer of our edition, Andreas Torresanus de Asula [1451-1529], was the father-in-law to the great Aldo Manuzio. The two became business partners from 1508 and Torresanus would carry on the work of the Aldine press after Manuzio's death in 1515. Both incunable editions of this title are rare. 



* Fourth edition, and the first edition by Manley. The Interpreter is considered to be the best law dictionary published before Jacob's New Law-Dictionary (1729). Though its significance was recognized almost immediately, it was not approved by all. At a time when Parliament and crown were vying for power, the House of Commons was angered by Cowell's royalist sympathies, which were evident in such definitions as "King," "Parliament," "Prerogative," "Recoveries," and "Subsidies." When a joint committee of Lords and Councilors reviewed the work, the ensuing controversy nearly halted the affairs of government. James I intervened in fear that his own fiscal interests would not be approved by Parliament, and ordered a proclamation that imprisoned Cowell, suppressed the book and ordered all copies burned by a public hangman on March 10, 1610. Moreover, The Interpreter contained a quotation critical of Littleton's scholarship that angered Sir Edward Coke. It comes as no surprise that he was instrumental in the book's suppression and in Cowell's persecution. It remained in use, however, and it went through several editions. 

* First edition. Along with those of Jacob and Marriot, this was one of the most popular comprehensive English dictionaries of the period. According to Hicks, it was "The first...which aimed at completeness as regards legal terms." Like Jacob, Cunningham aimed to give a complete account of the law. The result is a work that is also an abridgment that includes summaries of cases and precedents in equity and statutes. Hicks and the ESTC note this edition was issued in 140 parts. 

* Only edition. "In this work the effort has been to make the definitions as short as possible, yet so clear that a man without legal education can understand them. (...) Essays or long discussions of subjects have been avoided because few have time to read such, and fewer care to, while those who have time prefer to investigate for themselves" (Explanatory Statement). This is an uncommon book. OCLC locates 29 copies, a low number for a law dictionary published at the turn of the twentieth century. This is the first (non-reprint) copy we have seen. 

* First published in 1831, this eminent dictionary went though several editions in the nineteenth century and reached its latest edition in 1998. Along with imprints issued in Madrid and Paris were several issued by Latin American publishers in Mexico City, Caracas, Valparaiso, Santiago and Bogota. It is a comprehensive work with lengthy descriptions. The *Dictionario* has an appendix that compares the Spanish constitutions of 1869 and 1876. As their titles indicate, our volumes have supplemental material about Latin America. All editions are scarce.
