

\* Second and final edition. Early game and land laws record the earliest attempts to preserve the environment. They also offer fascinating insights into social history due to their relevance to topics ranging from class structure to foodways. First published in 1723, Bilderbeck's treatise deals mostly with Saxon law, with comparative commentary on Roman law. Both editions of this title are scarce. \* Only edition. A notable work of Historical School jurisprudence, this treatise addresses the Roman law of inheritance and succession and wills with comparisons to these laws in Prussia and, to a lesser extent, other German states. Bluntschli was one of the great Continental jurists of the nineteenth century. He published a code for the Canton of Zurich and works on German private law, the law of war and international law. His most important historical work is the Geschichte des Allgemeinen Staatsrechts und der Politik (1864). 

\* Fourth edition. Holy Roman Emperor Ferdinand II, a Habsburg, ruled the Kingdom of Bohemia. A document of the Thirty Years War [1618-1648], his *Vernewerte Landes Ordnung* (Revised Land Ordinance) for Bohemia, enacted in 1627, aimed to consolidate his power and suppress Protestantism, which was spreading though parts of that kingdom. Among other measures, it deprived the Bohemian estates of their military rights, placed all schools under Jesuit control and made Catholicism the kingdom's only legal religion. Due in part to his aggressive stance, Bohemia witnessed some of the most brutal battles of the war. Ferdinand, who died in 1637, was able to pass the kingdom to his heir, but the land and its crown were greatly diminished. Editions of the *Vernewerte Landes Ordnung* were published in 1627, 1628, 1638, 1640, 1714 and 1753. All are scarce. 

\* Fifth edition, corrected, with additions. With indexes. Bohmer was perhaps the leading German authority of his age on ecclesiastical law and its history. He played a leading role in the adaptation of canon law for use in the Lutheran church and established sound theoretical foundations for Lutheran church law. First published in 1701, *Ius Parochiale* addresses issues relating to church property, tithes and clergy. 

\* First edition. Coler, a professor at the Universities of Jena and Leipzig and chancellor to the prince of Anhalt, was a renowned authority on civil law. *Tractatus de Processibus Executivas* addresses executions, exceptions and the limitation of actions under canon law and the civil law of Saxony. It went through five more editions, the last one in 1718. All editions of this title are scarce. 

The text is preceded by an allegorical frontispiece that features cherubs armed with switches flying out of a copy of (we assume) the *Corpus Juris Civilis* to assail a trio of legal scholars. 

\* Only edition. An interesting study on laws relating to sheep, this is a dissertation defended at the University of Helmstadt. 

\* Second edition. First published in 1675, this book collects Fritsch's writings and consilia dealing with the forest and game law of the Holy Roman Empire and the local laws of German states. Early game and land laws record the earliest attempts to manage environmental resources. They also offer fascinating insights into social history due to their relevance to topics ranging from class structure to foodways. Other editions were published in 1677 and 1702. All are scarce. 

\* Second edition. Gail was a German judge and legal scholar. First published in 1578, this book deals with executions of contracts and pledges under the laws of the Holy Roman Empire. The final section is a collection of legal epigrams. Its final edition, a German translation, was published in 1601. The contents of this book were incorporated into Gail's *Practicarum Observationum* beginning with the 1589 edition. As an independent work *De Pace Publica* is a rare title. 



\* Third edition. First published in 1798, this influential treatise introduced the latest progressive theories of criminology to the German states. Unlike its predecessors, it emphasized deterrence and prevention rather than punishment. Its final edition was published in 1825. Grolman was a professor of law at the University of Giessen. 

It was adapted from the first two volumes of Appert's *Journal des Prisons, Hospices, Écoles Primaires et Établissements de Bienfaisance* (1825-1831); Hartleben, a law professor, added a great deal of original commentary and data drawn from German sources. 

The fourth and final edition was published in 1884. All are scarce, especially in North America. OCLC locates no copies of any edition in North America. 

\* Second edition, revised, the final and best edition of this work. Each item in this select bibliography has a detailed critical annotation, many of them running a page or more in length. The unusual allegorical title vignette, indicating a sifter separated human from animal heads, indicates the book's intention to steer the reader to the best law books. The first folding plate illustrates the novel pictorial method used in Johann Buno's Memoriale Institutionum Iuris (1672) and Memoriale Corporis Iuris (1673). The second plate reproduces a pair of facsimile tablet fragments from the Corpus Juris Civilis. It relates to a discussion of issues dealing with transcription and philology. The work concludes with a detailed index. The laid-in items are a slip of notes with references to this book and a circular for Quellen and Forschungen zur Strafrechtsgeschichte, a German legal journal. Kisch [1889-1985] was a prominent jurist and scholar who produced important works on humanism, Jewish law and history, German jurisprudence and the history of German-Jewish relations. The first two editions were published in 1751 and 1761. All are scarce. Including all three editions, OCLC locates 4 copies in North America, 4 in law libraries (Harvard, Library of Congress, University of Michigan, University of Texas-Austin, all 1761 editions), 1 of the 1779 edition (New York Public Library), no copies of the first edition. As indicated by its subtitle, this book has additional sections on marriage and inheritance and succession. It went through six editions by 1714.
