



Copperplate title page with architectural border, copperplate leaves, all with vignettes. * Rich was an English stenographer who published a series of manuals on shorthand writing based on the work of his uncle, William Cartwright. First published in 1659, The *Penns Dexterity Compleated* is the definitive exposition of the Cartwright-Rich system. It was a popular work that went through 20 editions by 1792. Illustrated throughout with religious figures and symbols, Botley's attractive edition has a section on "the whole terms of the law." 

* First edition. This well-indexed and annotated collection of cases and statutes was a well-regarded authority that went through five later editions, the last in 1827. The *ESTC* conjectures 1770 as the publication date, others suggest 1771. Despite its popularity, all editions of this book are scarce. 

* Only edition. Includes details on the recently completed 1736 survey indicated by the exact location of some 74 boundary stones on the Gloucestershire side and of 29 on the Somersetshire side. One example: "Stone 1. On the bank of the River of Avon, near a limekiln, on the East, and a sluice on the West, call'd Woodwell's-Lake, standeth the first stone." This is indeed the only edition; a copy at the Ransom Center at the University of Texas, Austin, with a suggested date of "1735?" must surely be a mistake. 



* Capece was a distinguished Neapolitan jurist and a counselor to the king of Naples, Ferdinand of Aragon, and the Holy Roman Emperor Charles V. First published in 1541, his *Decisiones*, a collection of opinions on complicated legal questions, went through eight editions, the last one in 1583. All are scarce. 

* Only edition. Holdsworth, who holds this work in high regard, says this the first significant work on the subject of parliamentary elections. Gross notes that "for the period covered [in this book, circa 1600-1754], this is the most exhaustive parliamentary history of the boroughs. Over 190 towns are discussed in detail. Carew was a Member of Parliament from 1702 to 1766. He dedicated this extensive and scholarly study to Arthur Onslow, the Speaker of the House of Commons during most of the reign of George II. 

* Second and final edition. That the Reports "passed to a second edition at a period when every new book was most closely scrutinized, would seem to show that the volume was in considerable favor with the profession generally" (Marvin). 

* Only edition. This book is a continuation of John Cay's An Abridgment of the Publick Statutes in Force and Use from Magna Charta, In the Ninth Year of King Henry III. As Cowley notes, the "need for an abridgment of the statutes more adequate than anything that had appeared since the last addition of Rastell's Collection probably gave rise to this compilation... Rich in sociological detail, it includes laws on such topics as witchcraft, sodomy and bestiality, adultery, dueling and gypsies A durable work, it was first published in 1773 and went through four more authorial editions and four later editions by other authors, the last (eighth) in 1871. * Adolf Beck was twice the victim of wrongful conviction (on two related cases) due to mistaken identity. The efforts of the judge who presided over his second trial led to the establishment of a committee of inquiry chaired by the noted jurist and Master of the Rolls Sir Richard Henn Collins [1842-1911]. The committee determined that Beck was convicted twice through unreliable methods of identification, erroneous eyewitness testimony and a rush to convict the accused. Along with its influence on police procedure, the committee's report led to the creation of the English Court of Criminal Appeal in 1907. 

As Cowley has pointed out, A New Law-Dictionary was both Jacob's masterpiece and "an entirely new departure in legal literature" that provided a model for several subsequent efforts. In contrast to earlier works, each entry summarizes all of the laws relating to the subject and offers extensive interpretive commentary. Obsolete terms are omitted. It was recognized almost immediately that Jacob created a highly useful legal encyclopedia that was more detailed and concise than any other abridgment of the period. An extremely popular work that went through twelve editions between 1729 and 1800, it offers unparalleled insights into Anglo-American law during the eighteenth century.
