

#### Rare Essay on Bills of Exception from the Library of Woburn Abbey

#### 1. Adam, William [1751-1839].

Armorial bookplate of Woburn Abbey (dated 1873) to front pastedown, "Bedford" in bold hand to front free endpaper, one leaf partially detached but secure. \* Only edition. This is a supplement to Adam's *Practical Treatise and Observations on Trial by Jury in Civil Causes* (1836). Adam produced this "supplement" to answer the objections of the dean of faculty of the University of Edinburgh to his doctrine on bills of exception and elaborate his argument. The signature "Bedford" is probably that of William Russell [1809-1872], Eighth Duke of Bedford and the owner of Woburn Abbey, or his son, Francis Charles Hastings Russell [1819-1891], Ninth Duke. Contemporary paper boards, rebacked with contrasting period-style paper spine retaining original printed paper spine label, large printed label reading "Kirton Sessions" to front board, corners repaired, endpapers renewed, untrimmed edges. \* First edition. This is an important commentary on the recently enacted criminal laws instituted under Sir Robert Peel. Archbold was a distinguished and prolific author and an expert on pleading. Highly regarded, Marvin expressed a common opinion when he wrote that "Mr. Archbold has no superior as a writer of practical works, whether we regard their number or utility, and but one equal, Mr. Chitty." \* Only edition. The dominant religious presence in Argentina, the Catholic Church was also its most important provider of social services and a powerful force in the national culture. Following independence from Spain in 1810, there were sharp disagreements within the national ruling elite over the proper degree of Church influence in the country. At the same time the Papacy, unwilling to offend Spain, condemned the revolutions sweeping South America at the time, which created additional tensions within Argentina. The *Memorial Ajustado* was written by Agrelo, the primary author of the 1813 *Projecto de Constitución Argentina*. It intended to clarify sections in the constitution concerning church-state relations. It called for state financial support for the Church, but allowed religious freedom. Other articles, all controversial, included compulsory secular education, support of civil marriage and the governmental appointment of religious authorities. Most of its articles were incorporated into Argentina's first constitution, which was adopted in 1853. \* First edition. Bell was an important figure in the history of Scottish law. Two of his books, *Commentaries on the Laws of Scotland* and *Principles of the Law* of Scotland, are, according to Walker, "among the half-dozen classics of Scottish legal literature." As Marvin indicates, Bell's writings on commercial law and bankruptcy were highly important during the first half of the nineteenth century and were cited often by Kent, Legere, Story and other American jurists. \* Only edition. With side-notes. This treatise is notable because it reflects contemporary debates about the extension of suffrage. An important figure in the history of Scots law, Bell was an advocate and professor of conveyancing to the Society of Writers to the Signet. He is known today as the author of *The Dictionary of the Law of Scotland* (1807) and several other treatises on Scots law, especially leases and conveyancing. \* This was Bentham's first essay on a legal aspect of economics. Presented in the form of a series of letters from Russia, it takes issue with Adam Smith's argument that a maximum interest rate of 5% would prevent speculators from tying up the supply of available currency. It was written in 1787 and first published in Dublin in 1788. Later American editions were published in 1796, 1837, 1841 and 1842. OCLC locates 6 copies of the 1796 imprint in North American law libraries (Georgetown, Harvard, Library of Congress, Southern Illinois University, University of Minnesota, Yale). #### A Notable Jurist Examines Secession and Slavery

\* Final edition. Bishop was one of the most influential American legal writers of the nineteenth century. According to Roscoe Pound, he belonged to the class of jurists who works "went far to shape the law." First published in 1863, this essay is a consideration of secession and slavery under constitutional law. It was substantially revised in 1864 and issued as a new work. Our 1866 edition, designated the second, addresses the legal conclusion of the Civil War, such as the status of freedmen and the re-admission of states that were part of the Confederacy. \* Butterworth is one of the most venerable names in English legal publishing. Most of the titles listed in this 1875 catalogue are accompanied by lengthy quotations from contemporary reviews.

\* First edition. The College of Justice is the collective name for the officers of Scotland's Court of Session. The senators are the judges. A valuable reference, this book contains brief biographies of the court's senators from 1532 to the time of publication. Sweet & Maxwell, *A Legal Bibliography of the British Commonwealth* 5:16.

\* Sixth (and final) edition. Buxton was an important English philanthropist and member of Parliament who lead efforts to alleviate poverty, abolish slavery and reform the prison system. Published in 1818 to immediate acclaim, his *Inquiry* went through five more editions that year and inspired the formation of the Prison Discipline Society. It was translated into French and Italian and disseminated widely throughout continental Europe. This edition not in the *British Museum Catalogue*.

\* Only edition. Canciani was a law professor at several universities, later as Papal Nuncio in London. He ended his career as a state archivist in Venice. A notable achievement from this part of his life, *Barbarorum Leges Antiquae* was one of the first scholarly editions of post-Roman and Germanic legal sources, all with annotations. \* Second edition. First published in 1697, this is the first English treatise on the subject. Its twenty comprehensive chapters consist of a digest of the case law relating to each topic with explanatory comments. Holdsworth notes that "[i]t was a useful book to practitioners since it covers all the topics connected with its subject." A third edition was published in 1726. All editions are scarce. \* "I CANNOT HELP FEELING GRAVE CONCERN FOR THE COUNTRY, Chase tells Mrs. McDowell. He fears "new convulsions" from former slave owners restored to prominence by President Andrew Johnson's lax reconstruction policies. "How strange it seems, this extensive change which has happened in these last four years! How wonderful the transition and the events: and yet how little the wiser we seem to be for them all. To me it's been as if the very same elements of disturbance were being permitted, and in new names & character to prepare new convulsions. I cannot help feeling grave concern for the country; and should be really heartsick if I did not remember that God rules; & that God is Love, and that thousands of prayers continually go up before Him from sincere & devoted hearts that He will bring Good out of apparent evil. The controversy

between the President & Congress is greatly to be deplored. Doubtless there are faults on both sides; but I think most on his. He is a Unit, Congress a Plural....and a very little consideration would have availed all our trouble." Helen McDowell was the wife of General Irvin McDowell [1818-1885], the General best known for his defeat in the First Battle of Bull Run, the first major battle of the American Civil War. Mrs. McDowell played an important role during the war through her work for the Sanitary Commission, the forerunner of the American Red Cross.

Title pages, all with large copperplate vignettes, printed in red and black, copperplate vignette to head of dedication, woodcut head-pieces, tail-pieces and decorated initials. Moderate toning occasional light foxing, some leaves have dampstaining to margins, internally clean. Ex-library. Bookplates to front pastedowns. An impressive set. \$2,500.

\* With subject topical indexes. Conceived as a supplement to the *Corpus Juris Canonici*, the *Bullarium* is a comprehensive collection of papal bulls and other decrees from St. Peter through Clement X, the pope when this edition was published. Each entry is headed by a copperplate portrait and brief biography. The indexes are notably detailed and useful. The first edition was published in 1586. Later editions of this collection, all updated, were issued into the late nineteenth century. Unofficial works produced to assist canonists, each edition is notable because the choice of material reflects the concerns of the editors and issues that were important at the time of publication. Our 1673 edition, for example, has a great deal of material concerning the Counter-Reformation, Science and other Baroque-era issues absent from later editions. \* Sole edition. "The following laborious compilation is designed to prevent that tedious research, to which even experienced Magistrates are, sometimes, compelled to submit. (...) If, for instance, he wishes to know whether Beer may be sold in private Houses, Booths, or Tents at Fairs, without Licence, he might have some trouble in meeting with the solution of his doubts; but by turning to Booths, Fairs, Houses, and Tents, he will be referred to Alehouses II.30. where he will meet with two references in Addington, Burn, and Williams, one in Hawkins, and one on the Law Dictionary" (v). \* First edition. Cobbett wrote this treatise to impose order on the tangled mass of turnpike law and thus to "prevent the mischiefs which have arisen in its operation; particularly in the various cases of toll, where the public have been so much abused" (3). A second edition was published in 1828. OCLC locates 9 copies, 1 copy in a North American Law Libraries: Library of Congress. The earliest significant compilations are the eleventh-century Rules of Oleron, the Laws of Wisby and the Hanseatic Laws of the Sea. Although *lex mercatoria* fell out of use during the seventeenth century, many of its principles were incorporated into the common law. They would later provide the foundation of the (U.S.) Uniform Commercial Code. Malynes' *Consuetudo* was the final significant contribution to this field. (Beawes's *Lex Mercatoria Rediviva* (1752) was an attempt to revive it.) Malynes was a commissioner of trade in the Low Countries and was frequently consulted by the Privy Council during the reigns of Elizabeth and James, a dynamic period of commercial expansion and colonization. He was one of the first writers on business practice, economic affairs and foreign exchange. These interests are explored at length in this collection, both in Malynes's treatise and the texts by Marius, Dassorne, Collins and Liset. This volume also includes a collection of sea laws and two works on international law by Richard Zouch and John Burroughs. These assert the thesis expounded by John Selden in *Mare Clausum* (1635). Taken together, this volume provides a broad holistic view of *lex mercatoria* during its final maturity.
