\* Only edition. According to Cooper, "Lord King was so much pleased with the work that he rewarded the author with a mastership in Chancery." 

\* Later edition. This long-lived treatise on pleading and procedure in canon law was first printed in 1470. As indicated by the title, it deals mostly with the proper form of *allegationes*, that is, arguments by advocates that direct the judge's attention to the canons that support their client's case. In this edition, each *allegatio* is followed by a summary. Lupo da Castiglionchio, Latinized as Lapus de Castellione, was a Tuscan noble and friend of Petrarch. His *Allegationes* went through several editions, five of them in the fifteenth century. OCLC locates no copies of this edition in North America. 





\* Second edition. The author of more than twenty books, Cunningham was one of the most prolific legal writers of the eighteenth century. First published in 1764, *The New Universal Parish Officer* was a successful work; later editions were published in 1767, 1771 and 1774. All editions are scarce. 





According to Sweet & Maxwell, the first studies were Freedom of Elections to Parliament (1680) and Observations Concerning the Regulation of Elections for Parliament (1689), a work attributed to the Earl of Shaftsbury). 

\* Only edition. A landmark in historical research, this was the first printed collection of Parliamentary addresses. Published during the Commonwealth period to help elucidate the events of the recent past, it records the tumultuous debates between Crown and Parliament during the early regnal years of Charles I. Fuller's preface, considered by some to the best of its kind ever written, "convincingly justifies the concept of viewing recent and current events as historically significant, and studying them in the same manner" (Wing). It is certainly a vivid collection, one that gives you a sense of presence as England moved toward civil war. 





\* Only edition. More accurately described as a practical handbook, this treatise on the drafting and interpretation of Parliamentary statutes is attributed to Sir Christopher Hatton. Lord Chancellor from 1587 until his death in 1591, he was a distinguished statesman, man of letters and favorite of Queen Elizabeth I. He was not a profound jurist, but he was admired for his temperament, good sense and administrative skill. Our copy once belonged to the library of Shirbirn Castle, the home of the Earls of Macclesfield, one of the finest private libraries in Great Britain. 



Hemard applied this treatment to two other legal works *Code Penal* (1940) and *Code Général des Impôts Directs et Taxes Assimilées* (1944). Hemard, a prolific artist, illustrator, designer and author, is best-known for his humorously illustrated editions of serious non-fiction books. 



\* First edition. This book examines an issue sparked by a motion initiated in the House of Commons to impeach Thomas Osborne, the earl of Danby, lord treasurer to Charles II, for treason. Proponents of impeachment, expecting opposition from the bishops seated in the House of Lords, said they, as ecclesiastical figures, could not be part of the impeachment trial because it was a capital offense. Hunt, an attorney, says this claim is false. A second edition was published the same year as the first. Housed in Shirbirn Castle, the library of the Earls of Macclesfield was one of the finest private libraries in Great Britain. *English Short-Title Catalogue* R200716.
