

* Attibuted to Magister Adam (Adamus), a 13th-century Cistercian monk from Aldersbach, lower Bavaria, the *Summula* is an epitome in verse of Raymond of Peñafort's authoritative *Summa de Poenitentia et Matrimonio* with commentary and interlinear glosses. More than a list of sins and suggested penances, this work discussed pertinent doctrinal and canon-law doctrines that pertained to the issue brought to the confessor. In this edition Adam's verse summary is accompanied by a detailed prose commentary on the *Summa*. It also contains the text of the *Summa*, along with Raymond's commentary on the trees of consanguinity and affinity, which indicated if couples were permitted to marry based on their degree of blood kinship. 

* Only edition. This compilation of laws concerning freedom of the press was published during the repressive reign of King Charles X, France's final Bourbon king. Its author was a conseiller-auditeur of the Cour Royale of Paris. This copy was annotated extensively by one of his colleagues at that court, De Vergès, who would later hold important judicial posts under Napoleon III. The annotations are fascinating because they indicate a deep engagement with the book. Some notes dispute the legitimacy of certain laws. The other ones interrogate their meaning, propose amendments or connect them to specific cases. All of the annotations indicate that De Vergès had a keen legal mind. 

(...) are not printed. The present volume--of his own decisions as Chief Justice of the Common Pleas, in Which Office he is conceded to have been very eminent--embraces...a term of but seven years.": Wallace, *The Reporters* 304. 

* Only edition. Defense submission for an appeal involving three men convicted of smuggling tobacco in a suit initiated by the licensed tobacco contractor Massa and Carrara. The arguments are erudite and learned; there are citations to Bartolus and Alberico de Rosate, for example, and, on p. 33, a eight-line quotation from Virgil. 

First published in 1609, this treatise on the Roman law on the right to use the property of another (usufruct) went through several editions and issues in Italy, Spain, France and Germany. According to the title page, this Venetian imprint has unique additions. 

* Fifth edition, "corrected." Coke's *Institutes*, which eventually comprised four volumes, are thought to be the first textbooks on the modern common law. Taken together, they are a virtual legal encyclopedia of the law as it stood in Coke's lifetime. The first *Institutes*, better known as *Coke on Littleton*, contains the text of Sir Thomas Littleton's *Tenures* with extensive commentary. First published in 1628, it was a standard work for decades and was often used as a textbook. "If Bracton first began the codification of the common law, it was Coke who completed it.... In the *Institutes* (...) the tradition of the common law from Bracton to Littleton, whose name Coke's *Commentary* made famous, firmly established itself as the basis of the constitution of the Realm.": *Printing and the Mind of Man* 126. *English Short-Title Catalogue* R33309, R34822 (*Table*). 

* This fascinating collection addresses a variety of topics, such as adultery, bail, burglary, cattle, children, counterfeiting, debtors, divorce, dogs, dowry, dueling, drunkenness, elections, executions, fornication, frauds and perjuries, fraudulent conveyances, gaming, horse racing, Indians, insolvent estates, jurors, lotteries, marriage, maritime affairs, murder, oaths, rape, rogues, rum, the Sabbath, slaves, taverns, tobacco, treason, usury and vice. The owner of this copy had his copy bound with 50 blank leaves. He filled most of these with fair copies of several later acts, laws and resolutions. The majority of these deal with toll bridges, the second largest group deals with Revolutionary War veterans. It is likely that the owner of this book was John Benjamin of Stratford, Connecticut, who was involved in several bridge-building ventures in Bridgeport. He was also a veteran. 

* First edition. Unlike previous compilations, *Jus Feudale* is an original work. "Indeed Craig was the first systematic writer on law in Scotland. The *Jus Feudale* is not a mere textbook of the law of land rights, but is a learned disquisition upon a great social system. The opening chapters are devoted to an examination of the sources of law in general, and trace the history and development of the Civil, Canon and Feudal laws. If Craig had accomplished no more than that he would have been entitled to a foremost place amongst our jurists, for unquestionably the form of his book not only exemplified the philosophical outlook of the learned Scots lawyer, but provided a model of construction and treatment for his successors" Black, *The Institutional Writers* 62-63. *English Short-Title Catalogue* R232723. 



* First edition. Dard's was the first annotated edition of the Code Civil (Code Napoleon), which was promulgated on March 21, 1804. It went through 3 later editions, the last one in 1827. Our copy is notable because it is annotated throughout around 1851. (Our date is conjectured from a note citing a law enacted on February 7, 1851 on the interleaf facing p.3, the latest date we found among the annotations). The annotations fall into three categories: elaborations and corrections of the text, comparisons between current laws and those in the code, elucidations of points in the text. Our copy is singular; all editions are scarce. OCLC locates 16 copies of the first edition, 4 in North America, 2 in law libraries (Louisiana State University, Northern Kentucky University). 

* Only edition, one of two issues from 1690. This is the earliest collection of printed decisions in Scots law, sometimes referred to as "Lord Durie's Practicks." It was published posthumously by the author's grandson from notes taken by Gibson himself from the time of his elevation to the bench in 1621 to July of 1642. Gibson was a high ranking Scottish judge, a serious student of the civil law whose attainments are discernible in the present work. *English Short-Title Catalogue* R249. Order This Item





* First edition. Fernand was the professor of civil law at the University of Toulouse, the second oldest university in France. He was an expert on issues concerning family law law, which is the topic of the first and final sections of *Libri Quinque Antehae*. The other sections address topic sin property, possession and contracts. A second edition was published in 1601. Both editions are rare. OCLC locates no copies of either in North America. * Second edition, a reissue of the first edition (1727) with an altered titlepage and a preliminary advertisement leaf. This was the first textbook on equity published since St. Germain's *Doctor and Student* (1523). It is generally considered to be the book that founded the field of equity jurisprudence. Francis outlines fourteen maxims, such as "Equality is Equity" and "Equity suffers not a right to be without a remedy." Each maxim is followed by a brief summary of cases that illustrate its application. As Roscoe Pound observed, Francis created a precursor to the casebook: "his maxims for the most part are independent attempts to state principles derived from the study of cases.": Pound, "On Certain Maxims of Equity" in *Cambridge Legal Essays* 261-262. *English Short-Title Catalogue* T118767. 

* Intended for novice priests, this pocket guide to the sacraments (with notes on canon law) has a chapter on marriage that discusses sexual problems, "De impedimento ompotentiae coeundi." It was a popular work in its day, but the Council of Trent (1563) and the creation of the Roman Catechism (1566) made this book obsolete. There is some debate concerning the printer of our imprint. The Catalogue des Incunables (CIBN) differentiates a Printer of Guido de Monte Rochen from the Printer of Persius, who is there identified with Maillet (cf. CIBN S-334 and T-36). The Gesamtkatalog der Wiegendrucke (GW) identifies proposes, tentatively, Michel Topié. All editions of this title are scarce or rare today. William Staley (or Stayley) was one of the victims of the Popish Plot, one of the cruelest hoaxes in British history and the inspiration for a wave of anti-Catholic violence. It was the invention of Titus Oates, an Anglican clergyman, and his friend, Dr. Israel Tonge, a cleric and passionate anti-Catholic. They pretended to have discovered a Jesuit plot to assassinate the King, massacre Protestants, and set James, Duke of York, the King's Catholic brother, on the throne. Convicted as a conspirator, Staley was executed and quartered in 1678. "Instead of his quarters being set upon the city gates the king allowed them to be delivered to his relatives. Mass was said over his remains and a 'grand' funeral was arranged from his father's house on 29 November, before his burial in St Paul's, Covent Garden. This incensed the government so much that the coroner ordered the body to be dug up and delivered to the sheriff to be set upon the city gates" (Oxford Dictionary of National Biography).
