* Probably compiled by a law student of layman, this book contains several important late-medieval legal reference works. In Utriusque Iuris Libros Introductorium is an anthology of "introductory" writings. It includes the Modus Legendi Abbreviaturas, a dictionary of abbreviations, the Arbor Consanguinitatis, an essay on descents, and the Ars Notariatus, a handbook on legal drafting. Flores Legum is a collection of maxims arranged alphabetically. The Tractatus Clausularum is a treatise on the drafting and interpretation of legal documents. 

* Later edition. A collection of four sets of decisions by the Rota Romana and two sets of regulations for the Apostolic Chancery, which regulated practice and procedure. The decisions cover the period 1376 to 1381. The Chancery *regulae* are those of Sixtus IV, promulgated in 1482, and Innocent VIII, promulgated in 1491. This 1521 imprint is based on the 1496 Venice edition printed by the de Gregoriis for Fontana. This work went through several editions, but all are scarce. * Probably intended for schools and homes, this hand-colored lithograph depicts the trial of Jesus before the Sanhedrin (the Jewish judicial body) following his arrest in Jerusalem. Indulging in a bit of license, the artist has seated Pontius Pilate to the right of the Jewish judges. Each judge holds a descriptive placard with original texts, presumably by Kling, or the Gospel of John. Kling, the presumed author was a senior official of the Lutheran Church in Regensburg. 

* Nelson, Israel and Isaac Thayer were brothers. Nelson and Israel, farmers who appear to have been lazy, owed a considerable amount of money to John Love, a wealthy bachelor who boarded with Nelson. Unable to clear their debts, the two older brothers enlisted their younger brother, Isaac, to murder Love. The broadside account concludes: "There is probably a parallel case to this in the history of man. It was truly afflicting to see three young men, brothers, thus brought to an ignominious death for a crime committed to gratify a love for idleness and a lust for money. 

* A set of verses in the voice of convicted poisoner William Palmer [1824-1856]. Also known as the Rugeley Poisoner or the Prince of Poisoners, Palmer, a first-rate sociopath, was convicted for the 1855 murder of his friend John Cook, and was executed the following year. He was suspected of poisoning several other people including his brother, his mother-in-law and four of his children, who were killed before their first birthdays. Palmer made large sums of money from the deaths of his wife and brother after collecting on life insurance. 

* Abraham Prescott was found guilty of the murder of Sally Cochran in two separate trials held in Concord in September 1834 and September 1835. Despite a well-crafted insanity defense, he was sentenced to be hanged on December 23, 1835, in Hopkinton, New Hampshire. The execution was postponed to January 6, 1836. The verse account in this broadside presents the murder as a crime of passion: "Oh! lust, accursed lust! 'twas this for which I did the deed; Forfeiting heaven, and life, and bliss, Forfeiting all I need." See McDade, *The Annals of Murder* 769. 



"Like Lambard, Tothill, and a few similar works, this volume is one which those great cases that occur from time to time, and stimulate inquiry into the very foundations of legal science, will occasionally call forth, and it ought, therefore, to be in every public law library. (...) There is a picturesqueness and dramatic interest about them, especially as seen by the half lights in which sitting so far off, we...necessarily view them, that makes them quite entertaining, and, indeed an exhibition of Elizabethan habits, manners, and peculiarities." (Wallace). The period covered by *Choyce Cases* is 1557-1606. 

* Dinus's distinguished commentary on *De Regulis Juris*, a collection of 88 maxims and phrases in Book 5, Title 12 of the *Liber Sextus Decretalium*, was first published around 1472. It went through several editions into the sixteenth century. Each *Regula* is followed by Dinus's commentary. The additions and commentary by Bohier and Moulin flanks or surrounds the main text. This edition, identical to editions published in Lyons in 1533 by Jacques Myt and in 1535 by Giunta, is not listed in Adams, Baudrier or the *Universal Short-Title Catalogue*. 

* History: second edition, corrected, one of three issues from 1716; Analysis: second edition, one of two issues from 1716. Hale was Chief Baron of Exchequer and Chief Justice of the King's Bench. A disciple of Selden and the author of several important books, he is considered the greatest common lawyer since Coke; Blackstone acknowledged his indebtedness to him in his Commentaries. First published in 1713, Hale's History was the first book on the subject. The Analysis was the second part of the first edition. It was then expanded and published separately in second, fourth and subsequent editions. Its third edition, however, was issued with the third edition of the History. Blackstone held both works in high regard; Holdsworth praises Hale's "very wide knowledge of both the legal and historical literature," "historical perspective" and "complete mastery of the law of his own day," which "enables him to detect the remote origins of the important doctrines of later law, to give the history of those doctrines their due weight, and thus, even when dealing with remote periods, to avoid unprofitable antiquarianism.": History of English Law VI:586-587. A wealthy Whig author and political philosopher, Hollis produced handsome and affordable editions of works by Locke, Milton, Sidney and other seventeenth-century proponents of English liberty, which he distributed to institutions in the British Isles, Europe and the American colonies. 

Pinniger's refusal precipitated his court martial and that of the fellow officers who supported him. All were removed from office without further penalty. The guards elected replacement officers; no one went into the U.S. Army. This pamphlet was published by the officers after the "unfavorable result" of the court martial in order to protect their reputations. All aspects of the case are covered. 

While it is nearly certain that Delamere sympathized with Monmouth's designs, he was able to explain his journey as a wish to visit a favorite child who was dangerously ill. Cooper, Tayler and Bloodgood joined the fight. Jenkins was awarded \$2,500.00 in damages. Bloodgood would later become mayor of Albany. Tayler, later a judge, went on to become lieutenant governor of New York. Taylor and Cooper, a judge, were involved in the controversy that precipitated the Hamilton-Burr duel.
