




#### Afflito's Principal Treatise

\* Later edition. D'Afflito was an important Italian jurist and royal official. *Tractatus de Jure Protomiseos*, a treatise on preemption, purchase and sale is a commentary on the *Constitutio de Jure Protomiseos* of Holy Roman Emperor Frederick I (Barbarossa) [1122-1190]. One of his principal works, it was first published in 1544 and went through several issues and editions into the eighteenth century. In Zennetti's 1573 edition offered here D'Afflito's treatise is followed by a discussion of the same topic by the great Bolognese commentator Baldus de Ubaldis. 

Contemporary vellum, raised bands and early hand-lettered title to spine, another title to foot of text block in early hand, ties lacking. Light soiling, rubbing to extremities with some wear to spine ends, top edge of front board and corners, a few worm holes to boards and front pastedown, partial crack between text block and rear free endpaper. Attractive crible initials. Toning, faint dampstaining to endleaves and a few text leaves. Early owner signature to foot of title page, annotation in his hand to endleaves, interior otherwise clean. \$1,000.

\* Later edition of a work first published in 1530 (one of three imprints issued in 1537, the others in Cologne and Venice). An important Italian humanist and professor of law at Avignon, Bologna, Milan, Padua, Ferrara and Bourges, Alciati was one of the first jurists to base his interpretation of civil law on the history, languages and literature of antiquity, and to conduct original research on the texts rather than merely copy earlier glosses. His work was deeply influential and his services were retained by the kings of France and Spain, as well as by several Italian princes. As one would expect, there was a large market for his works. In addition to those published by Alciati there are several unauthorized publications based on lecture notes compiled by his students. First published in Cologne in 1530, *Iudiciarii Processus Compendium*, a treatise on procedure in civil and canon law, appears to fall into this latter category. Some sources say it is not based on Alciati's work and is the work of an anonymous author. It was nevertheless a popular work that went through several editions and issues over the next 30 years. 

\* Second edition of a work first published in 1679. Blount's final work, it provides "under the heads of various places in which the land was situate, various curious tenures, and customs of manors, which he had come across in his study of records. It was meant both to amuse and instruct; and it does instruct, because it is a painstaking piece of work, taken from the original authorities, which preserved the memory of many old customs which were rapidly decaying when the book was written.": Holdsworth, *History of English Law* VI:611. \* First American edition. Based on the first British edition (1817) and enhanced with notes on American cases, this was the first treatise on arbitration published in the United States. Caldwell intended this work to replace Kyd's *A Treatise of the Law of Awards* (1791), which Caldwell felt was out of date. It contains a thorough overview of the subject and provides a large number of precedents. Cohen, *Bibliography of Early American Law* 9098.



A Rare Collection of Seventeenth-Century Papal Bulls

Contemporary limp vellum, early hand-lettered title and shelf number to spine, ties lacking. Moderate rubbing to extremities, chipping to center and foot of spine, corners bumped and lightly worn, hinges partially cracked, vellum just beginning to crack through pastedowns, a few partial cracks to text block. Moderate toning to text, somewhat darker in places, dampspotting in a few places, staining to a some leaves. Early owner inscription (of a Jesuit library) to title page, a few brief annotations to text, interior otherwise clean. \$1,500.

\*With index. Arranged chronologically, this volume contains papal bulls and related documents from the pontificates of Popes Gregory XV and Urban VIII issued between 1621-1628. They offer an interesting perspective on the Church and Papal States at an important point in its history. (The expansion of political territory and church missions are two highlights from this period.) Analogous in organization to volumes of session laws, collections of papal bulls were issued sporadically from the fifteenth century onward. All are scarce today. OCLC locates 5 examples in North America, all from the seventeenth century, two in law schools (Harvard, UC-Berkeley). None are identical to our copy. Not in the *British Museum Catalogue* or Ferreira-Ibarra.





\* First edition. The inscription reads: "To Caroline Bijur/ with the cordial good/ wishes of an old-time friend./ Benjamin N. Cardozo/ April, 1931." One of the most important legal books published in the twentieth century, it changed the way lawyers thought about the law. "It has remained for Judge Cardozo to give us the first real analysis of the literature of the bench. Himself one of America's outstanding judicial stylists, he brings to this task the rare combination of legal and literary learning, and our only loss is that we are foreclosed from an analysis of the judge's own decisions." (Garfinkel). Bijur [1883-1964], the daughter of a prominent New York lawyer, worked for several charities and civic organizations. John H. Garfinkel, *California Law Review* 19 (1930-31) 654.

\* Only edition. A collection of brief biographies and portraits of the judges who sent Charles I to the scaffold. A staunch Monarchist, Caulfield offers an unabashedly partisan perspective. An interesting feature of each portrait plate, which has a border featuring the skull and crossbones, chains, beheading axes, execution scenes and the Tower, is a caption that states the unpleasant demise of each Regicide. Caulfield seems pleased to report that most were executed, imprisoned or exiled. *British Museum Catalogue* (Compact Edition) 5:230.







Three-page letter on three 5" x 8" and 5" x 7" portrait photograph of Frankfurter in judicial attire in attractively matted 28" x 14" glazed frame. \$1,250.

\* In this interesting letter to an unidentified recipient Frankfurter shares his thoughts on the judicial system and elected judges. "I agree with you altogether that the quality of our judges is fundamental to the quality of our judicial output and I also agree that the method & selection, the tenure & termination of office are most important. Of course I am all against short election terms and recall of judges. My own inclination is strongly, on the whole, for an appointive judiciary particularly with, possibly, an elected C.J. as the administrative head of the whole judicial system..." Frankfurter was a professor at Harvard Law School from 1914 to 1939.





\* First edition. The inscription reads: "To Ned French, who/ makes me feel that/ a good railroad/ president is a/ statesman./ Yours sincerely/ Felix Frankfurter/ Algonquin Club/ 16 December 1938. *Mr. Justice Holmes* is one of Frankfurter's finest statements of his admiration for Holmes. This and other books did much to establish Holmes's posthumous reputation.





\* First edition. The inscription reads: "Dear Bob/ This is <u>not</u> a Roland for an Oliver, but law, at least in my poor hands, is only on the river of philosophy./ But 'we live by symbols,' and this brings you my gay devotion & ardent hopes./Yrs/Felix/18 December 1936." "Bob" is probably Robert H. Jackson [1894-1954], one of Frankfurter's closest friends. In 1936 Jackson was the assistant attorney general heading the Tax Division of the Department of Justice. He was attorney general from 1937 to 1941 and an associate justice of the Supreme Court from 1941 to 1954.





\* Fourth and final edition, the only edition with Somma's notes. First published in 1642, the *Florum Sparsio* is a topically digested selection of excerpts from Justinian's *Code* with commentary by Grotius. It was intended to serve as a tool for legal arguments. Somma, who wrote the additional notes in this edition, was a Neapolitan theologian. They add philological detail and information about Neapolitan and Italian law. 

\* Later edition. With index and the text of the U.S. Constitution. Of the eighty-five essays John Jay wrote numbers 1-5 and 54, Madison wrote numbers 10, 14, and 37-48. Numbers 18-20 were written by all three. The remaining 50 were written by Hamilton. The essays aimed to encourage ratification of the proposed constitution by New York State, but were immediately recognized as the most compelling commentary on the most radical form of government the world had yet seen. The present item follows the text of the 1818 Gideon edition, which was the first to contain Madison's notes and corrections. The author of each essay is indicated. 

\* First edition. The inscription reads To Ralph Goodman/With my regards/ Learned Hand/ March 20, 1958. The published version of the Oliver Wendell Holmes Lectures delivered at Harvard University in 1958, this influential book discusses the propriety of judicial efforts to expand the scope of the first ten amendments. It has three chapters, "When a Court Should Intervene," "The Fifth and Fourteenth Amendments" and "The Guardians."





\* First edition. This pioneering work was not superseded until the twentieth century. In 1843 it was reprinted and appended to Bouvier's *Law Dictionary*. The second part containing the laws of William the Conqueror is printed in three columns containing the text in Norman, Latin translations by a Dr. Wilkins and English translations by Kelham. 




#### Little & Brown Seek Subscribers for a New Series of Law Reports

\* This prospectus would have been folded, sealed, addressed and mailed to a potential buyer. It promises "a *new series* of English Law and Equity Reports, which shall, in all respects, be far in advance of any other reprint of English Reports in this country, and which shall furnish to the American lawyer the decisions of Westminster Hall, nearly *two years before they could otherwise be obtained*, and long before the publication of the contemporaneous decisions of most of our tribunals." This was a successful pitch: publication commenced in 1851.



#### **Early Bavarian Mining Laws**

\* Only edition. Bavarian mines were an important source of salt, graphite and iron from the middle ages to the mid-twentieth century. Lori's collection of Bavarian mining laws, arranged chronologically from 1285 to 1760 is both a legal and a historical work. The work begins with a brief treatise on Bavarian mining law and concludes with a well-organized index. Lori, a state official, was a Hof-Muenz-und Bergrath in the Kingdom of Bavaria. \* With a detailed table of contents. This is a carefully written fair copy by an anonymous student or scribe based on a set of lectures at the University of Papenburg by Homeyer. It covers the principal topics of criminal procedure (in the context of the local legal systems). Inherently interesting, this item is also worthy of careful study due to its insight into contemporary debates on the reform of criminal law in the German states and elsewhere.

\* Second edition. Carpani was the author of several commentaries on the laws of Milan. His commentary on Milan's criminal law, and its relation to canon law, was first published in 1583. Punishments are also discussed. A durable work, it went though three later editions, the last in 1646. Our 1608 edition is enhanced by notes by Ruginelli and additional commentary by "diversorum I.C.": Giulio Cesare Giussani, Giovanni Battista Cavazza, Pietro Cantone, Girolamo Saraceni and Claudius Vacarius. This is a rare title, especially in North America. Counting all editions, OCLC locates 4 in North America, 2 in law libraries: Library of Congress, which was a 1583 edition, and UC-Berkeley, which has one from 1609. This edition not in the *British Museum Catalogue*.



Arranged alphabetically by topic, it is a venerable handbook on canon law for clerics. The identity of the author is uncertain, but most sources attribute authorship to Niccolo di Milis, a 15th-century Franciscan friar from Sardinia. It went through numerous editions, but all are scarce today. OCLC locates 3 copies of this imprint, 1 in North America (at George Washington University Law School). 





A deeply influential work that was translated into Italian, Dutch and English, it was a part of the law libraries of such men as John Adams and Joseph Story. It remains an authority in South Africa. Voet discusses all of the titles, then explains how they were influenced by customary and local law. The second volume pays special attention to subjects relevant to the Netherlands, such as maritime law. Voet was Professor of Law at the Universities of Utrecht and Leiden.
