




Collected Works of d'Aguesseau, A Set from the Royal Library at Versailles

Contemporary calf, gilt spine, gilt insignia of the Royal Library of Versailles to front boards, marbled edges and endpapers. Worn, several boards and backstrips detached, a few backstrips and a board lacking, text blocks intact. Moderate toning to text, occasional light foxing, internally clean. Ex-library. Location labels to spines, stamps to title pages, annotations to versos. A reback-worthy set with an interesting provenance. \$500.

* Only edition. d'Aguesseau was an important magistrate, parliamentarian and judge during the time of Louis XIV and XV. A pupil of Jean Domat, he served two terms as chancellor of France in 1717-1722 and 1727-1750. Edited by Pardessus, this sixteen-volume critical edition collects most of his work. The contents of this set deal mostly with legal matters, but several pieces relate to politics and diplomacy. This copy belonged to the "Pages du Roi, Versailles," a library in the Versailles Palace at the time of King Louis XVIII [1755-1824].

* Second edition. First published in 1953, this study of the penal law of Colombia reached its third and final edition in 1977. OCLC locates few copies of any edition in North America: 5 of the first (Harvard Law School, Library of Congress, Southern Methodist University, University of Maryland, University of Texas, Austin), 3 of the second (Harvard Law School, University of Minnesota Law School, Yale Law School) and none of the third.



Contemporary vellum with later vellum rebacking, raised bands and later black-stamped titles to spines. Moderate soiling, rubbing and occasional stains to boards, most bowed, detached or partially detached, considerable rubbing to extremities with wear to spines, spine ends and corners, front board lacking from a volume. Title pages, with large Giunta devices, printed in red and black, woodcut decorated initials, text woodcuts in a few places. Moderate toning to text, somewhat heavier in places, occasional dampstaining and foxing, light soiling, worming and minor tears to a few leaves, a few endleaves detached, title pages lacking from three titles (those titles are enclosed with square brackets), wax seal to foot of *Super Authenticus* title page, early annotations to a few leaves. * Between 1250 and 1450 the Post-Glossators, a group of legal scholars and teachers in Italy, initiated the recovery of Roman law texts from the corruptions of the medieval Glossators. Their efforts to apply Roman law to the jurisprudence of their day also prepared the way for the natural law school of the seventeenth century and helped to lay the foundations of the modern state. The greatest member of this group was Bartolus, a practicing lawyer and professor at the University of Perugia. His unrivalled reputation derives from his enormous literary output, most of them commentaries on the texts later collected as the *Corpus Juris Civilis*. All of his works went through numerous editions. The Giunta editions offered here collects his commentaries on books of the *Corpus Juris Civilis*, consilia and smaller legal treatises.

These books were issued without volume numbers for those who wanted individual titles, but they comprised a set. Giunta issued them in a uniform style with an index volume. Most of these titles are found today in sets with the general title *Opera Omnia*. In 1590, and again in 1596, Giunta reissued these volumes as a set. *Censimento Nazionale delle Edizioni Italiane del XVI Secolo (EDIT16)*. Citations listed above.



Moderate toning to text, light soiling to title page of *Super Authenticus*, section clipped from fore-edge of *Consilia* title page with no loss to text. Early annotations in a few places, interior otherwise clean. Ex-library. Small inkstamps to title page of *Super Authenticus*. Three scarce titles worth rebinding. \$950.

* This volume collects three of Bartolo's most important works. *Super Authenticis et Institutionibus* is a commentary on the *Institutes*, a textbook on Roman law, and the *Authentica*, a collection of 134 constitutions of Justinian. Later included in the *Novels* of the *Corpus Juris Civilis*, the *Authentica* was believed to be a collection intended for Byzantine Italy. This assumption is doubted today. *Consilia, Quaestiones, & Tractatus* collects his consilia and other brief writings. Brederode's *Loci Communes Novi et Uberrimi* is an index of terms and concepts in the works of Bartolus. Complete in themselves and bibliographically distinct, the titles in our volume are part of a set issued in 1588-1589. (Brederode's work is indexed to this set.) All of these are scarce; few copies are held in North American libraries. None are listed in Adams.





* Only edition. A digest of diplomatic negotiations between Haiti and other nations. OCLC locates 5 copies in North American law libraries (Columbia, Harvard, LA County, Library of Congress, University of Michigan).

* Fourth edition. Brazil enjoyed a remarkable period of rapid material progress and international importance under Emperors Pedro I and, especially, Pedro II, who reigned from 1831 to 1891. The government enacted a law in 1823 calling for the gradual replacement of the Portuguese *Ordenacoes* with codes informed by the Enlightenment ideas of the eighteenth century and the work of Jeremy Bentham. A *Projecto* for commercial law was published in 1836, another in 1838. The code was enacted in 1850 and its first two editions were published in 1858 and 1869. The later editions (1878, 1886, 1896) are the best because they contain extensive commentary. All of these early editions are rare. OCLC locates 6 copies of the 1886 edition in North America (Columbia, George Washington University, Harvard, University of Arizona, University of Pennsylvania, Yale). 

According to Borchard, its "discussion of the literature of the early Spanish law and of the sources, of the modern bibliography, and of the sources of Spanish law is probably the best to be found in print": Borchard, *Guide to the Law and Legal Literature of Argentina, Brazil and Chile* 58.



* Revised second edition, the final and best edition of this JP manual, which was first published in 1887. Both editions are very scarce. * Only American edition. With notes and references to English and American cases. Emerigon was the leading French authority on commercial law. His work was held in the highest regard by English and American jurists. James Kent observed that "no subject in Emerigon is discussed without being exhausted." Lord Ellenborough said he was an "unrivalled" theorist and practical writer. This treatise on bottomry and respondentia is a useful companion to his treatises on maritime law and maritime insurance. 

* Later edition. Published by order of the Commercial Court of Bordeaux, this book is a collection of laws relating to its jurisdiction compiled from the Coutume of Bordeaux (completed 1527), legislation of the local Parlement and royal edicts. Texts of related documents are included as well. Also a procedural guide, it is an invaluable guide to the regulation of trade in one of France's most important commercial centers during the final decade of the Bourbon monarchy. This appears to be a reissue of a book published in 1710. No copies of this edition on OCLC or KVK. This edition not in Goldsmiths' or the *British Museum Catalogue*.

* Only edition. Gandolfo offers a thorough overview of Roman maritime law and its historical development. It was reprinted in 1980. Both issues are rare. OCLC locates 3 copies, all in Europe, none of the reprint. *British Museum Catalogue* (Compact Edition) 10:75.

Comprehensive 1876 Treatise on the Rights of Neutrals

* Second edition. Written by a German diplomat, this treatise is a comprehensive summary of the contemporary law of neutrality as it stood in the midnineteenth century. Written in French to reach the broadest educated audience possible, it is international in scope and lays particular emphasis on the contributions of German-speaking jurists, which Gessner believes are not as well known. After a general history of the field, Gessner devotes individual sections to contraband of war, blockade, the rights of neutrals when trading with belligerent nations, prize law and right of search and seizure. This edition not in the *British Museum Catalogue*.



* Third edition, enlarged and corrected. *Der Deutsche Rathgeber* was a standard reference for lawyers, bureaucrats and other professionals. Both a style manual and dictionary, it is a useful resource when dealing with nineteenth-century German texts. Heinsius, a professor at the Berlin Gymnasium, wrote several books on German grammar and literature. *Der Deutsche Rathgeber* was first published in 1825. *British Museum Catalogue* (Compact Edition) 11:1108.

* These are two volumes from the series *Repetitions Ecrites*, which offered general lecture notes on various academic topics to university and professional school students. The second volume's subtitle states: "Summary: Object of constitutional law. The state. Its role in the representative system. Course plan. Four parts: Sources of constitutional law, theoretical sources, the canonists, the legists, the economists. The theories of St. Thomas Aquinas, Hobbes, Francois Hotman, Jean Bodin, Locke, Montesquieu and Rousseau. Sources of positive constitutional law. Written and unwritten constitutions. The British constitution: compacts, statutes, treaties. Written constitutions" (2) Valuable guides to the general state of these areas in France at the time, these volumes will reward further research.


Only French Edition of Livingston's Criminal Code, Contains Unique Material

* First and only French edition, with material unique to this edition. Reflecting the reformist spirit of the early nineteenth century, Livingston aimed not only to punish crime, but to reform the criminal and prevent future criminal activity through social reform. While Livingston's code was never adopted, Bentham, Story, Marshall, Madison and Kent wrote him letters of approval. It also went on to exercise considerable influence in European. A reviewer said in 1836: "No one can fail to be impressed especially with the enlightened spirit of philanthropy, the single aim to benefit his fellow creatures, which breathes throughout these discussions; and to this may be added, that there is always an unaffected beauty and simplicity in the language, frequently rising, when the topic demands it, to a fervent eloquence, which will command the attention and interest of those who might be repelled by the gravity and want of imagination, with which such subjects are generally treated": Hicks, *Men and Books Famous in the Law* 159-189, quotations 179-180. * First edition. This is a digest of commercial laws and treaties regarding trade between France and Spain from the early seventeenth century to the Bourbon restoration. A second edition appeared in 1837. 1 copy located in the United States at Harvard Law School. One copy of the second edition located in the US at the Library of Congress. * Only edition. This is an interesting, historically grounded study of German criminal and civil procedure. A valuable work for legal historians, a facsimile edition was issued in 1965 by O. Zeller. Three of the woodcuts depict court scenes, the fourth is an allegorical (?) woodland court with animals. In this image a fox is being led to the gallows for his murder of a hen. * Second printing. Written in 1883 and promulgated on April 20, 1884, "[this code] was divided into six books, with a total of 1,619 articles. It included maritime commerce and special commercial courts and procedure among matters covered (...) Unfortunately, this second code...had an ephemeral life, and its demise was foreshadowed very soon after its promulgation by frequent criticism through both official pronouncements and the press. President Porfirio Diaz issued a decree on July 4, 1888, authorizing either the total or partial revision of the 1884 Code, and for this purpose appointed a commission of three jurists and a secretary. The work was promptly undertaken and completed within the following year, being approved on September 15, 1889, as the third Commercial Code of Mexico. It was decreed to go into effect on January 1, 1890.": Clagett and Valderrama, *A Revised Guide to the Law and Legal Literature of Mexico* 129-130.



* This was one of several publications inspired by the controversy surrounding the claims of Montpensier's children to the Spanish throne. Some argued that the Treaty of Utrecht, which ended the War of the Spanish Succession, annulled this claim. For them the treaty clearly stated that the crowns of France and Spain remain separate. The anonymous author of the present book does not agree. He supports his claim with an ingenious argument. The final section, entitled "Postscript to the Montpensier Marriage" was also published separately. Not in the *British Museum Catalogue*.

* Reissue of a book first published in Livorno in four volumes from 1847 to 1847. This book is an anthology of writings by contemporary German criminologists, who were considered the leading practitioners in Europe. They are: Mittermeier, Rosshirt, Hofacker, Walter, Bauer, Waechter, Scheurlen, Zachariae, Kleinscrod, Friedrich, Hepp, Sander, Jagemann, Schenck, Geib and Hesse. Mori was a pioneering Italian criminologist. He was influenced by Adolphe Chauveau [1802-1869], an important French criminologist. No copies listed on OCLC. Not in the *British Museum Catalogue*.

* Second and final edition. Rosicrucianism, a philosophical secret society with strong ties to Christian inquiry, originated in medieval Germany. By the eighteenth century Rosicrucians had organized into formal groups. Several Rosicrucian lodges had strong ties to Freemasonry. First published in 1742, Pongratz's manual is a compilation of its laws and regulations. The front matter contains several statements in support of Rosicrucianism from secular and Catholic officials, including Pope Urban VIII. The tail-piece is a Jesuit cipher, which indicates Jesuit support. OCLC locates 2 copies, both in Slovakia. Not in the *British Museum Catalogue*.


* First edition in Portuguese. Influential in Spain and Portugal, this essay on the Spanish constitution of 1812 was also a profound influence in Latin America. It was first delivered in 1811 before the Cortes that brought constitutional monarchy to Spain. This translation was prepared on the occasion of the revolution at Porto on August 24, 1820 that overthrew the regency and paved the way for the parliamentary deliberations that resulted in the Portuguese constitution of 1822. It also helped to inspire the Latin American independence movements of the 1820s. The identity of "R.F.C." is unknown. Arguelles was a Spanish statesman and diplomat. OCLC locates 2 copies (at Harvard Law School and the University of Kansas). Another copy located at the National Library of Portugal.

* These volumes are a compilation of laws, decrees, treaties and other documents issued by King John VI, King of the United Kingdom of Portugal, Brazil and the Algarves from 1816 to 1822 and Titular Emperor of Brazil from 1825 to 1826. Covering most of his reign, the contents of these books derive from a remarkable period in Portuguese history. This is the era of the Napoleonic invasion, the transfer of Portugal's court and government to Brazil, the Liberal Revolution of 1820 and the early stages of Brazil's independence movement.





* First edition. Sichard, or Sichardt, was a notable German humanist and professor of Rhetoric at the University of Basel. His edition is a notable imprint because it contains an early critical edition of the *Codex Theodosianus* and the first complete edition of the *Lex Romana Visigothorum*. Commissioned by the Emperor Theodosius II in 429 CE, the *Codex* is an official compilation of all laws enacted since the reign of Constantine. Completed in 438 CE, and ratified that year by the Senate, it was the standard legal text of the empire, one that superseded all earlier codes. It would later exert enormous influence on the legal systems of the barbarians who conquered the Western Empire, the Visigoths especially, as well as the Ostrogoths, Franks, Lombards and Burgundians. In addition to the entire *Codex Theodosianus, Codex Gregorianus, Codex Hermogenianus*, the *Novellae*, the *Institutiones of Gaius*, and the other sources forming the body of the Roman law of the Visigoths, this excellent edition also includes the *Liber de Asse*, a short treatise on monetary units, coins, weights and measures written for Marcus Aurelius by Lucius Volusius Maecianus, a second century Roman jurist and statesman. Also included is *De Controversiis Limitum* by Sextus Julius Frontinus, a compilation of passages from his works dealing with surveying and the law relating to surveying. Holbein's initials include a splendid 9-line opening initial 'S' on leaf a 1r, depicting two putti, one playing a lute. This initial belongs to the group of seven *Kinderinitialen* that, according to Schneeli & Heitz are Holbein's largest. 
