

Later nineteenth-century paneled morocco signed binding by Riviere & Son, gilt frames and corner fleurons to boards, discreetly rebacked retaining existing spine with raised bands, gilt and blind fillets and gilt ornaments, title and date, gilt edges, gilt rules to inner board edges, marbled endpapers, endpapers added. Light rubbing and a few minor scratches to boards, moderate rubbing to board edges, corners lightly bumped, hinges cracked, faint offsetting to edges of free endpapers, four later bookplates, of Guy Bechtel, the Huth family library, Arnold Hoffmann and George Abrams, to front free endpaper, recent French bookseller description tipped-in to front endleaf. Text printed in 33/34-line gothic type, rubricated throughout (including tables) in red ink, large initials in red and silver ink to [a1]r and red ink to [a5]r, smaller initials in red ink to [a9]r and [a1]v. Light toning to interior, very faint dampstain to upper corner of ff. [7] and [9] just touching text of f. [9], both tables trimmed close with minor loss to bottom edge, negligible loss at gutter of first table and fore-edge of second. An attractive, wide-margined copy of a fundamental treatise. \$16,000.


\* D'Andrea was an Italian canonist and professor of canon law at the University of Bologna. An eminent figure who received the highest tributes from Arithemius, Baldus, Forster and Bellarmin, his principal writings circulated widely in manuscript and were among the earliest printed works on canon law. Often included in editions of the *Corpus Juris Canonici*, the *Super Arboribus* is a fundamental treatise on degrees of consanguinity and affinity, also known as blood relations, and spiritual relationships created by godparents and their families. It was a work of vital importance in cases regarding estates, incest and conflicts of interest. It went through numerous manuscript and printed editions into the modern era.

Our undated edition is one of seventeen issued by Creussner. The provisional date range given by the *ISTC* is based on the bull's head watermark present in the contemporary endleaves. The woodcuts in the Creussner editions are so much larger than the type-pages that many, if not most, copies are trimmed to some degree. Our copy also includes an attractive hand-drawn table of spiritual relationships ("Arbor cognationis sp[irit]ualis tam ex sacramento baptismat[i]s confirmationis"). It was owned by several important collectors of rare books, among them George Abrams [1919 or 1920-2001], the distinguished graphic artist and typeface designer, and, most recently, Guy Bechtel [b.1931], a notable scholar and antiquarian. The *ISTC* locates 11 complete copies of this edition worldwide, none in North America.

Contemporary sprinkled calf, raised bands and lettering piece to spine. A few minor nicks and scuffs to boards, moderate rubbing to extremities with some wear to spine ends and corners, joints starting at ends, armorial bookplate of Hans Sloane to front pastedown, his signature to head of title page. Light toning to text, somewhat heavier in places, light foxing to a few leaves. \* First edition in English. First published anonymously in Livorno in 1764 as *Dei Delitti e Delle Pene*, this landmark work is, to quote *Printing and the Mind of Man*, "one of the most influential books in the whole history of criminology... and a work whose impact "can hardly be exaggerated." It is significant because it was the first systematic study of the subject. Infused with the spirit of the Enlightenment, its advocacy of crime prevention and the abolition of torture and capital punishment marked a significant advance in criminological thought, which had changed little since the Middle Ages. It had a profound influence on the development of criminal law. It was especially influential among American thinkers, such as Thomas Jefferson, who wished to use Beccaria to reform the system of criminal law Americans inherited from England. Sloane was the son of Sir Hans Sloane [1660-1753], the important physician, naturalist and collector. (Donated to the nation, his collection of nearly 71,000 items became the foundation of the British Museum, British Library and Natural History Museum, London.)



Publisher advertisements in Volume II, 2 leaves before title page and in Volume III at p. 456. Volume III includes the publisher's rare octavo broadside prospectus "To the Encouragers of Literature" tipped-in to leaf preceding title page announcing publication of *An Interesting Appendix to the Commentaries*, Volume IV lacks the advertisement leaf mounted on fly leaf preceding title page, which is often not present. Octavo (9" x 5-3/4").

Contemporary sheep, raised bands, lettering pieces, blind-stamped volume numbers and (at foot) hand-lettered later owner name to spines. Moderate rubbing and scuffing to boards, heavier rubbing to extremities, some cracking and flaking to spines, one board detached, other boards beginning to separate. Moderate toning, light foxing in a few places in each volume, sections torn from two leaves in Volume I (pp. 181-184) replaced with carefully joined facsimiles, minor careful paper repair to folding table (Volume II) near stub, which has some edgewear. Thomas's signature and later owner signature, Thomas Finletter, 1904, to head of each title page, other signatures of Thomas, Finletter and Richard Thomas, junior to preliminaries. Set housed in two lightly rubbed quarter-morocco clamshell cases, raised bands and gilt titles to spines. A desirable subscriber's copy in its original binding. \$7,500.

\* First American edition, first issue. Blackstone's *Commentaries*, a synoptic review of the English legal system, is the most influential publication in the history of modern Anglo-American law. It was especially popular in America, where it was the standard introductory legal textbook into the late nineteenth century and was the primary, or only, book studied by hundreds of self-taught lawyers, such as Abraham Lincoln. The first multi-volume book printed in America, Bell's edition, a reprint of the fourth London edition, 1770, is a landmark in the history of American publishing. Our set contains the tipped-in advertisement leaf for *An Interesting Appendix* often missing in copies of this set. Volume IV also includes a 22-page subscriber list of 839 men, who ordered 1,557 sets. This impressive group included John Adams, John Jay, John Dickinson, several colonial governors and many other leaders of colonial America. Sixteen of these were signers of the Declaration of Independence who went on to serve as members of the Continental Congress.




\* First edition of the first modern critical edition of Magna Carta. Blackstone's first important work, it contains the Articles of the Barons, the issues of the Great Charter in 1215, 1216 and 1217, with several charters of confirmation, the Charter of the Forest, and the Statute of Marlebridge. The introduction is in English and the texts of the Magna Carta and Carta de Foresta in Latin. Blackstone's essay, which is based on a great deal of original research, argued that the charter was the foundation of English liberties. This idea, first proposed by Coke, was a central tenet of Whig ideology. More important, Blackstone's research into the original texts demonstrated that all earlier editions of the charter were based on the significantly different reissue of 1225, in the reign of Henry III, rather than the original one endorsed at Runnymede. His philological approach was highly influential; it established the textual focus that has governed subsequent study of the charter.

This edition is esteemed for its handsome appearance, which was recognized as early as 1829 in Richard Thompson's An Historical Essay on the Magna Charta of King John, which described it as a "beautiful and rare edition" and the "elegance of typography is very great." The engraved dedication to the Earl of Westmoreland is surmounted with his armorial ensigns; engraved historiated initials in the text depict views of buildings at Oxford University. The tail-pieces on pages lxxvi and 73 are historical vignettes; the other ten engraved tail-pieces reproduce the royal seals attached to the original documents.




Superb period-style calf by Philip Dusel, blind fillets to boards, red and black lettering pieces and blind fillets to spines, blind tooling to board edges endpapers renewed. Moderate toning, light foxing in places, notes in contemporary hand to a few leaves in Volumes I, Part I and Volume III. A strikingly handsome set. Rare. \$15,000.

\* First edition. *Tucker's Blackstone* is a key resource for understanding how Americans viewed English common law in the years following the adoption of the Constitution and the Bill of Rights. Based on his lectures at the College of William and Mary, Tucker adapted Blackstone's often anti-democratic work to American practice. "Tucker's Blackstone became a standard reference work for many American lawyers unable to consult a law library, especially those on the frontier. It is impossible to measure its impact on American law, but it is clear that sales were strongest in Virginia, as could be expected; it was also widely used in Pennsylvania and South Carolina" (Bryson). More recently, Tucker's Blackstone has been cited in numerous constitutional cases by the United States Supreme Court relating to "original intent."



Twentieth-century signed binding (by Sangorski & Sutcliffe of London), green morocco, raised bands, gilt title, author name and date to spine, gilt rules to inner board edges, endpapers renewed. A few negligible shallow scratches to rear board, negligible light rubbing to extremities, corners lightly bumped, rear hinge discreetly reinforced. Woodcut initials, main text printed in Latin and English in parallel columns. Moderate toning to interior, somewhat lighter or heavier in places, occasional light foxing, light soiling and creasing in a few places, faint dampstaining in a few places, somewhat more noticeable to last several leaves, a few very small folded corners, tear to bottom margin of leaf S1 not affecting text. A notably handsome copy of a rare title. \$20,000.


\* First edition of the Colville translation. *De Consolatione Philosophiae* is widely considered Boethius's most important work and one of the last (if not the last) great works of the Classical period. Written while he was imprisoned on charges of treason, the work is structured as a dialogue between the prisoner Boethius and a female personification of philosophy. The two discuss many Christian themes, such as good and evil, predestination and free will, and the transient and the eternal, using secular philosophical modes of inquiry.

Given its wide influence, *De Consolatione* had many notable translators, among them Chaucer and Queen Elizabeth I. The Colville translation is notable for its inclusion of the Latin text alongside the English and the extensive additions and clarifications by Colville, both in marginal glosses and within the text itself. A remarkable work that not only translates but interacts critically with Boethius's text, it provides crucial insight into the reception of Boethius in the early modern era, particularly among Christians. (Colville dedicated the work to the Catholic Queen Mary.) It was reprinted in 1897. A 1561 edition referenced by some sources appears to be a ghost. OCLC and the *ESTC* locate 6 copies of this title in North America (Harvard, Yale, University of Minnesota, University of Illinois, Folger Shakespeare, Huntington Library).




Seventeenth century-style calf, blind rules, gilt rules and large central arabesques to boards, raised bands, blind fillets, gilt ornaments and lettering piece to spine, endpapers renewed (but not affixed to pastedowns to simulate period style), gilt rules to board edges, early hand-lettered title to fore-edge of text block. Light toning to text, occasional light browning to outer edges of margins, fold lines and some soiling to upper corners of 16 leaves near rear of text block, lower corner lacking from leaf GGGggiii (Fol. 393) with no loss to text, light soiling, edgewear and later owner signature (A. Hacker) to title page. A landmark work in a notably handsome binding. \$12,500.

\* First edition. Written between 1250 and 1256, *De Legibus et Consuetudinibus Angliae* [*The Laws and Customs of England*] is the first treatise on English law. A systematic work, it emphasizes the separation of procedural and substantive matters and also cites cases as sources of at least intellectual, if not formal, authority. The principles formulated in this work and its use of precedents determined the development of English law and established the method adopted by Littleton and Coke. In Maitland's words, it is "the crown and flower of English medieval jurisprudence" and "by far the greatest of our medieval law books.":





Moderate toning to interior, crack in text block between front free endpaper and title page of first part, which is soiled and has a small faint stain and an (illegible) early owner signature. A well-preserved copy in a handsome binding. \$7,500.

\* Scholars are unsure when the coutume of Brittany was compiled, or the names of its authors, but it was first cited officially in 1341. Its final codification was issued in 1580. It deals primarily with civil and criminal procedure and is original in many respects. It also incorporated some aspects of English law, especially in matters concerning succession of certain fiefs, and a good deal of canon law, more so than any other coutumiers. The first part of our pocket-sized edition is the text of the coutume. The second and third parts address parts of the coutume dealing with maritime law, commercial law and territorial jurisdiction. These three parts were also issued separately. OCLC locates 1 copy in a North American law library identical to ours (George Washington University). Not in Caswell & Sipkov. \* A list of more than 50 prisoners and their charges. Most entries mention the age of the prisoners, some mention verdicts, which are mostly death sentences. There are also a few acquittals. One prisoner, Charles Gunyon, was sentenced "to be transported for 14 years." James Tyler and Mary Deacon starved a child placed in their custody. Both received prison terms with hard labor, two years for Tyler, one for Deacon. This appears to be an unrecorded imprint. No copies listed on OCLC or Library Hub.

\* Fourteen-year-old John Any Bird Bell confessed to killing Richard Faulkner Taylor, thirteen, presumably for the small sum of money Taylor was carrying home. His younger brother, James (with whom John Any Bird is often confused in contemporary accounts), apparently a witness to the crime, testified against him at trial, where he was convicted of murder. Bell was the youngest person executed in England in the nineteenth century. This broadside appears to be unrecorded. No copies located on OCLC or Library Hub.

Light toning, horizontal and vertical fold lines, faint offsetting, minor creasing along fold lines and at edges, small hole near top-edge affecting headline with minor loss to text but not legibility, brief penciled note near headline. \$3,250.

\* Wilson was an infamous English serial killer connected with at least seven murders. A live-in nurse, she poisoned her victims, primarily with colchicum or sulfuric acid disguised as medicine, after persuading them to include her in their wills. As indicated by this broadside produced for street vendors at her execution, which was attended by a crowd of almost 20,000 people, her case attracted a great deal of attention. Wilson was the last woman publicly hanged in London. OCLC and Library Hub locate 1 copy of this rare broadside (Harvard Law School).




\* Memoriale: First edition, one of four issues. Buno, the rector of the St. Michael's Gymnasium in Lüneburg, was the inventor of a unique "emblematic teaching method" (ADB) that used allegorical pictures as mnemonic devices, most of them engraved by his brother, Conrad. He produced several textbooks on law, theology, history, geography and German and Latin grammar using this method. Memoriale Juris Civilis Romani, one of these textbooks, is an outline of the Digest and the Novels of Justinian, two of the four components of the Corpus Juris Civilis. Along with its tables, it teaches the text with statements arranged in the form of a catechism. The first part includes a guide to the emblematic method and instructions on the use of the plates. Other issues contain different numbers of plates; VD17 indicates 19 for the present issue. Counting all issues, OCLC locates 5 copies in North America (Columbia Law School, Harvard Law School, UC-Berkeley Law School, University of Illinois, Getty Library). We located another at the Library of Congress.

The other two works in the volume are later editions of treatises on royal authority by jurist Friedrich Pruckmann, who served the Electorate of Brandenburg from 1592 until his death.





It was the primary source for William Penn's *Excellent Priviledge of Liberty and Property* (1687), a work that inspired support for the revolution. George Mason used it when drafting Virginia's Declaration of Rights (1776). Jefferson, who owned two copies, probably referred to it when he wrote the Declaration of Independence and the Virginia Statute for Religious Freedom. 


\* First edition of this important and finely printed reference work. Tudeschi, a Benedictine canonist from Sicily, earned his doctorate in canon law at the University of Bologna. Also known as Panormitanus for his position as archbishop of Palermo, he taught at the Universities of Siena, Parma and Bologna. "It was his canonical works, especially his 'Lectura in Decretales' 'In Sextum,' and 'In Clementinas,' that won him the title of 'lucerna juris' (lamp of the law) and insured him great authority" (Catholic Encyclopedia).

The present volume is a comprehensive reference companion to Tudeschi's works, organized alphabetically in the form of a dictionary. Corsetti, also a lecturer at the University of Bologna, was highly respected as a canonist and appointed by Pope Alexander VI to the Sacra Roman Rota in 1500. "This table of contents, made in Bologna 1486, is his best work and makes the writings of Panormitanus accessible" (Schulte).


The printer of our edition, Andreas Torresanus de Asula [1451-1529], was the father-in-law to the great Aldo Manuzio. The two became business partners from 1508 and Torresanus would carry on the work of the Aldine press after Manuzio's death in 1515. Both incunable editions of this title are rare. He become an associate justice of the United States Supreme Court in 1863 and remained on the bench until 1897. Dictated in his later years "for a few friends," his *Reminiscences* provide vivid sketches of California during the boisterous early years of settlement.

The second section, by his associate George C. Gorman, recounts an attempt on his life in 1889 by David S. Terry, a former California chief justice. This part does not appear in the first edition, which was published in 1880. 

It was formed during the nineteenth century by the notable Scottish lawyer, bibliophile and antiquary, David Murray, who presented it to the Library of the Royal Faculty of Procurators in Glasgow in 1902. As we can see in the contents, which span almost the entire nineteenth century, Murray had long possessed a sustaining interest in law reform. Many titles touch upon the numerous areas of law that were dramatically reformed during the 1800s, including bankruptcy law, conveyancing and real property law, judicial administration, chancery and equity, and, to a lesser extent, codification, criminal law and jurisprudence.

Many of the works are presentation copies inscribed to other well-known international lawyers and reformers of the nineteenth century, among them Sir Travers Twiss, Sir John Connell, and Edwin Wilkins Field. Among the authors themselves are John Austin, Basil Montagu, Lords Brougham and Grenville, Edward Sugden and John Westlake. Most of the works appear to be quite rare. \* First edition. Better known as the "Reynolds Pamphlet," this remarkable work relates to one of the first sex scandals in American political history. While secretary of the Treasury, Hamilton had a three-year affair with a woman named Maria Reynolds. This affair was instigated and encouraged by her husband, James, as a way to extort hush money from Hamilton. Jailed for his participation in a shady speculative scheme, Reynolds attempted to implicate Hamilton in exchange for his freedom, through the help of political enemies, believing Hamilton would claim responsibility if threatened with public exposure of the affair. In the meantime, rumors linking Hamilton to the speculative scheme began to circulate and find their way into print, most notably in Callender's *History of the United States.* In a bold move to protect his public reputation, Hamilton addressed the rumors and prevented a political scandal by confessing the truth. Denying any charges of public financial impropriety, he admitted his "amorous connection" with Maria Reynolds with her husband's "privity and connivance." According to Sabin, Mrs. Hamilton tried to buy up all copies of the 1797 pamphlet, but some escaped. A second edition was reprinted in 1800 by anti-Federalists in the midst of the Jefferson-Burr election.

Rediscovered during the late middle ages, it became the standard textbook of Roman law. The main text of our 1501 imprint is accompanied by Accorso's great *Glossa Ordinaria* (or *Magistralis*). A Professor of Law at Bologna and a leading figure in the revival of classical jurisprudence, Accorso examined every extant note and commentary when he prepared his epochal edition of Justinian's *Institutes, Digest* and *Code*. 



First published in 1666 as *Traité de la Preuve par Comparaison d'Écritures*, this treatise gives a historical overview of the use of handwriting analysis in criminal cases with reference to Greek and Roman law, English common law and French procedure. The discussion of Roman law is particularly extensive. It concludes that handwriting evidence is generally insufficient to secure a conviction and should not be admitted in criminal cases.

Le Vayer was a lawyer in the *parlement* of Paris who wrote extensively on the rights of the accused. Our English translation of his work includes an extensive preface by the (anonymous) translator discussing the uses and abuses of handwriting evidence in English treason trials, including those of Algernon Sidney and Thomas Sprat. 

From the Federal Reserve to communism to nuclear disarmament, the self-identified bellyachers "have just about had a bellyful" of "elite' world planners." The tract stresses the importance of gun ownership, dismissing opponents of the Second Amendment as "conspirators" with "an axe to grind." It also condemns the Seventeenth Amendment, which established the direct election of senators, as "bungled" and insufficiently broad. It argues instead that federal appointees should be appointed by popular vote and not the Senate. It includes a bibliography listing Phyllis Schlafly's 1964 *A Choice Not an Echo*, among other similar titles. A fascinating and relevant piece of ephemera from a turbulent time in American history. 


\* An early printing of the Magna Carta, which was first printed around 1508 by Richard Pynson. It also includes the Charta de Foresta of Henry III, the Statutes of Merton and Marlebridge, the Statutes of Edward I and other statutes through the fourteenth regnal year of Elizabeth I, which are digested by topic and cross-referenced to Rastell's *Collection of All the Statutes*. Among the most notorious statutes are those of Edward I concerning Jews, including the Edict of Expulsion (1290), which banished them from England. Other statutes relate to women, wills, forcible entry, "Fraudulent Deedes" and other topics. The text is mostly in Latin or Law-French, then in English after Fol. 119. The early annotations range from a few words to a sentence or two. About half of these are interpretive, the others are references to statutes and cases.

As noted by Sotheby's: "Thomas Jefferson (who must have had Magna Carta in mind as he drafted the Declaration of Independence) and Alexander Hamilton both cited Magna Carta in support of the United States Constitution. Blackstone returns a transcription of the notes "together with the new ones that have occurred on a transient Perusal of Mr Steevens's second edition. 

\* Clark was an influential California lawyer and author. After coming to California from Illinois in 1861, he settled in Sacramento County and received his law license three years later. In the 1870s he wrote a number of legal works, including *A Treatise on the Law of Judgements*, the first national treatise written or published in California and still highly regarded today. He was also a member of California's Constitutional Convention of 1878-1879 and took an active interest in legal reform in the state.

In this register, he lists legal cases in which he was involved during his years in private practice. Nearly all are civil, and some involve noted California citizens such as the banker D.O. Mills or the businessman Sam Brannan. Several receipts and case-related documents are laid in. These include a postcard addressed to Freeman from an E.M. Marsham and a receipt for a \$702 money order from Wells Fargo dated 1879 related to the settling of a foreclosure.

Known as the *Registrum Brevium*, it was the source of the first printed collection of writs, which was published in 1494 by Richard Pynson.

\* First edition. Mazzolini, a theologian and wide-ranging scholar, was an inquisitor and censor of books for Rome. An early opponent of Martin Luther, he was involved in the juridical process against him. (Mazzolini was also involved in cases against Johann Reuchlin, Pietro Pomponazzi and Erasmus). A great deal of his scholarship was devoted to the works of St. Thomas Aquinas. Also known as the *Egregium vel Potius Divinum Opus in Iohannem Capreolum*, Mazzolini's Compendium is a summary of a work of another Aquinas scholar, Jean Capreolus [c.1380-c.1444] dealing with Aquinas's commentaries on the *Libri Quattuor Sententiarum* of Peter Lombard [c.1096-1160], one of the great works of Medieval theology. Silberschlag, the former owner of this copy, was a professor of theology at the University of Erfurt. This is a scarce imprint. \* *Punishments*: first edition, six plates watermarked 1818. As trade with China increased, Chinese culture began to take hold of the British imagination. This was particularly true in cases where Chinese people and practices could be stereotyped or depicted as barbaric. Written by an East India Company soldier who traveled to Canton in 1789, *Punishments of China* depicts lurid scenes of torture and contrasts Chinese and Western customs.

Export albums like ours were produced in the port cities of China for tourists in the late eighteenth and early nineteenth centuries. Early watercolors were done on European paper, which later shifted to the thin pith paper of the present example. They were typically sold in sets of 12 or 24 and depicted a variety of subjects, including tea culture, manufacturing and local flora and fauna. The first workshop to produce these albums was Pu-Qua's in Canton, where Mason may have purchased a similar group of drawings of punishments; the images in our album depict similar scenes as the stipple engravings in *Punishments of China* but with different compositions.



\* Second edition. A collection of 50 brief sermons on the parable of the prodigal son, told by Jesus in the Gospel of Luke. In the parable, a man with two sons gives the younger son his inheritance early at his request; he then leaves home and squanders the money, falling into poverty. He resolves to return home as a servant in his father's house, but when he does, the father welcomes him back as a son. The story is the third and final entry in a sermonic cycle on redemption, and is traditionally read on the fourth Sunday of Lent. The 18 full-page woodcuts in our title illustrate various aspects of the story; the seventh and eighth woodcut, depicting the prodigal son in poverty, are identical. They are attributed to the Master of Haintz-Narr, one of Dürer's main collaborators in the illustration of Brant's famous *Ship of Fools*. A poem attributed to Brant prefaces the work.

The first edition appeared under the same imprint in 1495 and was also illustrated; the woodcuts are identical with the exception of the seventh, which is revised. Helmut N. Friedlaender, the former owner of our copy, was an important collector of rare books and incunabula. 
\* First edition, and only edition with Dürer's frontispiece, which includes an image of Lady Justice. This was the first time her image appeared in a book. Nuremberg was the center of the Renaissance in Germany and was its leading cultural and intellectual center until the end of the sixteenth century. These qualities are reflected in the contents and design of this volume. Enacted in 1479, the *Reformacion*, or Reformed Civic Legal Code, of Nuremberg is known for its humanistic orientation, straightforward language and elegant production. It is also notable as the collection of German city laws to be issued in print.

The 1522 issue by Peypus is notable for its splendid full-page frontispiece by the great Nuremberg artist Albrecht Dürer, which was originally issued as an independent print in 1521. The bottom half depicts two putti displaying the arms of the city and empire. The upper half depicts Lady Justice, holding scales and a sword, and a female figure representing charity, who is pouring coins from a purse and opening her bodice to bear her heart, which is represented by a flame. 



This is a notably handsome copy one of the pre-eminent 18<sup>th</sup>-century printings of the *Statutes at Large* with a notable provenance: the library of the Earls of Macclesfield at Shirbirn Castle, one of the finest private libraries in Great Britain. Indeed, it is difficult to imagine a more desirable set. The library was established in the early eighteenth century by Thomas Parker, the first Earl of Macclesfield. A hugely successful lawyer and Whig MP, Parker became Lord Chief Justice of England in 1710 and, in 1718, Lord Chancellor. Unfortunately, his meteoric rise was countered by an equally rapid fall in 1725 when he was impeached and found guilty of financial irregularities as Lord Chancellor. It is not surprising that this library included a set of Pickering's edition of the *Statutes at Large*. Pickering dedicated his work to Charles Yorke, then the recently appointed Attorney General and the second son of Philip Yorke, the great Lord Chancellor whose career flourished due to his friendship with Macclesfield. The friendship appears to have begun with their introduction through Lord Macclesfield's nephew, Thomas Parker, who is listed as a subscriber to this edition.

On the first, Summenhart developed the argument for insured or guaranteed partnerships far more subtly and extensively than before. He also widened the *lucrum cessans* exception far more than anyone else had ever done. Money is fruitful, Summenhart declared boldly, it is the merchant's tool, which he can make fruitful by the use of his labor. Consequently, the merchant should be compensated for loss of the use of his money just as a farmer should be recompensed for the loss of his fields" (Rothbard). Alexandre Rosenberg [1921-1987], an art dealer, and his wife, Elaine [1921-2020], were important collectors of illuminated manuscripts and early printed books. Picasso, who was represented by Alexandre's father, the eminent Paris art dealer Paul Rosenberg [1881-1959], was a lifelong friend. 

\* First printed in 1509, the *Laienspiegel* (or *Layenspiegel*) responded to a popular need among laymen (i.e. *Laien*) and local political and legal officials for a compilation of civil, criminal and public law in the vernacular. It is somewhat notorious for its commentary on witches, heretics and Jews. The preface is by Brant, the humanist and legal scholar. Locher, a scholar and poet, wrote the introduction and a dedication in verse. Christoph Tengler, the author's son, prepared the text used in this 1544 edition.


Written in 1436, the *Clagspiegel* was the first book on Roman law in German. It has two parts, the first on civil law and procedure, the second on criminal law and procedure. Throughout, it shows relations between German practice and the *Corpus Juris Civilis*. The first edition by Brant was published in 1516. A durable work that went through 20 editions between 1475 and 1612, it played a leading role in the popularization of Roman law in early modern Germany and was especially influential in the development of criminal law. First printed in 1522 as *Deutsch Formulari*, the *New Formular Teutsch* is a style manual for German legal and business documents. It went through several editions into the seventeenth century.



The binding style and manuscript hand date to the eighteenth century. However, the identity of "Dartmouth" is unclear. According to the laid-in note, the bookseller, H.W. Edwards, says he purchased this volume came from "the Earl of Dartmouth's library." He may be referring to William Legge, 1st Earl of Dartmouth [1672-1750] or William Legge, 2nd Earl of Dartmouth. [1731-1810]. The 2nd Earl is remembered as a colonial administrator in the decades leading to the American Revolution. He was First Lord of Trade from 1765 to 1766 and Secretary of State for the Colonies and First Lord of Trade from 1772 to 1775.
