<sup>\*</sup> This issue has a portrait of Brandeis on the cover and a two-page article in the "National Affairs" section about the U.S. Supreme court. The article focuses on its response to the New Deal since the demise of the court-packing plan and an appraisal of Brandeis.

\* This set of recommendations was written while Brandeis was serving as counsel to the Policy Holders' Protective Committee, which aimed to curb the Equitable's risky investment policies. "In order to reduce the heavy burden [of risk and expense] upon policy holders, radical economies in management should be introduced, the competitive rush for business discounted, and the methods of the great savings-banks and mill mutual insurance companies more nearly followed" (4). 

Curtin, Governor, May 21, 1861. Toned and spotting with some wear to right-hand margin, three horizontal fold lines, two clean tears to head, another at center along fold line. \$250.

\* Approved on May 21, 1861, the same day Richmond was made capital of the Confederacy, this act protected indebted soldiers, sailors and their families from their creditors. The North Carolina Assembly passed a similar resolution in 1861, and one presumes other states did likewise at this time. By enacting these laws states offered debtor and creditor more time for legal settlement. No copies located on OCLC.

\* The text of this satirical broadside continues (in part): "The Public are particularly Cautioned against the depredations of the above-named FILTHY ANIMALS, as they are known to be peculiarly attached to that which is not their own:---i.e. 'Rates'." William Oran may have been the author of the broadside text. We were unable to locate a copy of this broadside in any library.





\* This sixteen-stanza "New Song of the Murder-Story of Joseph Miller" is attributed to Johannes Koppelberger. It tells the sad story of a murder-suicide committed by Miller, a German-American. The verses say he eloped from Poland with the daughter of a nobleman in 1817. The couple made their way to Philadelphia and from there to Lebanon, Pennsylvania, where Miller found work as a schoolteacher. The job paid poorly and his wife was increasingly homesick. Depressed, Miller killed his pregnant wife, two children with an ax and himself. It was a grisly affair involving and axe and a knife. This poem was quite popular and issued in a number of different broadside formats. According to Vellenreuter, there were, in all, 16 printings. All are rare. OCLC locates 3 copies of our version (American Antiquarian Society, Library Company of Philadelphia, University of Michigan). Not in Shaw & Shoemaker. 

\* Second edition. First published in 1867, this guidebook includes sections on bankruptcy, divorce law, contracts of married women, bonds, bills, and notes. It also has a valuable list of attorneys arranged by county. It is designated "second edition" with an 1867 copyright. Davis was a United States Commissioner and an Indiana attorney; the first two pages advertise his services as a specialist in bankruptcy law and debt collection. Davis also published a digest and reports of cases of the Indiana Supreme Court and edited a revision of Indiana statutes. OCLC locates 5 copies, 1 in a law library (Harvard).

\* First edition. De Beck describes the lives of over 100 people who committed murders in and around Cincinnati. Moralistic in tone, it is advertised as "A Book For the Family" on the front wrapper. This pamphlet was issued again in 1867 with the author's name and the same title beginning with *The Horrors of the Queen City. Being an Account...* OCLC locates 3 copies (New-York Historical Society, University of Michigan, American Antiquarian Society). Sabin, *A Dictionary of Books Relating to America* 19108.





\* A friendly note, addressed to Capt. Malcomb A. MacIntyre, beginning: "Dear Mac, It was good to hear from you...." Douglas was a justice of the United States Supreme Court from 1939 to 1975.

\* Only edition. The Congress of Panama was organized by Simon Bolivar in 1826. It aimed to organize a league of the new Latin American republics with unified policy towards Spain, a common military, a mutual defense pact and a supranational assembly. Its goals were never realized. The proceedings, which took place in Panama City from June 22 to July 15, 1826, attracted a good deal of attention from the international community. Dufour de Pradt was an ambassador sent to observe the proceedings by the French government. This book is a summary of his observations. OCLC locates 7 copies in North America, none in law libraries. *British Museum Catalogue* (Compact Edition) 7:827.



\* This catalogue was published for prospective and incoming students in the year when the faculty consisted of Jared Sparks, Theophilus Parsons, Joel Parker and Luther Stearns Cushing. It contains general information about the school, regulations, course outlines and lists of required and recommended texts. This catalogue is especially interesting because of its alphabetical and chronological lists of all students who attended the school.

\* Only edition. This little book was intended "for the justice of the peace who has been elected to office on account of his good common sense and integrity, rather than his knowledge of the law" (1). OCLC locates 1 copy (Pittsburg State University, KS).







\* Only editions. Founded in 1830 as the University of the City of New York, New York University initially struggled to establish sound finances and a clear educational mission. As it began to run out of money, the school began a process of retrenchment that resulted in the dismissal of several faculty members in 1838. They claimed to have been dismissed unfairly because the school failed to observe guarantees and procedures outlined in the school's charter.







\* An interesting anthology of pieces from the 1770s to the early 1800s. It includes contributions to the *Pennsylvania Magazine*, letters to Dundas and Lord Onslow, and addresses to the Society of the Theophilanthropists and the French National Assembly (upon his election to the Constitutional Convention). Pamphlets like this one were published for radical sectors of the literate working-class and lower middle-class public in Great Britain. 



\* First edition. Through its power of eminent domain, New York City took cemetery land from the Brick Presbyterian Church that the city needed for street-widening. The church was given \$28,000.00 as compensation. At issue was the disposition of the dead and the proper division of this money among the church, the vault owners and the heirs of the buried. In his report Ruggles presented a learned discussion of burial law and the history of burial practices. Ruggles was a notable New York Attorney and civic leader. 

\* This is the report of a commission headed by Teixeira that was convened to propose reforms for the criminal courts of Portugal. This followed an earlier reform of criminal procedure from 1832. The recommendations of Teixeira's committee, which aimed to simplify the court system and increase public access, were implemented in 1836 and 1837. Another round of reforms followed in 1841, a penal code in 1852. OCLC locates 2 copies, neither in North America.



\* First edition, issued the same year as the Boston imprint published by Russell and Gardiner. With an appendix containing texts of documents relating to irregularities at the Boston naval station and the misconduct of the naval agent, Amos Binney. Abbott was a decorated naval officer who fought under Commodore Rogers on the frigate *President* during the War of 1812. "In March 1822...he discovered a series of frauds upon the government... [and] made very serious charges against his commandant, Captain Isaac Hull. Failing to prove these accusations when brought before a court-martial, Abbot was suspended from the naval service for the period of two years.": *Dictionary of American Biography* 1:14. \* A fine presentation copy boldly inscribed on the front wrapper "J.W.P (?) with the compliments of Jno. A. Bingham." A prominent Ohio lawyer and politician, Bingham also played a leading role after the war in connection with the trial of the Lincoln's assassins, the impeachment of Andrew Johnson, and the passage of the Fourteenth Amendment, whose due process and equal protection clauses he framed. Bingham served in Congress from 1854 to 1873, except for his appointment as judge advocate in 1864. As a consequence of a clash with Secretary Stanton, Hammond was charged with irregularities in the awarding of military contracts. He was later exonerated, Hammond was a visionary reformer in his role as surgeon general. After the war he made pioneering contributions to American neurology. Not in the *Harvard Law Catalogue*.





\* This bill was presented to the 19th Congress, 2d Session but never enacted into law. The first Federal bankruptcy act enacted in February 1800, was aimed to encourage economic risk and supersede the patchwork of debtor laws in force in the different states. Never a popular law, it was routinely attacked as a shield for the financially irresponsible and finally repealed in November 1803. The United States would not have another national bankruptcy law until 1841. Three notable bills were proposed unsuccessfully during those intervening years; one in 1815, one in 1820 and this one. All are interesting for their conception of bankruptcy and awareness of the resistance Congress had to reforms of any kind. No copies located on OCLC.





\* An amendment passed in 1793 created a Council of Censors that is directed to hold a convention every seven years to review the state constitution and enact any changes proposed since the last convention. The records of these conventions are thus an excellent window into Vermont's constitutional history. The main issues addressed in the 1843 convention were the expansion of male suffrage and deciding whether offices formerly filled by appointment would be filled instead by election. Although Wharton is perhaps best known for his works on international law, he was also an authoritative writer in other fields, including evidence, contracts, civil and criminal law. OCLC locates 10 copies, all of the second edition. Not in the *Harvard Law Catalogue* (1909).
