



Notable Treatise on Riparian Law with Illustrations and Two Folding Tables

Text printed within rules borders. Moderate toning to text, slightly heavier in places, negligible dampstaining to margins of a few leaves, early struck-through signature to title page, which is slightly soiled. * Second edition. Aimo's influential treatise addresses a thorny aspect of riparian law: alluvium, that is, soil deposited on a shore by a river that modifies the dimensions of a parcel of land. A fine example of humanistic legal scholarship, it is notable for its application of geometry-based surveying techniques, which are illustrated in the plates and most of the woodcuts. 



* Tractatus: later edition; Epistolarum, only edition; Titulorum: secon edition. An important Italian humanist and professor of law at Avignon, Bologna, Milan, Padua, Ferrara and Bourges, Alciati was one of the most renowned jurists of his day. His work was deeply influential for generations. His commentaries and notes are based on lectures delivered during the years when he was a law professor in Avignon (1518-1522). They were edited by his students and colleagues, such as Nicolas. First published in 1542, his Tractatus de Praesumptionibus discusses the Roman law of presumption, that is, situations in which a particular fact can be made without proof. Raymundus's Epistolarum Legalium is an essay on legal writing and the proper forms of legal instruments. Little is known about its author. The final book in this volume is Oldendorp's Titulorum Iuris Civilis, a popular digest of the Corpus Juris Civilis in the form of an index. Best known for his Lexicon Iuris, Oldendorp, a state official and law professor, was a notable Protestant jurist. His Protestant viewpoint enhanced the value of his work in areas of Europe that rejected Catholicism. 



* Originally part of the Territory of Louisiana, then the Territory of Missouri, Arkansas Territory was established in 1819. It became a state in 1836. The first territorial compilation, a brief 149-page volume that included statutes of Missouri, was published in 1821. Steele and Campbell's alphabetically digested compilation was the second and last published during the territorial period. As indicated by such sections as Indians, Slaves, Vice and Immorality, it offers an interesting perspective on Arkansas when it was beginning its transition from a territory to a state. The Earliest Textbook of Scottish Law

* Only edition. One of the most important books on Scots law, *Practicks* is widely believed to be the first textbook of its kind. It was compiled during the late sixteenth century and circulated for several decades as manuscript copies. Balfour was part of the commission that consolidated Scottish law. Similar in its general form to the *Institutes* of Justinian, this book grew out of his association with the commission. Although it is not certain how much was written by him, the work became known as "Balfour's Practicks." * First edition. This was one of the most popular German treatises on forest and game laws during the eighteenth century. Its final edition, the fourth, was published in 1767. The scope encompasses the laws of the Holy Roman states and adjacent countries. The charming frontispiece depicts a forest scene with images of sport hunting, tree felling and other activities regulated by forest and game laws. 

* Remembered today as the author of the moral and satirical Narrenschiff (The Ship of Fools), Brant was also a noted legal scholar and humanist. He studied at Basel, where he completed a doctor of laws degree. After serving on Basel's law faculty he moved to Strasbourg, his birthplace, where he became city clerk and enjoyed a position of great prominence. Brant was later appointed imperial councilor by the Holy Roman Emperor Maximilian I, who elevated him to the nobility. Expositio Titulorum is a renowned textbook devoted to complex passages in Roman and canon law. First published in 1490, while Brant was in Strasbourg, it summarizes his thoughts concerning Roman and Canon law and reflects his conservative and somewhat cynical worldview. Our c.1496 edition also includes Caccialupi's Tractatus de Modo Studendi in Utroque Iure, an introductory textbook for law students. An important early legal reference work, The Margarita Decretalium, i.e. "Pearls of the Decretals," is the index to the Decretals of Gregory IX (or Liber Extra). First printed in 1481, the Margarita was probably assembled during the late thirteenth century, some time before the appearance of the Liber Sextus in 1298. 

* Decree no.865. Signed at the foot by Descene, Sécretaire-Générale, 27 Mai 1793. The creation of an army founded on the principles of the French Revolution was one the many great changes wrought by the National Convention. Popularly known as the Army of Year II, it was a fighting force under civilian control of 650,000 men consisting of volunteer soldiers, eventually supplemented by mass conscriptions (the *levée en masse*) and professional officers drawn almost exclusively from the middle classes. It became one of the greatest armies in history. Intended to be posted in a conspicuous place, and thus available to all who could read, this massive broadside contains the army's penal code and code of criminal procedure. They were by far the most liberal codes of their time. The format of our broadside also reflects the Assembly's commitment to transparency and desire to transmit legal knowledge as broadly as possible. This text was also issued as an octavo-sized book. 

* First Edition. Burgh was notable reformer of "public errors, defects, and abuses." Notable for its extensive use of statistics, his *Political Disquisitions* offers arguments in favor of several then-radical ideas, such as free speech and universal (male) suffrage. The first two volumes of this work were published in 1774, the third in 1775. Another edition was published in Philadelphia in 1775. It was a profound influence on the American Founding Fathers, John Adams especially, who said the book "ought to be in the hands of every American who has learned to read" (cited in Wood). 



* Only edition, one of two issues (the other bound into copies of Volume III of the American Law Journal). A translation of De Rebus Bellicus, part one of Bynkershoek's Quaestiones Juris Publici (1737), A Treatise on the Law of War addresses the customs of land and sea warfare. A notably humane work, it condemns actions against civilians and advocates the fair treatment of prisoners of war. Du Ponceau's able translation is prefaced by a biography of the author, a table of cases, an index of citations from the Corpus Juris Civilis and an annotated bibliography of civil law treatises cited or referred to by the author. This latter item, which lists editions and translations, is interesting for its insights into the American reception of the civil law in the early 1800s. Du Ponceau is an important figure in the early history of American law and letters. He founded the Law Academy of Philadelphia in 1821, was the President of the American Philosophical Society and was a much-consulted expert on international relations and linguistics. Edward Delafield Smith [1826-1878] was the U.S. District Attorney for the Southern District of New York from 1861-1866 and Corporation Counsel for New York City from 1871-1875. 



* Covering topics as diverse as the duties of the principal chief to game laws, this 1878 volume offers an interesting legal perspective on Cherokee life in the late-nineteenth century. This volume is a composite of new and re-used material. The first part (pp. 52, 4) is the 1876 Laws and Resolutions of the National Council. The printer discarded the wrappers and title page of that compilation and added the newly printed acts and resolutions of November 1877 and January 1878 and a new title page. 



* Known as the Standley Code, this was the final comprehensive compilation of Choctaw laws and legislation published before the passage of the Oklahoma Organic Act of 1890, which merged the Oklahoma and Indian territories into the State of Oklahoma. (Independent Choctaw government ended in 1906.) It contains texts of the constitution and an amendment of 1883, revised statutes and treaties with the United States of 1837, 1855 and 1866. Standley was a lawyer and newspaper publisher. "A latecomer (1873) from Mississippi, Standley had little Choctaw blood, but enough to establish tribal citizenship" (Hargrett). * Final edition. According to Wallace, this is the "best [edition], which has superseded all older ones..." It is also noteworthy because it contains Coke's complete prefaces. Written between 1572 and 1616 by the greatest legal practitioner of the day, The Reports are not reports in the conventional sense but highly detailed anthologies of precedents organized according to the cases they consider. In each instance Coke assembled a large body of cases, outlined their arguments, and explained the reasons for the judgment, using it as a basis for a statement of general principles. They are, in effect, a series of treatises on the points of law adjudged, and not merely notes for citation. A work of immense authority, it was often cited as The Reports, there being no need to mention the author's name. Several of Coke's reports are famous, such as Shelley's Case, in issues concerning future interests in real property, and Calvin's Case, which established the common law, and conferred English citizenship, in lands conquered or acquired by the English. This latter case was especially influential in Virginia and other English colonies, and it continues to inform recent American debates concerning birthright citizenship. Falconer [1805-1882], the owner of our copy, was an English jurist and notable explorer of the American West and Mexico. A resident in the Republic of Texas from 1840 to 1842, his writings include an Expedition to Santa Fé: An Account of Its Journey from Texas through Mexico, With Particulars of Its Capture (1842). * First published in 1551, this was the first comprehensive study of criminal procedure published in northern Europe. A synthetic work drawn mostly from Roman-Dutch sources, it was based on Philip Wielant's *Practycke Crimineele* and other earlier treatises. Published in Latin, Dutch and French, it was standard authority throughout the continent for many years. This Belgium edition from 1570 is illustrated throughout with woodcuts depicting adultery, murder, theft and many other crimes. 



* First Selden edition. De Laudibus Legum Angliae, a history of English law, was written for the instruction of Edward, the young Prince of Wales. Cast in dialogue form, it demonstrates that the common law was the oldest and most reasonable legal system in Europe. It also compares the common and Roman systems and extols the superiority of a constitutionally limited monarchy. De Laudibus was written around 1470 and first printed in 1567. Selden's was the first critical edition of this work, perhaps the first critical editions of an early English legal work. Aside from their value to the elucidation of Fortescue's text, Selden's notes interrogate aspects of Fortescue's text and offer rich insights into jurisprudence and the nature of the English constitution. As noted by Christianson, his conclusions disputed "the concept of immemorial custom argued by [Sir John] Davies and the anachronistic historical interpretations displayed by [Sir Edward] Coke." It was reissued in 1660, 1672 and 1737 with various additions. 



He ends his letter with a request for "the aid of your learning, experience, and judgment, to supply what is deficient, and to correct what is erroneous in the work." Plumer, the recipient of this copy was an important New Hampshire lawyer, politician and Baptist lay preacher. He is best known for his efforts to convert Dartmouth College into a public institution while governor of New Hampshire, a post he held in 1812-1813 and 1816-1819. His efforts resulted in the great U.S. Supreme Court case Trustees of Dartmouth College v. Woodward. Livingston's circular is a rare item. 

Addressed to the eminent Shakespearean George Steevens, the letter discusses Blackstone's critical notes on Shakespeare, which were ultimately published the following year (after his death) in Edmund Malone's supplement to the 1778 edition of Shakespeare's plays by Samuel Johnson and George Steevens. Blackstone returns a transcription of the notes "together with the new ones that have occurred on a transient Perusal of Mr Steevens's second edition. He will see that Sir W[illia]m (Author-like) continues a little prejudiced in favour of One of his Emendations, which Mr Steevens is afraid of proposing: but, to make amends, he has given up another to Mr Steevens's more accurate Judgement." He adds that there is no need to send a transcript of the new "observations," and concludes with a note on a legal case: "Inquiry has been made at the Exchequer; - & [the] Result is, that nothing can be done there till the Fine is estreated, & then it may be discharged upon Motion supported by Affidavit." The autograph transcription that accompanies the letter is a carefully exact copy of a letter written by William Warburton [1698-1779], the churchman, writer and literary critic best known for his editions of Pope and Shakespeare, in 1726. 





* Godolphin, Clerk(e) and Cocke, three eminent civil lawyers and judges of the Court of Admiralty, were asked to resolve a salvage issue concerning the formerly Royalist ship Revenge, renamed the Marmaduke after its capture. In this opinion the judges declare that the ship "is by law the Commonwealths, neyther is shee within the Letter of the Law of Salvage, for a halfe part..." This letter is notable, in part, as an example of the various legal issues raised by the English Civil War. It is also interesting as an example of an English civil-law opinion, a counterpart to a European consilium. From the Year Books onward, court reporting provided ample documentation of the development of the common law, much of it judge-made. The parallel development of English civil law, much of rising from opinions such as our example, never enjoyed the same degree of documentation. 

*This notebook offers an opportunity to "audit" two courses taught at the University of Michigan in the early 1890s by one of its leading professors. These appear to be notes taken in class. Lieghley added an index at a later point. The notes indicate the durability of the lecture format at Michigan, but with some influence from the new case-method system. Lieghley signed the front pastedown and noted his membership in the Sigma Alpha Epsilon fraternity. The lower part of the page contains a note stating the date of Professor Wells's death. Wells, the Kent Professor of Law, taught at the university from 1874 to 1891. After Thomas M. Cooley, he was the most distinguished member of Michigan's faculty in the late nineteenth century. Little is known about Lieghley. Martindale directories from 1890s and early 1900s indicate that he had a private practice in Detroit. Order this Item

* This docket provides a fascinating chronicle of criminal activity in a large New England industrial town at the end of the nineteenth century. Each entry is organized under the following headings: Date, Complainant, Defendant, offence, Process, Offer and Date of Return of Process, Date of Examination, Motions and Pleas, Continuances, Bail, By Whom Bailed; Committed, Finding of Court, Fine, Imprisonment, Superior Court and Result. The numerous offenses found here include possession of a dangerous weapon, assault on a police officer, an attempt to rescue a prisoner, breaking and entering, breaking glass in a building, burning a barn, burning a fence, contempt of court, cruelty to animals (horses, cows), defacing a school house, defrauding an inn keeper, disorderly conduct, diverting electric current, using electricity unlawfully, evading payment, embezzlement, fornication, gaming, theft, gaming on the Lord's Day, selling adulterated butter, reselling lottery tickets, illegal transportation of intoxicating liquors, keeping a child from school, lewd and lascivious cohabitation, lewdness, maliciously injuring a tree, failure to support a child, failure to support a wife, fraud, rape, riding a bicycle over 10 miles an hour, selling cigarettes to a minor under 16, sodomy, vagrancy, trespassing and selling drugs without a pharmacy licence. A large percentage of these cases involve alcohol and alcoholism. Some defendants were fined, others were jailed, sent to the state farm, placed on probation, issued warrants, dismissed for want of prosecution, released from the police station, bailed out or sentenced to the reformatory. The text continues (from above): "...and whereas by an Act of the General Court removing all Officers from their respective offices, many Civil Suits which had been commenced and were actually entered on the Docquet or Books of Entry of the Inferior Courts of common pleas, in several Counties within this Colony have not been prosecuted to final judgment, and much Injury will happen if an adequate remedy is not provided in that behalf; It is Resolved that all Civil Actions that were pending in any Inferior Court of Common please in any County within this Colony, by having the same entered on the Docquet of Minute Book of said Court, and on which judgment have not been given, may be brought forward at the next term of the said County in which the same was entered..." 



Based on an earlier work, Von Forstlicher Oberherrligkeit (1560), Jag und Forstrecht is a comprehensive treatise on forest, game and water laws under the Holy Roman, Roman legal systems, with some comparative commentary on German customary law. Grounded in Holy Roman and Roman law, Wasser Recht deals specifically with riparian and water-rights, principally fishing and navigation on the Rhine River. Editions of both titles are scarce. 

* Platea's was the first treatise devoted to usury and its punishment. Its first two editions were published in Padua c. 1472 and Venice in 1472. It reflected the commercial nature of Venice, the most active and wealthy city of the late-fourteenth century, which owed much of its financial success to loan-bearing investments. Indeed, increasingly stringent prohibitions of usury compelled Venetian authorities to admit Jewish bankers to the city. A standard work, later fifteenth-century editions of Platea's treatise were published in 1473, 1474, 1475 1477 and 1489. All are scarce. * Fourth English edition. In 1662 Pufendorf was appointed to the first modern professorship in natural law (at the University of Heidelberg). In 1670 he became professor of natural law at the University of Lund in Sweden. First published in 1672, *De Jure Naturae et Gentium* is his principal work and a landmark in the history of natural and international law. It proposed a thorough system of private, public, and international law based on natural law. Beginning with a consideration of fundamental legal ideas and their various divisions, Pufendorf proceeded to a discussion of the validity of customs, the doctrines of necessity and innate human reason. The work is significant in part because it developed principles introduced by Grotius and Hobbes. Unlike Hobbes, Pufendorf argued that peace, not war, was the state of nature, and he proposed that international law was not restricted to Christendom. *English Short-Title Catalogue* N61031. 



* First edition, one of two issues from 1522, the other published in Lyon by Jacques Secon, priority uncertain. Riva di San Nazarro, a Lombard noble, was a learned jurist and humanist scholar. His many works, all commentaries on aspects of Roman and canon law, went through several editions and were often excerpted and anthologized. As suggested by its title *De Peste* is a treatise on Roman and canon law concerning issues relating to plagues. The first legal work written about plague and one of the very first books on public health law, it reflects the near-annual occurrence of plague in early-modern Europe. All editions are scarce. 





*This sample book was used to sell copies of a popular account of one of the most sensational trials of the day. The pastor of Brooklyn's Plymouth Congregational Church and a spokesman for abolition and other progressive causes, Beecher was one of the most prominent clergymen and public intellectuals in nineteenth-century America. In the famous scandal known as the Beecher-Tilton Affair he was tried on charges that he had committed adultery with a friend's wife, Elizabeth Tilton. Tilton sued Beecher in 1875. Though probably guilty, Beecher was not convicted and his reputation survived intact. National's book is a fairly hefty book, a 617-page octavo. The considerably lighter sample book was carried door-to-door by salesmen. It contains the front matter, selected chapters and plates, sample backstrips, a folding table with a set of bullet points to promote the book, and 28 pages of ruled leaves in which to list subscribers. The longer annotations explain specific points. The longest of these, on the bound-in leaf, discuss estates. The pagination of Notes is irregular and follows that of his father's edition of Blackstone (Philadelphia, 1803). It is cited erroneously in some records as a two-volume work. This assumption is based on a copy bound as two books recorded in Shaw and Shoemaker (entry 26252). Williams [1763-1833] was a barrister of the Inner Temple and was called to the bar, but he didn't have success as a pleader. He was known instead for his writings. 





One of the first four books of the subject, *The Lady's Law* examines the doctrines of English Common Law relating to a "feme covert," that is a woman under the legal guardianship of the man who heads the household she belongs to. (Stated simply, this group included all females except divorced women and widows.) Written from a perspective sympathetic to women, it deals with precedents of conveyances not covered in *The Law of Baron and Feme* (1700), and as such can be seen as a companion volume. The treatise concludes with an account of Robert Hyde's argument in the case of Manby *v.* Scott (1663), in which he argued that a husband who is separated from his wife is not liable to a vendor for goods the wife purchased from the vendor. Commenting on the case in his diary, Samuel Pepys referred to Hyde's judgment as "most amusing." *Diary of Samuel Pepys*, January 28, 1663. Robert Hyde was a Chief Justice of the King's Bench from 1663-1665, having gained appointment through the influence of his cousin, Edward Hyde, first Earl of Clarendon. 
