



Contemporary calf, raised bands, early varnishing and traces of gilt ornaments to spine, small early repair to head. Moderate rubbing to extremities, corners bumped, two large scuffs, one to each board, front joint cracked, negligible worming to pastedowns and hinges, split in text block between front free endpaper and half-title. Title page printed in red and black, woodcut head-pieces, tail-pieces and decorated initials. Moderate toning to text, faint dampstaining to a few leaves, internally clean. Ex-library. * Second edition. Antonelli was Cardinal Antonio Barberini's chief curate and protonotarius (scribe). He went on to become the Cardinal of Ferranto. *Tractatus de Loco Legali* deals with domicile, jurisdiction and the definition of sacred space in canon law. First published in 1671, it went through three later editions, the last in 1744. All are scarce. OCLC locates 4 copies of the 1687 edition in North American law libraries (Harvard, UC-Berkeley, University of Michigan, Yale). Not in the *British Museum Catalogue* or *The Canon Law Collection of the Library of Congress*.



Contemporary vellum with early rebacking and later varnishing, raised bands and early hand-lettered title to spine. * Second edition. A canon lawyer by training, Antonelli was the Bishop of Ferentino. His treatise examines legal aspects of time, mostly under canon law. It is arranged in four books. The first treats "de tempore in generale"; the other books address years, months and hours. Published in 1642, it went through seven more editions, the last in 1753. Few copies of any edition are held in North American law libraries. Not in the *British Museum Catalogue* or *The Canon Law Collection of the Library of Congress*. 

* South Australia's origin is unique. Established by an act of Parliament in 1834, it was a planned British province rather than a convict settlement. It was the first place in the world to grant universal suffrage and to allow women to run for parliament. It was one of the states that formed the Commonwealth of Australia in 1901. 

* First edition. A church-state controversy involving the use of public funds to finance the common school system to the detriment of Catholic sectarian schools. The Clergy Reserve funds were intended for Catholics and Protestants alike. To avoid dissension the legislature decided instead to devote the funds to educational resources for the common school system and public libraries. Rev. Bruyere, representing Catholic interests, protests the use of Catholic and Protestant money to bolster common schools where religion is "banished ... where the child of Christian parents must be taught practically that all religious systems are equally pleasing ... be he a believer in the immutable decrees of eternal reprobation or a follower of the imposter Joe Smith." OCLC locates 14 copies worldwide, none in North American law libraries. We located 1 copy, however, at Osgoode Hall, York University. 






* Only edition. Volume II: The Public Statutes of New Brunswick, Passed in the Year 1854, Together with Those Unrepealed by the Revised Statutes; Volume III: The Local and Private Statutes of New Brunswick. Settled by the French, New Brunswick was taken by the British in 1759 and incorporated into the colony of Nova Scotia. Its population expanded significantly through an influx of Loyalists after the American Revolution. Its enlarged population and distance from Halifax, the capital of Nova Scotia, led the colonial administrators to establish New Brunswick as a separate colony in 1784. The first collection of New Brunswick acts, covering the years 1786-1805, was published in 1805. *The Revised Statutes* was the first compilation. 



Some toning to text, light foxing and dampstaining in places, occasional early annotations.
- 3, 4, 5, 10: Contemporary calf, raised bands and lettering pieces to spines. - 11: Recent period-style quarter calf over cloth, raised bands and lettering piece to spine. Boards very slightly bowed, light toning to text, occasional soiling to margins, somewhat heavier toning and foxing to preliminaries. - * First editions, except 7, which is a second edition. One of the most ambitious and admired works of its time, the *Modern Reports* began as a four-volume set issued from 1682 to 1703. A fifth volume was added in 1711. Six more, one of them in two parts, were issued by later reporters. Taken together, these books report cases from 21 Charles II to 4 George II (1669-1732). Thomas Leach edited the books and republished them in 1793-1796 as a twelve-volume set. Complete sets of early editions, such as ours, are rare in the trade. Very few have ever appeared at auction; we have not seen any sets in the past 30 years. (The Sweet & Maxwell annotation, otherwise excellent, gives incorrect publication dates for 3.) 

* Third American edition. First published in London in 1680, and in Boston in 1693 and 1772, this 1798 Philadelphia edition was the first printed after the Revolution. Possibly a response to the recent passage of the Alien and Sedition Acts, it has an interesting preface by the bookseller, Alexander Brodie: "But lest (sic) the title 'The Englishman's Right' should give offence to any, it is proper to observe that the Charter of the Liberties of England is a grant from their kings obtained by force. This charter is the fountain of all their Rights; and among others of the Englishman's Right to be tried by a Jury of his Equals. As Americans we possess the same Right, and Juries by our Laws have the same powers and privileges, as by the Law of England. Neither we or our Ancestors ever were Slaves. We hold our Liberties from God alone, and to him alone are we accountable for the use or abuse of them. It is no mark of Vassalage to borrow instructions from English Jurisprudence. To understand our rights well, we must study them, and endeavour to profit by the experience of other Nations. The better to enable Jurymen to discern between Judge and Prisoner, if a lawless stretch of power should be attempted, of which at present there appears no danger, from the high character of our American Judges, I have prefixed by way of Introduction, Lord Bacon's Essay on the Moral duty of a Judge. And let it be remembered, that Judges are appointed to interpret the Laws faithful but Juries were instituted to watch and restrain Judges; so may the blessing "Him That Was Ready To Perish Upon Them!"

A staunch Whig, Hawles wrote *The Englishman's Right* to outline the rights, duties and proper behavior of a juryman and to promote the jury system as a bulwark against tyranny. Immediately successful among Whigs and others who saw themselves as defenders of English liberties, it was received with great enthusiasm in America, where it was reprinted several times well into the nineteenth century. According to Cohen, it was probably the first English law book reprinted in the American colonies. Cohen, *Bibliography of Early American Law* 1481.



* Only edition. With a detailed analytical digest. Established by a Royal Charter in 1600, the British East India Company was granted a 21-year monopoly on all trade in the East Indies. Based in a series of fortified manufacturing and trading centers, most notably Fort William in Bengal, Fort St. George in Madras and the Bombay Castle, the company evolved from a commercial venture to one that virtually ruled India as it acquired governmental, legal and military functions. It was dissolved in 1858. Produced as an official record, these volumes are a compilation of all regulations from 1793 to 1853 in force at Fort William. OCLC locates 6 copies. 

* The (undated) inscription reads "To Arthur Goldberg-/ With the high regard and affection/ of his friend-/ Lyndon B. Johnson." Appointed by President Kennedy, Goldberg was an Associate Justice of the U.S. Supreme Court from 1962 to 1965 and one of the most significant justices of the twentieth century. In his three terms on the bench he pushed the Court toward a broader construction of personal rights, a course it followed over the following two decades. He is best known for his influential 1963 internal Supreme Court memorandum that condemned capital punishment as an example of "cruel and unusual punishment," as defined by the Eighth Amendment, and his opinion in Griswold v. Connecticut (1965), which argued against a Connecticut law banning the use of contraceptives because it violated an un-enumerated right to privacy guaranteed by the Ninth Amendment. The memo initiated a wave of litigation and legislation that led to the abolition of the death penalty in several states; the Griswold opinion laid the foundation for Roe v. Wade (1973), which established a women's right to have an abortion. When Adlai Stevenson, Ambassador to the United Nations, died in 1965 President Johnson decided to appoint Goldberg to fill his seat. Johnson's larger plan was to put Abe Fortas on the bench because he knew Fortas would defend his Great Society programs (and spy on the Court for him). Probably a recipient of the legendary Johnson "treatment," Goldberg was persuaded to resign while flying to Stevenson's funeral on Air Force One. Goldberg went on to say that he accepted the UN Ambassadorship in order to resolve the Vietnam Conflict. 






Image of Furnival's Inn by a Noted Engraver
