



* Only edition. This volume contains the text of Albany's 1686 Dongan Charter, which remained in force until 1998, and later laws and ordinances. It offers an interesting perspective on New York's second-oldest city. Not in Cohen.





* William Staley (or Stayley) was one of the victims of the Popish Plot, one of the cruelest hoaxes in British history and the inspiration for a wave of anti-Catholic violence. It was the invention of Titus Oates, an Anglican clergyman, and his friend, Dr. Israel Tonge, a cleric and passionate anti-Catholic. They pretended to have discovered a Jesuit plot to assassinate the King, massacre Protestants, and set James, Duke of York, the King's Catholic brother, on the throne. Convicted as a conspirator, Staley was executed and quartered in 1678. "Instead of his quarters being set upon the city gates the king allowed them to be delivered to his relatives. Mass was said over his remains and a 'grand' funeral was arranged from his father's house on 29 November, before his burial in St Paul's, Covent Garden. This incensed the government so much that the coroner ordered the body to be dug up and delivered to the sheriff to be set upon the city gates" [Oxford Dictionary of National Biography]. 

* Only edition. The work of a Neapolitan lawyer, this curious canon-law treatise examines the laws governing the liturgical year. It covers such topics as the punishment of illegal acts committed during holidays and the authority to set the dates of liturgical events. 

* Third and final edition, first published in 1819. Christian, chief justice of the Isle of Ely and professor of law at Cambridge University, is remembered today as a distinguished editor of Blackstone's *Commentaries*. The most notable of his charges are those dealing with criminal law. A supporter of the movement to reduce the number of capital crimes, Christian emphasizes the use of alternative punishments. * Only edition located. Colorado was one of the states established in land ceded by Mexico in the Treaty of Guadalupe Hidalgo, which concluded the Mexican-American War in 1848. This Spanish edition of the constitution adopted when Colorado became a state indicates the survival of that language among its residents some 30 years later. 



* Dinus's distinguished commentary on *De Regulis Juris*, a collection of 88 maxims and phrases in Book 5, Title 12 of the *Liber Sextus Decretalium*, was first published around 1472. It went through several editions into the sixteenth century. Each *Regula* is followed by Dinus's commentary. The additions and commentary by Bohier and Moulin flanks or surrounds the main text. This edition, identical to editions published in Lyon in 1533 by Jacques Myt and in 1535 by Giunta, is not listed in Adams, Baudrier or the *Universal Short-Title Catalogue*. 



* Later edition. With index and the text of the U.S. Constitution. Of the eighty-five essays John Jay wrote numbers 1-5 and 54, Madison wrote numbers 10, 14, and 37-48. Numbers 18-20 were written by all three. The remaining 50 were written by Hamilton. The essays aimed to encourage ratification of the proposed constitution by New York State, but were immediately recognized as the most compelling commentary on the most radical form of government the world had yet seen. The present item follows the text of the 1818 Gideon edition, which was the first to contain Madison's notes and corrections. The author of each essay is indicated. 

* Hémard presents the official text of the French Tax Code with witty, often racy illustrations, colored (an pochoir) by E. Charpentier. It is a sequel to his Code Civil: Livre Premier, Des Personnes (1925) and Code Penal: Commentaires Images (c. 1940). Hemard, a prolific artist, illustrator, designer and author, is best-known for his humorously illustrated editions of serious non-fiction books. The Code Général was issued in several forms. The present copy is from a trade edition of 1,000 copies. It was also issued in a limited edition of 800 numbered copies, the first 145 with an original sheet of text illustrations and a sheet of their original sketches. There is also a signed and numbered edition of 160 printed on Arches paper (papier vélin), an edition of 40 non-commercial copies intended for friends and associates (hors commerce) and 60 portfolios of the images alone. 

* Louisiana's 1868 constitution instituted the criteria necessary for readmission to the Union. It eradicated the Black Codes of 1865, removed property qualifications for holding office and disenfranchised former Confederates. Indicating support for the Fourteenth Amendment, which would be ratified on July 9, 1868, the constitution granted full citizenship to African-American men with equal civil and political rights. It also banned segregated public schools and segregated accommodations on public transportation. This constitution was the First in Louisiana's history to include a bill of rights. * Only edition. Louisiana's first constitution was adopted in 1812, its second in 1845. More liberal than its predecessor, it expanded white male suffrage, established public schools and granted the right of appeal to felons sentenced to death or hard labor. The final 11 pages contain a French translation of the 1845 Constitution. Also issued in English, Foullouze's report is not to be confused with the Official Reports of Debates (1844), a different account by an anonymous author. 

* This is a collection of canon law writings by Louis Boniface, intended (so the title-page states) to restore discipline at the famous Augustinian community of Grand Saint Bernard in the Swiss Alps, where the author was coadjutor and provost. We understand it to be an official report, later distributed as manuscript copies, which was presented at a synodical meeting of 1718. Much of the study concerns money and property. Other subjects include the officers of the community and a ban on women servants. Showing its high status as a report, other copies are found in the Grand-Saint-Bernard archives. Our copy has a remarkable binding featuring blind-stamped floral designs with red-painted inlay. It was probably made from a wall hanging or wallpaper. The archive of Grand Saint-Bernard has a copy of Boniface's baptism certificate (1664) and several of his papers, which include works on cosmography, geography and history, and a thirty-year travel diary. The archives of Grand Saint Bernard record four other manuscripts with the same author, title and date (AGSB 5056, 5057, 5058, 4049). We located no other copies. Order This Item

* Second edition. Parisio was a professor of law, later the Bishop of Nusco and an influential cardinal. These impressive volumes collect over 500 of his consilia on a variety of topics. Other editions were published in 1543, 1570-71, 1573, 1580 and 1593. All are scarce, especially in North America. OCLC locates copies of the 1543, 1552, 1570 and 1573 editions at Harvard Law School, the University of Alberta, University of Glasgow, and UC-Berkeley Law School respectively. 





* Only edition. Formed in 1774, the Kentish Guards of Rhode Island boasted General Nathanael Greene as an original officer. The Guards distinguished themselves at the Siege of Boston and elsewhere. In 1807 Colonel David Pinniger refused an order to select six guardsmen for federal service, asserting that the Guards's charter permitted the call up of the entire unit, but not individual soldiers. Pinniger's refusal precipitated his court martial and that of the fellow officers who supported him. All were removed from office without further penalty. The guards elected replacement officers; no one went into the U.S. Army. This pamphlet was published by the officers after the "unfavorable result" of the court martial in order to protect their reputations. All aspects of the case are covered. 

Appeals for clemency followed, but they were not successful. 

* Only edition, one of two accounts published in 1809. Before he launched his career as a reformer though his *Weekly Political Register* and his pamphlets Cobbett was a soldier. It was during this time that he took his first steps toward his future vocation. While stationed in Canada from 1784 to 1791 he found that several officers were stealing provisions. Moreover, there behavior established a system of corruption that influenced the other ranks. Cobbett collected evidence against these officers. After he returned to England and left the army in 1791 he presented his evidence to the Secretary of War. A court-martial of his former officers was convened, but no one appeared to prosecute the case. The charges were dismissed and the defendants acquitted. Other interesting legislation includes the act to build six frigates to combat the Algerian corsairs and acts concerning the Whiskey Rebellion. Indian affairs are treated at length. Legislation includes several Indian treaties, an act establishing the President's right to create "trading houses" with Indian tribes, acts appointing Indian Agents, an act providing for a boundary line between settlers and Indians running west of the new Ohio territories (which settlers were not allowed to cross). 


