


Laws Concerning Time

1. Antonelli, Giovanni Carlo.

Contemporary vellum with early rebacking and later varnishing, raised bands and early hand-lettered title to spine. Moderate rubbing to extremities, some worming, mostly to spine, front board slightly bowed, front joint starting at foot, hinges partially cracked, preliminaries and rear free endpaper partially detached and somewhat edgeworn. Large woodcut printer device to title page. Light browning to text, faint dampspotting in places, internally clean. Ex-library. Bookplate to front pastedown. A solid copy. \$1,250.

* Second edition. A canon lawyer by training, Antonelli was the Bishop of Ferentino. His treatise examines legal aspects of time, mostly under canon law. It is arranged in four books. The first treats "de tempore in generale"; the other books address years, months and hours. Published in 1642, it went through seven more editions, the last in 1753. Few copies of any edition are held in North American law libraries. Not in the *British Museum Catalogue* or *The Canon Law Collection of the Library of Congress*.

Contemporary calf with later varnishing, blind rules and small central arabesques to boards, raised bands and later lettering piece to spine, spine ends and corners mended. Some scuffing to boards, corners bumped, front joint partially cracked, front hinge just starting, rear hinge mended, later armorial bookplate to front pastedown. Light toning to text, a bit of soiling to title page. Early owner annotations to front pastedown, signatures and stamps to title page, interior otherwise clean. Ex-library. Bookplate to front pastedown. A nice copy of a rare title. \$1,250.

* Only edition. Asinio was a notable Florentine jurist who was patronized by Cosimo I de Medici. He is best-known for his treatises on practice and procedure in Roman and Florentine law. De Executionibus is a comprehensive treatise on the section of the Digest, Book XI, Title 7, which addresses funeral rites and burial. It is a scarce title. Octavo (7" x 4-1/2"). Contemporary calf, blind frames and central medallions to boards, raised bands, blind ornaments and later handlettered paper title label to spine. Some rubbing to boards, heavier rubbing to extremities with wear to spine ends and corners, joints starting at ends, hinges cracked but secure, later armorial bookplate and tipped-in leaf of notes to front pastedown. Light toning to text, light foxing and dampstaining in places. Occasional notes and glosses in a contemporary hand, interior otherwise clean. \$2,500.

* Later editions. Baudouin was an eminent French humanist jurist and theologian. Interested in the early history of Roman law, he emphasized the importance of history in the development of the law. This volume collects two of his principal works, De Legibus XII Tabularum, a study of the history and significance of the Twelve Tables, and Commentarius de Iurisprudentia Muciana, a study of Roman law during the Republic. The final title addresses the legal status of the early Christian Church. Adams, Catalogue of Books Printed on the Continent of Europe, 1501-1600 B87, B93, B84.



Contemporary quarter morocco over marbled boards, gilt titles, fillets and volume numbers to spine. Light rubbing to boards, somewhat heavier rubbing to extremities, corners bumped, hinges of Volumes I and II cracked, text blocks of both somewhat loose. Light toning to text, faint dampstaining and light foxing to some leaves. Later owner stamp to front free endpaper of each volume, interiors otherwise clean. A handsome copy of a rare edition. \$3,000.

* First Italian edition. This seminal work on penal reform and legislation established Bentham's reputation. The first of his works edited by Dumont, it consists partly of papers by Bentham, some originally written in French, and partly of a digest by Dumont of Bentham's ideas, including an essay on the Panopticon. Dumont, a Swiss writer and journalist, met Bentham at the house of Lord Shelburne in 1788. This meeting resulted in an enduring relationship.

Devoted to Bentham's ideas, Dumont translated and edited many of his works and served as his informal literary agent. The first edition of *The Theory of Legislation* was published in Paris in 1802 as *Traités de Législation Civile et Pénale*. Our Italian edition came next, followed by an edition in Spanish in 1821 1822 and one in German, with an abridged text, in 1830. The first edition in English was published in Boston in 1840. The first British edition followed in 1864. Harrison, Bentham xvii. OCLC loctaes 2 copies of the first Italian edition in North America (at George Washington Law School and Yale University). 

Contemporary polished calf, blind fillets to boards, raised bands and lettering pieces to spines. Moderate rubbing to spines and extremities, corners bumped, joints starting (or just starting), some hinges cracked, rear board of Volume 2 beginning to separate but still quite secure, contemporary copperplate armorial bookplate (of John Monins) to front pastedown. Light toning to text, negligible foxing in a few places in each volume, interiors otherwise clean. A nice set. \$1,000.

* Fourteenth edition. Paging irregular, following Blackstone's paging in margin. "Since the publication of the thirteenth edition, 1800, Christian had become Chief Justice of the Isle of Ely, and the Downing professor of the laws of England in the University of Cambridge. These titles appear on title pages of this fourteenth edition, in which his notes are printed as footnotes": Eller, *The William Blackstone Collection in the Yale Law Library* 26. Three-quarter contemporary vellum over patterned boards, faint early hand-lettered title to spine. Some rubbing and light edgewear, spine ends and corners bumped. Title page of Volume I printed in red and black, woodcut printer devices, head-pieces, tail-pieces and decorated initials. Light toning to text, light foxing in a few places, light inkstains and minor worming to a few leaves, internally clean. Ex-library. Bookplate to front pastedown. A nice copy. \$750.

* First edition. One of the most durable concepts in Roman law, fideicommissum involves situations in which something is committed to somebody's trust. It is central to the law concerning testators and was the subject of several treatises. Notable for its clarity and organization, Bonfini's treatise was one of the best. Later editions were published in 1755, 1760, 1781-1789. (The last edition has an additional volume of related Rota decisions.) All are scarce. OCLC locates 6 copies of the first edition in North America, 4 in law libraries (Catholic University of America, Columbia, Harvard, Southern Methodist University). Not in Roberts. This edition not in the *British Museum Catalogue*.





Handsome recent period-style calf by Philip Dusel, lettering piece and gilt fillets to spine, endpapers renewed. Light browning to text, negligible foxing in places. Head of title page has early owner signature partially covered by small owner label (S. Henry Norris), interior otherwise clean. A very attractive copy. \$650.

* Only edition, published the same year in London and New York. "[T]he author trusts he will not be thought presumptuous in stating, that a compendious digest, immediately calculated for the use of merchants and their agents, still remains a desideratum in the merchant's world. With a view to supply this deficiency, he commenced the following compilation": (vii). Burn was a barrister of the Inner Temple who published several law books. The appendix contains summaries of two recent English decisions, and the form of an insurance policy for a ship or goods. Cohen, *Bibliography of Early American Law* 7055.

Contemporary sheep treated to resemble tree calf, lettering piece, gilt fillets and faint early hand-lettered author name to spine. Some rubbing to extremities with wear to corners and head of spine, joints starting at head, a few minor scuffs to boards, hinges partially cracked, bookplate (of Thomas Robbins, 1827) to front pastedown. Moderate toning to text, "Colquhoun" added to title page in contemporary hand. A nice copy. \$750.

* Only American edition. Colquhoun was an tireless reformer and public-minded citizen. First published in London in 1796, his treatise on criminology offered innovative proposals, such as the appointment of public prosecutors and paid magistrates, productive labor by convicts and a system of preventative police. This Philadelphia imprint was a response to the keen interest in this subject among elite circles of reformers and legislators in America. Their efforts were reflected in Philadelphia's Eastern State Penitentiary, New York's Auburn Prison and Livingston's penal code. Cohen, *Bibliography of Early American Law* 1010.





* Third edition. A comprehensive treatise on forest law according to the French Civil Code. First published in 1828, it is a useful summary of the law as it stood at the time of the Bourbon restoration. Its final edition was published in 1853. All are scarce. OCLC locates no copies of the third edition in North America. British Museum Catalogue (Compact Edition) 6:730.

* Third edition. This book digests over 300 cases from 1628 to 1740. It was first published in 1734. Its last edition, designated the third but actually a revised edition of the third, was published in 1747. Our 1741 issue not listed in Sweet & Maxwell. *English Short-Title Catalogue* N42135.


A Brazilian Study That Called for the Abolition of Slavery

Moderate toning and foxing, light soiling to title page and verso of final index leaf. Early owner stamps to title page and a few text leaves, underlining in a few places, interior otherwise clean. \$950.

* Only edition. This study that called for the abolition of slavery was a controversial book when it was published. Its argument is grounded in legal and, to some extent, theological sources. Slavery was abolished when the Second Empire fell in 1888. This is an important date in the history of human rights because Brazil was the last nation in the Western Hemisphere to abolish slavery. OCLC locates 5 copies worldwide, 1 in North America (at UT-Austin). Another copy located at UC-Berkeley Law School. Not in Borchard.



The Book that "Made" the Common Law"



Recent paneled morocco, gilt rules, corner fleurons and central contrasting panels to boards, title to front panel, raised bands and gilt ornaments to spine, endpapers renewed, armorial bookplate (of Charles Gresley Arminger of Lichfield, 1854) mounted to front pastedown. Titles printed within woodcut architectural borders, woodcut decorated initials. Moderate toning, a few leaves have light edgewear, tears or dampstaining, early repair to upper margin of Fol. 1, title page of first part, which is lightly soiled and edgeworn, mounted. Early annotations and underlining in some places, later owner signature (of John Purivand) to head of title page, interior otherwise clean. A nice copy in a notably handsome binding. \$5,000.

* First Tottell edition. Arguably one of the most imposing volumes in the history of English law, Fitzherbert abridged 13,485 cases under 263 titles in alphabetical order. First published in 1514 (or 1516), it was the first serious attempt to arrange the common law in a systematic manner and was a model for such writers as Brooke and Rolle. According to Boersma, Fitzherbert accomplished "nothing less than to abridge all notes of significant cases at common law." A standard work in Great Britain, it was equally important in the American colonies. Thomas Jefferson, for example, owned a copy from 1577. Graham and Heckel refer to this work as the "book that 'made' the common law.": Law Library Journal 51 (1957) 100-101. Beale's record for the second part differs from our copy, which matches that in the ESTC. The most notable difference is that the Beale copy does not include the first 128 leaves of the second part. 





Contemporary vellum, gilt title to spine. Light soling to spine, spine ends bumped, negligible spotting to boards. Woodcut head and tail-pieces. Some toning to text, light foxing and browning in places, internally clean. \$1,500.

* Second and final edition. Gasparro, a Jesuit canon lawyer and member of the Papal Curia, taught criminal and civil law and the University of Rome. Published with Jesuit sponsorship, and notable for its Jesuitical perspective, Gasparro's restatement of Justinian's *Institutes* was a standard text throughout the eighteenth century. First published in 1707, editions appeared as late as 1787. Despite its popularity, all editions of this title are scarce today, especially in North America. Of all editions, OCLC locates 1 copy of the second (at UC-Berkeley Law School) and 2 copies of the first (at Harvard and Stanford Law Schools). Not in the *British Museum Catalogue*.

* This short-lived but well-regarded journal offers excellent insights into the Southern bench and bar at the beginning of the twentieth century. The owner of this bound set, Hamilton was a notable Alabama author and historian.



* Second and final edition of a work first published in 1789. "The oratory of the English bar, [being] wild and vicious," Hortensius seeks to introduce young English lawyers to the superior reasoning and eloquence through annotated examples by classical authors, such as Cicero and Demosthenes, and later authors, such as Milton. Both editions are scarce. OCLC locates 11 copies of the first edition in North American law libraries, 3 of the second (Columbia, Harvard, Osgoode Hall). 




Contemporary sheep, blind fillets to boards, rebacked retaining original spine with raised bands and lettering piece, original endpapers retained. Moderate rubbing to extremities with some wear to corners, some scuffing to boards and evidence of wear to joints and edges of lettering piece, hinges cracked but secure, upper portion lacking from front free endpaper. Some toning to text, darker in places, negligible light foxing to most of text, internally clean. A desirable copy. \$2,200.

* First American edition, designated the seventh on the title page in reference to the prior six editions published in London. This popular layman's guide by one of the most prolific legal writers of eighteenth-century England went through ten English editions between 1736 and 1788. The mention of "All Manner of Persons" in the subtitle is significant. Jacob, though certainly interested in boosting sales by attracting the widest audience possible, was an idealist who believed that widespread knowledge of the law would help create a more just society. This is also evident in his other publications, such as *The Common Law Common-Placed* (1726) and *Treatise of Laws* (1721). According to Cohen, this was the first laymen's guide published in America. The next two, which were intended also for aspiring lawyers, were *The Young Clerk's Magazine* (Philadelphia, 1774) and *The Young Clerk's Vade Mecum* (New York, 1776). Contemporary sheep, blind fillets to boards, lettering piece and blind fillets to spine. Some rubbing to boards and extremities, spine moderately abraded, joints starting at head, offsetting to margins of endleaves, very light browning to text. Early owner signature (of Stephen F. Miller) to front pastedown, interior otherwise clean. \$450.

* Only edition. As a lawyer, judge, author and the state's first law professor, Keyes was the most important figure in the early legal history of Alabama. A prominent secessionist, he was assistant attorney general for the Confederacy during the Civil War. He wrote two treatises, a treatise on real property and the present title, a review of case law as it relates to chattels personal, including "slaves, cattle, furniture, books, victuals, money and the like" (1). 



* Third and final edition, one of (at least) two issues from 1686. Also known as the law merchant, consuetudinary law or, somewhat anachronistically, commercial law, *lex mercatoria* is a system of customary law that developed in Europe during the middle ages to regulate the dealings of mariners and merchants. The earliest significant compilations are the eleventh-century Rules of Oleron, the Laws of Wisby and the Hanseatic Laws of the Sea. Although *lex mercatoria* fell out of use during the seventeenth century, many of its principles were incorporated into the common law. They would later provide the

foundation of the (U.S.) Uniform Commercial Code. Malynes' Consuetudo was the final significant contribution to this field. (Beawes's Lex Mercatoria Rediviva (1752) was an attempt to revive it.) Malynes was a commissioner of trade in the Low Countries and was frequently consulted by the Privy Council during the reigns of Elizabeth and James, a dynamic period of commercial expansion and colonization. He was one of the first writers on business practice, economic affairs and foreign exchange. These interests are explored at length in this collection, both in Malynes's treatise and the texts by Marius, Dassorne, Collins and Liset. This volume also includes a collection of sea laws and two works on international law by Richard Zouch and John Burroughs. These assert the thesis expounded by John Selden in Mare Clausum (1635). Taken together, this volume provides a broad holistic view of lex mercatoria during its final maturity. The first edition was published in 1622, later editions and issues in 1629, 1636, 1656 and 1685. Our 1686 copy, designated the third edition, is one of four variants of the 1686 edition we have examined. The ESTC lists two from 1686, which have somewhat different collations. *Only edition. George Tucker, a cousin of St. George Tucker, was an important Virginian and a notable early American man of letters. He was an attorney, author, educator and politician who served in the Virginia House of Delegates and the U.S. House of Representatives. He wrote the first fictional work set in colonial Virginia and was one of the first Americans to write science fiction. Tucker also published the first comprehensive biography of Thomas Jefferson and a history of the United States. *Essays on Various Subjects* is based on a series of essays, titled *Thoughts of a Hermit*, that were published in the Port Folio, a periodical published in Philadelphia. It also contains the first published versions of the constitution of the State of Deseret and the 1851 Ordinances of General Assembly.
