

* Only edition. Ashe was highly regarded for his treatises and indexes of reporters. His lucidly written treatise on obligations and conditions is an excellent introduction of these aspects of contract law as they existed in the seventeenth-century. The books listed in the Table of Pleadings were printed five and six decades after Thomas Ashe's death in 1618. There is some confusion about the author's identity. The Title page has a stylized T that looks like a J and the epistle is signed "J.A." It is likely that "J.A.", perhaps a relative of the author, was the editor of this book. 

* Final edition. Bonacina was one of the foremost moralists of his age and an influential church official. A fine introduction to his work on law and theology, *Tractatus Tres* was first published in 1622. Other editions followed in 1627, 1625 and 1629. As its subtitle indicates, the first of the three *tractati* discusses the jurisprudence of canon law. The other sections discuss sin and the Ten Commandments from the viewpoints of law and theology. 

* Only edition. One of the most durable concepts in Roman law, *fideicommissum* involves situations in which something is committed to somebody's trust. It is central to the law concerning testators. This treatise by a practicing attorney from Vicenza, reconciles received Roman law with practice in the Republic of Venice. 

* Later edition. First published in 1609, this treatise on the Roman law on the right to use the property of another (usufruct) went through several editions and issues in Italy, Spain, France and Germany. According to the title page, this Venetian imprint has unique additions. Complete in itself, this became the first part of a two-volume set when an additional volume was published by Turrinum in 1646. Castillo Sotomayor was a distinguished Spanish canonist. 



* Second edition. Coke on Littleton, or First Institutes, is one of the cornerstones of the common law and a primary legal text for generations. Several abridgements of this work were produced. Davenport's Synopsis is one of the best. First published in 1651 as An Abridgement of Lord Coke's Commentary on Littleton, its final edition, the third, was published in 1685. 

* Only edition. This book was the first digest of the London's laws and guide to its courts after the revisions of the city laws from 1647 and 1658. A useful work that gathered a great deal of disparate information, it is a valuable resource today for students of seventeenth-century London and its legal system. *English Short-Title Catalogue* R2792.

* First edition. This treatise deals with civil and criminal remedies in Roman, canon and feudal law. Little is known about Costa. The title page identifies him as a highly placed canon lawyer attached to the Vatican. The presence of a portrait frontispiece, with a cartouche bearing his arms, indicates that he was an important man. Costa is not to be confused with the French jurist Jean Lacoste (de la Coste) [1560-1637]. Costa's treatise went thought two later editions in 1629 and 1630. All three are rare. * First edition. This is the first English treatise on sheriffs. As its title suggests, it is a remarkably comprehensive work. 



* Composed in 1448 and revised in 1556, the Vermandois coutume governed much of the Ile-de-France and Picardy, lands that included four of the six French ecclesiastical peerages: the Archbishopric of Rheims, and the Bishoprics of Laon, Chalons and Noyon. Rheims's, which applied to areas beyond ecclesiastical control, was written in 1481 and first published in 1615. The coutume of Chalons, written in 1571, applied also to parts of Vitry and Barrois, that of Vitry-en-Pethois was issued in 1509 and first printed in 1618. 

* Jurisdictione, second and final edition; Opuscula, first edition. This volume collects two scarce titles on Roman law. Gentili, a brother of Alberico Gentili, was an eminent law professor and legal scholar. Held in high esteem all over Europe, his fame probably surpassed that of his brother during his lifetime. As indicated by its title, De Jurisdictione is a study of jurisdiction, more specifically, legal authority and power. Its first edition was published in 1601. Doneau, or Donellus, was a French humanist jurist and scholar. An antagonist of Cujas, his only real peer, he applied the latest philological methods to Roman law and attempted to organize its texts in a systematic fashion. Derived by a manuscript owned by Gentili, Doneau's Opuscula is a collection of writings. Most of these deal with the Codex Justinianus. Later editions were published in 1609, 1766 and 1768. 

* Second edition. Giffen was an important Dutch humanist, philologist, jurist and authority on Roman law who taught at the universities of Altdorf, Ingolstadt and Prague. *Antinomiae Iuris Feudalis* was first published in 1605. It is a collection of 11 essays on feudal law topics, such as inheritance and contracts based, presumably, on earlier research by Olemann. Later editions were published in 1647 and 1666. All are scarce. 

* Third edition, and the final authorial edition. With indexes. Huber was a well-known Dutch jurist and professor at the Universities of Francker, Utrecht and Leyden. He was also a judge in Friesland and the author of numerous legal works on Roman and Roman-Dutch law. He was as important in his day as Grotius, and his work remains influential in South Africa. First published in 1664, *Digressiones Justinianeae* went through eight editions, the final in 1721. More an essay collection than a treatise, it collects his thoughts on a variety of Roman law topics. He also discusses legal pedagogy and the work of his contemporaries and near-contemporaries, such as Grotius and Hobbes. These latter sections are especially interesting because they show what a learned contemporary thought of their work when it was new. 

* Later edition. Written during the reign of Edward IV [1442-1483] and first published around 1481, Littleton's Tenures is probably the most revered treatise in the history of the common law. Much admired for its learning and style, it is concerned with tenures and other issues relating to real property. He is equally important as the first English writer to publish works on jurisprudence. Elementa Jurisprudentiae is an ambitious general study that lays out a general theory of general principles applicable to all branches and systems of legal science. The second, third and fourth parts added for the first time in tis edition, Descriptio Juris et Judicii Sacri; Ad Quam Leges, Quae Religionem, Et Piam Causam Respiciunt, Referuntur, Descriptio Juris & Judicii Militaris; Ad Quam Leges, Quae rem Militarem et Ordinem Personarum and Descriptio Juris et Judicii Maritimi; Ad Quam quae Navigationem et Negotiationem Maritimam Respiciunt, Referuntur are distinct essays on topics in English ecclesiastical law, the laws of war and military discipline and laws concerning ships and sea-borne cargo.
