



* Fourth and final edition. A practical treatise on the canon and Holy-Roman laws governing marriage and divorce and, to some extent, children. It devotes a good deal of attention to reasons for divorce, with an emphasis on adultery. Apparently a well-received work, it was first printed in 1733, with second and third editions in 1738 and 1741.



* Only edition. A study of Brymar vs. Riddell, an unusual Scottish case. While underage, an heiress entered a clandestine marriage. Years later, she married again to an unknowing second husband. After the discovery of the first marriage the sole child from the second faced charges of illegitimacy. Bell's account provides lengthy excerpts from the arguments of counsel, including that of Francis Jeffrey.



* Only edition. A treatise on the moral and theological justifications for, and legal consequences of, divorce or separation. Like Milton, the Earl of Warrington believed that divorces should be granted for spousal incompatibility. He was not a disinterested scholar. A contemporary, "Philip Bliss, in a manuscript note in a copy of Walpole's Royal and Noble Authors," says Warrington and his wife "lived in the same house as absolute strangers to each other at bed and board."

Light toning to interior, light foxing to margins in a few places, slight creasing to a few leaves, occasional underlining, brief notes to margins and manuscript page numbers in pencil, manuscript table of contents tipped onto inner rear wrapper. * Second edition. The Crawford divorce case concerned a series of affairs carried on by Sir Charles Dilke [1843-1911], an MP and prominent member of the Liberal Party. In addition to an affair with Ellen Smith, wife of a Liberal politician and the mother-in-law of Dilke's brother, he was accused of seducing Smith's nineteen-year-old daughter Virginia and continuing the affair after she was married. Virginia's husband, Donald Crawford, sued for divorce with Dilke as a party to the suit. This trial resulted in a decree nisi for the Crawfords but an unclear verdict on Dilke's responsibility for the affair. Dilke sought to reopen the case in order to clear his name, with devastating consequences—he was humiliated in court and the flood of subsequent accusations of adultery ended his political career. Our account, sympathetic to Dilke, appears to have gone through at least five editions with the fifth appearing in 1887.

OCLC and Library Hub locate 5 physical copies of all editions worldwide and no physical copies of the second edition; we located 1 at the University of Minnesota Law School.



* Divorce: first edition; Impotency: third edition. A notorious Grub-Street publisher, Curll specialized in salacious and otherwise offensive material. He is remembered today as the nemesis of Alexander Pope. Case of Divorce, an anonymous work, offers salacious accounts of five notable seventeenth and eighteenth-century divorces proceedings involving members of the aristocracy for such causes as adultery, impotence and bigamy. The final section is a collection of documents on the "dissolution of marriage," many of them concerning impotence. Bound to our copy is the first volume of The Case for Impotency, which contains the case of Robert, Earl of Essex, and Lady Frances Howard.



* Only edition. This collection of pleadings (with background histories) suggests that Érard specialized in cases asserting the power of husbands and fathers. He seemed to have a particular talent for prosecuting aristocratic women for wayward behavior. Érard's presentation at the famous divorce of the Duc de Mazarin and his wife, Hortense Mancini, is probably the best-known example of his work. Hortense had been one of the mistresses of the English King Charles II before entering into an unhappy marriage with the bizarre Duc de Mazarin, whose extreme jealously and psychosexual oddities compelled her to flee to Rome and later England, an estrangement that lasted nearly 20 years, a period in which she conducted numerous affairs, a few with women.

* Only edition, one of two issues, the other issued the same year as a folio. Submitted as an academic thesis, this work is a detailed commentary on the sections on matrimonial law in Book IV of the *Decretals* of Gregory IX, one of the four works known collectively as the *Corpus Juris Canonici*. Among the topics discussed are marriage contracts, child marriage, bigamy, consanguinity and reasons for annulment, such as non-consummation. Unlike the typical thesis of the era, which is brief and confined to a single, well-defined topic, this work is broad and comprehensive.



* Only edition. This treatise explores marriage and the legal status and matrimonial responsibilities of women under Roman law. Grupen was a notable legal scholar and historian who served as an advisor to the House of Hanover. He had a particular interest in Woman and issues relating to marriage. His publications include *De Uxore Theoretica* (1748) and *Tractatio Iuridica de Virgine* (1716).





* One of two 1822 issues. This fascinating account of international marital customs covers nations and territories from the South Sea Islands to California, spanning almost every continent. Lady Hamilton likely traveled herself given her husband's extensive military service, but draws primarily on accounts "collected from the labors of enlightened travelers and navigators" such as Lady Mary Wortley Montague and Lewis and Clark (iv). The work concludes with a brief summary of English law respecting marriage.

* This book records the marriage service of Richard Tracy Stevens [1865-1941] and Georgiana Schanck Hand [1872-1965]. Georgiana was a cousin by marriage of Learned Hand, whose signature appears on the third page of witnesses. Also present is the signature of his cousin, Augustus Noble Hand [1869-1954], a New York judge who served on the District and Circuit courts. An interesting piece of Americana with a notable association.



* The Duke of Norfolk had previously sought to divorce his wife, Mary Mordaunt, in 1692 by private bill, but had been rejected by the House of Lords. His second try was successful and was one of the earliest divorces to be granted by Parliament rather than the ecclesiastical courts. Our broadside, sympathetic to the Duke, lays out the evidence supporting his wife's adultery and urges Parliament to grant the divorce.

* First editions. Collected by a German lawyer, these are collections of erotic texts presented as historical and legal studies. The first addresses virginity, the second discusses adultery and prostitution. Both offer fascinating, and often fantastical, content concerning love, sex, women and marriage laced with references to astrology, popular folklore, magic, superstition, history and classical authors.

Sibylla has two dedications. The first is to Kornmann's patron, Georg von Hatzfeld, the second to Juliana Morell [1594-1653], a Spanish Dominican nun and intellectual child prodigy who was the first woman to receive a university degree. Usually bound together by contemporary owners, Sibylla and Linea Amoris were originally issued separately. They were published together in subsequent editions. Popular works, they were reissued, and republished with other titles, well into the eighteenth century. Enjoyable as works of curiosa, they are also valuable for their insights into early-modern legal discourses on sexual, gender and family issues.

* Only editions. The author was a distinguished jurist and professor of civil, canon and criminal law at the University of Padua. *Apophtegmata* is a collection of maxims on, to use a modern term, family law. Most of these address marriage and inheritance. The maxims are accompanied by commentary, some of it topical, as in Apoph. 3, which refers to the struggle of Henry VIII and the pope. Other entries refer to the problems of a Paduan colleague (Apoph. 16) and abortion (Apoph. 187). The second work is a brief treatise on the legal status of children and young people (fourteen years old and under) in Padua. It does not have the errata on p. 80 present in some copies and may represent an earlier issue.





* Researchers interested in social rituals and letter-writing customs of America in the early 20th century will be engrossed by this archive. Hartshorne and Sahlin's courtship and early years of marriage and parenthood coincided with the U.S. entry into World War I, the 1920s and the financial disaster of 1929. A graduate of Wellesley College, Sahlin worked as an interior designer for a firm in New York City. Hartshorne, a graduate of Princeton and Columbia Law School of Law, enlisted in the Navy and was stationed on the Eastern seaboard during the war. After his tour of service, he advanced professionally in various legal firms and was a judge of the United States District Court for the District of New Jersey from 1951 to 1961 and a senior judge of that court from 1961 to the end of his life. Both came from renowned families. The Hartshornes were among the earliest settlers in New Jersey. Known for their probity, several Hartshornes served in judicial and legislative posts. Ellen's father, uncle and brother played important roles in the steel industry in the United States and India.

Although they were strong-willed, well-educated, career-oriented, individuals from pedigreed families, the still faced their share of challenges. For example, Hartshorne, while a naval ensign, had issues with senior officers. Sahlin mentioned her struggles with difficult clients. Several letters from Hartshorne and Sahlin include whimsical drawings. If there is a lesson in this archive, it is related to the importance of having an extensive circle of family and friends to draw upon during difficult times. As the family expanded, and the household fractured to accommodate Hartshone's work obligations, the couple received vital information and advice from others, especially from Ellen's "devoted brother," Bob. This support was important when Sahlin was hospitalized for the birth of her children and when Hartshorne fell into depression in 1927.

Several letters from well-wishers received upon their engagement provide examples of the manner in which the couple managed their social networks. The engagement announcement, for example, was sent to circles of intimates and acquaintances in ever-widening waves of correspondence and public notices. For months following, responses arrived from Connecticut, Massachusetts, New Jersey, New York, Ohio and Pennsylvania as well as from Belgium, France and Sweden. Besides the congratulatory remarks, there were many promises of future visits and renewals of friendship as the couple began a new phase of their lives.



* This manuscript appears to be a fair copy of two works by Catholic theologian Peter (or Pierre) Dens: *Tractatus de Sponsalibus et Matrimonio* and *Tractatus de Quatuor Novissimis*. The first, an extensive treatise on Catholic marriages in canon law, was published after Dens's death in 1775. The shorter *Tractatus de Quatuor Novissimis* was published in 1776 and again in 1790 with *De Sponsalibus*. It concerns "the four last things," i.e. death, judgment, heaven and hell, the final stages of the soul in Christian eschatology. Both treatises were highly regarded, with the final edition of *De Sponsalibus* appearing in 1894 and the final edition of *De Quatuor Novissimis* in 1864.

The first portion of the manuscript (*Tractatus de Sponsalibus et Matrimoniis*) has a completion date of 15 July 1767. The second part (*Tractatus de Quatuor Novissimis*) was completed on 14 October 1768. The transcriber is unnamed but may be the "V. Rymenant" noted on the spine label. The text is similar to the printed versions in organization and content, but has many differences of varying degrees and includes text not in the printed versions. It may represent an early version of Dens's work as taught to his students in theology at the University of Louvain, where he was a professor from 1723 until his death. Editions of both treatises are scarce in print.

* This is a personal copy of a law-degree thesis on woman and marriage according to Roman law and the laws of prerevolutionary and contemporary France. Its author, Dossat, was born and probably educated in Grenoble. He had a successful legal career, first as a lawyer in Bordeaux and later as a judge in Annecy. He appeared to have a deep interest in the legal status of women. In 1872, he delivered an address at the opening session of the Bordeaux Court of Appeals titled De l'Emancipation de la Femme, which was published (Bordeaux: G. Gounnouihou, 1872).



* Two almost stream-of-consciousness letters concerning Ober's contentious divorce from his wife. Ober's handsome penmanship is a stark contrast to his poor spelling, lack of punctuation and obviously anxious mental state. (Ober's spelling and sentence construction also suggests that German may be his native language.) Ober's letter of March 11 is an unleashed flood of words: "Sir I have the honor To inform you about the Notification To Appear befor the Court in Lawrenceburg [Dearborn County, Indiana] i got. Twice Notified now by Attorney Holman to appear the 10th of March and 24th April at 9 O'Clock. A.M. at Court Room in Lawrenceburg and i can't see my Wife or some of Parents nor of her Attorney's i see she tried to give me expenses to runn me Back and Forward my Wife and the familie Left me and Promised me her Little girl to cook my crop... She want to gve me the Divorce on Account to Collect the five hundred Dollars \$500 which i Loaned her father all the Charges are Lies except hard Words and der [there] i give you a Statement about does [those] words She Smashed the Buckey [buggy] and ruined the Horse She came Home in the Evening vitout [without] a Buckey nor Horse that on one Sunday and several other cases and i Notify that i never will Pay nothing about my wife so long She will Stay outside my House...i Married that woman not on Account her good Look or about her Money because it got none around the intire Familie want to get my Money I took her for to doe My work and to Live Still togeter [together]..."

Ober's second letter appears to assume the form of a personal, rather than court-issued, summons to appear in court. He seems to be reconciled to the divorce. The letter may be addressed to his attorneys, Holman and Schwartz, likely former (and future) Congressman William S. Holman and former mayor of Lawrenceburg and Bavarian immigrant, John Schwartz: "Sir i have the honor to inform you to be Notified to appear befor the court in Lawrenceburg throuh you the 12the of May 1880 to anwser [answer] the question about those charges those Charges are wrong Cruel treatment i never raised my Hand toward my Wife and Neglect for Providing necessairy Care or Treatment...so Mister Holman and Schwartz i wish you will finish the Divorce case to receive the Divorce From my Wife i been praieing [praying] and Talken to her to come Back shee wouldned [wouldn't] doed [do it] She want allways my Money and Put me Now in so deep expences and Shee Brought not one cent in the Marriage so is my will and wish to tak [take] the Divorce from her because we can Live any more Peacefull together [together]... " It appears that Anthony Ober wants out, at any cost.

* Third and final edition. The Marriage Law Reform Association was incorporated in 1851 as opposition to Lord Lyndhurst's Marriage Act of 1835 grew. The Act prohibited the marriage of a widower to his deceased wife's sister, reflecting Victorian anxieties around incest, family purity and the role of the church. Despite the Association's long campaign, the Act was not repealed until the Deceased Wife's Sister's Marriage Act in 1907.





The main text is preceded by a series of brief essays on miscellaneous unrelated topics. One of them discusses the opinions of Aristotle and other classical authorities concerning the use of cosmetics.





* Later edition. First published in 1614 after being circulated in manuscript during his lifetime, Overbury's poem A Wife discusses the ideal virtues a man should demand of a prospective wife. It was written in response to what he deemed to be a rash marriage by a friend, Robert Carr, who intended to marry a woman from a powerful and influential family. The poem and the subsequent backlash caused so much intrigue that James I tried to remove Overbury from court by offering him an ambassadorship; Overbury refused and was imprisoned in the Tower of London, where he died. An investigation into the circumstances of his death led by Coke and Bacon concluded that he had been poisoned and that James had been aware of the murder.

* First edition. The first American treatise on family law, Reeve's Law of Baron and Femme is a restatement of Blackstone's Commentaries, Book I, Chapters XIV-XVII. It rejects some of the fundamental doctrines of the common law, most notably coverture. As Blackstone puts it, "the husband and wife are one person in law; that is, the very being or legal existence of the woman is suspended during marriage." Reeve says the opposite. A prescriptive work, Baron and Femme aimed to liberalize the American law of domestic relations, arguing, for example, that married women were permitted to make wills, a point contradicted by the contemporary statute and case law of Connecticut and several other states.

* First edition. An interesting treatise on marriage in canon, Germanic, feudal, Roman and Roman-Dutch law. Educated at the Universities and Utrecht, Rodenburg was a state official and a canon of Saint Peter's Church in Utrecht. His *Tractatus de Jure Conjugum* is an interesting comparative treatise on marriage in canon, customary, Roman and Roman-Dutch law. A practical work, Rodenburg pays particular attention to conflicts between these different systems. Two more editions were published in 1676 and another in 1699.



This is an ambiguous scene. The husband, who appears somewhat smug, is significantly older than the wife, who looks rather sad. The barrister appears skeptical. Does the bride regret her choice to marry for money? Was she compelled to enter this union? Is the husband a dying man?



* Later edition. A scarce edition of Selden's work on the laws of Jewish marriage and divorce, applying his more general theory of natural law, and approaching the views of Milton. It was first published in 1646. Speaking of this and other works dealing with Jewish customs the DNB says "[his] acquaintance with the original of the Old Testament and the ancient versions and commentaries which all these works display is very great. Their author's familiarity with rabbinical literature was such as has been acquired by few non-Israelite scholars; and many details of oriental civilisation and antiquities were certainly brought to the knowledge of Europeans for the first time in them" (DNB). Despite the importance of this work it was not translated into English until 1991.



* Only edition. An interesting case that involved the conflict of English and Scottish divorce law, Gordon v. Pye held that a Scottish court did not have the power to dissolve the marriage of two English subjects who married in England and were currently living there. It is one of a group of Scottish cases cited by Story in his discussion of marriage in Commentaries on the Conflict of Laws (1834).





* Only edition. In 1880, Christopher Newman Hall, a minister who had gained fame in Britain and the United States with his tract *Come to Jesus* (1848), accused his wife Charlotte of adultery with a friend of the couple. She denied the accusations and accused him of infidelity in turn. The couple was not particularly compatible; Charlotte was a free spirit who loved to hunt and smoke, habits her husband despised on moral grounds. Newman Hall's high profile and the humor of much of the testimony made the trial a raucous affair, with frequent bursts of laughter from witnesses to the despair of the judge. Newman Hall ultimately succeeded in obtaining a decree nisi and remarried later that year.

This is a rare title. No physical copies listed on OCLC or Library Hub. We located a copy at Indiana University.





* Only edition. The colorful duchess is said to have been the basis for William Thackeray's character of Beatrice in Esmond and of the Baroness Bernstein in The Virginians and was also ridiculed in a play that she tried to legally suppress, The Capuchin. Prone to romantic entanglements and scandals, she had many lovers, and it is said that George II was one of many to be swayed by her charms. When she determined to marry the Duke of Kingston, Elizabeth feared the scandal of divorce from her first husband, Augustus Hervey, later Earl of Bristol, who wanted a divorce, so she instituted a suit of jactitation against him. His negative response ignored, she took an oath that she was unmarried, and the court so declared her. She married the Duke of Kingston in 1769, and he died in 1770 and left her a substantial estate on the condition that she remain a widow. The duke's nephew, Mr. Evelyn Meadow, brought suit against her for bigamy shortly after the duke's death, while she was traveling in Italy. She returned to England to stand trial. Found guilty, she would have been "burned on the hand" but she claimed the privilege of her peerage which served to exempt her from corporal punishment. She continued a life of travel and adventure until her sudden death in Paris in 1788.



* Third (stated) edition. The Welds married in 1727, but when there was no issue after three years, Catherine sued Edward for divorce in ecclesiastical court on the grounds that he was "unable to perform the Conjugal Rites, by Reason of some natural Imperfection which he well knew in himself." Edward fought to clear his name, claiming that after a simple surgical procedure he had, in fact, consummated the marriage twice. The case gained a great deal of public attention, largely because the detail of Catherine's claim and the amount of medical evidence presented were unusual even for an impotency trial. Ultimately, the divorce was denied and the couple reached a private resolution to live apart. Edward remarried after Catherine's death and fathered a daughter and four sons. It is unclear why our copy is designated the third edition. It appears to be based on an account issued by E. Raynor, which went through five editions and two Dublin reprints, all in 1732.



* Only edition. An account of one of the sensational trials of the early 1850s. Wikoff, or as he called himself, Chevalier Wikoff, was an American impresario, occasional European correspondent for the *New York Herald* and, possibly, a spy for Lord Palmerston. He was engaged to Jane Catherine Gamble, an English woman. Gamble changed her mind shortly before the wedding and fled to Genoa. Wikoff tracked her down and apparently tricked her into coming along with him to his apartment. Shortly afterwards Gamble filed a complaint of kidnapping that landed Wikoff in an Italian jail for 15 months. He was found guilty in an Italian court and forced to return her letters and "extorted promise of marriage." Ever enterprising, Wikoff responded to the negative publicity with a memoir entitled *My Courtship and Its Consequences* (1855), which became a best-seller.

Copies of *The Trial of Wikoff* are scarce. OCLC locates 7 worldwide: 2 in the British Library and 5 in North American law libraries (Harvard, Library of Congress, University of Georgia, University of Minnesota, University of Pennsylvania).



In 1785 George, the Prince of Wales and the future King George IV contracted an illegal marriage in secret with Maria Anne Fitzherbert, a Catholic commoner. (It violated the Bill of Rights and the 1701 Act of Settlement). King George III compelled the prince to leave her in 1794 to marry Duchess Caroline of Brunswick, but he continued his relationship with her (with some periods of estrangement). These items are part of a pamphlet war that grew out of a libel trial that resulted from Withers's public exposure of the clandestine marriage.






