


Contemporary limp vellum (colored green) with yapp edges, later gilt ornaments to spine, ties lacking. Rubbing to boards and extremities, some wrinkling to corners, minor worming to front board, small chip to front joint, spine ends bumped, corners worn, hinges cracked, front pastedown renewed, other endleaves lacking. Large woodcut printer device to title page, woodcut decorated initials, head-pieces and tail-pieces. Moderate toning to text, a bit heavier in places, occasional faint dampstaining, early annotations to a few leaves. An appealing copy. \$1,500.

\* Second edition. Agustin, a Spanish cleric and jurist, was Archbishop of Tarragona. He was a leading member of the group of antiquarians in mid-sixteenth century Rome who were involved in the study of ancient Roman institutions. First published in 1583, *De Legibus* is a dictionary of Roman law with an emphasis on legislation. The final section, a set of plates preceded by a half-title reading *Leges et Senatusconsulta Quae in Veteribus cum ex Lapide tum ex Aere Monumentis Reperiuntur*, is a collection of transcribed documents. *De Legibus* went through four editions, the last in 1694. All editions are scarce. OCLC locates 4 copies of the second edition in North America (Emory Theological Seminary, Library of Congress, St. Louis University, University of King's College, Nova Scotia). Contemporary calf with later varnishing, blind rules and small central arabesques to boards, raised bands and later lettering piece to spine, spine ends and corners mended. Some scuffing to boards, corners bumped, front joint partially cracked, front hinge just starting, rear hinge mended, later armorial bookplate to front pastedown. \* Only edition. Asinio was a notable Florentine jurist who was patronized by Cosimo I de Medici. He is best-known for his treatises on practice and procedure in Roman and Florentine law. *De Executionibus* is a comprehensive treatise on the section of the *Digest*, Book XI, Title 7, which addresses funeral rites and burial. It is a scarce title. Some soiling, especially to spine, minor wear to corners, some worming to pastedowns and endleaves, a few partial cracks to text block, boards slightly bowed. Some toning to text, light foxing in places. \* Later edition of a work first published in 1511. Tractatus Foecundus is concerned with the Roman law of prescription, the principle whereby a right or liability is created or extinguished over a certain period of time, usually in regard to a property title. It also includes an edition of a short treatise on this subject by Henricus de Segusio. It was a popular work that went through several issues and editions, the last one in 1582. Our 1564 copy was also issued in 1563. Both are identical in every respect and share the same entry number in EDIT16. All editions are scarce in North America. \* Later editions. Baudouin was an eminent French humanist jurist and theologian. Interested in the early history of Roman law, he emphasized the importance of history in the development of the law. This volume collects two of his principal works, *De Legibus XII Tabularum*, a study of the history and significance of the Twelve Tables, and *Commentarius de Iurisprudentia Muciana*, a study of Roman law during the Republic. 

- \* I. Remembered today as the author of the moral and satirical Narrenschiff (The Ship of Fools), Brant was also a highly regarded law professor and state official. First published in 1490, and Brant's only original legal work, Expositiones was a popular, highly regarded introduction to the Corpus Juris Canonici and Corpus Juris Civilis. According to Stintzing-Landsberg, it is a useful guide to contemporary legal pedagogy in the Holy Roman Empire. Our edition also includes an equally renowned introductory textbook that Brant held in high regard: Caccialupi's Tractatus de Modo Studendi in Utroque Iure, which offers a basic history and outline of Europe's legal systems and advice on study methods. - II. First edition. Probably compiled by a law student or layman, In Utriusque Juris Libros Introductorium is an anthology of works by two great late-medieval jurists. It includes, among other titles, the Modus Legendi Abbreviaturas, a dictionary of abbreviations, the Ars Notariatus, a handbook on legal drafting, and Flores Legum is a collection of maxims. It also includes, perhaps as a warning, the Processus Sathana Infernalis Contra Genus Humanum, a legalistic account of Judgment Day (Satan as prosecutor). A popular work, it went through several editions during the sixteenth century. All are rare today. OCLC locates 5 copies, 1 in North America (Harvard Law School). \* First edition. Choppin (or Chopin) was a French jurist and an avocat of the Parlement of Paris. Like Jean Bacquet and Jean Bodin, Choppin drew on Roman law and feudal principles to advocate a centralized state under royal rule. De Privilegiis Rusticorum addresses legal privileges enjoyed by rural people in Roman and civil law, such as access to uncultivated land. A well-written and remarkably comprehensive work, it went through seven subsequent editions in Latin. Its final edition, translated into French, was published in 1634. This was a rarely explored topic, and Choppin's treatise is the only early example we have encountered. According to the Biographie Universelle, "it deserves notice for the singularity of its subject, for its profound research, and the decisions it contains" (8:499). \* Third edition. Cipolla was a professor of law at the University of Padua, Venetian diplomat and one of the greatest Italian Jurists of the fifteenth century. His works are notable for their humanistic scholarship and coordination of theoretical and practical concerns. *Tractatus Memoriaque* is a collection of seven essays on servitudes, real property and related topics in Roman and canon law. It is a collection based on titles that circulated in manuscript and the early printed era. The first edition in its final, seven-essay form appeared in 1511. It was issued several times into the sixteenth century. All editions are scarce. OCLC locates no copies of the 1525 imprint in North America. This edition not in Adams. Order This Item



\* Second edition. With indexes. First published in 1565, this popular work on wills, gifts, feudal writs, usury and other topics in Roman criminal and civil law went through numerous editions throughout Europe well into the eighteenth century. These four tracts were books 3-4 of the author's unfinished Sententiae Receptae. Claro was a Milanese jurist. OCLC and KVK locate one copy of this edition in North America (at the Library of Congress). Another copy located at Harvard Law School. This edition not in Adams. \* First edition. Coler, a professor at the Universities of Jena and Leipzig and chancellor to the prince of Anhalt, was a renowned authority on civil law. *Tractatus de Processibus Executivas* addresses executions, exceptions and the limitation of actions under canon law and the civil law of Saxony. It went through five more editions, the last one in 1718. All editions of this title are scarce. 

\* Only edition (in this form), one of two issues from 1573 (the other, with identical format and collation, printed by Pierre Landry). This volume collects three notable canon-law treatises dealing with ecclesiastical patronage. All three were published previously, but our copy appears to be the only one to collect all three. \* Third edition. First published in 1544, this is a comprehensive treatise on the law of guardian and ward. Like Damhouder's works on civil and criminal law, *Pupillorum Patrocinium* has plates that illustrate points in the text. One depicts three young orphans with their guardian, tutor, godfather, conservator and executor before a magistrate, facing preface. Other plates depict situations in later stages of life, such as a guardian introducing a child to a teacher, the guardian and child at a shoemaker's shop and the guardian making a record of his charge's assets with an accountant. This edition incorporates two other works. *De Magnificentia Policiae Amplissimae Civitatis Brugarum*, first published in 1544, is a political and sociological study of Bruges. It is illustrated with a folding plan of the city. *Subhastationum Compendiosa Exegesis*, first published in 1546, is a brief treatise on public sales. It has an illustration of an auction scene. This is believed to be the first depiction of an auction to appear in a book. \* Only edition. This treatise analyzes benefit of inventory, a concept in Roman (and civil) law concerning an heir's right to commission a legally binding inventory of his ancestor's estate for representatives of the estate's creditors. It also concerns the right to limit debts and legacies to the amount of three fourths of an estate, thus preserving one fourth for the heir. 

\* Only edition. Ferretti was a member of the College of Jurisconsults during the papacy of Clement VII [1478-1534]. This volume collects 31 of his canon-law consilia (analyses of disputed legal points, usually submitted by a judge). This volume was reissued in 1563. OCLC locates 3 copies of this imprint, 5 of the 1563 reissue. \* Second edition. Gail was a German judge and legal scholar. First published in 1578, this book deals with executions of contracts and pledges under the laws of the Holy Roman Empire. 

\* Only edition. Commissioned by the Emperor Theodosius II in 429 CE, the *Codex* is an official compilation of all laws enacted since the reign of Constantine. Completed in 438 CE, and ratified that year by the Senate, it was the standard legal text of the empire, one that superseded all earlier codes. It would later exert enormous influence on the legal systems of the Barbarians who conquered the Western Empire. The first part, Books 1-8, was lost after the fall of empire and it was reconstructed by later scholars from sections preserved in later sources, most notably the Visigothic Code (*Lex Romana Visigothorum*). The first part in Du Tillet's edition presents the pieces of Books 1-8 in the Visigothic Code. The second part, which has its own title page, contains the rest of the *Codex*, Books 9-16. A French humanist jurist and associate of Cujas, Du Tillet was also the Bishop of Brieuc, later Meaux. He edited Ulpian's *Regulae* and assisted Cujas with his edition of the *Codex Theodosianus*. 

\* First edition. Commissioned by the Emperor Justinian in 530 CE, the body of writings known collectively as the Corpus Juris Civilis preserved and restated all existing Roman law. It has four books: the Code, Novels, Institutes and Digest. Intended for students, the Institutes is a synopsis of the reformed legal system. It supplanted the earlier Institutes of Gaius. Vultejus was a notable legal scholar and professor at the University of Marburg, where he also taught Greek. In later years he served as a diplomat and was raised to the nobility by Holy Roman Emperor Ferdinand II. In Institutiones Iuris Civilis is an extensive article-by-article commentary on the Institutes. It was a work of authority that went through five later editions, the last one in 1630. 




