

* D'Andrea was an Italian canonist and professor of canon law at the University of Bologna. An eminent figure who received the highest tributes from Arithemius, Baldus, Forster and Bellarmin, his principal writings circulated widely in manuscript and were among the earliest printed works on canon law. Often included in editions of the *Corpus Juris Canonici*, the *Super Arboribus* is a fundamental treatise on degrees of consanguinity and affinity, also known as blood relations, and spiritual relationships created by godparents and their families. It was a work of vital importance in cases regarding estates, incest and conflicts of interest. It went through numerous manuscript and printed editions into the modern era. Our 1483 imprint is the sixteenth of seventeen issued by Creussner. The three woodcuts are so much larger than the type-pages that many, if not most, copies are trimmed to some degree. OCLC locates 6 copies, none in North America. The ISTC locates 1 copy in North America, at the Huntington Library. Goff locates copies at the Huntington Library and the Collegiate-Rochester Divinity School, Rochester, NY (which is no longer in its collection). We did not locate copies in the Library of Congress, Harvard, the UC-Berkeley Robbins Collection or the British Museum. 

* Only edition. This is an anti-prohibition tract in the form of fictional autobiography by "Anonymous," a recently retired bootlegger. Anonymous ends his book with a four-point argument that demonstrates why Prohibition will never be repealed. That's okay, writes Anonymous, because "Prohibition made me a million dollars. If it had not been for [the prohibitionists and prohibition laws] I would be running a little beer saloon in a small town" (230). As indicated by the enclosed letters, this book was written by Kauffman, a notable author, novelist, screenwriter, editor and journalist. A Harvard graduate, he began his career as a journalist during World War I and later served as an editorial columnist for the *Washington Post*, the *Boston Transcript*, and, from 1934 to 1947, the *Bangor Daily News*. The first letter is from the librarian of the *Bangor Public Library*. It was sent along with this book to Kauffman. The librarian describes how he was able to locate a copy and encourages him to reveal his identity to the Library of Congress. The other two are from the Library of Congress. One acknowledges that the book's copyright is now registered to Kauffman. The other, with an enclosed catalogue card, shows that the book has been re-catalogued under his name. Order This Item





* First edition. Bachofen, a founder of the German Historical School, is best-known as the author of *Das Mutterrecht* (1861), a ground-breaking history of the family as a social institution. * From an edition limited to 750 copies, this copy not numbered or its illustrations colored. Hémard presents Balzac's 1825 study of rogues (*fripons*), described for the benefit of "decent people," with witty color pochoir illustrations. Hémard, a prolific artist, illustrator, designer and author, is best-known for his illustrated editions of serious non-fiction books, most notably the French penal code, tax code and civil code, book one. 

* Only American edition and the only abridgement of a legal treatise printed in America before the Revolution. Richard Burn was an attorney and antiquarian who edited the ninth, tenth, and eleventh editions of Blackstone's *Commentaries.* His *Justice of the Peace, and Parish Officer* (1755) was perhaps his most important work. Holdsworth considered it to be one of the best treatments of the subject, an opinion shared by Burn's contemporaries, both in England and in the colonies. The "best proof that his book...was accepted as the leading text-book on that topic is the number of editions through which it passed.... It deserved its success. Burn carefully abridged the statutes, and stated the manner in which their clauses had been interpreted by the courts. His treatment of the criminal law was based upon a thorough study of the works of Coke, Hale, and Hawkins." Greenleaf explains the nature of his abridgement in the preface: "The London edition takes in the whole practice of England and Scotland, this renders it both bulky and dear. The circle of a justices business in those places is vastly extensive, and is founded chiefly on acts of the British parliament, which can never have any relation to this colony" [i]. * First Koberger editions. This volume joins incunable imprints of two books from the Corpus Juris Canonici, a collective title first used in 1441. The Liber Sextus Decretalium was issued in 1298, the Liber Septimus Decretalium, better known as the Constitutiones Clementis V, or Clementinae in 1317. These, along with the other books, were edited in 1582 in response to the reforms authorized by the Council of Trent. In this form the Corpus Juris Canonici remained in force until it was replaced in 1917 by the Codex Juris Canonici. The 1482 Koberger imprint of the Clementinae is typographically important because it was the first book printed with Koberger's text-type 92 and commentary-type 65. Ernest Kyriss [1881-1974] was a leading collector and scholar of incunabula. His Verzierte Gotische Einbände im Alten deutschen Sprachgebiet is a standard work on early German bindings. 

* Doneau: first edition; Pinhel: later edition. Doneau was a French humanist jurist and scholar. A worthy antagonist of Cujas, he applied the latest philological methods to Roman law and attempted to organize its texts in a systematic fashion. A staunch Calvinist, he fled France after the St. Bartholomew's Night Massacre. He went on to become a professor at the Universities of Heidelberg and Leiden, where his teaching and numerous studies made a tremendous contribution to the promotion of Roman law in the Netherlands. *Commentarii ad Titulum Digestorum de Verborum Obligationibus* is one of his principal works. It is a treatise on Book 45 of Justinian's *Digest*, which deals with contracts and other obligations. Later editions were published in 1599 and 1622. Our copy is bound to Pinhel's distinguished commentary on Book VI, Title 60 of Justinian's *Code*, which addresses the inheritance and succession of maternal property (or property through a family's maternal side). It also considers this topic according to Spanish and Portuguese civil law. Originally published in 1557, it went through several issues and editions throughout Europe, the final published in Frankfurt in 1614. Neither imprint listed in Adams. <u>Order This Item</u>

* Later edition. First published in 1516, this was a leading treatise on the interpretation and construction of Roman law. It went through several editions into the mid-seventeenth century. Everaerts, an important legal humanist, was president of the Court of Holland and the Great Council of Mechlin. According to Walker, he was the "leading Dutch jurist of his time [and] one of the earliest authorities on Roman-Dutch law." Our 1587 edition has a summary by Legge and an introduction by the notable French jurist Pardoux. All editions are scarce. 

* L'Esprit: later edition; Commentaire: third edition. Montesquieu's classic study of the English Constitution and the most important commentary on that work were acquired during a trip to Paris by Stephen Johnson Field, then a lawyer about to move to California. Following the Gold Rush to California in 1848, Field served in local government, the California's state legislature and the Supreme Court of California, He was the principal draftsman of the 1851 California Practice Act. Appointed to the United States Supreme Court in 1863, he remained on the bench until 1897. One of the great justices of the nineteenth century, he had a lasting influence on Constitutional law through his contributions to Fourteenth Amendment jurisprudence and its Due Process Clause. Someone tried to remove Field's book tickets and erase his signatures, but almost all of the tickets and signatures remain. A letter offering these books to a client from San Francisco bookseller Warren R. Howell laid in to Volume I of *De L'Esprit des Lois*. Order This Item



* Second edition, a reissue of the first edition (1727) with an altered titlepage and a preliminary advertisement leaf. This was the first textbook on equity published since St. Germain's *Doctor and Student* (1523). It is generally considered to be the book that founded the field of equity jurisprudence. Francis outlines fourteen maxims, such as "Equality is Equity" and "Equity suffers not a right to be without a remedy." Each maxim is followed by a brief summary of cases that illustrate its application. As Roscoe Pound observed, Francis created a precursor to the casebook: "his maxims for the most part are independent attempts to state principles derived from the study of cases.": Pound, "On Certain Maxims of Equity" in *Cambridge Legal Essays* 261-262. *English Short-Title Catalogue* T118767. 

* First edition of the first complete translation in English. First published in Paris in 1625, *The Rights of War and Peace* established the system of modern public international law, based on the concept of "*droit naturel*," a morality-based law that superseded the personalities of individuals or nations. Grotius describes the situations in which war is a valid tool of law enforcement and outlines the principles of armed combat. Though based on Christian natural law, Grotius advanced the novel argument that his system would still be valid if it lacked a divine basis. In this regard he pointed to the future by moving international law in a secular direction. The first English edition, an abridged translation by Clement Barksdale, was published in London in 1654. It was reissued twice in 1655. This translation by Evats, which includes original notes, followed in 1682. These early English translations, both by Oxford-based theologians, mark an important phase in the reception history of this book. These projects were undertaken due to the author's reputation as a leading Protestant scholar and a faith-motivated desire to reduce international conflict. *English Short-Title Catalogue* R8527. 

* First edition in French. With side-notes and index. The first edition, in Latin, was published in Paris 1625. The first French-language edition is scarce. 





Henry Hunt, the radical politician, had presided over the Smithfield reform meeting on 21 July 1819, and at the meeting in St. Peter's Fields, Manchester, on 16 August, which was broken up by the yeomanry, and became known as the Peterloo Massacre. Hunt was tried at the York Assizes, in March 1 820, for his part in the protest, and was convicted. He spent his two-year term at Ilchester Gaol. The report of the Commission of Inquiry into Ilchester Gaol, instigated because of Hunt's complaints, provides a vivid portrait of the corruption, health hazards and horrifying regimes in place in local prisons in the early years of the nineteenth century. Hunt leveled 21 charges against Bridle, the gaoler. These included gross neglect of duty, drunkenness, gambling, cruelty, torture, bribery, embezzlement, false accounting, "licentious conduct towards female convicts (Bridle was suspected of fathering children with two of them), not feeding inmates properly, and for "making boys sleep with a man convicted of beastiality". It was Hunt himself who examined the witnesses and principals involved.

The plates by Robert Cruikshank are mock portraits of: "The Revd. T.G.D. Thring, one of the visiting magistrates of Ilchester Gaol," "The Rev.d. Will'm. Hungerford Colston, D.D. One of His Majesty's Justices of the Peace for the County of Somerset, and a visiting magistrate of Ilchester Gaol," "Mr. White, Agent to Bridle, the ex-gaoler of Ilchester," "Mr. Anstice, the County Surveyor" and "Doctor Woodford." The two supplementary addresses present in this copy are An address "To Mr. Baron Graham, one of His Majesty's Justices" and "To the Sheriff Magistrates, Freeholders, and County-Rate-Payers, of the County of Somerset" Hunt's charges were answered by William Bridle himself in *A Narrative of the Rise and Progress of the Imprisonments Effected in His Majesty's Gaol at Ilchester* in 1822. The anonymous author of The State of Justice positions himself as an opponent of bribery and the sale of offices and sinecures and a supporter of an equal distribution of justice and the rule of law. He warns: "It is not the law alone that makes a right government, but upright justice, and the equal distribution of it, which ought to be deeper engraven in the hearts of those who are authorised to execute justice, than in tables of stone" (9). It is a learned, and somewhat cranky, essay filled with references to Roman, European and English history. Trenchard's Short Essay is a classic argument against standing armies, a central theme in the commonwealthmen tradition (that was quite influential in America). One thing will interest you: the number of law-men whose letters showed, or shyly confessed, or brazenly announced interest in verse is such as to threaten the existing order. Some unsuspected and insidious propaganda has been poisoning the purer factuality of the profession. Unless something is done about it, and at once, verse-in-lawyers may become respectable." The partprinted laid-in card features a caricature of a naked Llewellyn (?) sitting cross-legged and gesturing to a motto: "Nothing endures, surely not these. But me they please - Now they are yours." Below this motto is an autograph inscription to Philip Jessup dated October 7, 1931: "To my friend Phil Jessup, these play-word jingglings, as a contrast to the serious ones of law." Jessup, a judge on the International Court of Justice, important legal scholar and U.S. diplomat, was credited with playing a major role in ending the Soviet blockade of West Berlin. He was a representative to the United Nations General Assembly, as well as a U.S. ambassador at large from 1949 until his resignation in 1953. Knox's Supreme Court argument in the landmark Northern Securities Case, and the federal government's appeal of the case from the Circuit Court to the Supreme Court, was likely bound by Knox as a gift to a colleague or friend. Decided in 1904, the Northern Securities Case was a pivotal case in the legal history of the Progressive Era and the history of railroads in the American West. The Northern Securities Company was a powerful trust formed by J.P. Morgan and James G. Hill to control railroad trunk lines in the Northwest and into Chicago and stifle competition. President Roosevelt, seeing an opportunity to exert federal power against a business monopoly, instructed Knox to bring suit against the Northern Securities Company. Knox handled the case personally, writing the appeal from the decision of the Minnesota Circuit Court, and arguing the government's case before the U.S. Supreme Court. Invoking the Sherman Antitrust Act of 1890, Knox argued that The Northern Securities Company acted in restraint of trade. The court's decision, on a 5-4 vote with Oliver Wendell Holmes and Chief Justice Melville Fuller dissenting, upheld the government's argument, affirming the constitutionality of the Sherman Antitrust Act. <u>Order This Item</u>





He was instrumental in promoting the adoption of a concept of *jus publicum* by legal theorists of the time after its introduction in his *Methodus Universi Iusis Civilis Absolutissima* of 1561. The present work draws on an earlier work by Tiraqueau, a vast treatise derived from the customary law of Poitou that first appeared in 1543. Wesenbeck, a leading Belgian humanist jurist who taught at the Universities of Jena and Wittenberg, was a distinguished and prolific scholar of Roman law with a pan-European reputation. A posthumous eight-volume collection of his consilia was published from 1611 to 1624. Our volume collects two books on jurisprudence for students. Exempla, a volume of legal points, was first published in 1573. Prolegomena, an introductory work on the law, was originally a section of the 1566 edition of Paratitla in Pandectas Iuris Civilis.
