\* Only edition. Brydall was a fellow of Queen's College, Oxford, and a bencher of Lincoln's Inn. A remarkably prolific writer, he published 36 legal treatises, and left 30 others in manuscript at the time of his death. All of these are brief, synthetic works. Holdsworth says they are good summaries that are "clearly arranged and based on the leading authorities." Lex Spuriorum, a handbook of English laws concerning illegitimacy, is cited in Holdsworth's review of legal writings of the seventeenth and eighteenth centuries. 

\* Only edition. With a detailed analytical digest. Established by a Royal Charter in 1600, the British East India Company was granted a 21-year monopoly on all trade in the East Indies. Based in a series of fortified manufacturing and trading centers, most notably Fort William in Bengal, Fort St. George in Madras and the Bombay Castle, the company evolved from a commercial venture to one that virtually ruled India as it acquired governmental, legal and military functions. It was dissolved in 1858. Produced as an official record, these volumes are a compilation of all regulations from 1793 to 1853 in force at Fort William. OCLC locates 6 copies. 



Originally published in 1828, it was the precursor of the modern forms of conveyancing, in respect to brevity and conciseness. Certainly it is most highly creditable to the sagacity of the author, and demonstrates the soundness of his acquaintance with principles, to find that so little advance has been made ahead of the principles which being then in a miserable minority, he so many years ago advocated, and so little improvement effected in the framework in which he embodied his views. But the book is not only remarkable it is in the highest degree adapted for use. (...) This work having been given to the world at a time when the public was not prepared for innovation, and had not acquired the now reigning tastes for brevity despatch, and economy of time, labour, and expense, attracted but little attention, and has never been as well known as it deserved to be. Mr. Horsey, however, the editor of the new edition, by careful additions and improvements, has brought up the work to the standard of the present day....": Law Magazine: Or Quarterly Review of Jurisprudence 23 (1855) 198. 





\* Fearne wrote an influential treatise on contingent remainders that was praised by Kent and Marvin. The present work was collected from his manuscripts by one of his pupils. Along with cases and opinions, it contains the reading of the Statute of Inrollments delivered in 1778 in Lyons Inn and the interesting case of General Stanwix. "Stanwix and his daughter had perished in the same shipwreck, and the question, as between their representatives, was whether either could be presumed to be the survivor; the case was compromised; but Fearne for his own amusement composed these two arguments for the two claimants.": Butler, preface to the seventh edition of *Contingent Remainders* cited in Holdsworth, *History of English Law XII:374. 

\* The (undated) inscription reads "To Arthur Goldberg-/ With the high regard and affection/ of his friend-/ Lyndon B. Johnson." Appointed by President Kennedy, Goldberg was an Associate Justice of the U.S. Supreme Court from 1962 to 1965 and one of the most significant justices of the twentieth century. In his three terms on the bench he pushed the Court toward a broader construction of personal rights, a course it followed over the following two decades. He is best known for his influential 1963 internal Supreme Court memorandum that condemned capital punishment as an example of "cruel and unusual punishment," as defined by the Eighth Amendment, and his opinion in Griswold v. Connecticut (1965), which argued against a Connecticut law banning the use of contraceptives because it violated an un-enumerated right to privacy guaranteed by the Ninth Amendment. The memo initiated a wave of litigation and legislation that led to the abolition of the death penalty in several states; the Griswold opinion laid the foundation for Roe v. Wade (1973), which established a women's right to have an abortion. When Adlai Stevenson, Ambassador to the United Nations, died in 1965 President Johnson decided to appoint Goldberg to fill his seat. Johnson's larger plan was to put Abe Fortas on the bench because he knew Fortas would defend his Great Society programs (and spy on the Court for him). Probably a recipient of the legendary Johnson "treatment," Goldberg was persuaded to resign while flying to Stevenson's funeral on Air Force One. Goldberg went on to say that he accepted the UN Ambassadorship in order to resolve the Vietnam Conflict. This photograph may be a memento of that 1965 flight, or one of the tools Johnson used to persuade Goldberg. Order This Item

\* Second edition. Text in Law-French. With a table. The *Liber Assisarum* is a selection of reports from the Year Books covering regnal years 1-50 of Edward III (1327-77). The contents are arranged alphabetically by topic. "The Book of Assizes (...) is of great authority in law; and so called because it principally contains proceedings upon Writs of Assize of Novel Disseisin, which in those days was *festinum et freems renaedium*. "Tis often quoted and referred to by most of our ancient writers. (...) The questions are here discussed with more precision and clearness, and they contain more of those points of law that have survived to the present times. In regard to precision and clearness, all the reports of this reign excel those of the preceding; but the merit of these [reports] is of a peculiar kind, and has a very different appearance from what has in later times been considered as excellent in this way" (Rastell). 

\* Cadwalader was a distinguished Philadelphia lawyer and the father of another notable jurist, John Cadwalader [1805-1879]. This 1816 letter is addressed to Pierce Butler of South Carolina [1744-1822], a former U.S. senator, member of the Continental Congress and signer of the U.S. Constitution. It concerns a dispute over a legal title and gently reminds Butler that "papers were submitted to your examination in June 1811 & are at any time open to your inspection. The conveyance Wallis to McClane is recited in the Marshal's deed to you." Order This Item







They are: Mittermeier, Rosshirt, Hofacker, Walter, Bauer, Waechter, Scheurlen, Zachariae, Kleinscrod, Friedrich, Hepp, Sander, Jagemann, Schenck, Geib and Hesse. 





\* This book reprints three rare pamphlets on political and legal subjects. The first two were originally published in 1659, the third in 1684. Little is known about the author, though he may have been a barrister. According to the editor, "[t]he principal value of the ensuing fugitive pieces consists in the curious and valuable information, both legal and historical, which they contain; and which, although mixed up with much extraneous and tedious matter, will not, on that account, be unacceptable to the *few* individuals who take an interest in our national history.": Preface [iii]. Robert Maxtone Graham was a notable Scottish book collector. 



(He was an important Whig jurist, Lord Chancellor during the reigns of William & and Mary and Queen Anne and framer of the English Bill of Rights). "In the most important case which came before him in the exchequer chamber, that of the bankers who had recovered judgment in the court of exchequer for arrears of interest due to them as assignees of certain perpetual annuities charged by Charles II upon the hereditary excise as security for advances, he expended some hundreds of pounds and an immense amount of thought and research, with no better result than to defeat an intrinsically just claim, on the technical ground that it was not cognisable in the court of exchequer, but only by petition of right. No judgment so elaborate had ever been delivered in Westminster Hall as that by which, in November 1696, he reversed the decision of the court of exchequer.": (DNB). 


#### Image of Furnival's Inn by Noted Engraver

Many were created for later editions of John Stow's *Survey of the Cities of London and Westminster*, which is probably the source of this plate. Furnival's Inn was an Inn of Chancery attached to Lincoln's Inn that was founded in 1383. 



\* Only editions. These items relate to a trial that followed the collapse of a notable Argentinean trading house. "Corruption or mismanagement by employees or partners of non-British houses frequently made news during the century. One of the more celebrated cases was the failure of Sebastian Lezica Brothers in September 1835. The manager of the house, a German named Frederick Hornung, apparently forged bills of exchange without the knowledge of his employers, three Argentine brothers. After the failure of a British house, Thwaites and Company, and after the retention of money in the Chilean branch, the Lezica Brothers had to raise money. Originally Hartung procured the signatures of a number of people, including Thwaites; but when persons declined, he began to forge names on bills of exchange--both the drawer's and drawee's names--in order to prevent bankruptcy. He thought this would need to be done for only a short time, but he became involved until the total sum owed the market was over one and a half million pesos." (Reber). 




