\* Only edition. A consideration of the economic effects of legislation prohibiting the export of wool, and a response to the needs of the British military during the Napoleonic Wars. Atkinson believes it would lead to an outflow of capital and a shortage of currency in Great Britain. The act was repealed without the repercussions he feared. However, The U.S. Congress enacted a protective tariff to discourage the importation of English wool. 





\* Only American edition. Colquhoun was a tireless reformer and public-minded citizen. First published in London in 1796, his treatise on criminology offered innovative proposals, such as the appointment of public prosecutors and paid magistrates, productive labor by convicts and a system of preventative police. This Philadelphia imprint was a response to the keen interest in this subject among elite circles of reformers and legislators in America. 



\* Second and final edition. Frasso, a Peruvian jurist of the Regalist school, presents an important legal analysis that supports the crown's power over the church in Spain's American colonies. The treatment of indigenous peoples was the source of tension between the Church and Crown. Both parties pursued colonial goals, but the Church was concerned about welfare of native people and attempted to ameliorate the effects of their exploitation by the Spanish government. \* First edition. Known as the *Book of Bounty*, this declaration clarified the confusing common-law precedents concerning monopolies and patents established during the Elizabethan period. It outlawed monopolies, but preserved the rights of inventors. It also restricted the King's power to grant patents. A landmark in the history of patent law, it established a precedent that inspired the 1624 Statute of Monopolies, which, as Holdsworth notes, established "the basis upon which our modern patent law still to some extent rests." The year 1610 is given according to Lady Day dating, the pre-1752 English practice in official business of beginning the year on March 25, the date of Annunciation. 



This book was based on an unpublished speech delivered in 1610 at the last session of the long Parliament before the Civil War by Hakewill, M.P. for Bossiney in Cornwall, Bencher of Lincoln's Inn and a notable legal antiquarian. Copies of the text circulated widely in manuscript. Appreciating its value, the Long Parliament ordered it to be printed. Based on a wide range of historical sources, some from the time of the Saxon kings, it asserts the illegality of extraparliamentary taxation. 



\* Only edition. This volume contains the first issue of Ladd's important "Essay on a Congress of Nations," the first important statement on the preservation of peace through international mediation published in the United States. It became a central text for American peace organizations and participants in international law conferences, and did much to persuade Americans to accept the idea of an international peace organization. It was also distributed widely in Europe, where it was well-received. Influential into the twentieth century, it was reprinted in 1916 by the Carnegie Endowment for International Peace. Anticipating the creation of the Permanent Court of International Justice and the League of Nations by a good 75 years, Ladd proposed an international "congress with legislative powers" that worked with a court that enforced its laws and settled international disputes. *Prize Essays* grew out of a contest sponsored in 1831 by the American Peace Society, of which Ladd was president. It offered a \$1,000.00 prize for the best essay describing the form and function of a "congress of nations." The judges were William Wirt, Joseph Story, Daniel Webster and John Marshall. They could not decide on a clear winner, so they published the five best essays. Ladd's essay, which was intended to serve as a summary and review of all of the submissions, synthesized their best elements, expanded them and combined them with his original ideas. 



The *coutume* of Lille was officially codified in response to orders issued by Emperor Charles V in 1531" (Caswell and Sipkov).
